PROCLAMATION

WESTERN AUSTRALIA, By His Excellency Sir James Mitchell, K.C.M.G., Lieutenant-Governor in and over the State of Western Australia Lieutenant-Governor.
[L.s.] and its Dependencies in the Commonwealth of Australia

WHEREAS by section 9 of the Fisheries Act, 1905-40, it is provided that the Governor may, by Proclamation, prohibit all persons from taking any fish whatsoever, in every or any specified portion of Western Australian in every or any specified portion of Western Austrahan waters by means of fishing nets and fishing lines, or either of such means of capture, or by any other specified means of capture, for any specified term: Now, therefore I, the said Lieutenant-Governor, do hereby, in exercise of the powers aforesaid and of every other power enabling me in this behalf, proclaim and declare as follows:—That all those portions of Western Australian waters defined in the Schedule hereto shall be closed against the use of fishing nets for a period of three years as from the date of publication of this Proclamation in the Government Gazette. Schedule.

All that area of Western Australian waters at City Beach extending along the foreshore one-quarter of a mile in each direction from the Groyne and to a width of one-half mile from mean low-water mark.
