



THE HIGH SCHOOL ACT, 1876.

HIS Excellency the Lieutenant-Governor in Council acting pursuant to section 4 of the High School Act, 1876, and the Acts amending the same has been pleased to approve of the repeal by the Governors of Hale School of the By-laws and Regulations heretofore made by the Governors of the High School, Perth, under the said section of the said Act and published in the Government Gazette on the 11th day of July, 1902, and the 24th day of March, 1910, and of the new By-laws and Regulations made under the said section of the said Act by the said Governors of Hale School in lieu of the By-laws and Regulations repealed as aforesaid, as set forth in the Schedule herennder.

Schedule.

Hale School-By-laws and Regulations.

These By-laws and Regulations may be cited as "Hale School By-laws, 1943," 1. and shall come into operation on the first day of January, 1944.

2. These By-laws and Regulations are divided into parts as follows:-

Part I.—By-laws 3 and 4—Preliminary. Part II.—By-laws 5 to 26—Proceed-ings of the Governors. Part III.—By-laws 27 to 41—School terms, fees, and admission of pupils. Part IV.—By-laws 42 to 45—Duties of Masters. Part V.—By-laws 46 to 51—Duties of Boys. Part VI.—By-laws 52 to 61-Miscellaneous.

Part I .--- Preliminary.

3 As from and after the date when these By-laws and Regulations come into operation all By-laws and Regulations heretofore made under section 4 of the High School Act, 1876, and still in force shall be and are hereby repealed.

In these By-laws and Regulations, subject to the context-""The Governors" means the Governors of Hale School as constituted under the said Act. "School year" means the year commencing on the first day of January.

Part II .-- Proceedings of the Governors.

Meetings.

The Governors shall hold meetings for the transaction of business at least once 5.in every month of the School year, except in the month of January, and may in addition hold meetings in the month of January whenever the same is deemed necessary.

So far as meetings of the Governors are held on specified dates, such dates shall be those which are fixed from time to time by the Governors.

7. Not less than three days' notice in writing of every meeting of the Governors shall be given or sent by post to each Governor.

8. At any time upon the written requisition of two Governors, who shall specify the particular business for which the meeting is required, the Chairman of the Governors shall convene a special meeting of the Governors to be held at any time after the expiration of seven days from the receipt of such requisition, but not later than 14 days from the date of the receipt of such requisition. Notice of such special meeting when given to the Governors shall state the purpose for which such special meeting is convened.

9. At the first meeting of the Governors held in the month of February in 9. At the first meeting of the Governors neutant the month of February in each year the Governors present at such meeting shall elect one of their number to be Chairman for the current year, and such Chairman shall hold office until the election of the Chairman for the year then next ensuing. Provided that if in the course of a current year the Chairman resigns, dies, is absent from the State for six calendar months or otherwise vacated his office, the Governors may elect another of their number to be Chairman for the remeinder of such suprest recerof their number to be Chairman for the remainder of such current year.

Any meeting of the Governors may be adjourned from time to time as often as may be necessary to conclude any unfinished business.

11. At all meetings of the Governors the Chairman (if present) shall preside, and in the absence of the Chairman, a Chairman for such meeting shall be chosen by a majority of the Governors present.

12. Four Governors shall form a quorum.

13. All questions which shall come before the Governors shall be decided by a majority of those present at the meeting, exclusive of the Chairman, and in the event of there being an equality of votes the Chairman presiding at the meeting shall have a casting vote.

14. All questions shall be decided on the voices, or, if any Governor shall so request, by a show of hands.

Order of Business at Meetings.

15. No business shall be transacted at any special meeting other than that for which such special meeting has been called.

16. (a) The order of business at ordinary meetings of the Governors shall be as follows:—(I) Confirmation of minutes of previous meeting. (II) Consideration of business arising out of minutes. (III) Correspondence. (IV) Financial Statements. (V) Report of Headmaster. (VI) Reports of sub-committees. (VII) Motions. (VIII) Notices of motion. (IX) General business. (b) In the event of any Governor having negent business to place before the meeting he may move the suspension of paragraph (a) of this By-law and, if such motion be agreed to by a majority of the Governors present, such business shall take precedence over all other business for that meeting.

17. (a) Any Governor who wishes to have rescinded any resolution carried at any previous meeting shall give to the Secretary of the Governors in writing at least seven days' notice of his intention to move at a meeting of the Governors that the said resolution be rescinded. (b) Particulars of such notice of motion shall be furnished to the Governors in the notice of the meeting at which the motion for rescission of the resolution will be moved.

Motions and Amendments.

18. A motion once it has been moved shall not be withdrawn except with the consent of the majority of the Governors present at the meeting.

19. Any number of amendments may be proposed on a motion before the meeting. Provided that when more than one amendment is moved the question shall first be put on the last amendment, then on the next in succession and so on until all the amendments are voted on, and lastly, on the original motion in the reverse order in which they were moved.

20. Unless seconded neither a motion nor an amendment shall be discussed by any Governor other than the mover or be put to the meeting by the Chairman.

21. When an amendment is carried the motion as amended thereby shall become the substantive motion upon which further amendments may be moved before it is finally dealt with.

22. When submitting a motion or an amendment to the meeting the Chairman shall put the question first for the affirmative and then for the negative.

Sub-committees.

23. (1) The Governors may at any time by resolution appoint any one or more of the Governors as a sub-committee, and may appoint such sub-committees as may be deemed advisable to inquire into any matter and to report and make recommendations regarding the same to the Governors, and to deal with any other matter or business which the Governors may delegate to such sub-committees. Provided that one of such sub-committees shall be a finance sub-committee. (2) No such subcommittee shall without the express authority of the Governors incur any financial liability or in any way commit the Governors to any obligation responsibility or liability whatsoever; and if any sub-committee without such express authority as aforesaid does incur any financial liability or does any act matter or thing which commits or may be deemed to commit the Governors to any obligation responsibility or liability aforesaid the Governors shall not in any way be bound or affected by the acts of the sub-committee unless and until the Governors, if they think fit so to do, shall affirm or ratify the said acts of such sub-committee.

Minutes.

24. Minutes of all the proceedings of the Governors shall be entered in a journal to be kept for the purpose by the Secretary, and at each meeting of the Governors the minutes of the preceding meeting shall be read and confirmed or amended and the presiding Chairman shall subscribe his signature thereto.

Appointment of Officers, Masters, etc.

25. The Governors may appoint and employ a secretary and such other clerks and servants in connection with the office of the Governors as they may deem necessary upon such terms as to salary or wages and conditions of employment as they may deem fit.

26. Subject to section 4 of the Act and as hereinafter provided the Governors shall as often as shall be necessary appoint and employ in connection with the school a headmaster and such other masters, teachers, instructors and other servants, including a matron, nurse, and household and domestic servants in the boarding house section of the school upon such terms as to salary or wages and subject to such conditions of service as the Governors may deem reasonable. Provided that:— (I) The Governors may at any time and from time to time delegate to the Headmaster authority to appoint and employ persons to and in any of the positions or services mentioned in this by-law. (II) Any authority delegated to the Headmaster as aforesaid may be so delegated with such restrictions and limitations and subject to such conditions as the Governors may think fit to impose.

Part III .- School Terms, Fees, and Admission of Pupils.

School Terms.

27. (1) There shall be three school terms to each and every year. (2) Each school term shall consist of not less than 12 weeks and not more than 14 weeks as the Governors shall from time to time determine. (3) The commencing and finishing dates of each school term respectively shall be such as the Headmaster shall recommend and the Governors approve.

28. Public holidays falling during the currency of a term may be observed or not as the Headmaster thinks fit and special holidays may be granted by the Headmaster during the currency of any school term provided the approval thereof of the Chairman of the Governors is first obtained.

School Hours.

29. The school hours shall be such hours as the Governors shall from time to time on the recommendation of the Headmaster by resolution prescribe.

30. Subject as hereinafter provided the school shall be open on all week days. Provided that the Governors may from time to time determine that the school shall not be open on Saturdays.

Fees.

31. (1) The school fees both for boarders and day boys shall be assessed and payable for and in respect of each school term at such rate or rates respectively as shall from time to time be prescribed by resolution by the Governors. (2) The school fees payable by boarders shall include the fee for thition. (3) In fixing the rate or rates of the school fees the Governors may prescribe such concessions rebates or discounts in relation to two or more brothers attending the school at the same time as they may think fit. (4) In necessitons or exceptional cases the Governors may waive payment of school fees either in whole or in part. (5) The Governors may grant such free scholarships or bursaries as they may deem desirable from time to time.

32. All fees shall be paid to the Secretary and shall be payable in advance at the commencement of each school term.

33. For the purpose of the assessment and payment of school fees the attendance of boys at the school shall be deemed to run from school year to school year, and the rate or rates of school fees s prescribed by the Governors may be varied either by increasing or reducing the same from time to time as the Governors think fit. Provided that the parent, gnardian or next friend of a boy attending the school and liable for the payment of school fees in relation to such boy shall not be liable for payment of school fees at an increased rate unless and until he shall have received from the Secretary of the Governors one term's notice in writing of the increase which has been made in the rate or rates of school fees applicable to such boy.

34. The person who, whether as parent, guardian or next friend of a boy attending the school, signed the application for the admission of such boy to the school shall be liable for the payment of the school fees chargeable by the Governors in respect of such boy.

35. At least one term's notice in writing of an intention to withdraw a boy from the school shall be given to the Secretary of the Governors by the person who in accordance with by-law 34 hereof is responsible for payment of the school fees of such boy; and where any boy is withdrawn from the school without the requisite notice being given in accordance with this by-law, the person responsible for payment of the school fees as aforesaid shall be liable for, and the Governors may recover from him as a debt, the amount of one school term's fees at the rate payable in respect of the boy in lien of such notice.

Admission of Boys to the School.

36. The Governors may from time to time by resolution prescribe:—(a) the minimum age at which boys shall be admitted to the school. (b) the minimum educational tuition which boys shall have received in order that they shall be eligible for admission to the school.

37. Any person who desires that a boy shall be admitted to the school shall make application in writing signed by him on a form from time to time prescribed by the Governors and shall deliver or send the same addressed to the Governors at the school.

38. When a boy is admitted to the school pursuant to such an application such application and such admission shall constitute a contract between the Governors and the person who has signed the application whereby the Governors agree to board and provide tuition in the case of a boarder, or to provide tuition in the case of a day boy in accordance with the Act and these by-laws and regulations and the person who has signed the application agrees to pay the school fees payable in respect of the boy and in all respects to observe, perform and comply with and to be bound by the provisions of the Act and these by-laws and regulations.

39. (1) Every application for the admission of a boy to the school shall be considered in the first instance by the Headmaster who may make such inquiries and investigations as he may think fit to determine whether or not the boy is a fit and proper person to be admitted. (2) If satisfied that a boy may properly be admitted to the school, the Headmaster may admit such boy accordingly without the prior approval of the Governors but shall report the fact of such admission to the Governors at their next meeting. (3) When the Headmaster admits a boy to the school without the prior approval of the Governors as provided for in paragraph (2) of this by-law, the Governors may at any time thereafter by notice to the person who signed the application for admission of such boy to the school cancel and revoke such admission and therenpon such boy shall cease to be entitled to attend the school. (4) Instead of admitting a boy to the school in the first instance as provided for in paragraph (2) of this by-law the Headmaster may refer the application for admission to the Governors, and in such case the Governors shall determine whether or not the boy shall be admitted to the school.

40. Whenever a boy is admitted to the school his name and such other particulars as the Governors may require shall be entered in a school register to be kept by the Headmaster for the purpose.

41. (1) The Headmaster may of his own motion and shall if directed so to do by the Governors, expel or otherwise request the parent, guardian or next friend to withdraw from the school any boy whose expulsion or withdrawal from the school is, in the opinion of the Headmaster or of the Governors (as the case may be), warranted in the interests of the school. (2) The expulsion or withdrawal from the school of a boy shall not relieve his parent, guardian or next friend from his liability to pay the school fees chargeable in respect of such boy for the school term during which the boy is expelled or removed.

Part IV.-Duties of Masters.

The Headmaster.

The Headmaster shall-

42. (a) See that these by-laws and regulations and any special rules not inconsistent with these by-laws and regulations which may from time to time be approved by the Governors are duly and faithfully observed performed and complied with by all persons affected thereby. (b) With the assent of the Governors prescribe the duties of the several masters, teachers, instructors and other servants engaged or employed in the school. (c) Undertake and be responsible for the control and management of the school as a whole including the supervision of all the several uasters, teachers, instructors and other servants aforesaid and of the several classes or departments in the charge of or in which such masters, teachers, instructors and other servants are engaged respectively. (d) Carry out such other duties as the Governors may require and which are compatible with his office as Headmaster.

43. The masters, teachers and instructors other than the Headmaster shall— (a) Carry out the duties for which they are employed under and subject to the supervision and direction of the Headmaster. (b) Obey and perform or carry out faithfully any instructions or directions issued or given to them by the Headmaster, and which are compatible with the particular office in which they are employed.

44. No master, teacher or instructor shall be absent from the school at any time when he should be on duty therein, without the permission of the Headmaster except in case of sickness, in which case the absence of such master, teacher or instructor shall be immediately reported by him to the Headmaster.

45. Every master, teacher, instructor or other servant shall, if required so to do by the Governors, sign and execute with the Governors a written contract setting forth the period for which, the rate of salary at which and the terms and conditions upon which he is employed by the Governors as such master, teacher, instructor or other servant.

Part V.-Duties of Boys.

46. Boys who are admitted to the school must—(a) come to school clean and neat in their persons and clothes, and, if so required by the Governors, wear such uniform clothing as the Governors may on the recommendation of the Headmaster from time to time prescribe. (b) attend school and remain in school during the school hours on every day on which the school is open, unless excused from such attendance by the Headmaster or any master, teacher or instructor for the time being in charge of the boy. (c) When absent from school contrary to paragraph (b) hereof, furnish to the Headmaster upon the day when they next attend school an explanation in writing signed by their parent, guardian or next friend, of the reason for their absence from school as aforesaid.

47. Any boy who absents himself from school except on account of sickness or other reason satisfactory to the Headmaster shall be liable to forfeit his standing in the school and in his class, and his right to attend the school for the remainder of the then current term.

48. (1) Every boy, who is admitted to the school, and is duly registered, shall attend at the commencement of each term and continue in punctual attendance until the close of such term or until he is regularly withdrawn from the school by notice to that effect given in accordance with the provisions of these by-laws and regulations. (2) Any boy violating paragraph (1) hercof shall not be entitled to continue in the school until such violation is certified by the parent, guardian or next friend of the boy either personally or in writing to have been necessary and unavoidable.

49. The boys shall be responsible to the Headmaster for any misconduct on the school premises, or when going to or returning home from school, except when they are accompanied by a parent, guardian or next friend or by some person appointed by them or on their behalf.

50. Every boy entitled thereto shall, when he leaves the school, receive from the Headmaster a certificate of good conduct and standing if in the opinion of the Headmaster the granting of such certificate is warranted.

51. (1) Any property of the school that is injured or destroyed by any boys shall be made good forthwith by the person liable under these by-laws and regulations for the payment to the Governors of the school fees of such boy.

Part VI.-Miscellaneous.

Common Seal.

52. (1) The corporate seal of the Governors shall be kept at the office of the Governors and at all times shall be in the custody and under the control of the Chairman of the Governors. (2) The said seal shall not be affixed at any deed document or

instrument except by order of the Governors, and then shall be so affixed at a meeting of the Governors by the Chairman presiding at such meeting and in the presence of the Secretary of the Governors, and the deed, document or instrument to which the corporate seal is affixed as aforesaid shall also be signed by three of the Governors present at the meeting.

Curriculum.

53. The ordinary curriculum of the school shall include such subjects as the Headmaster may from time to time recommend and the Governors may approve.

Inspection and attendance by the Governors.

54. The Governors, or any one or more of them shall be entitled at all times to enter any part of the school for the purpose of making such inspections and investigations or for any other purpose connected with the conduct and management of the school as they or he may deem necessary or expedient. Provided that when the Governors or any of them enter the school during school hours they shall do so in a manner which shall canse the least interference with or interruption of the carrying on of the work of the masters, teachers, and instructors and of the boys in the school.

Establishment of Clubs and Societies in the School.

55. Subject at all times to the approval, and, if thought fit, to the direction of the Governors, the Headmaster, with the assistance of the other masters, teachers, and instructors and of the boys may establish within the school any club or society, of which the boys may become members, for the purpose of promoting and encouraging literature, science and art, the playing or taking part in healthy games, exercises and open air pastimes, or for any other object or purpose which may be beneficial to the boys in their physical and mental development.

56. (1) Subject to the approval of the Governors the Headmaster may establish and maintain and enlarge such general and special libraries for the use of the boys in the school as he may think necessary or expedient. (2) The Headmaster may appoint such committees as he may think fit for the control and management of any libraries established under the authority of this by-law, and may make rules in relation to such control and management of the libraries and the use thereof by the boys. (3) Any committee appointed by the Headmaster as aforesaid may consist either of masters only, or of boys only, or of both masters and boys.

Finance.

57. All revenue or income from fees and other sources received by the Governors in their conduct and carrying on of the school—(a) shall be paid to the credit of an account in the corporate name of the Governors at a bank or banks to be selected by the Governors; and (b) shall be chargeable with the payment of the salaries and wages payable by the Governors, and with all other expenditure incurred by the Governors in the conduct and carrying on of the school.

58. All payments made by the Governors shall be made by cheques drawn on the said account, signed by any two of the Governors, and countersigned by the Secretary of the Governors.

59. The Governors shall cause books to be provided and kept, and true and regular accounts to be entered therein—(a) of all moneys received and paid by the Governors, and of all moneys owing to and by the Governors, and of the several purposes for which such moneys shall have been received and paid and shall be owing; and (b) of all the assets and liabilities of the Governors.

60. The Governors shall—(a) cause their accounts to be balanced every year on the 31st day of December; (b) cause a full and true balance sheet of the assets and liabilities together with a revenue account or a profit and loss account for each year and such other statements as may be necessary to be compiled from the books and to be submitted for examination and audit by an established public accountant practising in Perth.

Special Rules.

61. The Governors may from time to time by resolution make any special rules not inconsistent with the High School Act, 1876, or any Acts amending the same or with these by-laws and regulations which they may deem it necessary or desirable or convenient to make in relation to the proceedings of the Governors, the duties of the Headmaster and of the other masters, teachers or instructors or other servants employed by the Governors or in relation to the duties of the boys attending the school or in relation to any of the activities established or carried on at or in the school incidentally to the ordinary conduct, management and carrying on of the school by the Governors as authorised by law.

THE ROAD DISTRICTS ACT, 1919-1942.

Wanneroo Road Board—Additions and Amendments to By-laws.

BY-LAWS Nos. 1, 2, 3, 4, 5, and 6, made by the Wanneroo Road Board on the 15th day of April, 1938, and published in the *Government Gazette* on the 19th day of Angust, 1938, are hereby repealed and the following By-laws substituted therefore:—

By-laws for the Management of Reserves under the control of the Board and the Camping and Playing of Games thereon.

1. In the construction of this By-law, unless the context otherwise requires—(a) The word "Reserve" shall mean the ground owned by, vested in, or otherwise under the control of the Board. (b) The word "Caretaker" shall mean any person appointed by the Board to take care of any reserve or reserves. (c) "Servant" shall mean and include any person employed by the Wanneroo Road Board.

2. No person shall damage or interfere with any tree, shrub, fence, building, seat, treeguard, soil, or other property in any public reserve.

3. No person shall climb or be upon any tree, shrub, treeguard, wall, or fence in any public reserve.

4. No person shall tether any animal to any tree, shrub, treeguard, wall or fence in any public reserve.

5. No person shall throw stones or other missiles in any public reserve, or leave therein any bottle, orange peel, banana skins, paper, cast-off clothing, or any refuse or litter.

6. Any person found in a state of intoxication, or behaving in a disorderly manner, or using indecent, profane, or insulting language, or creating or taking part in any disturbance, or making harangues whereby a crowd is collected, or committing any act of indecency in any public reserve, shall be liable to be forthwith removed by any officer or servant of the Board or by any constable, and shall be guilty of an offence against this By-law.

7. No person shall cause, allow, or suffer any horse or cattle to be or to depasture upon any public reserve without first having obtained a license from the Board to do so.

8. No person, unless authorised in that behalf by the Board, shall lead, ride, or drive any horse, cattle, bicycle, tricycle, or vehicle upon or over any portion of any public reserve, except upon a carriage way.

9. No person, unless authorised in that behalf by the Board, shall leave any vehicle, whether in charge of any person or not, stationary upon any public reserve except upon a carriage way. 10. No person shall, unless authorised by the Board in that behalf, interfere with or remove any plant or flower, in any public reserve.

11. No person shall hawk or offer for sale in any public reserve any goods or articles of any description, without having previously obtained written permission from the secretary.

12. No person shall light any fire within any public reserve without permission from the secretary.

13. No person shall deface or write upon, or post, stick, stamp, stencil, paint, or otherwise affix, or cause to be posted, stuck, stamped, stencilled, painted, or otherwise affixed any placard, handbill, notice, advertisement, writing, or picture whatsoever upon any tree, building, fence, post, gate, wall, flagging or path in or around any public reserve without the written consent of the Board first obtained.

14. No person shall carry firearms through any public reserve, or shoot, snare, or destroy any bird or animal therein.

15. No person shall use any spring gun or catapult in any public reserve.

16. No person shall in any public reserve wilfully obstruct, disturb, interrupt, or annoy any other person in the proper use thereof, or wilfully obstruct in the execution of his duty, or insult, or neglect to obey the lawful directions of any caretaker or other servant of the Board.

17. No person shall spit or expectorate on the paths or seats or any structure or erection within any public reserve.

18. No person shall gamble or play pitch and toss or any other game of chance in any public reserve.

19. No person shall bring, carry or take into any public reserve any fermented or spirituous liquors, nor shall any person consume or drink same therein nor shall be found therein, having any fermented or spirituous liquors in his possession or under his control, without the written consent of the Board first obtained.

20. No person shall camp, lodge, or tarry overnight in any public reserve, or frequent the same for the purpose of camping, lodging, or tarrying overnight therein without having first obtained a written permit from the secretary so to do.

21. No person or organised club shall practise or play at any game on any public reserve without having first obtained a written permit from the secretary so to do.

22. No person or organised club having obtained any such permit as aforesaid shall practise or play at any such game, except at such times and upon such portions of the public reserve as shall be specified in such permit.

23. The sums to be charged by the Board to the various persons, clubs, sporting bodies, or associations for the use of any reserve or any portion thereof shall be such as shall be fixed by the Board from time to time.

24. The Board may grant the exclusive use of any reserve or any portion thereof to any particular person, elub, sporting body, or association for any particular day or days, and the fees to be charged to the public for admission shall be such as shall be fixed with the consent of the Board, by the person, elub, sporting body or association to whom such exclusive use shall be granted.

25. The Board reserve the right to refuse to rent any reserve or portion thereof to any applicant without assigning any reason for such refusal.

26. No person shall train or exercise any horse or dog within any public reserve.

27. No person shall suffer or allow any dog to enter or remain in any part of any public reserve.

28. No person shall erect or place within any public reserve any tent, stall, platform, or table for public amusement or for any performance, whether for gain or otherwise, without the consent of the secretary being first had and obtained.

29. No person shall commit a nuisance on or in any part of any pavilion, dressing room, or other building erected on any part of any public reserve.

30. No person shall fly any kite or balloon on any public reserve.

31. No male person, except children under the age of seven years accompanied by females, shall enter any place set aside for the use of females.

32. No person shall erect, keep or maintain or suffer or allow to be erected, kept or maintained any camp or other building within the boundaries of any reserve save s. d.

and except within that portion of such reserve as may be leased by the Board to any person or organised club and marked by special pegs and numbered on the plan open for inspection at the offices of the Board.

33 The camping permit shall indicate the site to be occupied and the secretary's decision in any dispute shall be final.

34. Fees for camping are payable prior to the issue of permits on the following scale :-

- For permits to camp for period not exceeding 1 0 24 hours
- For permits to camp for period not exceeding 2 48 hours 6 For permits to camp for period not exceeding
- 7 days 5 0
- Extension of the permits may be secured upon the payment of a further fee upon the above scale.
