PROCLAMATION

WHEREAS by the Game Act, 1912-1913, it is provided that the Governor may from time to time, by Proclamation, declare any one or more portions of the State, or any one or more localities, to be respectively defined in such Proclamation a Reserve for Native Game or any particular Native Game: Now, therefore I, the said Lieutenant-Governor, in exercise of the power aforesaid, do hereby, with the advice of the Executive Council, declare that the portions of the State and localities mentioned and defined in the Schedule hereto shall be a Reserve for Native Game.

Schedule.

Bunbury.—All that portion of land bounded by lines starting from the junction of the southern alignment of Beach road, with the western alignment of Spencer street, Bunbury, and extending southerly along the latter alignment, to the northern alignment of Clarke street; thence westerly, along the latter, and onwards, to the consluent theme north-north-north-negative along the to the seashore; thence north-north-easterly, along the said seashore, to a point situate in prolongation westerly of the southern alignment of Beach road aforesaid, and thence generally easterly, north-easterly and again easterly, to and along the latter alignment, to the starting point. starting point.

The Metropolitan Water Supply, Sewerage and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 260/43.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909, it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct and extend Water Works, Sewerage Works and Stormwater Drainage Works; and whereas the preliminary requirements of the said Act have been complied with, and plans, sections and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Lieutenant-Governor, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage and Drainage to undertake the construction of the following works under the said Act, namely:—Metropolitan Sewerage—Main Gravitation Sewer—Natural Ventilation.—Steel educt stacks and induct vents, with necessary connections to manholes or main sewer pipe, as shown in red on Plan M.W.S.S. & D.D., W.A. No. 6720.

This Order in Council shall take effect from the 17th day of November, 1943.

Workers' Compensation Act, 1912-1941. ORDER IN COUNCIL.

WHEREAS it is enacted by section 10 of the Workers' Compensation Act, 1912-1941, that it shall be obligatory for every employer to obtain from an incorporated insurance office approved by the Minister a policy of insurance for the full amount of the liability to pay compensation under the said Act to all workers employed by him, but that if an employer proves to the satisfaction of the Minister that such employer has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability, the Governor may by Order in Council exempt such employer from the operation of the said section; and whereas the New Zealand and Australian Land Company, Limited, of Yathroo Station, Dandarragan, in the State of Western Australia, being an employer within the meaning of the said Act, and as such subject to section 10 of the said Act, has duly, in accordance with the regulations, made application for exemption from the operation of the said section 10, and has proved to the satisfaction of the Minister that it has established a fund for insurance against its liability under the said Act and has deposited with the Treasury a security, to wit, Australian Inscribed Stock of the amount of £5,150, already held by the Treasurer, charged with all payments to become due under the said liability: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act, doth hereby exempt the said the New Zealand and Australian Land Company, Limited, from the operation of section 10 of the Workers' Compensation Act, 1912-1941, for a period of two years commencing on the 1st day of November, 1943.

Peppermint Grove Road Board-Resolution.
