ORDER IN COUNCIL.

WHEREAS it is enacted by section 6 of the Water Boards Act, 1904, that for every Water Area constituted under that Act there shall be a Water Board constituted by the Governor by Order in Council; and whereas it is enacted by section 3 of the Water Supply, Sewerage and Drainage Act, 1912, that the Governor may revoke any Order in Council made before or after the component of the gold lest werehand. mencement of the said last-mentioned Act, for the constitution of a Water Board under the Water Boards Act, 1904, aforesaid, and dissolve the Water Board constituted pursuant to any Order so revoked; and whereas by an Order in Council dated 11th day of October, 1905, and published in the Government Gazette on the 13th day of October, 1905, the Governor, acting in exercise of the power conferred by section 6 of the Water Boards Act, constituted the Port Hedland Water Area and the Port Hedland Road Board a Water Board to administer the Water Boards Act, 1904, in the said Water Area; and whereas it is now deemed desirable and expedient that the Order in Council aforesaid should be revoked so far as it constituted a Board for the Port Hedland Water Area and the Water Board constituted pursuant thereto should be dissolved: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the power conferred by section 3 of the Water Supply, published in the Government Gazette on the 13th day of the power conferred by section 3 of the Water Supply, Sewerage and Drainage Act, 1912, doth hereby, as from and after the 1st day of February, 1944, revoke so much of the said Order in Council as constituted a Board for the Port Hedland Water Area and dissolve the Port Hedland Road Board as the Water Board constituted

for the Port Hedland Water Area pursuant to the said Order in Council now hereby revoked.

Workers' Compensation Act, 1912-1941.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 10 of the Workers' Compensation Act, 1912-1941, that it shall be obligatory for every employer to obtain from an incorporated insurance office approved by the Minister a policy of insurance for the full amount of the liability to pay compensation under this Act to all workers employed by him, but that if an employer proves to the satisfaction of the Minister that such employer has established a fund for insurance against such liability and has deposited at the Treasury, securities charged with all payments to become due under such liability, the Governor may, by Order in Council, exempt such employer from the operation of the said section; and whereas The National Bank of Australasia, Limited, of St. George's terrace, Perth, being an employer within the meaning of section 10 of the said Act and as such subject to the provisions of the said section 10, has duly, in accordance with the regulations made under the said Act, made application for exemption from the operation of section application for exemption from the operation of section 10 aforesaid, and has proved to the satisfaction of the Minister that it has established a fund for insurance against its said liability under the said Act, and has deposited at the Treasury securities, to wit, a bond for £5,000, charged with all payments to become due under the said liability: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act, doth hereby exempt the said The National Bank of Australasia, Limited, from the operation of section 10 of the Workers' Compensation Act. 1912-1941. for a period of two years commencing Act, 1912-1941, for a period of two years commencing on the 1st day of January, 1944.

ORDER UNDER REGULATION 4 OF THE NATIONAL SECURITY (GENERAL) REGULATIONS.

WHEREAS by regulation 4 of the National Security (General) Regulations it is provided (amongst other things) that if it appears to the Minister to be necessary or expedient in the interests of the Defence of the Commonwealth or the efficient prosecution of the war, or for maintaining supplies and services essential to the life of the community that special precautions should be taken for the security of any place, he may by order declare that place to be a prohibited place either any place, he may by order declare that place to be a prohibited place either generally or during such hours or during the existence of such circumstances as are specified in the Order for the purposes of the Regulations; and whereas by instrument of delegation dated the twenty-first day of September, 1943, made in pursuance of section 17 of the National Security Act, 1939-1940, the Minister of State for the Army, acting for and on behalf of the Minister of State for Defence delegated to every officer who should at any time during the continuance of the delegation be holding the office or performing the duties of the Office of Commander of a Lines of Communication Area the powers and functions conferred upon the said Minister. of Communication Area the powers and functions conferred upon the said Minister by regulation 4 of the National Security (General) Regulations in relation to that lines of Communication Area; and whereas it appears to me, Oswald Vick Hoad, Brigadier, the officer for the time being holding the office of Commander of Western Australia Lines of Communication Area, necessary and expedient in the interest of the Defence of the Commonwealth and the efficient prosecution of the war and for maintaining supplies and services essential to the life of the community that special precantions should be taken for the security of the places referred to in the Schedule hereto, being places situate within the said Western Australia Lines of Communication Area: Now therefore I, the said Oswald Vick Hoad, acting in pursuance of the said Instrument of Delegation and of the said regulation and of all other powers me hereunto enabling:-

- 1. Do hereby order:—(a) That the places described in the Schedule hereto are declared to be prohibited places generally for the purpose of the National Security (General) Regulations from the date of the making of this Order. (b) That WX29331 T/Major Colin Ednie Brown, G.S.I., W. Aust. L. of C. Area, is authorised to issue permits to enter, approach, inspect, pass over, or be in or in the neighbourhood of the said prohibited places. (e) That W244159 T/Capt. Joseph Eric Piercy, M.C., W. Aust. L. of C. Area Section, Aust. Intelligence Corps is specified as the Officer to exercise and perform the powers and functions of the officer in charge of the said prohibited places for the purposes of the National Security (General) Regulations.
- 2. Do hereby revoke the Orders made by me under regulation 4 of the National Security (General) Regulations on the twenty-third day of November, 1942, the seventh day of December, 1942, and the twenty-ninth day of January, 1943, respec-The Schedule.

the Defence of the Commonwealth and the efficient prosecution of the war and for maintaining supplies and services essential to the life of the community that special maintaining supplies and services essential to the life of the community that special precautions should be taken for the security of the place referred to in the Schedule hereto, being a place situate within the said Western Australia Lines of Communication Area: Now therefore I, the said Oswald Vick Hoad, acting in pursuance of the said Instrument of Delegation and of the said regulation and of all other powers me hereunto enabling do hereby order:

(1) That the place described in the Schedule hereto is declared to be a prohibited place generally for the purpose of the National Security (General) Regulations from the date of the making of this Order.

That, subject to the consent of the Governor under section 12 of the Bulk Handling Act (1935), the Articles of Association be amended as follows:—Add to Article 5 the following proviso:—"Provided that the number of shares which may be held by or by and on behalf of any one shareholder shall be limited to five, that no person shall be allotted or registered as the holder of more than five shares, that no transfer shall be approved by the Directors if its registration would result in the transferee being the registered holder in his own name of or otherwise beneficially entitled to more than five shares in the aggregate and that the shares shall not be quoted for sale or purchase at any stock exchange or in any other public manner whatever.'

Insert the following new Article after Article 5, namely:—"5. (a) The Company may purchase out of its reserve funds any shares of a member of the Company but the shares so purchased and not sold or disposed of shall not at any time exceed one-twentieth part of the paid up capital of the Company. The shares so purchased shall not be deemed to be cancelled nor to be a reduction of capital but may be sold re-allotted or otherwise disposed of by the Company in terms of Article 5 hereof.''

In Article 37 delete the word and figures "Article 40" and substitute the following words and figures, namely:—"Articles 5 and 40 and 44 (a) to 44 (d) inclusive hereof."

Insert at the commencement of each of Articles 43 and 44 hereof the following words and figures, namely:-'Subject to Article 5 hereof.''

Insert the following new Articles after Article 44, namely:

"44. (a) Subject to Articles 5 and 40 hereof a share may be transferred by a member or other person entitled to transfer the same to any member selected by the transferor; but save as aforesaid and save as provided by Article 44 (d) hereof no share shall be transferred to a person who is not a member so long as the Company or any of its members or any person (being an active grower of wheat) selected by the Directors as one whom it is desirable in the interests of the Company to admit to membership is willing to purchase the same at its par value.

"For the purpose of this and succeeding Articles the term 'par value' shall be deemed to be the amount paid up or properly credited as paid up on such share.

"44. (b) Except where the transfer is made pursuant to Article 44 (d) hereof the person proposing to transfer any shares (hereinafter called the 'proposing transferor') shall give notice in writing (hereinafter called a 'transfer notice') to the Company that he desires to transfer the same. Such notice shall constitute the Directors his agents for the sale of the share to the Company or to any member of the Company or person selected as aforesaid at the par value. A transfer notice may include several shares and in such case shall operate as if it were a separate notice in respect of each. A transfer notice shall not be revocable except with the sanction of the Directors.

"44. (c) If the Company shall within the space of twelve calendar months after being served with a transfer notice decide to purchase the share itself or find a member or person selected as aforesaid willing to purchase such share, and shall give notice thereof to the proposing transferor then the proposing transferor shall be deemed to have sold the share accordingly and the Company may then or at any time thereafter cause the

name of the purchaser to be entered in the register as the holder of the share and shall hold the purchase money in trust for the proposing transferor and pay the same to him upon delivery up to the Company for cancellation of the certificate for such share. The receipt of the Company for the purchase money shall be a good discharge to the purchaser and after his name has been entered in the register in purported exercise of the aforesaid power the validity of the proceedings shall not be questioned by any person.

"44. (d) If the Company shall not within the space of twelve calendar months after being served with a transfer notice purchase the shares itself or find a member or person selected as aforesaid willing to purchase the shares and give notice in manner aforesaid the proposing transferor shall at any time within three calendar months afterwards be at liberty subject to Articles 5 and 40 hereof to sell and transfer the shares or those not placed to any person and at any price.

"44. (e) Should it come to the notice of the Directors that a member has died or has had a sequestration order in bankruptcy made against his estate or has assigned his estate for the benefit of his creditors under any Act for the time being in force for the relief of insolvent debtors or has ceased to be or is not an active grower of wheat in his own right the Directors shall resolve that this Article shall apply to the shares registered in the name of such member and thereupon such member or other person entitled to transfer such shares shall be deemed to have served the Company with a transfer notice pursuant to Article 44 (b) hereof. Without detracting from the right of the Directors to act at any time on information received the fact that no wheat grown by a particular member shall have been received by the Company during the last two completed seasons shall for the purposes of this Article and of Article 94 be conclusive evidence that such member is not or has ceased to be an active grower of wheat unless such member proves to the satisfaction of the Directors that such failure to deliver wheat to the Company in either season has been occasioned by drought, flood, fire, storm or other untoward happening to his crop.'

In Article 59 delete the word "three" and substitute the words "twenty-five."

Add the following paragraph to Article 94:—"(e) If he ceases to be an active grower of wheat in his own right."

Delete Article 65 and substitute:—"65. Twelve members present in person shall form a quorum for a General Meeting."

Delete Article 71 and substitute:—"71. A poll may be demanded by the Chairman presiding at any meeting or by five or more members present personally or by proxy or attorney and if demanded but subject to Article 72 hereof such poll shall be taken by postal voting in accordance with such directions as shall be given by the Chairman presiding at such meeting. The result of such poll shall when notified to the Company by the returning officers or scrutineers appointed by the Chairman be deemed to be the resolution of the Company in general meeting."

Delete Article 76 and substitute:—"76. On a show of hands and also in case of a poll taken under Article 72 hereof every member whether present in person or by attorney or proxy shall have one vote only and a member present in person and being attorney or proxy of or for another member or members may cast his own vote and also a vote for each other member whom he so represents."

"At a poll taken under Article 71 hereof every member shall have one vote but he shall not be entitled to vote by proxy or attorney."

In Article 78 interpolate before the words "that one of said persons" the words "and also in the case of a poll taken under Article 71 hereof."

In Article 79 interpolate after the words "General Meeting" the words "or any poll taken under Article 71 hereof."
