WHEREAS by the Transfer of Land Act, 1893, Amendment Act, 1896, (60 Vict., No. 22), the Governor is empowered by Proclamation in the Government Gazette to revest in His Majesty as of his former estate all or any lands, whereof His Majesty may become the registered proprietor; and whereas His Majesty is now the registered proprietor of portions of Nelson Locations 1700 and 5257 registered in the Office of Titles in Volume 1079, Folio 780: Now, therefore I, the said Lieutenant-Governor, with the advice and consent of the Executive Council, do by this Proclamation revest in His Majesty, his heirs and successors, portions of Nelson Locations 1700 and 5257 aforesaid as of his former estate.

AT a meeting of the Executive Council held in the Executive Council Chamber, at Perth, this 8th day of February, 1944, the following Order in Council was authorised to be issued:—

The Land Act, 1933-39.

ORDER IN COUNCIL.

Corr. No. 314/99. WHEREAS by section 34 of the Land Act 1933-39, it is made lawful for the Governor, by Order in

Council, without issuing any deed of grant, to place any Reserve under the control of any Municipality, Road Board, or other person or persons, as a Board of Management, and to empower such Board to make, repeal, and alter by-laws for the control and management of such Reserves, and prescribe fees for depasturing thereon, and for other purposes, such by-laws to be approved by the Governor and published in the Government Gazette; and whereas it is deemed expedient that Reserve 6741 (Boyanup Sub.-lot 27) for Recreation and Showground at Boyanup, should be placed under the control of the Capel Road Board as a Board of Management: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby place the before-mentioned Reserve under the control of the Capel Road Board as a Board of Management, and doth empower such Board to make, repeal, or alter by laws for the control and management of the said Reserve; for prescribing fees for depasturing thereon; for directing the manner in which such fees shall be imposed, paid, collected, and disposed of, and to impose penalties not exceeding in any case £5 for any breach thereof, and £2 a day for a continuing breach, but not more than £20 in the aggregate.

officer who joins or has joined the service of the Bank when over the age of nineteen years his salary on reaching the age of twenty-eight years shall be not less than that prescribed for an officer in his twelfth year of service and shall be increased thereafter as though he had completed eleven years' service on reaching his twenty-eighth birthday.

2.—Branch Managers.

Minimum salaries to be paid to Branch Managers shall be similar to those obtaining in New South Wales.

3.—General Conditions.

Save as hereby altered all the provisions contained in the Award of the Court of Arbitration of Western Australia No. 22 of 1943, shall apply to the conditions of service between the Bank and its officers until amended or varied by an Award of the Court of Arbitration pursuant to the Industrial Arbitration Act, 1912-1941, by which the parties to this Agreement shall be bound.

4.—Privileges.

Notwithstanding anything in this agreement no officer shall suffer loss by way of salary, allowance, position and/or any other privileges existing at the date hereof and of existing practices in regard to allowances privileges and rights on the date mentioned shall not be diminished by this Agreement.

5.—Period of Agreement.

This Agreement shall take effect as on and from the First day of November, One thousand nine hundred and forty-three, and shall remain in force for a period of three mouths and thereafter until all or any of its clauses are terminated by notice in writing given by either party to the other or by authority of both parties to this Agreement: Provided nevertheless that the term of this Agreement shall not in any event extend beyond the thirty-first day of October, One thousand nine hundred and forty-six.

6.—Termination of Previous Agreement.

It is hereby mutually agreed and declared that a certain Agreement bearing date the Thirtieth day of April, One thousand nine hundred and forty-three, and made between the parties hereto shall as from the Thirty-first day of October, One thousand nine hundred and forty-three, be determined and cease to be of further effect.
