The Medical Act Amendment Act, 1940. PROCLAMATION

WESTERN AUSTRALIA, By His Excellency Sir James Mitchell, TO WIT. K.C.M.G., Lieutenant-Governor in and over the State of Western Australia Lieutenant-Governor. LLs.] KICLM.G., Lieutenant-Governor in and over the State of Western Australia wealth of Australia.

WHEREAS under the provisions of the Medical Act Amendment Act, 1940, where the Governor in Council is satisfied that the residents of any area are not adequately provided for in respect of medical or surgical services, the said Governor in Council may, by Proclamation, declare such area to be a region within the meaning of the said Act; and whereas the Governor in Council has proclaimed a region to be known as the Kondinin Region; and whereas it is now desired to amend the boundaries of the said Region under the provisions of the said Act: Now, therefore, I the Lieutenant-Governor in and over the State of Western Australia, being satisfied that the residents of the area specified in the Schedule hereunder are not adequately provided for in respect of medical or surgical services, proclaim the said area to be added to the Kondinin Region under the provisions of the said Act, and to be incorporated as part of the said Kondinin Region

The application to the Board for its approval of a Children's Nurses Training Hospital shall be accompanied by a statement in writing signed by the person who has signed the applica-tion setting out the following information, namely— (a) the daily average number of beds occupied by child patients for each of the last two years preceding the application; (b) the name and qualifications of matron; (c) the names of the medical staff of the hospital; (d) a statement that the consent of the medical staff of the hospital to give lectures in accordance with the prescribed schedule of training has been obtained; the prescribed schedule of training has been obtained; (e) the number of trained nurses and probationers employed in the hospital; (f) the number of operations performed in the hospital during the year next preceding the application; (g) the proportion of medical and surgical cases dealt with during the year next preceding the application; and (h) the number and variety of cases of infectious diseases dealt with during the year next preceding the application. 23B. The provisions of regulation 22 hereof shall apply to hospitals which have been approved as Children's Nurses Training Hospitals. 23C. If a trainee at a Children's Nurses Training Hospital intends to proceed to the further training required by regulation 47 hereof, then the additional period of training in the nursing of adults shall be incorporated with the prescribed period of training as a children's nurse, unless in any individual case approved by the Board other arrangements are made.
