AT a meeting of the Executive Council held in the Executive Council Chamber, at Perth, on the 20th day of July, 1944, the following Orders in Council were authorised to be issued:—

The Workers' Compensation Act, 1912-1941.
ORDER IN COUNCIL.

WHEREAS it is enacted by section 10 of the Workers' Compensation Act, 1912-1941, that it shall be obligatory for every employer to obtain from an incorporated insurance office approved by the Minister a policy of insurance for the full amount of the liability to pay compensation under this Act to all workers employed by him but that if an employer proves to the satisfaction of the Minister that such employer has established a fund for insurance against such liability and has deposited at the Treasury, securities charged with all payments to become due under such liability the Governor may by Order in Council exempt such employer from the operation of the said section; and whereas The Union Bank of Australia, Limited, of St. George's terrace, Perth, is an employer within the meaning of the said Act and as such is subject to the said section 10 and having in accordance with the Act and the regulations made thereunder made application for exemption from the operation of the said section has satisfied the Minister that it has established a fund for insurance against its said liability and has deposited at the Treasury, securities, to wit, a bond for Five thousand pounds charged with all payments to become due under such liability: Now, therefore, His Excellency the Lieutenant-Governor acting with the advice and consent of the Executive Council and in exercise of the power conferred by the said Act doth hereby exempt the said The Union Bank of Australia, Limited, from the operation of section 10 of the Workers' Compensation Act, 1912-1941, for a period of two years commencing on the 21st day of June, 1944.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 10 of the Workers' Compensation Act, 1912-1941, that it shall be obligatory for every employer to obtain from an incorporated in-

surance office approved by the Minister a policy of insurance for the full amount of the liability to pay compensation under the said Act to all workers employed by him, but that if an employer proves to the satisfaction of the Minister that such employer has established a fund for insurance against such liability and has deposited at the Treasury, securities charged with all payments to become due under such liability the Governor may by Order in Council exempt such employer from the operation of the said section 10; And whereas Cuming Smith & Mt. Lyell Farmers Fertilisers, Limited, of 133 St. George's terrace, Perth, is an employer within the meaning of the said Act and as such is subject to the provisions of the said section 10 and, having made application in accordance with the regulations made under the said Act for exemption from the operation of the said section, has proved to the satisfaction of the Minister that it has established a fund for insurance against its liability under the said Act to pay compensation to all workers employed by it, and that it has deposited at the Treasury, securities, to wit, a fixed deposit receipt for Five thousand pounds issued by the English, Scottish, and Australian Bank, Limited, at Perth, charged with all payments to become due under the said liability: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said section 10, doth hereby exempt Cuming Smith & Mt. Lyell Farmers Fertilisers, Limited, of 133 St. George's terrace, Perth, from the operation of section 10 of the Workers' Compensation Act, 1912-1941, for a period of two years computed from and including the first day of July, 1944.

Health Act, 1911-42. ORDER IN COUNCIL.

WHEREAS it is enacted by section 19 of the Health Act, 1911-1942, that the Governor may by Order in Council constitute any portion of the State, not being a municipal district, a health district with such boundaries and by such name as may be specified in the order, and may abolish any such district; and whereas health districts were constituted to be known respectively as the Moora (Townsite) Health District and the Moora (Road Dis-

trict) Health District: Now therefore His Excellency the Lieutenant-Governor acting with the advice and consent of the Executive Council and in exercise of the powers conferred by section 19 of the Health Act, 1911-1942, doth hereby abolish the health districts heretofore constituted and known respectively as the Moora (Townsite) Health District and the Moora (Road District) Health District and doth hereby constitute all that portion of the State comprised in the Moora Road District to be a health district for the purposes of the said Act to be known as the Moora Health District.

THE HEALTH ACT, 1911, AND AMENDMENTS. Rockingham District Road Board and Local Health Authority—By-laws Prohibiting Dairies in Townsites. WHEREAS under the provisions of the Health Act, 1911, and amendments, a local health authority may make by-laws for all or any of the purposes in the said Act and amendments mentioned: Now the Rockingham District Road Board being the local health authority for the Rockingham Road District in pursuance of the powers vested in it by the said Act and amendments and of every other authority enabling it in that behalf, doth hereby make and publish the following by-laws:—

- 2. The townsites of Safety Bay, Kwinana and Rockingham (excepting that portion thereof consisting of Rockingham Town Lots 318, 319 and 320) within the Rockingham Road District are hereby defined as areas within which it shall not be lawful to establish and open dairies, and the establishment and opening of dairies in such areas is hereby prohibited.
- 3. No person shall open, establish or carry on a dairy within any of the areas defined in paragraph 2 above, and neither the owner nor the occupier of any land within any of such areas shall permit, suffer or allow any dairy to be established, opened or carried on upon any such

4. Every person guilty of an offence against any of these by-laws shall be liable on conviction—(a) for a first offence to a penalty not exceeding twenty pounds, and (b) for every subsequent offence to a penalty not exceeding fifty pounds, or imprisonment with or without hard labour for not exceeding six months.

INDUSTRIAL AGREEMENT No. 5 of 1944. (Registered 12/7/44.)

THIS Agreement made in pursuance of the Industrial Arbitration Act, 1912-1925, this 25th day of June, one thousand nine hundred and forty-four between Victor Leggo Mining Co. Pty., Ltd., of Wiluna (hereinafter called the employer) of the one part and The Australian Workshap, Union Workshap, Property Living Property Industrial Living Property Industrial Living Property Industrial Prop Workers' Union, Westralian Branch, Industrial Union of Workers (hereinafter called the union) of the other part witnesseth that for the considerations hereinafter appearing the parties hereto mutually covenant and agree the one with the other as follows:-

1.—Term.

The currency of this Agreement shall be for two years from the 25th day of June, one thousand nine hundred and forty-four.

2.—Area.

This Agreement shall operate over the arsenic plant at Wiluna.

3.—Wages.

Basic wage—£5 6s. 7d.

For all work not specified as above the rates of pay shall be as prescribed by the current Mining Award for the class of work performed: Provided that where under such Award the rate per shift is calculated on the basis of six (6) full shifts per week the rate per shift under this Agreement on the basis of five and one-half (5½) shifts per week shall be so calculated that the aggregate payment of five and one-half (5½) shifts under this Agreement shall be equal to the aggregate payment of six (6) shifts under the said Award.

Payment of wages shall be made each alternate Friday. The above rates are payable under a contract of daily

4.—Hours.

- (a) For roastermen, packermen, screwmen and rousabouts (hereinafter called essential arsenic workers) the hours of employment shall not exceed seventy-eight (78) hours per fortnight to be worked in alternate weeks of thirty-six (36) hours and forty-two (42) hours. For all other workers the hours of employment shall not exceed forty-four (44) hours per week.
- (b) The hours to be worked per shift shall be as set cut hereunder according to the classification of the worker:—(i) For essential arsenic workers six (6) hours exclusive of crib time. (ii) For change room attendants seven and one-third (7 1/3) hours exclusive of crib time. (iii) For all other workers eight (8) hours exclusive of crib time.

Provided that no worker shall during any one shift work for a longer period than six (6) hours within any section of the arsenic works in which essential arsenic workers are or would be normally engaged.

(c) Crib time shall not exceed three-quarters (¾) of an hour in the case of ronsabouts or one-half (½) hour in the case of all other workers.

5.—Overtime.

- (a) No overtime shall be worked excepting to effect repairs (this clause not to apply to roastermen when the relief man fails to turn up at the change of shift).
- (b) All work done beyond the ordinary hours of duty on any ordinary working day (Monday to Saturday) inclusive, shall be paid for at the rate of time and onehalf for the first two (2) hours and at double time there-
- (c) All work done on Sundays shall be paid for at the rate of time and one-half up to six (6) hours and at double fime thereafter.
- (d) When a worker is required to continue working after the usual knock-off time for more than one hour without having been notified on the previous day and providing such overtime carries him over a recognised meal hour he will then be provided with a meal or be paid two (2s.) shillings in respect to any such meal.

6.—Public Holidays.

The following shall be holidays:-Christmas Day, Easter Monday and Labour Day. If Christmas Day falls on a Sunday the following Monday shall be kept. In the event of a worker not being required by the employer to present himself for duty on any of these days payment may be deducted. All work done on public holidays shall be paid for at the rate of double time.

7.—Annual Holidays.

A fortnight's holiday including twelve (12) ordinary working days on full pay shall be granted once in each year to every worker: Provided he has worked two hundred and ninety-eight (298) shifts at ordinary rates of pay and should he have worked less than two hundred and ninety-eight (298) shifts when such holiday is taken or at the termination of his employment he shall be paid for a proportionate number of holidays. This clause shall operate regardless of the circumstances attending the termination of the worker's employment.

8.—Resumption of Work after Holidays.

Where a worker is not notified prior to taking his holidays that no further work is available he shall be re-engaged upon his return.

9.—Accident Pay.

In the event of a worker meeting with an accident during the course of his shift or being required to attend to one who has met with an accident he shall be deemed to have rendered duty during the whole of the shift and shall be paid accordingly.

10.-Full Payment for Shift.

- (a) After beginning a shift, workers shall not be paid less than for a full shift unless they leave of their own accord or are dismissed for misconduct.
- (b) If before a worker leaves the works at the end of the shift and because he is not so informed he attends the next shift ready to work it and there is no suitable work which he is allowed to perform he shall be paid the wages he would have been entitled to if he had worked the shift he was ready and willing to work.

11.—First Aid.

A suitable first-aid kit shall be supplied by the employer and shall be accessible at all times.

12.—Drinking Water.

Drinking water cool and free from dust shall be provided by some approved method other than by water

13.—Showers.

A suitable change-room with hot and cold showers shall be provided.

14.—Working Clothes and Equipment.

The following articles shall be supplied by the employer when necessary to the welfare of the workers and shall be laundered and kept in good repair by the employer: -Gloves, goggles, masks, overalls, bloomers.

15.—Quick Shifts.

No worker shall be required to report for work unless he has had at least eight (8) hours off duty since his previous shift.

16.—Retrenchments.

Should the occasion arise to reduce the number of men employed the company shall give full weight to the consideration of length of service and shall retain those who have been longest in their employ all things being equal.

17.—Casual Labourers.

Any worker employed for less than one week shall be considered casual and shall be paid two shillings per shift (2s.) above the rate specified for the work.

18.—Preference of Employment.

Preference of employment shall be given to members of the Australian Workers' Union.

19.—Time and Record Books.

These books shall be kept by the employer and shall be open to inspection by the union representative when required.

20.—Fluctuations of Basic Rate.

- (a) Whatever the actual increase over the present basic wage of six pounds twelve shillings and seven pence (£6 12s. 7d.) per week for male adults at Wiluna is shall be added to the agreed rates as set out in this Agreement.
- (b) In the event of the basic wage decreasing from the present figure of £6 12s. 7d. the employer may proportionately lower the daily rate of the worker until the basic rate of £4 7s. 0d. per week at Wiluna is reached when no further reduction may take place.

21.—Clause 42 of the Mining Act. This clause to be observed.
