PROCLAMATION

WESTERN AUSTRALIA, By His Excellency Sir James Mitchell, TO WIT. K.C.M.G., Lieutenant-Governor in and over the State of Western Australia and its Dependencies in the Commonwealth of Australia.

WHEREAS it is enacted by section 25 of the Pharmacy and Poisons Act, 1910-1937, as reprinted under the Amendments Incorporation Act, 1938, that the Governor may by Proclamation declare any article to be a poison within the meaning of the said Act, and may revoke or vary any proclamation made under the said section by a subsequent Proclamation; and whereas the Governor has under and in accordance with the said section from time to time proclaimed certain articles to be poisons as aforesaid; and whereas it is now deemed desirable and expedient to add to

such poisons declared as aforesaid; Now, therefore, I the said Lieutenant-Governor acting with the advice and consent of the Executive Council and in exercise of the power conferred upon me in that behalf by section 25 of the said Act do hereby declare that the article specified in the Schedule hereunder shall be deemed a poison within the meaning of the Pharmacy and Poisons Act, 1910-1937, and that the name thereof shall be inserted in Part 11 of the Fifth Schedule to the said Act.

Schedule.

The description of the article declared aforesaid as a poison and to be inserted in Part 11 of the Fifth Schedule to the Act is as follows:—Pethidine ethyl 1-methyl-4phenylpiperidine-4carboxylate hydrochloride and preparations or solutions thereof.

WESTERN AUSTRALIA, By His Excellency Sir James Mitcheil, K.C.M.G., Lieutenant-Governor in and over the State of Western Australia and its Dependencies in the Commonwell (i.s.)

IN pursuance of the provisions of section 10 of the Fisheries Act, 1905-1940, I, the Lieutenant-Governor of the State of Western Australia, do hereby prohibit all persons from taking any fish whatsoever by means of fishing nets in any of the portions of Western Australian waters specified in the Schedule hereto from the 15th day of August, 1944, until the 31st day of December, 1944, inclusive.

The Land Act, 1933-1939. ORDER IN COUNCIL.

Corr. No. 119/44. WHEREAS by section 34 of the Land Act, 1933-1939, it is made lawful for the Governor, by Order in Council, without issuing any deed of grant, to place any reserve under the control of any municipality, road board, or other person or persons, as a board of management, and to empower such board to make, repeal, and alter by-laws for the control and management of such reserves, and prescribe fees for depasturing thereon, and for other prescribe fees for depasturing thereon, and for other purposes, such by-laws to be approved by the Governor and published in the Government Gazette; and whereas it is deemed expedient that reserve \$22417 for Swimming Pool at Marradong should be placed under the control of the Marradong Road Board as a board of management: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby place the before-mentioned reserve under the control of the Marradong Road Board as a board of management, and doth dong Road Board as a board of management, and doth empower such board to make, repeal, or alter by-laws for the control and management of the said reserve; for prescribing fees for the use thereof; for directing the manner in which such fees shall be imposed, paid,

Local Authorities (Reserve Funds) Act, 1942. ORDER IN COUNCIL.

P.W. 404/43. WHEREAS it is enacted by section 4 of the Local Authorities (Reserve Funds) Act, 1942, that the Governor may, on the recommendation of the Honorary Minister, but subject to the requirements of the proviso to ter, but subject to the requirements of the proviso to the said section, by Order in Council, authorise a local authority to establish during the present war and to maintain a reserve fund for the purpose of accumulating therein any surplus of ordinary revenue of the local authority and of applying the moneys in such reserve fund and any income or profit derived from the investment of moneys in such reserve fund in the carrying out, after the cessation of the present war, of works and undertakings authorised by the Local Government Act of the local authority which the local authority may not be able conveniently to carry out during the present war; and whereas it is desirable that such reserve fund shall be established by the local authorities as set forth in the Schedule hereto: Now, therefore, His Excellency the Lieutenant-Governor, acting pursuant to the recom-mendation of the Honorary Minister and by and with the advice and consent of the Executive Council, and in exercise of the power conferred by the said Act, after being satisfied as required by the proviso to section 4 of the said Act, doth hereby authorise the local authority as set forth in the Schedule hereto, to establish and maintain a reserve fund.

# THE HEALTH ACT, 1911-1942.

The City of Perth-Rubbish Tip-By-law No. 48. WHEREAS under the provisions of the Health Act, 1911-1942, a local authority may make a by-law preventing or regulating the deposit of rubbish or offensive matter on lands under the control of the local authority. Now, therefore, the City of Perth being the local authority for the Municipal District of Perth, doth hereby make the following by-law:-

- 1. In the construction of this by-law "The Lake Monger Rubbish Tip" shall mean all that piece of land described in the Schedule hereto all of which land is under the control of the City of Perth.
- No person without the approval of the Chief Health Inspector first obtained shall deposit on the Lake Monger Rubbish Tip any of the following classes of rubbish or refuse:—Scrap iron or metal, saw dust, food waste, offal or liquid wastes.
- 3. Any person committing a breach of this by-law shall be liable to a penalty not exceeding twenty pounds (£20).

#### IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

### (No. 45 of 1944. File 11,492.)

Between Merchant Service Guild of Australasia, Western Australian Section, Union of Workers, Fremantle, Applicant, and The Commissioners of the Fremantle Harbour Trust, Respondents.

HAVING heard Mr. S. F. Schnaars on behalf of the abovenamed union, and Mr. H. C. Rudderham on behalf of the respondents, and by consent, the Court doth hereby order and declare that Award numbered 30 of 1941 made between the abovenamed parties is hereby amended so as to read as follows:

#### 1.—Area and Scope.

This Award shall apply to all employees directly engaged or acting as signalmen at Cautonment Hill Signal Station, or as coxswain, engineer or driver on any of the employers' launches, and the area covered shall be all the sea and coastline within a radius of twenty (20) miles from the North Mole Lighthouse, and, in addition, the Swan River to and including Perth waters, and the Caming River to Lower Canning Bridge.

#### 2.—Definitions.

"Employers" means the Fremantle Harbour Trust and includes the Commissioners constituted under the Act and in office for the time being.
"Employees" means any person employed under the

provisions of this Award.

Coxswains, Engineers, Drivers and Signalmen (other than on M.L. "Victor").

### 3.—Hours of Duty.

(a) Forty-four (44) hours shall constitute a week's work. Subject to paragraph (c) hereof, the ordinary working hours shall not exceed eight (8) hours per day on five days of the week and four hours on the sixth day.

(b) The hours per week may be worked on any day of the week at the discretion of the employers, and during the continuance of the present system of shifts shall be worked as under:—

Coxswains, engineers and drivers:—Day shift, 7 a.m. to 3 p.m.; afternoon shift, 3 p.m. to 11 p.m.; night shift, 11 p.m. to 7 a.m.

Signalman:—Day shift, 8 a.m. to 4 p.m.; afternoon shift, 4 p.m. to midnight; night shift, midnight to 8 a.m.

- (c) For the purpose of this Award, the week's work will be deemed to commence at 3 p.m. each Sunday for the coxswains, engineers and drivers and 4 p.m. each Sunday for the signalmen and to conclude at 3 p.m. and 4 p.m. respectively on the following Sunday. The weekly change of shifts shall take place at the completion of the day shift on Sundays when the watch which finished night shift that morning shall resume on the afternoon shift that day and shall, in turn, be relieved by the watch which performed the day shift that day: Provided that the extra shift thus worked on Sundays to enable the rotation of shifts shall not be regarded as overtime but as part of the ensuing week's ordinary work; provided further that the present arrangement of shifts to which this paragraph is solely related may be altered by agreement between the parties.
- (d) Employees shall be allowed to relieve one another to suit their convenience to eatch trains or trams, so long as the full shift is maintained at all times.

#### 4.-Rates of Pay.

Basic wage, £4 19s. 8d. per week.

(a) The margins over the basic wage shall be:-

- (b) The above margins include 6s. per week, which shall be regarded as compensation for shift work.
  - (c) Wages shall be payable weekly.

### 5.—Sunday Time and Overtime.

- (a) Overtime shall mean and include all time worked outside of, or in excess of, the ordinary working hours in any shift, and shall be paid for at the rate of time and a-half for the first four (4) hours and double time thereafter.
- (b) The time worked on Sundays up to a maximum of eight (8) hours shall be included in the ordinary week's work, but employees required to work on Sundays, other than those finishing a shift commenced earlier than 11 p.m. on the preceding Saturday, or employees commencing duty at 11 p.m. on Sunday, shall be paid an extra half day's pay in addition to the week's earnings, provided that this payment shall be deemed to have been complied with by the addition of 6.5 per cent. to the ordinary weekly wage for forty-four (44) hours' work, it being agreed that the amount so arrived at represents the average weekly payment during the year for Sunday work.

#### 6.-Special Allowances.

- (a) Crib Time.—The pilot service shall operate continuously (or as directed by the employers) during each shift without cessation for a recognised meal hour; provided that each employee shall be allowed twenty (20) minutes between 4½ hours and 6½ hours after the commencement of a shift in which to have his meal; provided further that when the pilot boats are engaged upon any pilotage service, the aforementioned break for crib may be taken at any time between 3½ hours and 6½ hours from the commencement of any shift. In the event of the requirements of the service being such that the break for crib cannot be taken during the appropriate period specified herein, the employees shall receive a special payment of 5s.
- (b) Senior Signalman.—The senior signalman at Cantonment Hill Signal Station shall be paid a special allowance of 7s. 8d. per week, in addition to his ordinary week's earnings.

#### 7.—Contract of Service.

Employees shall be deemed to be engaged on a monthly basis, and one month's notice shall be given on either side to terminate such engagement: Provided that an employee may be instantly suspended or dismissed without notice for insobriety, misconduct, or neglect of duty.

#### 8.—Annual Leave.

- (a) An employee who serves the employers continuously for a period of twelve months shall be granted leave of absence on full pay for an unbroken period of 30 days. Such leave shall at all times be granted at the convenience of the employers, and shall be taken in accordance with a roster prepared each year.
- (b) If the employee serves continuously for one month or more but for less than 12 months, he shall be entitled to payment in lieu of leave for the proportion of thirty days as his length of service is to the full year.

#### 9.-Long Service Leave.

Employees shall be granted three months' long service leave after each seven years' service, but periods of absence on long service leave shall not count as service qualifying towards the next grant of such leave.

#### 10.-Sick Leave.

- (a) An employee who is incapacitated through sickness or injury other than that arising out of or in the course of his employment may be granted sick leave with pay for a period of or periods not exceeding in the aggregate one month in any year, upon production within 48 hours of the commencement of any such period of absence of a medical certificate as to his incapacity.
- (b) Where such incapacity arises through the wilful act or misconduct of the employee, or where a medical certificate is not furnished as required, or where the employee has already had sick leave with pay for a period of or periods aggregating one month during the preceding 12 months, the employee shall not be entitled to any pay for the period he is absent from duty.
- (c) Upon the period of absence in any instance exceeding one month, or in the case of paragraph (b) hereof, immediately an employee absents himself, the contract of service shall be deemed to have been terminated without requiring further notice by the employers, who shall thereby be relieved of any further obligation to the employee: Provided that any such period of incapacity may at the discretion of the employers be regarded as leave without pay.

#### 11.—Rates of Pay when on Leave, etc.

Employees on annual, long service or sick leave in accordance with the provisions of clauses 8, 9 and 10 of this Award, or absent from duty during a period of incapacity resulting from sickness or accident arising out of or in the course of employment in circumstances provided for in clause 17 of this Award, shall receive the same weekly remuneration as is payable for the usual week's work of 48 hours.

# Driver M.L. "Victor." 12.—Hours of Duty.

The hours of duty shall be 44 per week, between 8 a.m. and 5 p.m., on all days Mondays to Fridays, inclusive, and 8 a.m. to noon on Saturdays.

## 13.—Rate of Pay.

Basic wage—£4 19s. 8d. per week.

- (a) Margin over basic wage—£2 5s. 1d. per week.
- (b) Wages shall be payable weekly.

#### 14.—Overtime.

Overtime shall mean and include all time worked in excess of eight (8) hours on any week day or four (4) hours on Saturday, and shall be paid for at the rate of time and a-half per hour.

# 15.—Contract of Service.

Engagement shall be on a weekly basis, and one week's notice shall be given on either side to terminate the engagement: Provided that an employee may be instantly suspended or dismissed without notice for insobriety, misconduct, or neglect of duty.

#### 16.—Leave.

(a) An employee who serves the employers continuously for 12 months shall be granted leave of absence on full pay for a period of two weeks. Where the period of service is less than 12 months but exceeds one month, the leave shall be *pro rata* as the length of service is to the full year.

- (b) Employees shall be entitled to long service leave in accordance with the conditions authorised by the Government of Western Australia for wages employees.
- (c) Annual and long service leave shall be taken at the convenience of the employers.
- (d) Sick leave may be granted subject to the same conditions as are prescribed in clause 10 of this Award, excepting that for the term "one month" wherever appearing therein, the term "one week" is to be substituted.

#### General.

### 17.—Sickness or Accident arising out of duty.

- (a) An employee who, while on duty or acting under the instructions of the employer, receives an injury arising out of, or in the course of his employment, or contracts an illness due to the nature of and attributable to such employment and is thereby incapacitated from duty in circumstances which entitle him to the benefits prescribed under the Workers' Compensation Act, 1912-1941, shall be entitled to receive in addition to such benefits, a weekly sum equal to the difference between the compensation provided for under that Act and the wages prescribed in this Award, from the date of the commencement of his said incapacity up to and including the date of his recovery as certified by his medical attendant: Provided that the employers' liability hereunder shall in no case exceed three calendar months in respect of each separate injury or illness.
- (b) All amounts payable under this clause shall be paid in the manner provided for the payment of wages.

#### 18.—Uniforms.

The employers shall provide all employees with uniforms, free of cost, after each eight months' continuous service, an oilskin coat and sou'wester each year, and to coxswains and signalmen only a great coat every four years. Uniforms shall belong to the employers and shall be worn by employees when on duty. Should the service of any employee terminate within one month from the date of issue of uniforms or any portion of them, all the issue last made to that employee shall be returned to the employers before the employee shall be entitled to be paid any moneys which may be due to him.

#### 19.—Board of Reference.

Should any dispute arise between an employee and the employers, the service concerned shall be continued without any cessation and the matter referred to a Board of Reference, consisting of two representatives each of the employees and employers and a chairman, to be mutually agreed upon by those representatives; failing their agreement the Registrar of the Court of Arbitration shall act as Chairman.

#### 20.—Term.

The term of this Award shall be for a period of 12 months and shall operate as from 3 p.m. Sunday, May 21st, 1944.

# 1.—Area and Scope.

This Award shall apply to all employees directly engaged or acting as deckhands or firemen on any of the employer's launches, and the area covered shall be all the sea and coastline within a radius of twenty (20) miles from the North Mole Lighthouse, and in addition, the Swan River to and including Perth Water and the Canning River to Lower Canning Bridge.

#### 2.—Definitions.

"Shift or Shifts" means a period of eight (8) consecutive hours worked in reliefs of two or three, as may be required by the Commissioners.
"Employee" means any person employed under the

provisions of this Award.

"Wages" includes overtime payment.

"Employer" means the Fremantle Harbour Trust and includes the Commissioners constituted under the Act and in the office for the time being.
"Harbour Master" means the Harbour Master for

Fremantle appointed by the Commissioners.

#### 3.—Hours of Duty.

- (a) Forty-four (44) hours shall constitute a week's work. Except as provided in paragraph (c) hereof the ordinary working hours shall not exceed (8) hours per day on five days of the week and four hours on the sixth day.
- (b) The hours per week may be worked on any day of the week at the discretion of the employers, and during the continuance of the present system of shifts shall be worked as under:-

Day shift ... Afternoon shift 7 a.m.—3 p.m. 3 p.m.—11 p.m. .. 3 p.m.—11 p.m. .. 11 p.m.—7 a.m. ٠. Night shift ٠.

- (d) Where a deckhand is called upon for any reason to perform the work of a fireman for a period of two hours or more in any shift, he shall be paid at fireman's rates for the whole of that shift. Where the period is less than two hours, he shall be paid his ordinary rate for the whole shift.
- (e) All wages due shall be payable at 2.30 o'clock p.m. on Friday in each week.
- (f) Wages may be payable on the written order of the employee to the person named in such order, and the Commissioners by paying to such order shall be relieved of all responsibility on obtaining the signature of the person named in the said order.

# 5.—Sunday Time and Overtime.

- (a) Overtime shall mean and include all time worked outside of, or in excess of, the ordinary working hours in any shift, and shall be paid for at the rate of time and a-half for the first four hours and double time there:
- The time worked on Sundays up to a maximum of eight (8) hours shall be included in the ordinary week's work, but employees required to work on Sundays, other than those finishing a shift commenced earlier than 11 p.m. on the preceding Saturday, or employees commencing duty at 11 p.m. on Sunday, shall be paid an extra half day's pay in addition to the week's earnings, provided that this payment shall be deemed to have been complied with by the addition of 6.5% to the ordinary weekly wage for forty-four (44) hours' work,

#### 6.-Engagement and Dismissal.

- (b) The engagement of employees may be made by the Harbour Master or his deputy at the recognised pick up place at the shelter shed adjacent to the Pilot Office, between the hours of 7.45 a.m. and 9 a.m. on any week day. Should it be necessary to fill any vacancy urgently and outside the above hours, the man or men required may be picked up at any place convenient to the Harbour Master or his deputy: Provided that notification shall be sent forthwith to the secretary of the Union as to the man or men so engaged, the Harbour Master or his deputy shall at all times retain the right of free selection among members of the Union, provided same are available.
- (c) The employer shall not discriminate, without just cause, against any member of the Union who bears good conduct record, and who agrees to continue to work under the terms of this Award, and for whom there is a vacancy, and the employer shall consider any representations made to them by the Secretary of the Union.
- (d) In cases where an employee misconducts himself, the employer shall have the right to dismiss him instantly.

#### 7.—Crib Time.

The Pilot service shall operate continuously (or as directed by the employers) during each shift without cessation for a recognised meal hour provided that each employee shall be allowed twenty (20) minutes between 4½ hours and 6½ hours after the commencement of a shift in which to have his meal: provided further that when the Pilot boats are engaged upon any pilotage service, the aforementioned break for crib may be taken at any time between 3½ hours and 6½ hours from the commencement of any shift. In the event of the requirements of the service being such that the break for crib cannot be taken during the appropriate period specified herein, the employees shall receive a special payment of 5s.

# 8.—Change Room.

A change room shall be provided, as heretofore, by the employers to allow of employees changing their clothes or taking their meals when ashore.

#### 9.—Annual Leave.

- (a) An employee who serves the employers continuquesly for a period of 12 months shall be allowed leave of absence on full pay, as soon thereafter as convenient to the service, for a continuous period of one calendar month of 30 days.
- (b) If he serves continuously for one month or more and not for one year, he shall be entitled to payment in lieu of leave, at the rate of two and a-half days for each completed month of service.
- (c) The employers shall give at least 24 hours' notice to each employee of their intention to give the employee his leave of absence, and his wages for the leave period shall be paid, together with all other moneys due, prior to his going on leave.

## 10.—Sickness and Accident When on Duty.

- (a) If in the course of his employment an employee engaged under this Award, whilst on duty or whilst acting under the instructions of the employer, receives an injury or contracts any sickness arising out of or in the course of his employment, he shall be entitled to receive the wages prescribed in this Award from the date of his said incapacity up to and including the date of his recovery, as certified by his medical attendant: Provided that the maximum period of payment under this clause shall not exceed three months of 30 days each.
- (b) The illness or injury which so entitles the employee to the benefits provided for in this clause shall be suffered while on duty and shall be:—
- 1. Such as wholly to incapacitate him from performing his duty;
- 2. So far as can be ascertained, an illness or injury contracted or sustained whilst on duty in the service of the employer: Provided that, if the illness or injury

- is due to his own wilful act or to his misbehaviour, the employee shall not be entitled to the benefits provided in this clause.
- (c) In the case of an accident suffered while on duty the expenses of providing the necessary medicines, surgical and medical advice and attendances shall be paid by the employer without any deduction from the wages on that account until the employee is certified as recovered by his medical attendant: Provided that the aggregate amount so paid shall not exceed the amount that would have been paid had such payment been made under the provisions of the Workers' Compensation Act, 1912-1941
- (d) All wages payable under this claim to the employee while sick or injured shall be paid on Fridays of each week and as provided for in Clause 4.

#### 11.-Sick Leave.

- (a) An employee who is incapacitated through sickness or injury other than that arising out of or in the course of his employment may be granted sick leave, with pay, for a period or periods not exceeding in the aggregate two weeks in any year, upon production within 48 hours, of the commencement of any such period of absence, of a medical certificate as to his incapacity.

Employees on annual, long service or sick leave in accordance with the provisions of clauses 9, 11 and 12 of this Award, or absent from duty during a period of incapacity resulting from sickness or accident arising out of or in the course of employment in circumstances provided for in clause 10 of this Award shall receive the same weekly remuneration as is payable for the usual week's work of 48 hours.

#### 14.—Uniforms.

The employers shall provide for the use of each employee, free of cost, one cap and one serge suit, on the completion of each eight months' continuous service, and one oilskin coat and sou'wester hat each year. One suit of dungarees shall also be supplied to employees on the completion of the following periods of service, viz., deckhands—each eight months; firemen—each six months. Uniforms shall belong to the employers, to be worn on service, and shall be kept clean and tidy. Should the service of any employee terminate within one month of the date of issue of uniforms or any portion of same, all the issue last made shall be returned to the employers before the employee is paid any moneys which may be due to him.

#### 15.—Casual Employees.

- (a) A casual employee is one who is engaged in a temporary capacity, and the contract of service in respect of such employee shall be a daily one. The services of casual employees may be terminated at any time without previous notice.
- (b) The daily rates of pay for casual employees shall be:—(1) For the first 14 consecutive working days—one sixth of the rates prescribed in Clause 13 hereof, plus 10%; (2) Thereafter—one sixth of the rates prescribed in clause 13.
- (c) A casual employee shall be entitled to annual leave in accordance with clause 9 hereof, but shall not be entitled to any issue of uniform.

#### 16.—Board of Reference.

Should any dispute arise between the employees and the employers, the matter shall be referred to a Board of Reference, consisting of a representative of the employers, a representative of the Union and a chairman to be mutually agreed upon by those representatives; failing their agreement, the Registrar of the Arbitration Court of Western Australia shall act as chairman. The decision of the Board shall be final and binding.

#### 17.—Term.

The term of this Award shall be for a period of 12 months and shall operate as from 3 p.m. Sunday, May 21st, 1944.

# IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

(No. 91 of 1944.)

Between Hospital Employees Industrial Union of Workers, W.A., Coastal Branch, Applicant, and The Perth Hospital, Respondent.

Matter referred into Court by the Hon. President following upon compulsory conference.

Thursday, the 13th day of July, 1944.

#### Reserved Decision.

The PRESIDENT: This is a matter referred into Court for decision following a compulsory conference between the parties. The point in dispute was whether the head orderly and the deputy head orderlies employed at the Perth Public Hospital should receive any, and if so what, remuneration because of certain clerical work included in their duties and in particular in the duties of the deputy head orderlies. From the evidence it is clear that the head orderly is occupied for a short period of his time in filling in application forms for admission and associated particulars and the deputy head orderlies for a much greater portion of their time are occupied in doing similar work. During the ordinary times of day work these duties are usually carried out by an officer now termed a "casualty clerk" and this officer also checks over all the admission particulars filled in on the forms by the head orderlies and completes the forms, thus acting in a supervisory capacity so far as this clerical work is concerned.

In consequence of regulations made under the National Security Act, before there may be any change in remuneration it is necessary for the Court to arrive at the conclusion that an anomaly exists. After a full consideration the Court is satisfied that though this clerical work is not of very great importance and is supervised, nevertheless it is of such a nature as, when the remunration of the head orderlies and clerical workers is compared, to be sufficient to constitute an anomaly. The question then remains of what additional remuneration, should be paid to the orderly officers for the purpose of ironing out this anomaly. After a full consideration of all the evidence it has been decided that an allowance of 5s. per week to the head orderly and to each of the deputy head orderlies would be sufficient for this purpose.

The following clause will therefore be added as an amendment to the agreement now in existence (No. 21 of 1936)—

(a) The head orderly and the deputy head orderlies at the Perth Hospital whilst required as part of the duties of his or their office to fill in particulars in admission cards and other associated clerical work connected with admissions shall be entitled to an allowance in each case of 5s. per week.

(b) The above provision shall be read as part of and be co-terminous with Industrial Agreement No. 21 of

1936.

This decision will be forwarded to the Minister of State for Labour and National Service for approval as required by National Security Regulations.

Mr. TRAINER: I agree. Mr. THOMAS: I agree. Decision accordingly.

The approval of the Honourable the Minister of State for Labour and National Service under regulation 17 (1) (b) of the National Security (Economic Organization) Regulations was given to the above determination on the 24th day of July, 1944.

Between Federated Moulders (Metals) Union of Workers, Perth, Applicant, and Tomlinson & Company, Ltd., Respondent.

Matter referred into Court by the Hon. President following upon compulsory conference.

Monday, the 7th day of August, 1944.

#### Reserved Decision.

The PRESIDENT: This is a matter that has been referred into Court following on a compulsory conference between the parties. There was one matter in dispute, and that was whether the use of a "Horn" runner in connection with plate moulding was such as to bring that moulding within the definition of jobbing moulding as contained in the Award so that the worker, or workers, engaged in that act of moulding would be entitled to the margin paid to the jobbing moulder. Another question was introduced, that of the use of the loose "risers," but in order that there may be no mistake in regard to that, I want to say here and now that the union representative agreed that the use of "risers" was not such as would entitle his men to be paid under the jobbing moulders' margin.

The question of the "Horn" runner, however, is of a different nature and I thought at the time, and as a fact still think, that it would be a rather difficult matter to bring the use of that particular aid to moulding within the definition of jobbing moulding, nevertheless it was conceded between the parties that the matter should be left to be decided on what was the practice in the Eastern States. That is not surprising in these days when so much is made of the question of anomaly in other matters referred to the Court.

There is really no difference between the parties that, generally speaking, when these "Horn" runners are used the moulders making use of them as an aid are in the Eastern States paid the wage rates for jobbing moulding, and that being the case I am of opinion that the men engaged at Tomlinson's making use of the same assistance, that is the "Horn" runner, should also be paid as jobbing moulders. I want, however, to add this limitation, that whilst that is the decision of the Court on the Award as it now stands, and on the work as it is now being done, I do not say it should be looked upohn as a precedent or should be regarded as a binding permanent decision. In case the Award comes for a full review before the Court of Arbitration at any future time the whole matter should be argued out from the beginning from the standpoint that the use of the "Horn" runner, or similar aid may occupy, perhaps, some intermediate position between jobbing moulding and plate machine moulding.

Mr. TRAINER: In view of the fact that the parties before the Court agree that the jobbing moulders' rate is being paid in the Eastern States in regard to this class of work, I agree with the decision.

Mr. THOMAS: I agree with the remarks of the President in this case. I certainly do not think that the "Horn" runner comes within the definition of jobbing moulding as specified in the Award, but we are faced with the fact on the information supplied with regard to the practice in the Eastern States, that in a large number of cases this work is being done by jobbing moulders or paid for at their rate.

Decision accordingly.
