WHEREAS it was enacted by section 10 of the Aborigines Act, 1905, and is now enacted by section 10 of the Native Administration Act, 1905-1941, that the Governor may by Proclamation declare any Crown lands to be reserves for aboriginals or natives and abolish any reserve so declared; and whereas by a Proclamation issued under the Aborigines Act, 1905, and published in the Governoment Gazette on the 22nd day of October, 1909, the Governor declared portions of Kojonup Location P14 more particularly described and defined in the Schedule to such Proclamation to be a reserve for aboriginals; and whereas it is now deemed desirable and expedient to abolish the said reserve: Now, therefore I, the said Lieutenaut-Governor acting with the advice and consent of the Executive Council and in exercise of the power in that behalf conferred by section 10 of the Native Administration Act, 1905-1941, do hereby abolish the reserve for aboriginals as declared and described and defined in the hereinbefore mentioned Proclamation published in the Government Gazette on the 22nd day of October, 1909, as aforesaid.

WHEREAS by sections 223 and 228 of the Municipal Corporations Act, 1906-1941 (6 Edwardi, No. 32), it shall be lawful for the Governor, on request of the Council, by notice in the Government Gazette, to declare any land reserved, used, or by purchase or exchange acquired for a street or way, or any place, bridge, or thoroughfare, to be a public highway, and such land shall thereupon and thenceforth, from the date of such Proclamation, become and be absolutely dedicated to the public as a public highway within the meaning of any law now or hereafter in force; and whereas the City of Poeth, Municipal Council her reverted that carries had Perth Municipal Council has requested that certain land named and described in the Schedule hereunder which has been used for a street or way within the Municipality of Perth, be declared public highways: Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, do by this my Proclamation declare the said land to be public highways, and such land shall, from the date of this Proclamation. be absolutely dedicated to the public as highways within the meaning of any law now or hereafter in force.

# NATIONAL SECURITY (GENERAL) REGULATIONS.

State of Western Australia.

Lighting of Motor Vehicles Order.

WHEREAS it is provided by regulation 35A of the National Security (General) Regulations (as amended by Statutory Rule 1941, No. 287 and subsequent Statutory Rules) that the Premier of any State may after consultation with the Minister of State for Home Security or an officer of the Department of Home Security authorised by that Minister to act on his behalf and with a Commander of a lines of communication area or an officer authorised by the Minister of State for the Army to act on behalf of such a Commander by order—

- (a) direct any total or partial "black out" and may prohibit or regulate the display of lights of any description within the State; and
- (b) make such provision as he deems necessary to protect the persons and property of the civil population in that State or any part thereof in case of emergency—

and that all persons within such State or part thereof (as the case may be) to which any such order shall apply shall comply with the requirements of that order; and whereas I, John Collings Willcock, M.L.A., Premier of the State of Western Australia, acting under the authority conferred by the said regulation 35A made and issued an order which was dated the 16th day of October, 1942, cited as the Lighting of Motor Vehicles Order No. 2 and was published in the Government Gazette of Western Australia on the said 16th day of October, 1942, and subsequently made and issued a further order which was cited as the Lighting of Motor Vehicles Order No. 3 was dated the 5th day of July, 1943, and was published in the Government Gazette of Western Australia on that date whereby the operation of the provisions of the Lighting of Motor Vehicles Order No. 2 was suspended as regards a certain specified part of the State and other provision was made in relation thereto; and whereas it is now deemed expedient to revoke the said Lighting of Motor Vehicles Order No. 2 and the said Lighting of Motor Vehicles Order No. 3 and in lieu thereof to make other provision as in this order hereinafter mentioned: Now therefore I the said John Collings Willcock as such Premier aforesaid acting pursuant to the said regulation 35A and after due consultation as required thereby do hereby make the following order—

- 1. This order may be cited as the Lighting of Motor Vehicles Order No. 4.
- 2. The Lighting of Motor Vehicles Order No. 2, and the Lighting of Motor Vehicles Order No. 3 hereinbefore mentioned are hereby revoked.
- 3. In this order, unless the context otherwise requires—"Armed Forces" means the Armed Forces of His Majesty the King or of any Power which is allied or associated with His Majesty in any war in which His Majesty is at present engaged. "Civil Defence Council" means the Civil Defence Council in Western Australia as constituted by the Civil Defence (Emergency Powers) Act, 1940, of the State. "Commissioner of Police" means the Commissioner of Police of Western Australia. "Essential Service Vehicle" means a police vehicle, a post office vehicle,

a fire service vehicle, an ambulance vehicle, any public utility vehicle, or a vehicle used for any civil defence purpose by any person using the same with the authority of the Civil Defence Council. "Public Place" includes—

- (a) any public highway, road, street, footway, footpath, court, alley, passage, motor drive, or thoroughfare, notwithstanding that it is formed on private property;
- (b) any park, garden, foreshore, reserve, place of public resort or open space; and
  - (c) any pier, jetty or wharf.
- 4. This order shall not apply to any essential service vehicle or to any vehicle used by a member of the Armed Forces acting in the course of his duty as such.
  - 5. Subject to clause 4 hereof-
  - (a) The Commissioner of Police or any member of the Police Force acting under his general or special direction and any person authorised in that behalf by the Civil Defence Council may, and shall if requested so to do by the Civil Defence Council, in the event of hostile attack or the apprehension of hostile attack give directions prohibiting or restricting the display of any light on any motor vehicle;
  - (b) A person in charge of any motor vehicle which is in any public place in any part of the State in which the "air raid warning" signal is sounded at any time shall, during the period between the sounding of such "air raid warning" signal and the sounding of the "raiders passed" signal—(i) extinguish and keep extinguished the front lamps on that motor vehicle; and (ii) cause the vehicle to remain stationary in a position in such public place which is least likely to render that motor vehicle an obstruction to traffic in such public place.
- 6. Any direction which any person is authorised to give in pursuance of this order—
  - (a) may be given either verbally or in writing, by telephone, telegraph, or in such manner as that person deems sufficient to bring the direction to the notice of any person affected thereby;
  - (b) may be given so as to operate for any period or periods or for any time or times or in any part or parts of the State;
  - (c) may contain such incidental and supplementary directions as appear to the person giving the direction to be necessary or expedient for the purposes of the direction.
- 7. This order shall come into operation and have effect as from the date upon which publication thereof is made in the *Government Gazette* of Western Australia

Lighting Restriction Order.

WHEREAS it is provided by regulation 35A of the National Security (General) Regulations (as amended by Statutory Rule, 1941, No. 287 and subsequent statutory rules) that the Premier of any State may after consultation with the Minister of State for Home Security or an officer of the Department of Home Security authorised by that Minister to act on his behalf and with the Commander of a lines of communication area or an officer authorised by the Minister of State for the Army to act on behalf of such a Commander by order—

- (a) direct any total or partial "black out" and may prohibit or regulate the display of lights of any description within the State; and
- (b) make such provision as he deems necessary to protect the persons and property of the civil population in that State or any part thereof in case of emergency—

and that all persons within such State or part thereof (as the case may be) to which any such order shall apply shall comply with the requirements of that order; and whereas I, John Collings Willcock, M.L.A., Premier of the State of Western Australia, acting under the authority conferred by the said regulation 35A made and issued an order which was dated the 16th day of October, 1942, cited as the Lighting Restriction Order No. 2 and was published in the Government Gazette of Western Australia on the said 16th day of October, 1942, and subsequently made and issued a further order which was cited as the Lighting Restriction Order No. 3, was dated the 5th day of July, 1943, and was published in the Government Gazette of Western Australia on that date whereby the operation of the provisions of the Lighting Restriction Order No. 2 was suspended as regards a certain specified part of the State and other provision was made in relation thereto; and whereas it is now deemed expedient to revoke the said Lighting Restriction Order No. 2 and the said Lighting Restriction Order No. 3, and in lieu thereof to make other provision as in this order hereinafter mentioned: Now, therefore I, the said John Collings Willcock as such Premier aforesaid acting pursuant to the said regulation 35A and after due consultation as required thereby do hereby make the following order:—

- 1. This order may be cited as the Lighting Restriction Order No. 4.
- 2. The Lighting Restriction Order No. 2 and the Lighting Restriction Order No. 3 hereinbefore mentioned are hereby revoked.
- 3. In this order, unless the context otherwise requires—"Armed forces" means any of the Armed Forces of His Majesty the King or of any Power which is allied or associated with His Majesty in any war in which His Majesty is at present engaged. "Civil Defence Council" means the Civil Defence Council in Western Australia as constituted by the Civil Defence (Emergency Powers) Act, 1940, of that State. "Commissioner of Police" means the Commissioner of Police of Western Australia.
  - 4. This order shall not apply to-
- (a) any light displayed by any member of the Armed Forces acting in the course of his duty as such;
  - (b) any light displayed with the consent of the Naval Board from a lighthouse or other structure on shore or from a light vessel or other floating structure being a light provided solely for the guidance of shipping;
  - (c) navigation lights displayed on ships under the instructions or with the consent of the Naval Board; and
  - (d) navigation lights displayed on aircraft or other lights displayed at aerodromes in accordance with instructions given by or on behalf of the Minister of State for Air.
  - 5. Subject to clause 4 hereof-
  - (a) during the period between sunset and sunrise a person shall not cause or allow any light to be emitted from or by any fire, lamp, sign or other device at any place outside a building situated in such proximity to the sea coast of the State that such light or any reflection therefrom will be visible from the sea when in the opinion of the Commissioner of Police or any member of the Police Force of Western Australia acting under his general or special direction, or of any officer of the Civil Defence Council duly authorised in that behalf by the said Council such light is not necessary for purposes of illumination of such place.
  - (b) In the event of any hostile attack or the apprehension of any hostile act, the display of any light, the display of which would otherwise be lawful under the provisions of this order may be, and if so requested by the Civil Defence Council, shall be prohibited or restricted by the Commissioner of Police or any member of the Police Force of Western Australia acting under his general or special direction; and it shall not be lawful for any light to be displayed in any part of the State in contravention of any such prohibition or restriction.
  - (c) (i) Whenever I the said Premier by a notice in writing shall direct that during any period and in any part or parts of the State specified in such notice no light shall be emitted from any fire, lamp, sign or other device whether the same is not inside or is inside any enclosed building, and while such notice remains

unrevoked, a person in any enclosed building affected by such notice shall not cause or allow any light to be emitted from such enclosed building contrary to the requirements of such notice. (ii) Any notice referred to in subparagraph (i) of this paragraph shall operate as from the date specified therein for the coming into operation thereof. (iii) Every such notice shall be deemed to have been published sufficiently for the information of the public when it is published in the Government Gazette of Western Australia or in any newspaper circulating in the part or parts of the State specified in the notice or is broadcasted by means of wireless transmission. (iv) Every such notice may be directed to the public generally or to a particular person or to particular persons. Provided that when a notice is directed to a particular person or to particular persons the notice may be served upon him or them by delivering the same personally or by sending it by post to the last known place of abode of the person or persons concerned in a prepaid addressed euvelope. #### MEEKATHARRA DISTRICT HOSPITAL MEDICAL FUND.

AT a meeting of the Board of Management of the Meekatharra District Hospital on the 10th day of July, 1944, also at a meeting held on Monday, 8th February, 1943, the following resolution was passed:—Whereas under the provisions of section 23 of the Hospitals Act, 1927, a Board may itself establish and manage a Medical Fund, the object of which shall be to secure for its subscribers medical attendance, hospital treatment, or other similar benefits; and may by by-laws provide for the regulation and control of such Fund; and whereas a Medical Fund has been established by the Board of Management at the Meekatharra District Hospital: Now, therefore, the said Board of Management acting pursuant to section 23 of the Hospitals Act, 1927, do hereby make by-laws for the regulation and control of the said Medical Fund in the manner set forth in the Schedule hereunder:

The term "subscriber" shall mean any person. male or female who has paid his or her subscription and is financial and has paid at least two weeks' subscription prior to seeking any benefits or privileges and shall include so far as benefits are concerned, all dependants of the subscriber. A person whose total income exceeds £550 per annum shall not be normally entitled to become a subscriber, but the Board, at its discretion, may accept such person as a subscriber with such full or partial benefits as the Board may decide.

2. The subscription to be paid by a subscriber shall be 2s. per week or £1 6s. per quarter, as the subscriber

may elect.

- 3. The word "dependant" shall mean the parents and grandparents of a subscriber, the sons, daughters, brothers and sisters not over 16 years of age of a subscriber, who are actually residing with and wholly dependent on him at the date of the illness or wholly dependent on him at the date of the illness or accident which the Medical Officer is required to treat. (b) If the Medical Officer is not aware or is in doubt as to whether any person is or is not a dependant he may refer the matter to the Secretary and be guided by his decision.
- 4. Every subscriber and his dependants shall, if required, submit to a medical examination by the Medical Officer of the Fund before he is accepted as a subscriber.
- Every subscriber shall be entitled to medical and hospital treatment as an indoor or outdoor patient and to medicine and dressings, subject to the conditions and limitations set forth in these by-laws for so long as the Medical Officer deems necessary, free of charge.
- 6. Subscribers employed by any mining company shall be deemed to be financial as from the date of their employment, provided that the mine management under-takes the collection of their subscriptions from wages
- Subscribers shall not receive free treatment in any of the following cases:—(a) Incurable diseases; (b) Disorders for the cure of which other establishments are provided; (c) Any person requiring food and not mediprovided; (c) Any person requiring food and not meal-cine and who is more propertly the subject for a benevo-lent institution; (d) Venereal disease; (e) Alcoholism, or conditions resulting therefrom; (f) Dentistry; (g) Insanity; (h) Accouchements (abortive or other-(g) Insamey; (n) Accountments (abortive or otherwise); (i) Any person for any condition for which he is already covered by insurance under the provisions of the Workers' Compensation Act; (j) Sera and vaccines; (k) Pathological examination fees; (l) Major operations with the exception of urgent operations. (An urgent operation is one where the postponing of the operation for more than 2d hours after the decision has operation for more than 24 hours after the decision has been made, would, in the opinion of the Medical Officer, be detrimental to the health of the patient); (m) No patent medicines or any medicines prepared and sold under any proprietary name will be supplied free of charge to any subscriber or his dependants, unless the Board decided that any particular medicine may be included as a benefit. In all other cases any patent medicine or proprietary line prescribed by the Medical Officer must be paid for by the subscriber at a price to be fixed by the Board.
- The Board shall have discretionary powers regarding the payment of hospital maintenance incurred in any subsidised public hospital by subscribers or their dependsubstitused public hospital by subscribers or their dependants who are temporarily outside the district, and who suddenly become seriously ill or meet with a serious accident which precludes their returning to the hospital covered by their Fund. In approved cases the Board will be responsible for payment to the other hospitals concerned at the rate of 7s. 6d. per day for a period not exceeding 60 days in any one year, but any amount in addition to this charged as fees by the other hospitals in addition to this, charged as fees by the other hospital, will be a matter for settlement between the subscriber and the hospital concerned. The Board will not be responsible to doctors for treatment of such cases.
- 9. Subscribers and their dependants, requiring outpatient attendance shall attend at the Medical Officer's surgery between such times as shall be fixed by the Board from time to time. In the event of their not being able to attend, a message should be left at the Medical Officer's surgery or residence before 9 a.m. (b) The Medical Officer shall be in attendance at his surgery for treatment of subscribers at the hours fixed by the Board.
- 10. When a subscriber residing outside a radius to be fixed by the Board, requires the services of a Medical Officer, he shall pay the Medical Officer mileage at such rates as shall be arranged between the Fund and the Medical Officer.
- 11. The doctor shall keep such records as the Board may determine from time to time.
