# The Game Act, 1912-1913. PROCLAMATION

WESTERN AUSTRALIA, | By His Excellency Sir James Mitchel, TO WIT. | K.C.M.G.. Lieutenant-Governor in and over the State of Western Australia and its Dependencies in the Commonwealth of Australia.

WHEREAS it is provided by the Game Act, 1912-1913, that the Governor may, by Proclamation, declare from time to time that any bird or animal indigenous to Western Australia shall be at all times strictly preserved either generally throughout the State or in any one or more portions thereof, and that the Governor may in like manner exempt from the operations of any such declaration under the said Act any defined locality; and whereas by a Proclamation dated the 30th day of July, 1924, it is provided that the portions of the State and localities defined in the Schedule thereto shall be a reserve for Grey Kangaroos, known scientifically as Macropus giganteus; and whereas it is desirable to exempt from the operations of the said Proclamation a defined locality: Now, therefore I, the said Lieutenant-Governor, in exercise of the powers aforesaid, do hereby, by and with the advice and consent of the Executive Council, exempt from the operations of the aforesaid Proclamation and the declaration contained therein all those localities mentioned and defined in the Schedule hereto as from November 1, 1944, until January 31, 1945. Schedule.—The Sussex Road District.

#### PROCLAMATION

WESTERN AUSTRALIA, By His Excellency Sir James Mitchell, TO WIT. K.C.M.G.. Lieutenant-Governor in and over the State of Western Australia over the State of Mestern Australia (L.S.)

WHEREAS by section 6 of the Game Act, 1912-1913, it is provided that the Governor may from time to time by Proclamation declare a close season for any particular

native game either generally throughout the State or in any one or more districts thereof: Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, do hereby proclaim and declare that the Proclamation under the Game Act, 1912-1913, dated April 14, 1926 (published in the Government Gazette of April 16, 1926), as amended by a Proclamation dated November 12, 1930 (published in the Government Gazette of November 14, 1930), whereby the close season for Wild Ducks was declared as being from the beginning of June to six o'clock in the morning of December 23 in every year within the district specified as District A in the third column of the Schedule to the said Proclamation is hereby further amended by substituting the date "22nd January" for the date "23rd December" appearing in such Proclamation.

### PROCLAMATION

WESTERN AUSTRALIA. By His Excellency Sir James Mitchell, TO WIT. K.C.M.G., Lieutenant-Governor in and over the State of Western Australia lieutenant-Governor. IL.S.] wealth of Australia.

WHEREAS by section 9 of the Fisheries Act, 1905-1940, it is provided that the Governor may, by Proclamation, prohibit all persons from taking any fish whatsoever, in every or any specified portion of Western Australian waters, by means of fishing nets and fishing lines, or either of such means of capture, or by any other specified means of capture, for any specified term: Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid and of every other power enabling me in this behalf, proclaim and declare as follows:—That all those portions of Western Australian waters defined in the Schedule hereto shall be closed against the use of fishing nets, and also against the use of fishing lines set for the capture of sharks,

as from the 1st day of January, 1945, until the 31st day of December, 1947, inclusive.

#### Schedule.

Scarborough Beach .- All that area of Western Australian waters at Scarborough Beach commencing at a point fronting the western extremity of Reserve street and extending in a southerly direction to a point two chains south of Brighton road, and to a width of one half-mile from high water mark.

#### Bush Fires Act, 1937-1942.

#### PROCLAMATION

WESTERN AUSTRALIA, By His Excellency Sir James Mitcheil, TO WIT. K.C.M.G., Lieutenant-Governor in and over the State of Western Australia and its Dependencies in the Commonwealth of Australia.

Corres. No. 163/42. WHEREAS it is provided by section 18 of the Bush Fires Act, 1937-1942, that whenever, in the opinion of the Minister, it is desirable that any plant, or the refuse thereof, should be burnt during the prohibited times in order to prevent or eradicate disease arising or likely to arise from such plant, or the refuse thereof, the Governor may, on the recommendation of the Minister, by Proclamation authorise the burning of any plant and by Proclamation attnorise the burning of any plant and the refuse thereof during the prohibited times or during any period of the prohibited times and declare that such Proclamation shall take effect either generally or in the particular road districts specified in the Proclamation; and whereas the Minister is of opinion that it is desirable that the plants specified hereunder and the refuse thereof should be burnt in order to preput or engligate disease. should be burnt, in order to prevent or eradicate disease arising or likely to arise from such plants or the refuse thereof during the period of the prohibited time and in the particular road districts specified hereunder: Now, therefore, I, the said Lieutenant-Governor, acting by and with the advice and consent of the Executive Council, do hereby authorise the burning, subject to the regulations, of the undermentioned plants and the refuse thereof during the periods and in the particular road districts set out in the Schedule hereto.

#### Schedule.

Name of Plant, Period in which Burning may take place, Road District.

Tomato (lycopersicum esculentum) and Potato (solanum tuberosum); the whole of the prohibited period; those districts comprised in Zones 3 and 3A as defined in the Government Gazette of 13th October, 1944, page 871, together with the Road Districts of Geraldton, Greenough and Upper Chapman.

#### The Cemeteries Act, 1897. PROCLAMATION

WESTERN AUSTRALIA, By His Excellency Sir James Mitchell, K.C.M.G., Lieutenant-Governor in and over the State of Western Australia [L.s.]

WHEREAS, under the provisions of the Cemeteries Act, 1897, and its amendments, it is made lawful for the Governor in Executive Council from time to time by Proclamation to appoint such place or places in each district as shall be deemed expedient to be reserved for the burial of the dead: Now, therefore, I, Sir James Mitchell, Lieutenant-Governor of the said State, with the advice and consent of the Executive Council, in exercise of the powers in me vested as aforesaid, do by this my Proclamation appoint Korrelocking Lots

Nos. 147 and 170 (Reserves Nos. 13598 and 7832 respectively) as Public Cemeteries under the provisions of the said Act, but subject always to such regulations as may be published from time to time for the proper management of the same.

WATER BOARDS ACT, 1904-1942.

Manjimup Water Area-Extension of Reticulation Mains. ORDER IN COUNCIL.

P.W.W.S. 895/35.

WHEREAS by section 40 of the Water Boards Act, 1904-1942, it is enacted that subject to the provisions of the said Act a Water Board shall have power to construct water works for the purposes of the said Act; and whereas it is provided by section 41 of the said Act (as amended by the Water Boards Act Amendment Act, 1937), that the Governor may exempt reticulation works from the operation of certain sections of the said Act; and whereas it is deemed expedient that the reticulation works referred to in the following Schedule shall be exempt from the operations of the said sections of the said Act: Now, therefore, His Excellency the Lieutenant-Governor acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act and of all other powers in this behalf enabling him doth hereby exempt from the operations of sections 41, 42, 43, 44 and 45 of the Water Boards Act, 1904-1942, the reticulation works included in the following schedule.

Proposed construction of reticulation mains as shown hereunder:-1. 3in. main in Somerville street from the through lot 248, approximately 2.8 chains, from the proposed 3in. main in lot 249; 3. 1½in. main in

Plunkett street from the proposed 3in. main in Somerville street to lot 227, approximately 7.0 chains; 4. lin. main from the proposed 1½in. main in lot 248 through lots 248 and 247, approximately 7.0 chains; 5. lin. main in Pritchard street from the proposed 3in. main in Somerville street to lot 241, approximately 14.0 chains; 6. lin. main in Pritchard street from the proposed 3in. 6. lin. main in Pritchard street from the proposed 3in. main in Somerville street to lot 233, approximately 4.5 chains; 7. 1in. main in Plunkett street from the proposed 3in. main in Somerville street to lot 224, approximately 16.0 chains; 8. lin. main in Plunkett street from the end of the proposed 1½in. main in Plunkett street, for a distance of approximately 2.0 chains; 9. lin. main in Somerville street from the southern end of the proposed 3in. main in Somerville street westwards across to its western side, approximately 1.0 chains; 10. %in. main from the end of the proposed lin. main on the western side of Somerville street along the latter street, across Caldwell street, to lot 256, approximately 10.0 chains; 11. ¾in. main in lot 248 from the end of the proposed 1½in. main through lot 248, approximately 2.0 chains; 12. ¾in. main in Pritchard street from the western end of the proposed lin. main to lot 239, approximately 2.0 chains; 13. %in. main in Pritchard street from the eastern end of the proposed lin. main to lot 233, approximately 2.5 chains; 14. %in. main in Plunkett street from the western end of the proposed lin. main to lot 223, approximately 4.0 chains. All as shown in red on Plan P.W.D., W.A. 30166.

The above mains to be complete with all valves and necessary fittings.

#### Goldfields Water Supply Act, 1902. ORDER IN COUNCIL.

### The Land Act, 1933-1939. ORDER IN COUNCIL.

Corr. No. 1173/35. WHEREAS by section 34 of the Land Act, 1933-1939, it is made lawful for the Governor, by Order in Council, without issuing any deed of grant, to place any reserve under the control of any Municipality, Road Board, or other person or persons, as a Board of Management, and to empower such Board to make, repeal, and alter by-laws for the control and management of such reserves, and prescribe fees for depasturing thereon, and for other purposes, such by-laws to be approved by the Governor and published in the Government Gazette; and whereas it is deemed expedient that reserve "A" \$\dagge 21487\$ for Recreation at Rockingham should be placed under the control of the Rockingham Road Board as a Board of Management: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby place the before-mentioned reserve under the control of the Rockingham Road Board as a Board of Management, and doth empower such Board to make, repeal, or alter by-laws for the control and management of the said reserve; for prescribing fees for depasturing thereon; for directing the manner in which such fees shall be imposed, paid, collected, and disposed of, and to impose penalties not

exceeding in any case £5 for any breach thereof, and £2 a day for a continuing breach, but not more than £20 in the aggregate.

The Forests Act, 1918.

ORDER IN COUNCIL.

Forests File 338/30; Lands File 716/29. WHEREAS, by the Forests Act, 1918, it is provided that the Governor may, by an Order in Council, declare any Crown Lands as State Forests within the meaning and for the purpose of that Act: Now, therefore, His Excellency the Lieutenant-Governor, with the advice and consent of the Executive Council doth hereby declare Sussex Location 3833 as an addition to State Forest No. 33 within the meaning and for the purpose of the Forests Act, 1918.

Fire Brigades Act, 1942. ORDER IN COUNCIL.

WHEREAS it is enacted by section 5 of the Fire Brigades Act, 1942, that the municipal and road districts mentioned in the Second Schedule to the said Act are, for the purposes of the Act, constituted fire districts by the names as in the said Schedule stated, but that the Governor may by Order in Council inter alia (a) excise from any fire district any specified portion thereof and thereupon such portion shall be no longer included in or be part of such district; and whereas by an Order in Council made by the Governor under the said section and published in the Government Gazette the Leonora, Meekatharra, Merredin and Moora fire districts as constituted by the said Act were amended by excising therefrom certain portions of the land comprised in the Leonora, Meekatharra, Merredin and Moora road districts, which are more particularly defined and described in the second column of the First Schedule to the said Order in Council opposite the names of the said fire districts in the first column of the said Schedule; and whereas it is now deemed expedient to reconstitute the said fire districts as at present subsisting by reinstating therein certain portions of the said lands which were heretofore excised therefrom by the said Order in Council: Now, therefore, His Excellency the Lieutenant-Governor acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act doth hereby for the purposes of the said Act reconstitute the said Leonora, Meekatharra, Merredin and Moora fire districts as part thereof respectively those portions of land being respectively portions of the land comprised in the Leonora, Meekatharra, Merredin and Moora road districts which are more particularly defined and described in the second column of the Schedule hereunder opposite the name of each of the said four districts respectively in the first column of such Schedule.

All that portion of land, bounded by lines, starting from the northernmost north-western corner of the existing district as described in the Government Gazette of 4th June, 1943, page 548, and being the western corner of Moora Suburban Lot 63, and extending westerly, along the southern alignment of Clarke street, to the eastern alignment of Long street; thence southerly along the said eastern alignment and onwards; to join the present boundary of the aforesaid district at the northernmost corner of suburban lot 164; and thence easterly, northerly, easterly, northerly and again easterly and northerly, along existing boundaries of the said district, to the

#### BUSH FIRES ACT, 1937.

By-laws of the Merredin Road Board relating to the Establishment, Maintenance and Equipment of the Bush Fire Brigades for the Road District of Merredin.

#### Establishment of Brigade.

1. On the resolution of the Board to establish, maintain and equip a bush fire brigade under the provisions of the Bush Fires Act, 1937, and regulations thereunder, the brigade shall be formed in accordance with these by laws; and a name shall be given to the brigade and applications accompanied by a copy of these by-laws shall be made to the Minister for Lands for its registration accordingly.

A bush fire brigade may be established for the whole of the road district or for any specified area thereof. Provided that, unless the resolution of the Board establishing a bush fire brigade specifies therein only a part of the district as the area for which such brigade is established, the brigade shall be deemed to be established for the whole of the said road district.

### Appointment of Officers.

- 2. The Board shall appoint a captain, lieutenant, a second lieutenant and such additional officers as it shall deem necessary to act as officers of the brigade, and who, in the Board's opinion, have the necessary qualification and knowledge of the district required in such capacity.
- The secretary of the Board, or such other person as the Board shall appoint, shall be the secretary of the brigade.
- 4. The Board may appoint an equipment officer who shall be responsible for the custody and maintenance in good order and condition of all equipment and appliances acquired by the Board for the purposes of the brigade. Such officers may station the equipment at a depot approved by the captain where, if possible, motor trucks can easily be called upon. If there are more than one such depots in the area, the equipment officer shall appoint at each depot a person to look after the equipment and have it ready for immediate use when required.
- 5. The Board shall appoint bush fire control officers in accordance with the requirements of the district, and may prescribe the area over which each officer shall have The employment, dismissal and payment for services of persons (other than officers) employed for duty under this Act shall be vested in the chairman and secretary of the Board conjointly.

#### Duties of Officers.

6. The duties of all officers appointed under these by laws shall be as laid down in the provisions of the Bush Fires Act, 1937, and each officer so appointed shall be supplied with a copy of the Act and regulations. The captain shall have full control over the members of the brigade whilst engaged in fire fighting, and shall issue instructions as to the methods to be adopted by the firemen. In the absence of the captain, the first lieutenant; and in the absence of the first, the second lieutenant or senior officer of the brigade present at the fire shall exercise all the powers and duties of the cap-tain. The captain shall, when so directed by the Board, instruct all land owners or occupiers to plough a break or breaks on all cleared land or land under pasture.

#### Membership of Brigade.

- 7. (1) The membership of a bush fire brigade may con ist of the following:—a. Subscribing members, b. Fire fighting members, and c. Associate members.
- (2) Subscribing members shall be those persons who, being interested in forwarding the objects of the brigade, pay an annual subscription to the funds of the brigade at the following rates:
  - i. Owner or occupier of land within the brigade area—minimum subscription 10 0 .. .. . .
  - ii. Other person, minimum subscription of .. 5 0
- (3) Fire fighting members shall be those persons, being able-bodied men over 18 years of age who are willing to render service at any bush fire when called upon, and who sign an undertaking in the form contained in the First Schedule to these by-laws.
- (4) Associate members shall be those persons who are willing to supply free motor transport for fire fighting members or equipment, or who are prepared to render other approved assistance, and who sign an undertaking in the form contained in the Second Schedule to these by laws.
- (5) No fees or subscriptions shall be payable either by fire fighting members or associate members, and the enrolment of persons as such members shall in every case be subject to the approval of the Board.
- (6) A subscribing member shall be eligible for enrolment as a fire fighting member.

#### Finance.

8. The expenditure incurred by the Board in the purchase of equipment, etc., payment for services and generally for the purposes of this Act, shall be a charge on the ordinary revenue of the Board, but the secretary shall keep a separate record of the expenditure incurred under this Act.

#### Meetings of the Brigade.

9. The brigade shall meet at times notified from time to time by the captain for the conduct of ordinary business, and shall meet annually in October of each year, to arrange all matters in connection with the prevention and extinguishing of fires during the coming summer, and to overhaul the organisation of the brigade, and of its equipment.

These by laws under the Bush Fires Act, 1937, were passed by a resolution of the Merredin Road Board (a local authority under the provisions of such Act) at a meeting held at Merredin on 14th October, 1944.

#### IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

#### (No. 2 of 1944.)

Between Eastern Goldfields Federated Engine-drivers and Firemen's Union of Workers of Western Australia, applicant, and Goldfields Firewood Supply Limited, respondent.

THE Court of Arbitration of Western Australia doth hereby make the following Award in connection with the industrial dispute between the abovenamed parties:-

#### AWARD.

#### 1.—Area.

This Award shall be limited in effect to the area enclosed within lines parallel to and ten (10) chains on either side of the respondent company's railway lines from Lakewood.

#### 2.—Term.

This Award shall have effect for a period of three (3) years from the date hereof.

#### 3.--Wages.

The minimum rate of wage shall be:-

(a) Basic wage, £5 7s. 1d. per week

The workers hereinbefore specified who are stationed outside of Lakewood (main depot) shall be paid an additional one shilling and twopence (1s. 2d.) per working day for six (6) days a week.

#### 4.—Hours.

(a) Forty-four (44) hours (excluding Sundays) shall constitute a week's work, to be worked in five (5) consecutive shifts of eight (8) hours each, from Mondays to Fridays inclusive, and four (4) hours on Saturdays, or, alternatively, at the option of the employer, eightyeight (88) hours per fortnight, to be worked in five (5) consecutive shifts of eight (8) hours each in one week and six (6) consecutive shifts of eight (8) hours each in the following week, and so on from week to week.

(b) Time-table Committee: A time-table consultative

committee is hereby established for the purpose of this clause. The committee shall consist of the general manager of the company and the traffic manager and the bush foreman, representing the employer, and three representatives to be selected by the union, representing the workers. The committee shall meet at least once in each calendar quarter of the year, the first meeting to be held prior to the 31st December, 1944, at a date and time to be mutually arranged. The functions of the time to be mutually arranged. The functions of the committee are limited to consultation, discussion, and

recommendation with a view to improvement in timetable and running conditions being arrived at by agreement between the parties.

#### 5.—Preparation and Stabling.

Preparation: Each driver, fireman, and guard if required to do the work shall be granted an allowance of thirty (30) minutes for preparing the engine and/or train: Provided, however, that where any of these workers is relieved from the ordinary duties of preparation and another worker or workers is employed, a deduction shall be made from this time allowance apportioned to the duties discharged by such other worker or workers.

Stabling: The actual time on duty occupied by each worker in stabling or finishing shall be allowed to the driver, fireman, and guard.

#### -Overtime, Sunday Time, and Holiday Time.

For all work performed beyond the hours of duty on any shift the worker shall be paid at the rate of time and a quarter for the first two (2) hours, time and a half for the next two (2) hours, and double time thereafter. For all time worked on Sunday, Christmas Day, Easter Monday, and Labour Day, double time rates shall be paid. In all cases of reckoning time of duty, any time necessarily occupied in raising steam or in banking fires shall be included.

#### 7.—Annual Holidays.

(a) A fortnight's holiday, including twelve (12) working days on full pay, shall be granted once in each year to every worker provided he has worked 298 shifts at ordinary rates of pay, and should he have worked less than 298 such shifts when the said holiday is taken or at the termination of his employment, he shall be paid for a proportionate number of holidays. Payment for the said holidays shall be at the rate of pay the worker is receiving immediately before the holiday is taken or employment is terminated: Provided that where the worker is dismissed for wilful misconduct he shall not be entitled to the benefits of the provisions of this clause.
(b) Workers shall be entitled to receive one month's

notice of the date on which a holiday is to commence. To assist the management in the preparation and arrangement of a suitable roster a committee of three (3)

may be appointed by the workers.

#### 8.—General Conditions.

(a) Each locomotive driver shall be supplied with the services of a competent fireman and, when guard's work is to be done, with a guard, both of whom shall be not less than eighteen (18) years of age.

(b) The employer shall provide suitable housing ac-

commodation for all married workers who are stationed outside Lakewood and in the case of single workers, suitable quarters with necessary beds, stove, and cooking utensils. Accommodation shall be provided for the use of workers who may be compelled to remain in the bush

overnight.

(c) The employer shall provide suitable camps for train crews who are temporarily transferred from their home station, with stove, stretchers and mattresses, together with two (2) bush rugs for each bed, and shall provide each member of the crew with provisions to the extent of four shillings and sixpence (4s. 6d.) per day or a payment in cash of such sum over and above the prescribed rates of pay.

(d) A worker shall not be transferred for a lesser period than three (3) months. If required to work temporarily at another depot for relief or other purposes he shall be paid the allowance provided in the preceding

subclause (8) (c).

(e) Reasonable notice shall be given to a worker required to permanently transfer from his home station

to another depot.

(f) Any worker who receives notice of permanent transfer from his home station to another depot shall have free pass for himself and family, all of whom are resident with him and wholly or partly dependent on his earnings, and also free railway transport for his furniture and effects. This shall also apply to the mother of a single worker who is wholly dependent upon him.

9.—Worker Booked for Duty and not Required.
Any worker booked for duty but informed that his services are not required shall be paid a minimum of two (2) hours' pay; provided that any worker who has received two (2) hours' notice or in respect of whom reasonable proof is shown that efforts were made to give such notice shell not be entitled to any ellegate. such notice, shall not be entitled to any allowance.

#### 10.—Seniority.

- (a) The seniority of locomotive engine-drivers, locomotive firemen, cleaners and guards shall be based upon the length of service with the employer in the different grades, and when the service of any worker is required in any of these classes of labour the senior worker, provided he is competent and suitable to hold the position shall be signed. tion, shall be given the first opportunity of working a train, provided that his services are available, and in the event of the senior worker not being available the next in seniority, provided he is competent and suitable, shall be appointed. So far as practicable the time of employment shall be equally distributed among all workers.
- (b) In order to give effect to the preceding subclause, a seniority list shall be prepared by the representatives of the respondent company and the applicant union within fourteen (14) days after the delivery of this Award. A copy of the list when agreed upon shall be posted up in the sheds at Lakewood.

#### 11.—Active Duty.

Each driver, fireman, and cleaner shall be considered to be on active duty all the time he has to stay with the engine whilst under steam.

#### 12.-Free Wood and Water.

The workers shall be supplied with water and wood by the employer free of charge, delivered at appointed places as hitherto.

#### 13.-Mixed Functions.

A worker engaged for more than one half of a shift on duties carrying a higher rate than his ordinary classification shall be paid the higher rate for such shift; if employed for one half or less than half of a shift he shall be paid the higher rate for the time actually worked: Provided however that acting time of less than twenty (20) minutes in any one shift shall not be counted. Should any worker be required to perform work in a lower grade his wage shall not be reduced whilst employed in such capacity.

#### 14.—Union Representative's Right of Access.

(a) Right of access to the works and undertakings (a) Right of access to the works and undertakings of the employer shall be granted to a duly accredited representative of the union to investigate any complaint.

(b) The accredited representative of the union shall be allowed to inspect time sheets and pay sheets relating

to any worker affected by this Award and make extracts therefrom at such time or times as may be mutually agreed upon between such representative and the employer.

#### 15.—Guarantee of Employment.

Except in cases where stoppage of work is occasioned by causes beyond the respondent's control, a minimum weekly wage equivalent to pay for forty-four (44) hours (exclusive of Sunday but inclusive of early and late attendance) shall be guaranteed and paid to each worker ready and available for work.

#### 16.—Payment for Sickness.

- (a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health, for one half (½) day for each completed month of service: Provided that payment for such absence through such ill-health shall be limited to six (6) days in each calendar year. Payment hereunder may be adjusted at the end of each calendar year or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred. This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.
- (b) No worker shall be entitled to the benefits of this clause unless he produces proof to the satisfaction of the employer or his representative of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) days or more.
- (c) No payment will be made for any absence due to a worker's own fault, neglect, or misconduct.

HAVING heard Mr. E. L. Hodges on behalf of the above-named union and Mr. S. S. Fisher on behalf of the Hon. Minister for Water Supply, Sewerage and Drainage, the Court in pursuance of the powers contained in section 90 of the Industrial Arbitration Act, 1912-1941, doth hereby order that the Award made on the 24th day of December, 1938, numbered 26 of 1937, as amended by Orders numbered 154 of 1939 and 47 of 1942, be and the same is hereby further amended as follows:-

#### PART IV. Clause 9 .- Hours.

Omit subclause (4) hereof and insert in place thereof the following:-

- (4) Starting and Finishing Places:-(a) Workers shall start and finish their day's work at the depot or on the job as required; provided however that maintenance workers shall start and finish their day's work at the department's yards or stores where they are usually employed.
- (b) Workers usually employed asworkers shall when employed on construction work be entitled to start and finish at the said yards or stores or on the job as may be required; provided that if required to start on the job compensation for the extra time involved shall be paid them at ordinary rates but such extra time shall be the time necessarily occupied by taking the shortest and most convenient route and shall not be included for purposes of overtime; provided further if the duration of the construction work extends over four weeks payment of such extra rates shall cease as from four weeks from the time when the worker commenced work.

#### 34.—Tool Allowance.

Where a worker (except an under-rate worker or an apprentice worker) is required to supply his own tools and files, a tool allowance at the rate of 7/- a week shall be paid.

Rudderham on behalf of the employers, and by consent, the Court, in pursuance of the powers contained in section 88 of the Industrial Arbitration Act, 1912-1941, doth hereby order and direct that Award numbered 30 of 1941, as amended by Order numbered 45 of 1944, be and the same is hereby further amended in the manner following for the purpose of remedying a defect therein, that is to say:—

#### Clause 6 .- Special Allowances.

Add the following to subclause (a) Crib Time:—"As compensation to signalmen, who are not provided for in this subclause, and for whom the work will not permit a break for crib being arranged, a weekly allowance equal to four (4) hours' overtime at the rate of time and a half shall be paid."

#### Schedule of Amendments.

#### I. Clause 23-Hours.

Omit this clause and insert the following in lieu thereof:-

- (a) The working hours at a centre shall be, for beat and office duty, eight continuous hours per day, but not more than 96 hours per fortnight; provided that these hours shall apply to police work generally where circumstances permit, but where duties are light and intermittent, such as watch-house or garage duty, mounted duty, orderly work or escort, or any duty for which travelling allowance is paid, they need not be adhered to.
- (b) The ordinary working hours at a centre shall consist of three shifts or reliefs as follows, and shall, as far as practicable, be worked fortnightly in rotation:—First relief, 7 a.m. to 3 p.m.; second relief, 3 p.m. to 11 p.m.; third relief, 11 p.m. to 7 a.m.

- At outside towns or at other places, shifts of eight hours, as required according to local conditions, shall be worked. Where two foot-constables are employed in addition to a mounted constable, and the officer in charge of the station, alternate weekly shifts shall be worked.
- (c) Each shift or relief shall be allowed 30 minutes for a meal, at a time to be arranged by the non-commissioned officer, except in the case of men on night duty, who shall be allowed 20 minutes for crib, but such refreshment must be taken on beat.
- (d) The ordinary working hours at a place not a centre shall be, as far as practicable, the same as abovementioned.
- (e) The Commissioner shall give his employees at least one day's notice of all Sunday duty and leave, and at least seven days' clear notice of all annual leave, and there shall be posted in the day room at all police centres a return showing the particulars of such duty and leave; provided that each employee shall be entitled to one day's leave in each seven days, or, alternatively, to two days' leave in every 14 days; also, provided that whenever practicable one of such days' leave shall be on a Sunday.
- (f) Employees due for Sunday leave and having completed their ordinary tour of duty on the previous day may then be granted leave: Provided that the circumstances are normal and that they inform their immediate superiors where they may be found if required before they are due for duty.
- (g) The ordinary working hours of members of the C.I.B. shall not exceed 96 hours per fortnight, and shall, as far as practicable, be worked as follows:—9 a.m. to 1 p.m., 2 p.m. to 6 p.m.; 9 a.m. to 1 p.m., 7 p.m. to 11 p.m.

On Sundays, one detective shall do duty from 10 a.m. to 1 p.m.; one detective from 2 p.m. to 5 p.m.; and two detectives from 7 p.m. to 10 p.m.

Office staff hours of the C.I. Branch shall be 8.30 a.m. to 1 p.m. and 2 p.m. to 5.30 p.m. Other shifts shall be 9 a.m. to 12 noon and from 6 p.m. to 11 p.m.; 9 a.m. to 1 p.m. and 2 p.m. to 6 p.m.; Sunday duty, 9 a.m. to 12 noon and 7 p.m. to 10 p.m.

- (h) In case of riots or disturbances or for the preservation of peace, or the protection of human life, or the pursuit of criminals, or for any sufficient reason, the Commissioner or any officer or non-commissioned officer may call upon employees for duty at any hour of the day or night or to remain continuously on duty.
- (i) The Commissioner may suspend the eight hours' provision in this clause when the circumstances, in his discretion, call for such action in the public interest.

#### II. Clause 24-Overtime.

Omit this clause and insert the following in lien thereof:—

- (a) Subject to subclause (g) of clause 23, every member attached to a centre or the C.I.B. station, where at least two men are employed on foot patrol or town duty (other than members of the Pillaging Staff) who perform more than 96 hours per fortnight shall be given equivalent time off in lieu thereof as soon as practicable or shall be paid overtime in accordance with the scale contained in subclause (g) hereunder.
- (b) Members of the Pillaging Staff who perform more than 96 hours in any one fortnight shall be paid overtime in accordance with the scale contained in subclause (g) hereunder.
- (c) Any employee who performs escort duty involving a continuous period of 16 hours shall be granted at least 24 hours' leave in lien of every such period and may, if practicable, be allowed to spend such leave at the city or town nearest the place where he relinquished charge of the prisoners or property escorted; provided that if he takes his leave where he relinquished charge of the prisoners or property escorted, and he could begin his return to his station before the expiration of such leave, he shall only be paid travelling allowance up to the time at which he would ordinarily return to his station.
- (d) At each centre a record shall be kept showing the amount of overtime worked by each employee working thereat. Such record shall be available at all reasonable times for inspection by any employee concerned, and a copy shall be forwarded to Chief Office to arrive by mid-day on the Monday of each alternate fortnight,

so that such overtime, if to be paid for, can be included on the fortnightly pay sheet.

- (e) No overtime is to be worked without the permission first obtained of the inspector in charge of the district or branch.
- (f) Work performed as escort or other light duty where travelling allowance is paid shall not be claimed or paid for as overtime but the prevailing practice of time off shall continue.
- (g) The scale of allowances in consideration of duty in excess of 96 hours per fortnight shall be as fol-

#### INDUSTRIAL AGREEMENT No. 7 of 1944. (Registered 2/11/44.)

THIS Agreement made in pursuance of the Industrial Arbitration Act, 1912-1941, of Western Australia, this seventh day of September, 1944, between the Commissioners of the Fremantle Harbour Trust, hereinafter called the Employers, of the one part and the Coastal Dock, Rivers and Harbour Works Union of Workers, hereinafter called the Employees, of the other part, witnesseth as follows: nesseth as follows:-

#### 1.—Area and Scope.

This Agreement shall apply to the mooring and unmooring and shifting of vessels, rigging and removing gangways, etc., where such services are undertaken by the employers within the Port of Fremantle.

#### 2.—Hours of Duty.

Forty-four (44) hours shall constitute a week's work. The daily hours of duty shall not exceed nine (9) per day, and shall be worked on any five (5) days of the week between the hours of 6 a.m. and 6 p.m. or between such other hours as may be mutually agreed upon: Provided that the spread of hours from the beginning to the end of the day's work shall not exceed twelve (12) hours, and no shift shall consist of more than two (2) periods of working time.

### 3.—Days Off.

Employees shall be rostered to have two (2) days off in each week, such days off to be consecutive where possible: Provided that if through unforeseen circumstances an employee's day off is cancelled and he is required for duty, the employee shall be paid a minimum of eight (8) hours at time and half for the extra time on duty during the week.

#### 4.-Overtime and Sanday Time.

- (a) Overtime shall mean and include all time worked:—(1) in excess of nine (9) hours on any working day, (2) outside of the daily spread of hours prescribed in clause 2 of this agreement, (3) in excess of 44 hours in any one week.
- (b) Overtime worked consecutive with ordinary hours of duty shall be paid for at the rate of time and half for the first four (4) hours and double time thereafter.
- (c) Employees recalled to duty outside of the prescribed spread of hours, shall be paid overtime at the rate of double time for the period of recall, with a minimum of two hours.
- d) Employees called on to start work within an hour and half of starting time shall be paid at the rate of time and half until starting time.
- (e) The time worked on Sundays up to a maximum of nine (9) hours shall be included as part of the ordinary week's work, but employees required to work on Sundays, other than those finishing Saturday's shift, shall be paid an extra half day's pay in addition to the week's earnings.

#### 5.-Meal Hours.

Employees who cannot be released for one hour for-(a) breakfast between the hours of 8 a.m. and 10 a.m., (b) lunch between the hours of 12 noon and 2 p.m., (c) tea between the hours of 5 p.m. and 7 p.m., shall be paid at the rate of time and half until a full hour for a meal is allowed: Provided that such extra rate shall not be payable to employees who commence work at or during a specified meal time: Provided further that the provisions of this clause, so far as they relate to breakfast, shall not apply to employees called on to commence work for the day at 7.15 a.m. or later.

#### 6.—Rates of Pay.

#### 7.—Engagement and Dismissal.

All regular employees shall be deemed to be engaged upon a weekly basis, and one week's notice on either side shall be necessary to terminate the services of any employee: Provided that an employee may be instantly dismissed or suspended for insobriety, misconduct or neglect of duty.

### 8.—Casual Employees.

A "casual" is an employee engaged to assist in the performance of any of the specified services defined hereunder. The rates of pay to casual employees shall be as follows:-

(b) The foregoing rates shall be varied in accordance with the variations in the said basic wage by one penny for each complete two shillings by which such basic wage is varied from the present rate. (c) Where any portion of any of the services defined in subclause (a) hereof:—(1) is undertaken prior to 6 a.m. on Mondays to Saturdays inclusive, or completed after 6 p.m. on Mondays to Fridays inclusive, or between noon and 6 p.m. on Saturdays, the specified rate shall be increased by ninepence (9d.); (2) is undertaken or completed after 6 p.m. on Saturdays or at any time on Sundays, the specified rate shall be increased by 1s. 3d.

#### 9.-Waiting Time.

- (a) Waiting time for casual employees shall be paid after one hour has elapsed from the time when such employees are in attendance according to orders in connection with mooring or unmooring a vessel: Provided such period of one hour has been exceeded owing to the vessel not having arrived at her berth or not being ready to sail at the appointed hour. The rate of pay shall be 2s. 11d. per hour or portion thereof between 6 a.m. and 6 p.m. Monday to Friday, and from 6 a.m. to 12 noon on Saturday, and 3s. 8d. per hour or portion thereof at all other times, excepting on Sandays when the rate will be 4s. 2d. per hour or portion thereof at all other times, excepting on Sandays when the rate will be 4s. 2d. per hour or portion thereof.
- (b) Should a casual employee report for duty to moor or unmoor a vessel, and, not being required, be released and ordered down for a later hour, he shall be paid at the rate of 2s. 11d. for each such attendance.

#### 10.—Annual Leave.

Employees who serve continuously for twelve (12) months shall be granted annual leave on full pay for a continuous period of twenty-nine (29) days. Where a continuous period of twenty-nine (29) days. the period of service is less than twelve months, but is not less than one month, the period of leave shall be reduced pro rata to the period of service. Annual leave shall at all times be taken at the convenience of the employers.

#### 11.—Sick Leave.

- (a) A regular employee who is incapacitated through sickness or injury, other than that arising out of or in the course of his employment, may be granted sick leave with pay for a period of, or periods not exceeding in the aggregate, four weeks in any year, upon produc-tion, within 48 hours of the commencement of any such period of absence, of a medical certificate showing the nature of the illness and the probable duration.
- (b) Where such incapacity arises through the wilful act or misconduct of the employee, or a medical certificate is not furnished as required, or where the employee has already had sick leave with pay for a period of or periods aggregating four weeks during that year, the employee shall not be entitled to any pay for the period had been found that he is absent from duty.
- (c) Upon the period or periods of absence exceeding four weeks in the case of paragraph (a) hereof, or upon the happening or occurrence of any of the events specified in paragraph (b) hereof, immediately such absence commences or such event happens or occurs, the contract of service shall be deemed to have been terminated without requiring further notice by the employers, who shall thereby be relieved of any further obligation to the employee: Provided that any such period of incapacity may at the discretion of the employers be regarded as leave without pay.

### 12.-Sickness or Accident Arising out of Duty.

- (a) A regular employee who, while on duty or acting under the instructions of the employer, receives an injury arising out of, or in the course of his employment, or contracts an illness due to the nature of and attributable to such employment, and is thereby incapacitated from duty in circumstances which entitle him to the benefits prescribed under the Workers' Compensation Act, 1912-1941, shall be entitled to receive in addition to such benefits, a weekly sum equal to the difference between the compensation provided for under that Act and the wages prescribed in this Award, from the date of the commencement of his said incapacity up to and including the date of his recovery as certified by his medical attendant: Provided that the employer's liability hereunder shall in no case exceed 30
- days in respect of each separate injury or illness.

  (b) All amounts payable under this clause shall be paid in the manner provided for the payment of wages.

#### 13.—Uniforms.

Regular employees shall be provided with uniforms consisting of sac coat, vest and tronsers each eight months and, in addition, there shall be provided each year, if required, one oilskin coat and sou'wester hat and one cap. Badges and buttons will be renewed when necessary. Uniforms, which will at all times remain the property of the employers shall be been uncertainty. property of the employers, shall be kept neat and tidy by employees and must be worn by them when on duty.

#### 14.—Rest Room.

A rest room shall be provided by the employers for the use of regular employees. Employees must provide their own rugs, etc., and must keep the room clean and tidy.

#### 15.—Telephones.

Each regular employee shall be provided with a telephone at his place of residence, the rental and a reasonable amount of calls to be paid by the employers.

#### 16.-Use of Bicycles.

Regular employees who are required by the employers to use their own bicycles during the course of players to use their own bicycles during the course of their duties, shall receive a special allowance of 2s. 6d. per week as compensation for wear and tear. Such allowance, which shall be payable monthly, will not accrue while the employee is absent from duty for any cause whatsoever for a period of a complete week or longer.

#### 17.—Long Service Leave.

Employees shall be granted long service leave after each seven years' service, but periods of absence on long service leave shall not count as service qualifying towards the next grant of such leave.

#### 18.-No Discrimination.

The employers shall not discriminate against members of the Coastal Dock, Rivers and Harbour Works Union when members of this union are available and capable of carrying out the work required.

#### 19.—Board of Reference.

Should any dispute arise between the employers and the employees under this Agreement, the matter shall be referred to a Board of Reference, consisting of a representative of the employers, a representative of the employees, and the Registrar of the Court of Arbitration of Western Australia, who shall act as Chairman. The decision of the board shall be final and binding.

#### 20.—Term.

This Agreement shall come into force from the date This Agreement shall come into force from the date of signature thereto, and shall continue for a period of twelve months therefrom. This Agreement replaces Industrial Agreement No. 5 of 1934 (as amended by No. 24 of 1939), made between the herein named parties on the 14th June, 1934.

It is hereby agreed that pursuant to the National Security (Economic Organisation) Regulations, nothing herein contained (other than the provisions of clause 8 (c), 1 and 2 hereof) shall be deemed to increase or decrease the rate of remuneration of any worker covered by this Industrial Agreement from that in force on the 10th day of February, 1942.
