BY-LAW No. 35 in connection with the Management of Reserves under the control of the Board and the campthe Board and the composing and playing of games thereon made and passed by the Wanneroo Road Board at a meeting held on the 8th day of October, 1943, and published in the Government Gazette on the 5th day of November, 1943, is hereby repealed and the following inserted in lieu thereof:—

35. (a) Fees are payable prior to the issue of permit on the following scale:

For frontages up to but not exceeding 20 feet-Per Annum or

Part thereof. s. d. 2 Boat shed 2 2 Boat shed and camp ...

For every foot of frontage in excess of 20 feet, 4/-(four shillings) per foot.

- (b) Should any fees due under the preceding section become 12 months in arrears such permission to camp as granted by the Board shall cease without further notice and all buildings erected on such lease shall forthwith become the property of the Board.
- (c) The type of camp, camp and boat shed, boat shed or other building permitted to be erected shall be defined by the Board.
- (d) No person or organised club shall erect any camp, camp and boat shed, boat shed or any other building or add to any camp, camp and boat shed, boat shed or any other building without having first obtained a writ-ten permit from the Board.
- (e) The building fee to be paid on application to build as prescribed in by-law 36 (e) shall be (10s. 6d.) ten shillings and sixpence.
- (f) No boat shed, camp and boat shed, camp or any other building shall be occupied continuously for any one period exceeding 48 hours without first having obtained permission in writing to do so from the Board.

KELLERBERRIN VERMIN BOARD.
