PROCLAMATION

Western Australia, By His Excellency Sir James Mitchell, TO Wr. K.C.M.G., Lieutenant-Governor in and over the State of Western Australia Lieutenant-Governor. [L.s.] wealth of Australia.

WHEREAS, under the provisions of the Cemeteries Act, 1897, and its amendments, it is made lawful for the Governor in Executive Council from time to time by Proclamation to appoint such place or places in each district as shall be deemed expedient to be reserved for the burial of the dead: Now, therefore I, Sir James Mitchell, Lieutenant-Governor of the said State, with the advice and consent of the Executive Council, in exercise of the powers in me vested as aforesaid, do by this my Proclamation appoint reserve 11496 at Boraning in the Williams Road District, a Public Cemetery under the provisions of the said Act, but subject always to such regulations as may be published from time to time for the proper management of the same.

PROCLAMATION

WESTERN AUSTRALIA, By His Excellency Sir James Mitchell,
TO WIT. K.C.M.G., Lieutenant-Governor in and
Over the State of Western Australia
Lieutenant-Governor. and its Dependencies in the Commonwealth of Australia.

WHEREAS it is enacted by section 3 of the Abattoirs Act, 1909-1941, that the said Act shall be in force only in such portions of the State as the Governor may from time to time by Proclamation declare to be districts for

the purposes of the said Act; and whereas it is deemed expedient that the said Act shall be in force in that portion of the State hereinafter described: Now, therefore I, the said Lieutenant-Governor acting with the advice and consent of the Executive Council and in exercise of the power conferred by section 3 of the said Act do hereby declare that all that portion of the State in and around the Town of Bunbury comprised within the circumference of an imaginary circle having a radius of ten miles from the Post Office in Bunbury aforesaid as the centre thereof shall be and is hereby constituted a district within the meaning and for the purposes of the Abattoirs Act, 1909-1941, with the intent that the said Act shall be in force in such district.

Land Drainage Act, 1925-1941.

Harvey Drainage District.

ORDER IN COUNCIL.

P.W.W.S. 625/32.

WHEREAS by section 12, subsection (1), paragraph (g) of the Land Drainage Act, 1925-1941, the Governor may repeal, vary, or amend any order relating to any drainage district: Now, therefore, His Excellency the Lieutenant-Governor, with the advice of the Executive Council doth amend the Harvey Drainage District's boundaries by varying the boundaries as defined in the Government

Gazette of the 9th day of September, 1938, and substituting the boundaries described in the Schedule attached hereto.

All that portion of land bounded by lines starting from a point on the right bank of the Harvey River situate at the easternmost boundary of Wellington Location 50A and extending southerly along the said boundary to the southern side of road No. 804; thence generally westerly along the said side to the eastern side of the South-Western highway; thence south-westerly along the said side to the north-western corner of Korijekup Estate Lot 197; thence easterly, along the northern boundary of the said lot, to a point situate in prolongation northerly of the eastern boundary of lot 221, reserve 17482; thence southerly to and along the said boundary to the south-eastern corner of the latter lot; thence westerly to the north-eastern corner of lot 33 of Wellington Location 50, as shown on Land Titles of Wellington Location 50, as shown on Land Titles Office Diagram 4878; thence southerly along the eastern boundary of the said lot, and onwards to the southwestern corner of lot 46 of location 1 as shown on L.T.O. Plan 2527; thence south-westerly, passing through Wellington Location 4472 and onwards to an internal south-western corner of lot 2 of the latter location, as shown on L.T.O. Diagram 5044; thence south-southwesterly to and along the south-eastern boundary of lot 55 of the same location to its south-eastern corner; thence easterly along the northern side of a road to thence easterly along the northern side of a road to a point in prolongation north-easterly of the south-eastern boundary of lot 53; thence south-south-westerly to and along the latter boundary onwards along the south-eastern boundaries of lots 51, 49, 47, 45 and 43 (as shown on L.T.O. Diagrams 3972, 581, 958 and 4302) and continuing in the same direction to the centre of the Norah Brook; thence generally north downwards along the said centre and onwards westerly to and along the centre of the Norah Brook Diversion Drain to a south-eastern boundary of the Benger Drainage District; thence generally south-westerly along the said boundary to the centre of the Mornington River; thence southerly and generally westerly downwards along the said centre of river and onwards to the centre of the Wellesley River; thence in a general north-westerly direction in a straight line through Wellington Location 1 to the western side of Wellington road at its intersection with the northern side of Mysore road; thence following the said western side in a generally northerly direction to the northern boundary of location 1 aforesaid; thence easterly to and along Marriott road to a point situate in prolongation southerly of the western side of Richardson road; thence northerly along the said side to the south-eastern corner of Wellington Location 3171; thence westerly and northerly along boundaries of the said location to the south-western corner of location 4447; thence northerly to the south-eastern corner of location 881; thence westerly to the south-western corner of location 719; thence northerly to and along a western boundary of location 881 aforesaid to a point situate due east of Post H33 on road No. 102; thence west to the said post; thence north-easterly along the side of said road to its intersection with the southern side of Forrest road; thence east along the said side to its intersection with the alignment of the western boundary of location 3204; thence northerly along the said boundary and the western boundary of location 2302 then east along the northern boundary of the said location and its prolongation easterly to the eastern side of Richardson road aforesaid; thence northerly along the said side to the north-western corner of Uduc Agricultural Area Lot 33; thence northerly, westerly and again northerly along boundaries of Wellington Location 3071 and onwards in the latter direction to the northern side of road No. 488; thence generally westerly along the said side of road to a point situate in prolongation southerly of the eastern boundary of location 1023; thence northerly to and along the said boundary; thence westerly along its northern boundary to its north-western corner; thence northern boundary to its north-western corner; thence northerly in prolongation of its western boundary to a northern boundary of location 2841; thence easterly along the said boundary to a point in prolongation southerly of the western boundary of location 2830; and thence generally northerly to and along the said boundary and onwards to and along the eastern boundary of location 1142 to its north eastern covery thouse of location 1143 to its north-eastern corner; thence easterly along a southern boundary of location 3584 to a point situate in prolongation southerly of the western boundary of location 3907; thence northerly along the said prolongation to the north-eastern side of road No. 891; thence generally south-easterly along the said

side of road to a point on a south-western boundary of the latter location and situate 40 chains west from the western boundary of location 1269; thence north 28 chains; thence east 40 chains to the said western boundary; thence south-easterly through a point on the eastern boundary of said location 1269, and situate 55 chains southerly from the north-eastern corner of the chains southerly from the north-eastern corner of the latter location and continuing onwards to the western boundary of location 1306; thence northerly along the said western boundary and onwards to a south-western corner of Harvey Agricultural Area Lot 247; thence generally south-easterly along the boundaries of the said lot to a point situate in prolongation westerly of the southern boundary of lot 227; thence easterly to and along the said boundary; thence northerly along its contour boundary; thence northerly along its eastern boundary; thence westerly, northerly and easterly along the side of a one chain road to a south-eastern corner of lot 225; thence northerly along its eastern boundary to a point situate in prolongation westerly of the southern boundary of lot 223; thence easterly to and along the said boundary and onwards to the western boundary of lot 201; thence northerly, southeasterly, and easterly along boundaries of the said lot to its north-eastern corner; thence east-south-easterly to a point on the eastern boundary of lot 150 and situate 24 chains northerly from its south-eastern corner; thence southerly along the said eastern boundary and onwards to the south-eastern corner of lot 146; thence easterly, northerly and again easterly to and along boundaries of lot 145 to its south-eastern corner; thence easterly to the south-westernmost corner of Murray Location 279; thence easterly to and along the southermost boundary of location 420 and onwards to the western boundary of Wellington Location 4238; thence northerly, easterly, southerly and westerly along boundaries of said location to the north-western corner of location 945; thence southerly and easterly along boundaries of the said location to the north-eastern corner of location 2606; thence southerly, westerly and north-north-west-erly along boundaries of the said location to a point in prolongation easterly of the southern boundary of Harvey A.A. Lot 173; thence westerly to and along the said boundary to the eastern boundary of the south-western Railway Reserve; thence generally southerly along the said boundary of reserve to a point in proalong the said boundary of reserve to a point in pro-longation westerly of the northern boundary of reserve 8385; thence easterly, southerly, south-westerly, west-erly and again southerly to and along boundaries of the said reserve and onwards in the last-mentioned direction to the northern boundary of location 897; thence easterly, southerly, and westerly along boundaries of the said location and onwards in the last-mentioned direction to the western side of road No. 1443; thence generally southerly along the said side of road and onwards to the southern side of road No. 479; thence easterly along the said side of road to the western side of the South-Western highway; thence generally southerly to a point in prolongation westerly of the northern boundary of location 572; thence easterly, southerly and westerly to and along boundaries of the said location to the north-western corner of location 284; thence southerly along the western boundary of the said location and onwards to the southern boundary of location 423; thence westerly along the said boundary to the eastern side of the said highway; thence generally southerly along the said side to a point in prolongation easterly of the southern boundary of location 288; thence westerly to and along the said boundary; thence northerly along its western boundary to the southern boundary of along its western boundary to the southern boundary of location 530; thence westerly along the said boundary and onwards to the western side of Salisbury street in Cookernup Townsite; thence southerly along the said side and onwards to the northern boundary of location 648; thence easterly, southerly, easterly, northerly and again easterly to and along the southern side of road No. 580 and onwards to the said eastern side of the No. 580 and onwards to the said eastern side of the South-Western highway aforesaid; thence generally southerly along the said side to the western side of the North Supply Channel of the Harvey Irrigation District, situate near the south-western corner of location 3125; thence generally southerly, following the said side of the said channel to its intersection with the said eastern side of the highway near the northern corner of Korijekup Estate Lot 68; thence again southerly along the said eastern side of the highway to the said western side of channel at a point near the south-western corner of lot 69; thence generally easterly, southerly, and south-westerly again following the western side of the channel to its intersection with the said side of the highway on a western boundary of lot 70; thence southerly again along the said side of highway to join again the said side of the channel near the south-western corner

of the said lot 70; thence generally south-easterly and south-westerly and again south-easterly and southwesterly again following the said side of the channel to join the said side of the highway on a western boundary of lot 61; thence southerly along the said side of the highway to its intersection with the said western side of the channel on a western boundary of lot 60; thence generally easterly following along the said side of chan-nel through lots 60, 59 and 58 to the easternmost boun-dary of location 50A aforesaid; thence southerly along the said boundary to the starting point as shown within the green border on Plan P.W.D., W.A. 30153, but ex-cluding the Benger Drainage District as described in the Government Gazette of August 23rd, 1918, and shown outlined in red on said plan.

Closure of the Hines Hill Cemetery (Reserve No. 11108). The Cemeteries Act, 1897, and its Amendments.

ORDER IN COUNCIL.

Corres. No. 8665/07. WHEREAS by the provisions of the Cemeteries Act, 1897, and its amendments, it is made lawful (in case it should appear to the Governor that burials in any cemetery under any law relating to public cemeteries or other burial grounds or place of burial whatsoever should be wholly discontinued) for the Governor, by order to be published in the Government Gazette, to direct that after a time mentioned in such order (not being less than three months from the date thereof) burials in such cemetery or burial place, ground, or place of burial shall be discontinued wholly, or subject to any exception or qualification; and whereas it has been made to appear to the said Governor that it is advisable that all burials should be discontinued in the Public Cemetery at Hines Hill, being reserve No. 11108, except in graves at present Hill, being reserve No. 11108, except in graves at present owned by private persons: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby direct that from and after the first day of March, 1945, burials within the limits of the said Public Cemetery (reserve No. 11108), at Hines Hill, shall be wholly discontinued except in cases where the special permission of the said Lieutenant-Governor be first obtained.

after being satisfied as required by the proviso to section 4 of the said Act, doth hereby authorise the local anthority as set forth in the Schedule hereto, to establish and maintain a reserve fund.
