AT a meeting of the Executive Council held in the Executive Council Chamber, at Perth, on the 21st day of December, 1944, the following Order in Council was authorised to be issued:—

Abattoirs Act, 1909-1941.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 11 of the Abattoirs Act, 1909-1941, that the Governor may by Order in Council inter alia extend to and confer upon any local authority the powers conferred on the Governor by the said Act; and whereas the said Act is by virtue of a Proclamation issued by the Governor under section 3 of the said Act, and published in the Government Gazette on the 15th day of December, 1944, in force in a part of the State which includes the municipal district of Bunbury; and it is deemed expedient that the powers conferred on the Governor shall be extended to and conferred upon the Municipal Council of Bunbury accordingly: Now, therefore, His Excellency the Lientenant-Governor acting with the advice and consent of the Executive Council and in exercise of the power in that behalf conferred by section 11 of the said Act doth hereby extend to and confer upon the Municipal Council of Bunbury all the powers conferred on the Governor by the Abattoirs Act, 1909-1941.
