The Shipping and Pilotage Ordinance, 1855.

PROCLAMATION

WESTERN AUSTRALIA, } By His Excellency Sir James Mitchell,
TO WIT. } K.C.M.G., Lieutenant-Governor in and
JAMES MITCHELL, } over the State of Western Australia
Lieutenant-Governor. and its Dependencies in the Common-
[L.S.] wealth of Australia.

WHEREAS it is provided by the Shipping and Pilotage Consolidation Ordinance, 1855, that the Governor may by Proclamation from time to time frame, alter, amend or repeal rules and regulations not repugnant to any of the provisions of the said Ordinance to be observed by all Masters and Commanders of all ships or vessels in any of the ports or harbours of Western Australia and by all persons duly appointed or licensed to act as harbour masters or pilots in such ports or harbours and may substitute others in their stead but so that all such rules and regulations shall be promulgated by Proclamation in the *Government Gazette* at least one month before the same shall take effect at the expiration of which time the same shall be in full force and effect; and whereas the Governor did by Proclamation dated the 14th day of November, 1917, and published in the *Government Gazette* on the 16th day of November, 1917, make regulations in accordance with the said Ordinance which came into force on the 20th day of December, 1917, and are still in operation as from time to time subsequently amended which said regulations are contained and set forth in the Schedule to the said Proclamation; and whereas by a Proclamation dated the 24th day of February, 1931, and published in the *Government Gazette* on the 27th day of February, 1931, the Governor amended the said regulations first hereinbefore mentioned by adding thereto after regulation 61 thereof further regulations numbered 61A to 61R, both inclusive, which came into operation on the 1st day of April, 1931, and are still in operation; and whereas it is deemed desirable to amend further the said regulations in the manner hereinafter mentioned: Now therefore I, the said Lieutenant-Governor acting with the advice and consent of the Executive Council and in exercise of the powers conferred on me by the said Ordinance do hereby amend the said regulations as contained in the Proclamation dated the 24th day of February, 1931, and published

in the *Government Gazette* on the 27th day of February, 1931, as aforesaid in the manner mentioned in the Schedule hereunder and I do by this Proclamation declare that the amendments in such regulations hereby made shall come into operation forthwith after the expiration of one month from the publication of this Proclamation in the *Government Gazette*.

Schedule.

The regulations under the said Ordinance as contained in the Proclamation dated the 24th day of February, 1931, and published in the *Government Gazette* on the 27th day of February, 1931, are amended as follows:—

1. Regulation 61C is amended by adding thereto a paragraph as follows:—

Where the wharf or jetty mentioned in this regulation is part of a Government railway and by reason thereof such wharf or jetty is under the control of the Commissioner of Railways, the agents or Master aforesaid when giving notice to the Harbour Master as hereinbefore provided shall also give the like notice to the Station Master employed under the said Commissioner of Railways who is directly in charge of such wharf or jetty.

2. Regulation 61F is amended as follows:—

(a) by adding to paragraph (d) at the end thereof the words "Where the wharf or jetty mentioned in this regulation is part of a Government railway and by reason thereof such wharf or jetty is under the control of the Commissioner of Railways the matters required by this regulation to be done to the satisfaction of the Harbour Master shall also be done to the satisfaction of the Station Master employed under the said Commissioner of Railways who is directly in charge of such wharf or jetty."

(b) by adding to paragraph (e) a proviso as follows:—Provided that where such loading or unloading takes place from or on to a wharf or jetty which is part of a Government railway and by reason thereof such wharf or jetty is under the control of the Commissioner of Railways, then in so far as the work of loading or unloading aforesaid may be likely

to involve the risk of damage to such wharf or jetty such work shall be carried out not only as directed by the Harbour Master but also as directed by the Station Master employed under the Commissioner of Railways who is directly in charge of such wharf or jetty.

(c) by adding to paragraph (g) a proviso as follows:—Provided that where such loading or unloading is proposed to be carried out from or on to a wharf or jetty which is part of a Government railway and by reason thereof such wharf or jetty is under the control of the Commissioner of Railways, in addition to the written permission of the Harbour Master as aforesaid there shall also be obtained the written permission of the Station Master employed under the Commissioner of Railways who is directly in charge of such wharf or jetty.

(d) by adding to paragraph (h) a proviso as follows:—Provided that when the oil vessel is berthed at a wharf or jetty which is part of a Government railway and by reason thereof is under the control of the Commissioner of Railways then in so far as the working at the general cargo as aforesaid may be likely to involve the risk of damage to such wharf or jetty, in addition to the written permission of the Harbour Master as aforesaid there shall also be obtained the written permission of the Station Master employed under the Commissioner of Railways who is directly in charge of such wharf or jetty.

3. Regulation 61I is amended as follows:—

(a) by deleting the figures "50" in line seven of the regulation and inserting in lieu thereof the figures "100."

(b) by adding thereto a proviso as follows:—Provided that when the oil vessel is berthed at a wharf or jetty which is part of a Government railway and by reason thereof is under the control of the Commissioner of Railways then in addition to the authority or approval of the Harbour Master as aforesaid there shall also be obtained the authority or approval of the Station Master employed under the Commissioner of Railways who is directly in charge of such wharf or jetty.

4. Regulation 61J is amended by adding to paragraph (2) thereof a proviso as follows:—Provided that when the wharf or jetty mentioned in this paragraph is part of a Government railway and by reason thereof such wharf or jetty is under the control of the Commissioner of Railways then in so far as any valves aforesaid are situate on the said wharf or jetty or other premises of such railway pumping operations shall not be commenced before the correct position of all such valves has been verified not only by the Harbour Master but also by the Station Master employed under the Commissioner of Railways who is directly in charge of such wharf or jetty or other premises aforesaid.

5. Regulation 61L is amended by deleting therefrom the words "in writing" in line 2 of the regulation and inserting in lieu thereof the words "or by the Harbour Master and a Station Master where by these regulations the permission of both of the said officers is required."

6. Regulation 61M is amended by adding to paragraph (1) thereof a proviso as follows:—Provided that when the said pipe line or a part thereof is situate on a wharf or jetty which is part of a Government railway and by reason thereof is under the control of the Commissioner of Railways or on any other premises of such railway, in addition to the verification by the Harbour Master of the satisfactory condition of such pipe line there shall also be obtained the like verification by the Station Master employed under the Commissioner of Railways who is directly in charge of such wharf or jetty or other railway premises aforesaid.

7. Regulation 61N is amended by adding at the end thereof a proviso as follows:—Provided that when the oil vessel mentioned in this regulation is berthed at a wharf or jetty which is part of a Government railway and by reason thereof is under the control of the Commissioner of Railways then in addition to the written authority of the Harbour Master provided for in paragraph (1) of this regulation and the permission in writing by the Harbour Master provided for in paragraph (3) of this regulation there shall be obtained the written authority or the permission in writing as the case may be of the Station Master employed

under the Commissioner of Railways who is directly in charge of such wharf or jetty who shall have the like powers to impose conditions as are by this regulation conferred on the Harbour Master.

8. Regulation 61O is amended by inserting in paragraph (1) thereof after the word "Master" in line 3 of the said paragraph the words "or by the Harbour Master and a Station Master where in accordance with these regulations the permission of both of the said officers is required."

9. New regulations are added to the said regulations after regulation 61R as follows:—

61S. (1) The loading or unloading of inflammable liquid into or from an oil vessel while berthed at a wharf or jetty shall not be commenced until a barricade efficient to prevent access to the vessel and pipe line hose connections by any unauthorised person has been erected on such wharf or jetty and until satisfactory provision has been made for watchmen to be in attendance to prevent the entrance of any unauthorised person and to take possession of matches from all persons passing through the barricade towards the oil vessel and to assist generally in the enforcement of these regulations.

(2) (a) Where the wharf or jetty mentioned in paragraph (1) hereof is part of a Government railway and by reason thereof is under the control of the Commissioner of Railways the erection and maintenance of the barricade aforesaid and the employment or engagement of the watchman aforesaid shall be carried out and arranged in accordance with the directions and subject to the satisfaction of the Station Master employed under the Commissioner of Railways who is directly in charge of such wharf or jetty.

(b) In the case of any wharf or jetty mentioned in paragraph (1) which is not part of a Government railway the erection and maintenance of the barricade aforesaid and the employment or engagement of the watchman aforesaid shall be carried out and arranged by or in accordance with the directions and subject to the satisfaction of the Harbour Master.

(3) Any barricade erected on a wharf or jetty in compliance with this regulation may be so erected as to enclose any area of the wharf or jetty extending to a distance not exceeding 100 feet past each end of the oil vessel and to the greatest distance from the side of the vessel not exceeding 100 feet which the width of the wharf or jetty may permit.

61T. Where in any of these regulations provision is made requiring in certain circumstances that the permission or authority both of the Harbour Master and of a Station Master employed under the Commissioner of Railways shall be obtained before the commencement or doing of any act, matter or thing or that the doing of any act, matter or thing shall be done subject to the direction or to the satisfaction both of the Harbour Master and a Station Master aforesaid, the Harbour Master and the Station Master concerned shall act in co-operation after consultation and so as to avoid any conflict between their respective decisions. In the event of the Harbour Master and the Station Master being unable to agree in relation to any matter in which they are both concerned under these regulations and such matter is likely to involve the risk of damage to a wharf or jetty of which the Station Master is directly in charge, the decision of the Station Master shall prevail and the Harbour Master shall make his decision in conformity therewith accordingly.

61U. Where the Commissioner of Railways acting pursuant to section 23 of the Government Railways Act, 1904-1939, has made by-laws regulating the admission of any vessels to any wharf jetty berth or mooring connected with and forming part of a railway and their usage of and removal from the same and while such by-laws remain in force, these regulations shall be read and applied as far as practicable in conjunction with the by-laws of the Commissioner of Railways aforesaid and where in relation to any wharf or jetty aforesaid to which the said by-laws apply any inconsistency or repugnancy exists between these regulations and such by-laws, the by-laws shall to the extent of such inconsistency or repugnancy prevail over and supersede these regulations.

61V. The foregoing regulations relating to oil vessels shall apply and have effect subject to any regula-

tions made under the National Security Act, 1939-1940, of the Commonwealth whilst such regulations remain in force.

UNIVERSITY OF WESTERN AUSTRALIA.

Election by Convocation of Six Members of the Senate.

IN pursuance of the University of Western Australia Act Amendment Act, 1944, and in conformity with the present statutes with necessary modifications, an election will be held on Tuesday, 6th March, 1945, for the election by Convocation of six members of the Senate. The election is to give effect to section 4 of the new Act which deals with the constitution of the Senate and sets down that six persons (other than persons holding any salaried office in the University as a dean of faculty, professor, lecturer or assistant lecturer but not part-time lecturer) be elected by Convocation.

The period of office for which each member is elected will vary from one to six years, depending on the number of votes polled at the election. One member will retire in each year, but will be eligible for re-election.

Under the provisions of the new Act, and an Order in Council, providing for the change over from the old to the new Senate, the term of office of the present members of the Senate will expire on 14th March when the new Senate will come into operation.

Nominations signed by two qualified voters and bearing the written consent of the nominee must be in the hands of the Warden of Convocation, University of W.A., Nedlands, not later than 5 p.m., 13th February. Nomination forms are obtainable from the University Office.

This notification supersedes any previous notice of an election by Convocation on 6th March of two members of the Senate.

INDUSTRIAL AGREEMENT.

No. 10 of 1944.

(Registered 19/12/44.)

THIS Agreement made in pursuance of the Industrial Arbitration Act, 1912-1941, of Western Australia this third day of November, 1944, between the Commissioners of the Fremantle Harbour Trust of the one part, and the Merchant Service Guild of Australia, Western Australian Section, Union of Workers, Fremantle, of the other part witnesseth as follows:—

1.—Area and Scope.

This Agreement shall apply to the berthing master's assistant in the employ of the Fremantle Harbour Trust, and shall operate over that area within the boundaries of the Port of Fremantle vested in the Commissioners of the Fremantle Harbour Trust.

2.—Definitions.

“Employers” means the Fremantle Harbour Trust and includes the Commissioners constituted under the Act and in office for the time being. “Employee” means any person employed under the provisions of this agreement.

3.—Hours of Duty.

(a) The ordinary hours of duty shall be such hours as the employers require between the hours of 6 a.m. and 6 p.m. on each and every day of each week, provided that a break of one hour shall be granted between 7 a.m. and 10.30 a.m. for breakfast, 12 noon and 2 p.m. for dinner, 5 p.m. and 7 p.m. for tea.

(b) Except when on annual, long service or sick leave, the employee shall be rostered off duty for one complete day of 24 hours in each week, and one complete week end, from 6 a.m. Saturday to 6 a.m. Monday, in every three weeks.

4.—Overtime and Special Rates.

(a) Overtime shall mean and include all time worked before 6 a.m. or after 6 p.m. on any working day, and shall be paid for at the rate of time and half.

(b) Where through unforeseen or special circumstances the employee cannot be granted the days off provided for in clause 3 (b) hereof, or is recalled to

duty on a rostered day off, he shall be paid at the rate of time and half for the actual period of such extra duty, with a minimum as for two hours, in addition to the week's earnings.

(c) In all cases where the employee is ordered to stand by at home for a period of two hours or more, at any time after 6 p.m. or before 6 a.m. and is not required for duty during such period, he shall be paid 5s. for each night so required to stand by.

(d) In the event of the requirements of the work being such that a break of one hour for the taking of meals cannot be granted during the appropriate periods specified in clause 3 (a) hereof, the employee shall be paid a special allowance of 5s. in respect of breakfast and dinner, 2s. in respect of tea; provided that this allowance shall not be payable when work begins, or is resumed at or during a meal period.

6.—Annual Leave.

At the completion of twelve months' continuous service, the employee shall be granted leave of absence on full pay for a period of thirty days. Such leave shall at all times be taken at the convenience of the employers.

7.—Long Service Leave.

After each seven years' continuous service the employee shall be granted three months' long service leave on full pay, but periods of absence on long service leave shall not count as service qualifying towards the next grant of such leave.

8.—Contract of Service.

The employee shall be deemed to be engaged on a monthly basis, and one month's notice shall be given on either side to terminate such engagement: Provided that the employee may be instantly suspended or dismissed, without notice, for insobriety, misconduct, or neglect of duty.

9.—Uniforms.

The employers shall provide the employee with uniforms free of cost after each eight months' continuous service, an oilskin coat and sou'wester each year, and a greatcoat every four years. Uniforms shall belong to the employers and shall be worn by the employee when on duty. Should the service of any employee terminate within one month from the date of issue of uniforms or any portion of them, all the issue last made to the employee shall be returned to the employers before the employee shall be entitled to be paid any moneys which may be due to him.

10.—Sick Leave.

(a) When the employee is incapacitated through sickness or injury other than that arising out of or in the course of his employment, he may be granted sick leave with pay for a period of or periods not exceeding in the aggregate one month in any year, upon production within 48 hours of the commencement of any such period of absence of a medical certificate as to his incapacity.

(b) Where such incapacity arises through the wilful act or misconduct of the employee, or where a medical certificate is not furnished as required, or where the employee has already had sick leave with pay for a period of or periods aggregating one month during the preceding twelve months, the employee shall not be entitled to any pay for the period he is absent from duty.

(c) Upon the period of absence in any instance exceeding one month, or in the case of paragraph (b) hereof, immediately the employee absents himself the contract of service shall be deemed to have been terminated without requiring further notice by the employers, who shall thereby be relieved of any further obligation to the employee: Provided that any such period of incapacity may, at the discretion of the employers, be regarded as leave without pay.

11.—Sickness or Accident arising out of Duty.

(a) An employee who, while on duty or acting under the instructions of the employer, receives an injury arising out of, or in the course of his employment, or contracts an illness due to the nature of and attributable to such employment and is thereby incapacitated from duty in circumstances which entitle him to the benefits prescribed under the Workers' Compensation Act, 1912-1941, shall be entitled to receive in addition to such benefits, a weekly sum equal to the difference between the compensation provided for under that Act and the wages prescribed in this Award, from the date of the commencement of his said incapacity up to and including the date of his recovery as certified by his medical attendant: Provided that the employers' liability hereunder shall in no case exceed three calendar months in respect of each separate injury or illness.

(b) All amounts payable under this clause shall be paid in the manner provided for the payment of wages.

12.—Use of Bicycles, etc.

An employee required by the employers to use his own bicycle or other vehicle during the course of his duties shall receive a special allowance of 2s. 6d. per week as compensation for wear and tear. Such allowance, which shall be payable monthly, will not accrue while the employee is absent from duty for any cause whatsoever for a period of a complete week or longer.

13.—Term.

This Agreement, which shall come into force from the date of signature hereto, and shall continue for a period of twelve months therefrom, replaces Industrial Agreement No. 3 of 1943, made between the herein named parties on the 1st January, 1943.

INDUSTRIAL AGREEMENT.

(No. 11 of 1944.)

(Registered 22/12/44.)

THIS Agreement made in pursuance of the Industrial Arbitration Act, 1912-41, this 21st day of December, 1944, between the Metropolitan and South Western Federated Engine Drivers and Firemen's Union of Workers of Western Australia of the one part, and the State (W.A.) Alumite Industries of the other part, whereby it is mutually agreed as follows:—

1.—Term.

The term shall be for a period of one year from the date hereof.

2.—Scope.

The Agreement shall cover all workers employed by the State (W.A.) Alumite Industries of categories coming under the above Union in the State of Western Australia.

3.—Rates of Wages.

(a) Basic Wage:	Per week.

(b) District Allowance.—A district allowance of 5s. per week shall be payable to all employees. This allowance covers a week, whether of six or seven days. For a period of less than six days, one seventh of the above shall be payable for each day or part thereof.

(c) Margin for Skill.—(i) Engine driver who shall also supervise all auxiliary equipment in and around power house, such as pumps, feed water heaters, dynamos, motors, switchboards, etc., 25s. 0d. margin per week.

If two or more firemen are employed on one shift, this margin would only be payable to one fireman per shift.

Note.—This does not include driver of tractor drawn excavator or driver of "Tournapull."

4.—Hours of Work.

(a) Day Workers.—A week's work for a day worker shall consist of 44 hours worked in five days of 8 hours and one day of 4 hours, exclusive of crib time; or in such other manner as shall be mutually agreed on between the Management and the Union. Overtime shall be paid for at the rate of time and a half for the first 4 hours, and double time thereafter. Work carried out on Sundays, Good Fridays, Labour Day, Christmas Day and Easter Monday shall be double time, except in connection with repairs to the employer's machinery which has broken down and caused a stoppage of operations, when the rate of time and a half shall apply. If a man is called upon to work without a break of 8 hours from the end of the preceding shift he shall be paid at the rate of time and a half until he is allowed a break of at least 8 hours.

(b) Continuous Process and other Continuous Shift Workers:—

(1) 44 hours shall constitute a week's work, inclusive of crib time: Provided, however, that this provision shall be deemed to have been complied with if the ordinary working hours do not exceed 88 hours per fortnight, to be worked in alternate weeks of 40 and 48 hours respectively, each of such weeks to be worked in shifts of 8 hours each, including crib time.

(2) All time worked in excess of or outside the usual working hours shall be paid for at the rate of time and a half for the first 4 hours and double time thereafter. Work done on Sundays shall be paid for at the rate of time and a half for a shift of 8 hours and double time for any time over 8 hours. Time worked on Sundays shall not be included in the weekly hours for the purpose of calculating overtime.

(3) Overtime rates shall not apply to excess time due to private arrangements between the workers themselves, or for one hour where the overtime is caused owing to a relieving man not coming on at the appointed time, or where overtime is necessary for effecting periodical rotation of shifts.

(4) If a man is called upon to work without a break of eight hours from the end of his preceding shift, he shall be paid at the rate of time and a half until he is allowed a break of at least eight hours.

(b) (5) When shift workers are required to work more than 13 shifts consecutively on afternoon and night shift, they shall be paid 2s. 6d. per shift extra.

(c) Shift Workers other than Continuous Process Workers.—

Men working on shifts other than men working continuous shifts shall work eight hours (8) inclusive of twenty (20) minutes crib time and receive a margin of one shilling (1/) per shift. This allowance shall not apply to workers employed solely on day shift.

5.—Holidays.

The following shall be holidays without pay:—Good Friday, Easter Monday, Labour Day and Christmas Day. If Christmas Day falls on a Sunday the following Monday shall be kept.

6.—Annual Holidays.

Annual holidays shall be taken at the convenience of the Management, workers to receive one month's notice of the date on which holidays are to commence. Workers are to receive payment for one day of 8 hours for every completed month's service and pro rata for periods down to one week.

7.—Mixed Functions.

If a worker be employed on work classified at a higher minimum than his ordinary work for more than 2 hours in any shift, he should be paid the minimum rate for such work for the whole of that shift. If he is employed for less than 2 hours, he should be paid at his ordinary rate for the whole shift.

8.—Accident Pay.

In the event of a worker meeting with an accident during the shift, or being required to attend to one who has met with an accident, he shall be deemed to have rendered duty during the whole of the shift and be paid accordingly.

9.—Full Payment for Shift.

(a) After beginning a shift, workers shall not be paid less than for a full shift, unless they leave of their own accord, or are dismissed for misconduct. This shall not apply in matters beyond the control of the management.

(b) If before a worker leaves the works at the end of his shift, and because he is not so informed, he attends at the next shift willing to work it, and there is no suitable work which he is allowed to perform, he shall be paid the wages he would have been entitled to if he had worked the shift he was ready and willing to work. This shall not apply in matters beyond the control of the Management.

10.—Relieving Engine Drivers.

Relieving engine drivers who are not employed full time at relieving shall be found other suitable work to make up full time, for which they shall be paid at the rates of the highest classification worked during the shift.

11.—Dirty Work.

Workers engaged in cleaning the inside of producers, scrubbers, or engine crank cases shall be paid 6d. per hour extra while employed on such work.

12.—Boiler Cleaners.

Any person engaged inside the gas or water space of a boiler shall be paid at the rate of 9d. per hour in addition to his ordinary rates.

13.—Casual Workers.

Workers employed for less than one week shall be considered casual and shall receive one shilling (1s.) per shift above the rates specified for the work.

14.—Union Official.

A duly accredited official of the Union shall be allowed to collect union fees at the offices of the Works on pay days, and shall be allowed to inspect time sheets and pay sheets relating to any worker affected by this Award, and make extracts therefrom.

15.—Board of Reference.

(a) A Board of Reference is to be appointed for the purpose of this agreement. This Board shall consist of a Chairman, who shall be a person selected by the representative of the parties, and two other representatives, one to be the Manager or his nominee representing

the employer, and the other a representative of the Union, appointed for such purpose by the Union, which may at any time by notification to the employer and the Registrar change such representative.

(b) There shall be assigned to such Board the functions of:—(i) deciding matters specifically referred to in the agreement as being the subject matter of a decision of the Board; (ii) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of the agreement, or any of them; (iii) deciding all matters and questions referred to in the agreement as being the subject of mutual agreement, if not agreed upon; (iv) deciding any other matter that the Court may refer to such Board from time to time.

(c) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the Regulations to the Industrial Arbitration Act, 1912-1941, which for this purpose are embodied in and form part of this agreement (Regulation 92).

(d) There shall be no cessation of work, pending the reference to and the settlement of any dispute by the Board.

16.—Absence through Sickness.

(a) (i) A worker shall be entitled to payment for non-attendance, on the ground of personal ill health, for one half ($\frac{1}{2}$) day for each completed month of service (ii) The liability of the employer hereunder shall in no case exceed one (1) week's wages during each calendar year in respect of each worker. (iii) Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(b) This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

(c) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer, or his representative, of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) consecutive working days or more.

(d) No payment will be made for any absence due to the worker's own fault, neglect, or misconduct.

AT a meeting of the Executive Council held in the Executive Council Chamber at Perth on the 1st day of February, 1945, the following Order in Council was authorised to be issued:—

University of Western Australia Act, 1911-1944.

ORDER IN COUNCIL.

WHEREAS section 10 of the University of Western Australia Act, 1911-1944 (No. 37 of 1911 as amended by No. 43 of 1944), enacts that the Senate of the University of Western Australia (as newly constituted under the said section 10 as inserted in the said Act by subsection (1) of section 4 of the University of Western Australia Act Amendment Act, 1944) shall consist inter alia of—

(a) Six persons (other than persons holding any salaried office in the University as a dean of faculty, professor, lecturer or assistant lecturer but not part time lecturer) to be elected by Convocation;

(b) Two persons (being persons holding a salaried office in the University as a professor, an associate professor, lecturer or assistant lecturer but not as Vice-Chancellor or part-time lecturer) to be elected by the persons holding the various salaried offices aforesaid; and

(c) Four persons to be selected and co-opted as members of the Senate by the other members of the Senate as newly constituted as aforesaid;

And whereas it is enacted by subsection (2) of section 4 of the said University of Western Australia Act Amendment Act, 1944, that the said new section 10 as now contained in the University of Western Australia Act, 1911-1944, shall come into operation and take effect upon a day to be fixed by Proclamation but that at any time after the commencement of subsection (1) of section 4 of the University of Western Australia Act Amendment Act, 1944, the Governor may inter alia by Order in Council direct and authorise the holding of any elections of members of the Senate which would be authorised under the provisions of the University of Western Australia Act, 1911-1944, if subsection (1) of section 4 of the University of Western Australia Act Amendment Act, 1944, were in operation; and whereas the University of Western Australia Act Amendment Act, 1944, was assented to on the 12th day of January, 1945, but subsection (1) of section 4 thereof has not yet been proclaimed to come into operation; and whereas it is intended that the Governor shall by Proclamation fix the 14th day of March, 1945, as the day upon which the said subsection (1) shall come into operation and take effect; And whereas it is deemed desirable and expedient that the elective members of the Senate shall be elected and the co-optive members of the Senate shall be selected before the said 14th day of March, 1945, so that on such day the Senate as newly constituted by section 10 of the University of Western Australia Act, 1911-1944, shall be then in existence and able and ready to function as the Senate aforesaid: Now therefore His Excellency the Lieutenant-Governor acting with the advice and consent of the Executive Council and in exercise of the power conferred by the proviso to subsection (2) of section 4 of the University of Western Australia Act Amendment Act, 1944, and of all other powers in this behalf enabling him doth hereby order, direct and authorise as follows:—

1. The Chancellor of the University shall cause to be taken such measures as may be necessary for the holding of elections for the election—

(a) of the first six persons to be elected by Convocation as members of the Senate of the University

as newly constituted under section 10 of the University of Western Australia Act, 1911-1944; and

(b) of the first two persons (being persons holding a salaried office in the University as hereinbefore mentioned) to be elected by the persons holding the various salaried offices aforesaid as members of the Senate as newly constituted as aforesaid.

2. The said elections shall be held and completed on the 6th day of March, 1945, and in relation thereto, the following provisions shall apply and be observed that is to say:—

(a) Subject to the exceptions and modifications hereinafter mentioned, the provisions of University Statute No. 12 as at present in force and operation, which prescribes the method of election by Convocation of persons to be members of the Senate, shall, as far as the same can be applied, apply and be observed both in relation to the election of the six persons to be elected by Convocation, and to the election of the two persons holding salaried office in the University to be elected by the persons holding salaried offices in the University under the authority of this Order in Council.

(b) The exceptions and modifications mentioned in subparagraph (a) of this paragraph are as follows:—

(i) Notice of the holding of the said elections shall be given at least thirty days before the said 6th day of March, 1945, and section 3 of the University Statute No. 12 shall be read and construed and operate as if the word "thirty" were contained therein in lieu of the word "sixty."

(ii) In respect of the election of the six persons to be elected by Convocation the notice of such election shall be advertised and posted in the manner prescribed by section 3 of the University Statute No. 12 aforesaid.

(iii) In respect of the election of the two persons to be elected by persons holding salaried offices in the University the notice of such election need not be advertised in the *Government Gazette* or in any daily newspaper but shall be posted at the University in such manner and in such place as will enable all the persons who are entitled to vote at the election to become aware that the said election is to be held.

(iv) The Chancellor shall cause to be prepared in writing a list of the names of the persons holding salaried offices in the University who are entitled to vote in the election of the two persons to be elected by the holders of such salaried offices, and shall himself certify in writing as to the correctness of such list, which thereupon shall be used and be conclusive as the roll of such electors in relation to the said election.

(v) Nominations of candidates in the said elections respectively may be lodged with the Warden of Convocation at any time not later than 12 o'clock noon on the 13th day of February, 1945, but in other respects the provisions of section 4 of the University Statute No. 12 shall apply.

(vi) The names of the persons nominated as candidates for the said elections respectively shall be advertised in accordance with the provisions of section 6 of University Statute No. 12 on the 14th day of February, 1945, save and except that the names of candidates nominated for the election of the two persons to be elected by persons holding salaried offices in the University need not be advertised in the *Government Gazette* or in a daily newspaper but shall be posted at the University.

(vii) In the event of the number of candidates nominated for the said election respectively being in excess of the number of persons to be elected at such election respectively, ballot papers shall be posted or delivered to persons who are entitled to vote at the respective elections in accordance with the provisions of section 8 of University Statute No. 12 not later than the 20th day of February, 1945.

3. For the purpose of enabling the first four co-optive members of the Senate as newly constituted under section 10 of the University of Western Australia Act, 1911-1944, to be selected and co-opted by the other members of such Senate before the said 14th day of March, 1945, the Chancellor shall cause the following things to be done, that is to say—

(a) A meeting of the Senate as newly constituted by the new members appointed by the Governor,

held on the 6th day of March, 1945, under the authority of this order, and the ex officio members as the elective members elected at the election to be designated by section 10 aforesaid to be convened for and held under the chairmanship of the Chancellor on the 12th day of March, 1945.

(b) Notice of the convening of such meeting to be given in writing to each of the said members not later than the 9th day of March, 1945.

(c) The said members to be invited to nominate persons for selection and co-option of first four persons to be selected and co-opted as members of the Senate newly constituted as aforesaid.

(d) Direct that nominations shall be in writing, be signed by a proposer and seconder (who shall be members of the Senate as newly constituted), and by the person nominated, and shall be deposited with the Vice-Chancellor at any time before the expiration of five minutes after the commencement of the said meeting.

4. (a) The selection and co-option of the first four persons to be selected and co-opted as members of the Senate newly constituted as aforesaid shall take place at the meeting of the said Senate to be held on the 12th day of March, 1945, as aforesaid.

(b) The Vice-Chancellor shall examine the nominations duly received, and make a list of the names of the persons who have been duly nominated, and submit the same at the meeting. If the number of persons who have been duly nominated do not exceed four, and such persons are all eligible for selection and co-option the Chancellor shall declare such persons duly selected and co-opted. If the number of persons nominated and eligible as aforesaid exceed four, then a ballot of the members present at the said meeting of the new Senate shall be taken at such meeting to select the persons to be selected and co-opted.

(c) Voting on the ballot to be taken at the meeting shall be preferential and in accordance with the provisions of University Statute No. 12.

(d) Subject to the requirements of paragraph (g) of section 10 of the University of Western Australia Act, 1911-1944, the persons nominated shall be elected, selected and co-opted according to the order in which they are placed when the votes have been counted.

(e) The Vice-Chancellor shall cause the names of the persons selected and co-opted as the result of the said ballot to be advertised in the *Government Gazette*, and once at least in a daily newspaper published in Perth and once in the *Government Gazette*, and to be posted at the University.
