WHEREAS by regulation 4 of the National Security (General) Regulations it is provided (amongst other things) that if it appears to the Minister to be necessary and expedient in the interests of the defence of the Commonwealth or the efficient prosecution of the war, or for maintaining supplies and services essential to the life of the community that special precautions should be taken for the security of any place, prosecution of the war, of for maintaining supplies and services essential to the fife of the community that special precautions should be taken for the security of any place, he may by order declare that place to be a prohibited place either generally or during such hours or during the existence of such circumstances as are specified in the Order for the purposes of the regulations; and whereas by Instrument of Delegation dated the fourth day of December, 1944, made in pursuance of section 17 of the National Security Act, 1939-1940, the Acting Minister of the State for the Army, acting for and on behalf of the Minister of State for Defence, delegated to every officer who should at any time during the continuance of the delegation be holding the office or performing the duties of the office of Commander Western Command the powers and functions conferred upon the said Minister by regulation 4 of the National Security (General) Regulations in relation to the State of Western Australia exclusive of that area situate northward of the straight line joining Yampi Sound and the intersection of twenty de-grees south latitude with the western boundary of the Northern Territory; and whereas I, Horace Clement Hugh Robertson, Major-General, the officer for the time being holding the office of Commander Western Command did on the twentieth day of February, 1945, acting in pursuance of the said Instrument of Delegation and of the said regulation and of all other powers me thereunto enabling, make an order relating to the place described in the schedule thereto; and whereas it appears to me the said Horace Clement Hugh Robertson necessary and expedient in the interests of the defence of the Common-wealth and the efficient prosecution of the war and for maintaining supplies and services wealth and the efficient prosecution of the war and for maintaining supplies and services weath and the efficient prosecution of the war and for maintaining supplies and services essential to the life of the community that the said order should be revoked and that special precautions should be taken for the security of the place referred to in the schedule hereto, being a place situate within that portion of the State of Western Australia as above limited: Now therefore I, the said Horace Clement Hugh Robertson, acting in pursuance of the said Instrument of Delegation and of the said regulation and of all other powers me hereunto enabling do hereby revoke the said order made by me on the twentieth day of February 1945 and do hereby order on the twentieth day of February, 1945, and do hereby order:

(b) That the officer for the time being holding the office or performing the duties of the office of General Staff Officer (Intelligence) Grade II Western Command is authorised to issue permits to enter, approach, inspect, pass over, or be in the neighbourhood of the said prohibited place.

FARMERS' DEBTS ADJUSTMENT ACT, 1930-1934.

NOTICE is hereby given that the following Stay Order has been issued in accordance with section 7, subsection 1 of the Farmers' Debts Adjustment Act, 1930-1934, which reads as follows:

A Stay Order shall direct that no action, execution, distress for rent, proceedings on default for breach of covenant under any mortgage or other security for money, or under an agreement for sale and purchase of lands, or other process of proceedings, shall be commenced or proceeded with or put in force against the farmer, or any of the farmer's assets whether utilised in connection with or forming portion of the assets comprised in his farming business or not during


(2) No person over the age of seven years shall enter or remain on any kindergarten playground: Provided that mothers and female attendants in charge of children under the age of seven years shall be allowed to accompany such children into any such playground and to remain thereon with them.

It shall be lawful for any officer or servant of the Council, or any constable, to remove from any children's playground or from any kindergarten playground any person who is not entitled under this by-law to the use thereof.
