AT a meeting of the Executive Council held in the Executive Council Chamber at Perth this 14th day of March, 1945, the following Orders in Council were authorised to be issued.

The Health Act, 1911-1942, as amended by the Health Act Amendment Act, 1944.

ORDER IN COUNCIL.

WHEREAS the Health Act, 1911-1942, as amended by the Health Act Amendment Act, 1944, enacts that the provisions of Division 3 of Part V. of the Principal Act shall operate and have effect in certain specified districts, and also in the Health District of any other Local Authority which the Governor may from time to time declare: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby declare that the said provisions of Division 3 of Part V. of the said Act shall operate and have effect in the Health District of the Midland Junction Local Health Authority, a Local Authority within the meaning of the said Act.

Constitution of the Upper Blackwood Health District under the provisions of the Health Act, 1911-44.

ORDER IN COUNCIL.

WHEREAS it is enacted, by section 19 of the Health Act, 1911-44, that the Lieutenant-Governor may constitute any portion of the State, not being a Municipal District, to be a Health District, with such boundaries and by such name as may be specified in the

Order; and whereas, by Order in Council dated the 2nd of May, 1934, and published in the *Government Gazette* of the 4th May, 1934, all that land contained within the townsite of Boyup Brook was declared to be the Upper Blackwood Health District; and whereas it is desired to extend the boundaries of the Upper Blackwood Health District, now, therefore, His Excellency the Lieutenant-Governor of Western Australia, by and with the advice and consent of the Executive Council, does hereby cancel the Proclamation dated the 2nd May, 1934, published in the *Government Gazette* of the 4th May, 1934, and does hereby declare that all that land embraced within the boundaries of the Upper Blackwood Road Board shall be a Health District to be known as the Upper Blackwood Health District under the provisions of the Health Act, 1911-44.

THE HEALTH ACT, 1911-44.

Balingup Road Board—Resolution.

WHEREAS it is enacted by section 320 of the Health Act, 1911-44, that every Local Authority may from time to time make by-laws as in the said Act and may amend or repeal or alter by-laws so made, and by section 321 of the said Act that the Governor may cause Model By-laws to be prepared and published in the *Government Gazette* and that any Local Authority may adopt such by-laws with or without modification as the by-laws of the Local Authority; and whereas Model By-laws were prepared and gazetted on the 9th day of April, 1927, and same were adopted by the Balingup Road Board; and whereas the Balingup Road Board being a Local Health Authority for the Balingup Health District desire to amend its by-laws in the manner hereinafter mentioned: Now, therefore, the Balingup Road Board doth hereby adopt a new by-law to be inserted in Part I, after by-law 6, to stand as by-law 6A as follows:—

6A. The occupier of any premises shall not deposit and shall not cause or permit or suffer any other person to deposit in any sanitary pan used in any privy appurtenant to such premises any tins, bottles, boxes, kitchen refuse or other rubbish of a like or similar character.

NURSES REGISTRATION ACT AMENDMENT
ACT, 1944.

Nomination of a Registered General Trained Nurse, a Registered Mental Nurse, and a Registered Midwifery Nurse to be members of the Nurses Registration Board for a term of three years.

NOMINATIONS of persons to be their representatives on the Board are hereby called from registered general trained nurses, registered mental nurses, and registered midwifery nurses, and must be in the hands of the Commissioner of Public Health, Department of

Public Health, Perth, at midday, Thursday, the 29th March, 1945. Every nomination shall be in writing, shall contain the name in full and address of the person nominated, shall be signed by at least two registered nurses of the appropriate category, and be accompanied by the written consent of the person nominated to serve on the Board.

HOSPITALS ACT, 1927.

Wiluna District Hospital—Amendment of By-laws for the Control of the Medical Fund.

AT a meeting of the Board of Management of the Wiluna District Hospital held on the 13th day of August, 1944, the following resolution was passed:—

Whereas under the provisions of section 23 of the Hospitals Act, 1927, a Board may itself establish and manage a Medical Fund the object of which shall be to secure for its subscribers medical attendance, hospital treatment, or other similar benefits and may by by-laws provide for the regulation and control of such Fund; and whereas the Board of Management of the Wiluna District Hospital has established a Medical Fund and has made by-laws for the control and management thereof as published in the *Government Gazette* on the 1st day of May, 1942; and whereas the said Board of Management now deems it expedient to amend the said by-laws in the manner mentioned in the Schedule hereunder: Now, therefore, the said Board of Management of the Wiluna District Hospital, acting pursuant to section 23 of the Hospitals Act, 1927, doth hereby amend the by-laws for the control and management of its said Medical Fund hereinbefore mentioned in the manner set forth in the Schedule hereunder.

Schedule.

1. By-law 2 is deleted, and a new by-law is inserted in lieu thereof as follows:—

2. Any person who subscribes 2s. 6d. per week or the sum of 32s. 6d. per quarter, or any male person under the age of 16 years or single woman or widow who subscribes the sum of 1s. 6d. per week or 19s. 6d. per quarter shall be termed a subscriber. Males under the age of 16 years earning more than 30s. per week but less than £3 per week shall subscribe 1s. 6d. per week, and males under the age of 16 years earning £3 or more per week shall subscribe 2s. 6d. per week. Females under the age of 16 years earning more than 30s. per week shall subscribe 1s. 6d. per week.

2. By-law 2a is deleted and a new by-law is inserted in lieu thereof as follows:—

2a. The wife of any member of the Navy, Army or Air Force serving at home or abroad who subscribes the sum of 1s. 6d. per week shall be termed a "subscriber."

3. By-law 7 is amended as follows:—

(a) by inserting in paragraph (k) immediately below the words "Accouchements or Miscarriages" the following words:—Subscribers or their dependants who are admitted to hospital for accouchement or miscarriage will be charged 7s. per day for the first 14 days treatment. Further treatment after the first 14 days will be charged as follows:—

(i) Seven days after the first 14 days, free.

(ii) Any period after 21 days the fees to be charged shall be such fees as the Board may decide.

(b) by adding at the end of the by-law after paragraph (k), a further paragraph as follows:—

(1) Private ward accommodation. Subscribers or their dependants desiring private ward accommodation shall be granted same if available and shall be charged the difference between the charge for public ward accommodation and that for such private ward accommodation chargeable to a non-subscriber at the time prevailing.

4. A new by-law is added after by-law 11 as follows:—

12. At any general meeting of subscribers 5 per cent. of the subscribers who are registered in the register of subscribers shall form a quorum.

(d) No employee shall work more than five (5) hours without a suitable interval for a meal.

4.—Overtime.

(a) All time worked in excess of or outside the usual working hours shall be paid at the rate of time and a-half for the first four hours and double time thereafter.

(b) A worker called back after completing a day's work or called out on a Sunday or holiday, shall be paid a minimum of two (2) hours at overtime rates, but if he is called out for more than once within any period of two (2) hours of a call, he shall not be entitled to any further payment for time worked within the period of two (2) hours from the time when he commenced work in response to his first call.

(c) When a worker is required for duty during any meal time whereby his meal time is postponed for more than (1) one hour he shall be paid at overtime rates until he gets his meal.

(d) When a worker is required to continue working after knock-off time for more than one hour without being notified the previous day, he shall be supplied with any meal required, or be paid one shilling and sixpence (1s. 6d.) for such meal.

(e) For all work done on Sunday, New Year's Day, Anniversary Day, Good Friday, Easter Saturday, Easter Monday, Labour Day, Anzac Day, Christmas Day, Boxing Day, and Foundation Day, double time shall be paid with a minimum of two hours.

5.—Casual Workers.

A casual worker shall be paid at 10 per cent. over the rate prescribed for the particular worker's occupation. The contract of service shall be terminated by one (1) hour's notice.

"Casual worker" shall mean a worker employed for less than six (6) consecutive working days.

6.—Holidays.

(a) The following days or the days observed in lieu shall be observed as holidays and paid for, namely:—New Year's Day, Anniversary Day, Good Friday, Easter Saturday, Easter Monday, Labour Day, Anzac Day, Foundation Day, Christmas Day, and Boxing Day.

(b) A holiday of one week on full pay shall be granted to each worker upon completion of each year of service. A worker, other than a casual, not completing one year of service, shall be granted pay in lieu of holidays in proportion to the length of his or her service.

(c) All workers other than casuals who have not served the full calendar year shall be entitled to the same proportion of holidays leave or payment in lieu thereof as their length of service is to the full period of leave for the twelve (12) months.

(d) A worker dismissed for misconduct or who illegally severs his contract of service shall lose all rights under subclauses (a) and (b) above.

(e) At least one (1) week's notice shall be given to a worker prior to his going on his annual leave as mentioned in subclause (b) hereof; provided, however, that when the employer or his representative and the worker so agree a shorter notice will be sufficient.

(f) Holiday pay shall be at the rate the worker is in receipt of at or immediately prior to the holiday being taken.

7.—Higher Duties.

(a) A worker engaged for more than one half ($\frac{1}{2}$) of one (1) day or shift on duties carrying a higher rate than his ordinary classification shall be paid the higher rate for such day or shift. If employed for one half ($\frac{1}{2}$) or less than half ($\frac{1}{2}$) of one (1) day or shift, he shall be paid the higher rate for the time actually worked: Provided, however, that the acting time of less than twenty (20) minutes in any one day or shift shall not be counted.

(b) Should any worker be required to perform work in a lower grade, his wage shall not be reduced whilst employed in such capacity.

8.—Contract of Service.

(a) All workers, except casual workers, shall be employed on a weekly engagement. Such workers must be ready and willing to work on the days and during the hours usually worked by the class of worker affected. A worker shall not be entitled to payment for any time absent from employment unless such absence from work is due to illness and comes within the provisions of clause 18.

(b) A week's notice of termination of engagement shall be given on either side. Such notice may be given on any day during the week to terminate such engagement on the corresponding day of the following week or on any later day thereof. Any worker may be dismissed peremptorily without notice for malingering, inefficiency (otherwise than through temporary illness), neglect of duty or misconduct, and shall be entitled to payment of wages up to the time of such dismissal only.

(c) The employer shall be entitled to deduct payment for any day or portion of a day upon which the worker cannot be usefully employed because of any strike by the union or unions affiliated with it, or by any other association or union, or through the breakdown of the employer's machinery or any stoppage of work by any cause which the employer cannot reasonably prevent.

9.—Record Book.

The wages sheet of the Controller shall be open for inspection by the secretary of the Union upon reasonable notice being given of his desire to inspect same.

10.—Right of Entry to Works.

On notifying the officer in charge, any officer of the Union, authorised in writing by the president and secretary of such Union, shall have the right to enter any place or premises during ordinary working hours.

11.—Payment of Wages.

Wages shall be paid weekly in the employer's premises, in the employer's time, and on any day other than Saturday or Sunday.

12.—Aged and Infirm Workers.

Any worker who by reason of old age or infirmity is unable to earn the minimum wage may be paid such lesser wage as may from time to time be agreed upon in writing between the Union and the employer.

13.—Wet Pay.

Where the conditions of work are such that workers are unable to avoid their clothing becoming excessively wet, they shall be supplied with protective clothing or material or be paid an allowance of 1s. per day extra.

14.—General Clauses.

(a) No female worker shall be permitted to lift weights above shoulder high or to carry weights in the case of workers under 18 years of age in excess of 25 lbs. and in the case of over 18 years in excess of 35 lbs.

(b) Female workers shall be allowed two rest periods daily, each of 10 minutes. These periods shall be computed as time worked, and shall be allowed between 9 a.m. and 10 a.m. and 2 p.m. and 3 p.m.

(c) Any female worker required to stand continuously on concrete floors whilst working shall be provided with proper protection under foot.

(d) Rest rooms with locker accommodation (rooms suitable for females to change in) shall be provided.

15.—Preference.

All workers covered by this Agreement are to be members of the Union and if not members at the time of the making of the Agreement shall, within 14 days thereafter, make application to the Coastal Food Manufacturers and Wholesale Mixing and Packing Establishments Employees' Industrial Union of Workers for membership.

16.—Junior Worker's Certificate.

(a) Junior workers shall furnish the employer with a certificate showing the following particulars:—(a) Name in full; (b) Age and date of birth.

(b) This certificate shall be signed by the worker.

(c) No worker shall have any claim upon the employer for additional wages, in the event of his age being wrongly stated on this certificate.

17.—Board of Reference.

For the purpose of this Agreement, a Board of Reference is hereby appointed, which shall consist of a chairman and two (2) other representatives, one to be nominated by each of the parties. The said Board shall have assigned to it in the event of no agreement being arrived at between the parties to the dispute the functions of:—

(a) Adjusting any matters of difference which may arise from time to time except such as involve interpretations of the provisions of this Agreement or any of them;

(b) Classifying and fixing wages, rates and conditions for any occupation or calling not specifically mentioned in the Agreement;

(c) Dealing with any other matter which the Court may refer to the Board from time to time.

An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the Industrial Arbitration Act, 1912-1941, which for this purpose are embodied in this Agreement.

18.—Payment for Sickness.

(a) (1) A worker shall be entitled to payment for non-attendance on the ground of personal ill health for one half ($\frac{1}{2}$) day for each completed month of service.

(2) The liability of the employer hereunder shall in no case exceed one (1) week's wages during each calendar year in respect of each worker.

(3) Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(b) This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

(c) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer, or his representative, of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) consecutive working days or more.

(d) No payment will be made for any absence due to the worker's own fault, neglect, or misconduct.
