WHEREAS under the provisions of the Medical Act Amendment Act, 1940, where the Governor in Council is satisfied that any hospital within the meaning of the Mental Treatment Act, 1927, is not adequately provided for in respect of medical or surgical services, the said Governor in Council may, by Proclamation, declare such hospital to be a region within the meaning of the said Act: Now, therefore I, the Lieutenant-Governor in and over the State of Western Australia, being satisfied that the Claremont Mental Hospital is not adequately provided for in respect of medical or surgical services, do hereby proclaim the said hospital, together with the whole area of the reserve on which it is erected, to be a region under the provisions of the said Act, to be designated the Claremont Mental Hospital region.

WHEREAS by the Native Administration Act, 1905-1941, it is provided that the Governor is empowered by Proclamation to declare any Crown Lands to be Reserves for Natives; and whereas it is deemed desirable that a Reserve for Natives should be declared at Badjaling: Now, therefore I, James Mitchell, Lieutenant-Governor as aforesaid, with the advice of the Executive Council, do hereby declare a Reserve of 1066 acres 3 roods 25 perches at Badjaling, more particularly described in the Schedule hereto, to be a Reserve for Natives.

All that portion of land bounded by lines starting from the southern corner of Avon Location 9223 and extending north-easterly along the south-eastern boundary of said location and onwards to the westernmost corner of location 20693; thence south-easterly along the south-western boundaries of locations 20693 and 25212 to the southern corner of the latter location; thence south-westerly and south-easterly along the sides of a one chain road to the northern side of a one chain road along the northern side of the railway reserve (Quairading to Bruce Rock); thence gener-ally westerly along said northern side of railway reserve to the eastern boundary of Badjaling Townsite Reserve; thence northerly and westerly along boundaries of the said Townsite Reserve to the northdaries of the said Townsite Reserve to the north-eastern side of a road along the north-eastern side of the No. 2 rabbit-proof fence; and thence north-westerly along said side of road to the starting point. (a) Each worker (other than a casual worker) shall be entitled to twelve (12) days' holiday on full pay for each year of service. Such holiday shall be granted in the following manner:-

Subject as hereunder provided, the following nine (9) days, or the days observed in lieu, shall be taken as they occur, namely, New Year's Day, Anniver-sary Day, Good Friday, Easter Monday, Labour Day, Anzac Day, Foundation Day, Christmas Day, and Boxing Day.

The remaining three (3) days shall be taken be-The remaining three (3) days shall be taken be-tween the twenty-seventh and thirty-first days of December, inclusive: Provided that, if it be con-sidered by the employer to be inconvenient to grant such three (3) days between the dates above re-cited, he shall notify the Union in writing on or before December the eleventh, and the employer and the Union shall thereupon agree upon the dates that such three (3) days shall be taken: Provided further, that the dates so agreed upon shall be such as to enable the worker to take the three (3) days due by the last day of February following. following.

When any of the abovenamed holidays falls on a Sunday, some other day shall be granted in lieu thereof.
