## INDUSTRIAL AGREEMENT. No. 9 of 1945.

#### (Registered 2/8/45.)

THIS Agreement made in pursuance of the Industrial Arbitration Act, 1912-1941, of Western Australia, this Arbitration Act, 1912-1941, of western Australia, this thirty-first day of July, 1945, between the Commissioners of the Fremantle Harbour Trust of the one part, and the Federated Clerks' Union of Australia, Industrial Union of Workers, W.A. Branch, of the other part, witnesseth as follows:

#### 1.-Area and Scope.

This Agreement shall apply to all employees of the Fremantle Harbour Trust engaged upon clerical work and not provided for by any other Agreement or Award.

#### 2.—Definitions.

"Officer" shall mean any member of the clerical staff of the Fremantle Harbour Trust, male or female, covered by this Agreement.

"Commissioners" shall mean the Commissioners of the Fremantle Harbour Trust in office for the time being.

"Union" shall mean the W.A. Branch of the Federated Clerks' Union of Australia, Industrial Union of Workers.

#### 3.-Hours of Duty.

on Mondays to Fridays inclusive, with an interval of one hour for lunch, and from 9 a.m. to 12 noon on Saturdays.

(b) Handling and Custody of Cargo Staff.—From 8 a.m. to 5 p.m. on Mondays to Fridays inclusive, with an interval of one hour for lunch, and from 8 a.m. to

an interval of one nour for funch, and from 8 a.m. to 12 noon on Saturdays.
(c) Storeman.—From 8 a.m. to 5 p.m. on Mondays to Fridays inclusive, with an interval of one hour for lunch, and from 8 a.m. to 12 noon on Saturdays.
(d) The week's work may in any case by agreement between the Commissioners and the Union, be worked

in five (5) days from Mondays to Fridays inclusive, in which case the hours of duty shall be as mutually arranged between the parties.

#### 4.—Overtime.

Overtime shall mean and include all time worked out-side the ordinary hours of duty, and shall be paid for as follows:

(a) All such time worked between 5 p.m. and mid-night on any of the days Mondays to Fridays inclusive, at the rate of time and half, provided that an officer called back after the usual finishing time shall be paid

a minimum of two hours at the appropriate rate. (b) All such time worked between midnight and the a minimum payment as for four hours, except where the period of duty commences at or within four hours for the usual starting time, when the payment shall be for the actual time worked. (c) Where the weekly hours of duty are worked in

five days from Mondays to Fridays inclusive, all time worked on Saturdays between the ordinary starting time and noon shall be paid for at the rate of time

and half with a minimum payment as for two hours. (d) All such time worked between noon and mid-night on Saturdays, at the rate of double time with a minimum as for two hours.

(e) All such time worked on Sundays and holidays, at the rate of double time with a minimum as for four hours.

(f) Overtime shall not be paid for unless such work is authorised by the Manager or the Secretary of the Commissioners.

#### 5.-Meal Allowance.

In addition to the overtime prescribed in clause 4, a meal allowance of 2s. 6d. shall be paid to each officer in the following circumstances:-

(a) Where an officer is required to remain on duty after the usual finishing time and is so detained on duty for a period exceeding one hour on any working

day. (b) Where an officer is required to commence duty a half after the usual finishing time before being re-quired to resume duty on any working day.

(c) Where an officer is required on duty on other than a working day and commences at or before 12 noon or 5 p.m. or on Saturday at or before 5 p.m. and continues on duty until or beyond 1.30 p.m. or 6.30 p.m. respectively; provided that the actual period of duty in either case exceeds two hours.

#### 6.—Rates of Pay.

(d) Nothing in this Agreement shall entitle any officer to an advancement in salary unless and until such officer shall have served for twelve months at the lower rate. Any such advancement shall be by the appropriate annual increment and shall be subject to the satisfactory conduct, diligence and efficiency of the officer.

#### 7.—Appointments.

Should a vacancy occur in any position covered by this Agreement, then such vacancy shall be advertised by notice on the office notice board and in such other manner as the Commissioners may deem fitting and appointment to such vacancy shall, where practicable, be made from officers already in the service of the Com-missioners. Any officer may have the right of appeal to the Commissioners against any such appointment.

#### 8.-Higher Duties.

Officers required to relieve temporarily in positions outside their own classifications will be entitled to retain their existing salary or be paid the minimum of the position being relieved, whichever is the greater.

#### 9.—Public Holidays.

All gazetted holidays and picnic day shall be observed as public holidays.

#### 10.—Annual Leave.

All officers shall be granted leave of absence on full pay for two weeks in each calendar year, as though within the appropriate provision of the regulations of the Commissioners.

#### 11.-Long Service Leave.

All officers shall be entitled to long service leave as All officers shall be entitled to long service leave as though within the appropriate provision of the regula-tions of the Commissioners. Any officer who resigns or is retired for any reason other than misconduct or un-satisfactory service, and who has served continuously for at least twelve months next prior thereto shall be paid for long service leave pro rata to the date of programment. resignation or retirement.

#### 12.-Sick Leave.

(a) An officer who is too unwell to attend to his duties may upon the production of a certificate from a duties may upon the production of a certificate from a registered medical practitioner be granted sick leave in accordance with the following scale, provided that where the period of incapacity is three days or less, such cer-tificate shall not be necessary:—

Under 3 years' service-

- 1 month on full pay.
- 4 months on half pay. 9 months on third pay.
- Three years' service and over 3 months on full pay.
  - 8 months on half pay.
  - 3 months on third pay.

(b) At any time after the expiration of two months' absence on sick leave, the officer may be required to submit himself to examination by a medical officer approved by the Commissioners.

(c) Sick leave may be granted in one or more periods, but the aggregate amount of leave on pay as provided in this clause, must not be exceeded in any one triennial period.

(d) For the purpose of this clause a triennial period shall be the three years preceding the date of the appli-cation under consideration.

(e) Should the sickness be of a contagious or infectious character the officer shall not return to duty without a medical certificate stating that he may return without danger to others.

(f) Prior to resumption, an officer may be required to produce a medical certificate stating that he is fit to resume.

#### 13.-Engagement.

(a) The engagement of any officer, other than one in a temporary or relieving capacity, shall be terminable by one month's notice on either side, excepting that an by one month's notice on either side, excepting that in officer deemed guilty of gross misconduct or neglect of duty may be instantly dismissed or suspended, and shall not be entitled to any such notice or payment in lieu. (b) Temporary officers may be engaged at such daily or weekly rate as may be appropriate to the particular class of work, and shall be subject to one day's or one week's notice on the case may be appropriate to any such

week's notice as the case may be, provided that any such officer engaged on a daily basis but whose period of engagement has exceeded one week shall be subject to one week's notice, and provided further that the mini-mum wage payable to a temporary officer shall not be less than the rate prescribed for similar work under this Agreement.

#### 14 .-- Preference of Employment.

All officers shall be members of the Federated Clerks' Union of Australia, provided that any officer who at the time of engagement is not a member of such Union shall become a member thereof within fourteen days of such engagement, and provided also that the Union shall not refuse to accept as member any such officer who is eligible, and applies in the manner prescribed, under the rules of the Union, to become a member thereof.

#### 15.-Preservation of Accrued Rights.

Nothing herein contained shall affect the rights or privileges accrued to any officer prior to this Agreement.

## 16.-Time and Wages Record.

Records shall be kept by the Commissioners showing the name of each officer under this Agreement, the nature of the work performed, the hours worked each day, and the amount of wages received each pay. The said records shall be open to the inspection of an accredited repre-sentative of the Union during working hours.

#### 17.-Board of Reference.

The Court may appoint for the purpose of the Agree-ment a Board of Reference. Such Board shall consist of a Chairman and two (2) other representatives, one to be nominated by each of the parties hereto, as pre-scribed by the regulations. There are assigned to the Board, in the event of agreement not being arrived at between the said parties, the functions of:— (a) Adjusting any matters of difference which may arise between the parties from time to time event

arise between the parties from time to time, except such as involve interpretations of the provisions of (b) Classifying and fixing of salaries, rates, and

conditions for any position, occupation, or calling not specifically mentioned in the Agreement.

(c) Deciding any other matter that the Court may refer to such Board from time to time.

(d) An appeal shall lie from any decision of such Board, in the manner and subject to the conditions prescribed in the regulations to the Industrial Arbitration Act, 1912-1941, which for this purpose are em-bodied in this Agreement.

#### 18.—Area.

The area covered by this Agreement shall be the whole of the premises controlled by, vested in, or for the time being occupied by the Commissioners.

#### 19.---Term.

This Agreement, which shall operate as from and including the first day of January, 1945, and shall con-tinue in force for a period of three years therefrom, or for the duration of the war and six months thereafter,

whichever period shall be the shorter, replaces Industrial whichever period shall be the shorter, replaces industrial Agreement No. 14 of 1938, made between the herein named parties on the 27th May, 1938; provided that after the expiration of twelve months from its com-mencement, any term or terms hereof may, by mutual consent, be amended or revised upon either party giving the other party one month's notice of a desire to so amend or revise.
