(b) to do such others acts, matters and things in relation to the said Bill as you might or could do as a Select Committee of the Legislative Assembly of the Parliament of Western Australia pursuant to the resolution thereof referring the said Bill to you as such Select Committee;

(c) to consider and make any recommendation in relation to the amendment of the provisions of the said Bill, the deletion therefrom of any of the said provisions or the insertion therein of any further provisions which in the opinion of the Commission are justified or warranted by any of the inquiries and investigations made under paragraphs (a) and (b) hereof.

And I hereby appoint you the said Herbert Henry Styants to be Chairman of the said Royal Commission.

And I declare that you shall by virtue of this Commission be a Royal Commission within the Royal Commissioners' Powers Act, 1902, as reprinted in the Appendix to the Sessional Volume of the Statutes for the year 1928 and that you shall have the powers of

a Royal Commission or the Chairman thereof under that Act.

(e) whether the administration of harbours throughout the State should be concentrated under one harbour authority and to what extent existing legislation would need to be amended for this purpose.

And I hereby appoint you the said Herbert Henry Styants to be Chairman of the said Royal Commission.

And I declare that you shall by virtue of this Commission be a Royal Commission within the Royal Commissioners' Powers Act, 1902, as reprinted in the Appendix to the Sessional Volume of the Statutes for the year 1928 and that you shall have the powers of a Royal Commission or the Chairman thereof under that Act.

WHEREAS by section 10 of the Fisheries Act, 1905-1940, it is provided that the Governor may by Proclamation prohibit all persons from taking any fish whatsoever, in every or any specified portion of Western Australian waters, by means of fishing nets and fishing lines, or either of such means of capture, or by any other specified means of capture, for any specified term: Now, therefore I, the said Lieutenant-Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid and of every other power enabling me in this behalf, prohibit the taking, by means of fishing nets, of any fish whatsoever in the Western Australian waters of Sharks Lake, situated about eight (8) miles from the town of Esperance in the Esperance Land District for a period of one (1) year from 1st April, 1946, inclusive.

Workers' Compensation Act, 1912-1944.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 10 of the Workers' Compensation Act, 1912-1944, that it shall be obligatory for every employer to obtain from an incorporated insurance office, approved by the Minister, a policy of insurance for the full amount of the liability to pay compensation under this Act to all workers employed by him, but that if an employer proves to the satisfaction of the Minister that such employer has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability the Governor may by Order in Council exempt such employer from the operation of the said section 10; and whereas Amalgamated Collieries of W.A., Limited, of St. George's terrace, Perth, is an employer within the meaning of the said Act and as such is subject to the provisions of the said section 10, and has made application duly in accordance with the said Act and the regulations made thereunder for exemption from the operations of the said

section, and has satisfied the Minister that it has established a fund for insurance against its liability to pay compensation under the said Act to all workers employed by it, and has deposited at the Treasury securities, to wit, a bond by the Bank of New South Wales of Perth, charged with all payments to become due by the company under the said liability: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the power conferred by section 10 of the said Act, doth hereby exempt Amalgamated Collieries of W.A., Limited, from the operation of section 10 of the Workers' Compensation Act, 1912-1944, for a period of two years from and including the 1st day of March, 1946.

Workers' Compensation Act, 1912-1944.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 10 of the Workers' Compensation Act, 1912-1944, that it shall be obligatory for every employer to obtain from an incorporated insurance office approved by the Minister a policy of insurance for the full amount of the liability to pay compensation under this Act to all workers employed by him, but that if an employer proves to the satisfaction of the Minister that such employer has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability, the Governor may by Order in Council exempt such employer from the operation of the said section; and whereas The Mutual Life and Citizens' Assurance Company, Limited, of 179a St. George's terrace, Perth, being an employer within the meaning of the said Act, and as such subject to the said section, and having made application in accordance with the said Act and the regulations made thereunder for exemption from the operation of the said section 10, has satisfied the Minister that it has established a fund for insurance against its liability to pay compensation under the said Act to all workers employed by it, and has deposited at the Treasury a security, to wit, Commonwealth Government Securities of the value of Five thousand pounds (£5,000): Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Act, doth hereby exempt the Company, the said The Mutual Life and Citizens' Assurance Company, Limited, from the operation of section 10 of the Workers' Compensation Act, 1912-1944, for a period of two years commencing on and including the 1st day of March, 1946.
