WHEREAS by a proclamation dated the 17th day of August, 1945, that portion of the land comprised in Conditional Purchase Lease 21813/68, described in the First Schedule hereto was in exercise of the power conferred by section 11 of the Land Act, 1933-1939, resumed for the purpose of "Water"; and whereas it is desir-able that the portion of land comprised in the said lease described in the Second Schedule hereto should be resumed for the said purpose in lieu of the land described in the First Schedule: Now, therefore I, Sir James Mitchell, Lieutenant-Governor as aforesaid, with the advice and consent of the Executive Council, do hereby revoke the recited proclamation of the 17th day of August, 1945, and do by this my proclamation resume that portion of the said Conditional Purchase Lease 21813/68, which is described in the Second Schedule hereto for the purpose aforesaid.
