WHEREAS by section 6, subsection (1) of the War Funds Regulation Act, 1939, it is provided that the Governor on the recommendation of the Council, may by proclamation vest in the Council the moneys, securities for money, and articles in any war fund on being satisfied-(a) that a majority of at least three-fourths

in number of the persons who are trustees of who have the control of the moneys or securities for money or articles in such fund has consented thereto; and whereas the Council has recommended, and such a majority of the Women's Australian National Services, W.A., War Fund has so consented; and whereas by subsection (2) of section 6 of the Act the Governor may by proclamation vary such trusts and authorise the Council to apply the said moneys and securities and articles of any part thereof to such other purposes in connection with the present war, as it may direct: Now therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred on me by section 6 of the War Funds Regulation Act, 1939, hereby proclaim that the Council is authorised to apply the said moneys, securities and articles as set out in the Schedule attached to Executive Council Minute 1138, to the trusts of the Wanslea Hostel Committee.

The Fisheries Act, 1905-1940. PROCLAMATION

WE3TERN AUSTRALIA, By His Excellency Sir James Mitchell, TO WIT. { K.C.M.G., Lieutenant-Governor in and JAMES MITCHELL, Lieutenant-Governor, and its Dependencies in the Common-[L.S.] wealth of Australia.

File No. 102/34, Ex. Co. No. 1118. IN pursuance of the provisions of section 10 of the Fisheries Act, 1905-1940, I, the Lieutenant-Governor of the State of Western Australia, do hereby prohibit all persons from taking any fish whatsoever by means of fishing nets in any of the portions of Western Australian waters specified in the Schedule hereto for a period of three years as from the date of the publication of this proclamation in the *Government*. *Gazette*.

Proclamation dated 29th January, 1946, and published in the *Government Gazette* of 8th February, 1946, is hereby cancelled.

Schedule.

All that portion of Hardy Inlet South of a line drawn in a Westerly direction from Point Irwin (on the Eastern side of the inlet) to a point where the Southern boundary of Harford Street touches the foreshore (on the Western side of the inlet); thence extending to the Southern Ocean and including all waters which may be or may have been cut off from the main stream by a change of course of the inlet near its junction with the ocean.
