#### PROCLAMATION

WHEREAS by section 10 of the Native Administration Act, 1905-1941, it is provided that the Governor is empowered by proclamation to declare any Crown Lands to be Reserves for Natives; and whereas it is deemed desirable that a reserve for Natives should be declared in the Kwinana District: Now, therefore I, the said Lieutenant-Governor, with the advice of the Executive Council, do hereby declare an area of about 245,000 acres, more particularly described in the Schedule hereto, to be a Reserve for Natives.

#### Schedule.

Kwinana. No. 15530 (Native Mission Station—Presbyterian Church).—Bounded by lines starting from the most Westerly point of Lushington Valley and extending North-Easterly along the North-West side of the latter

to the shore of the Half Way Bay; thence along the shores of Half Way Bay, Hanover Bay, Brunswick Bay, Port George IV., and Augustus Water to the most Southerly shore of the same; thence Westerly to the Western side of Camden Peninsula; thence Southerly along the prolongation of said side of Camden Peninsula about 350 chains to its intersection with the Northern boundary of late pastoral lease 2059/98; thence Easterly about 350 chains, Southerly about 1,180 chains to the right bank of the Glenelg River; thence generally North-Easterly along same to the South-West corner of reserve 8241; thence Northerly along Western boundary of said reserve; thence Easterly about 180 chains, Northerly about 640 chains, Westerly about 1,030 chains to the South-West corner of reserve 15528; thence Northerly along West boundary of same to the starting point. (About 245,000 acres.) (Plan 144/300.)

## IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

No. 2 of 1945.

Between Australian Workers' Union, Westralian Branch Industrial Union of Workers, Applicant, and A. Pangaroni, P. J. Della-Bosca, and Densdale Brothers, Respondents.

THE Court of Arbitration of Western Australia doth hereby make the following Interim Award in connection with the industrial dispute between the abovenamed parties:—

Interim Award.

1.—Area and Scope.

This Award shall operate over the State of Western Australia and apply to workers engaged in the producing of firewood from the bush, provided that it shall not apply to workers who are at present provided for in any Award of the Court of Arbitration of Western Australia or in any industrial agreement registered in accordance with the provisions of the Industrial Arbitration Act, 1912-1941.

2.—Term.

The term of this Award shall be one (1) year from the date hereof.

3.—Contract of Service.

The contract of service shall be deemed to be a contract of hiring by the week.

4.—Hours.

Forty-four (44) hours shall constitute a week's work to be worked as follows—eight (8) hours on each day from Monday to Friday, inclusive, to be worked between the hours of 7 a.m. and 5 p.m., and four (4) hours on Saturday to be worked between the hours of 7 a.m. and 12 noon. Provided that by agreement between the Union and employer the forty-four (44) hours may be worked in five (5) days, Monday to Friday, inclusive, of eight (8) hours forty-eight (48) minutes each.

5.—Overtime.

All work performed beyond the specified hours of duty on any ordinary day shall be paid for at the rate of time and a half for the first two (2) hours and double time thereafter. Work done on holidays and Sundays shall be paid for at double time rates.

6.—Holidays.

The following days shall be holidays—Christmas Day, Labour Day and Easter Monday.

7.—Annual Holidays.

A fortnight's holiday on full pay shall be granted to each worker at the end of twelve (12) months' service. Should he have worked for less than twelve (12) months' service when the said holidays are taken, or at the termination of his employment, he shall be paid for or allowed a proportionate number of holidays.

8.—Stores and Supplies.

The employer shall cart to the woodcutter at his camp, stores and supplies, ordered by the woodcutter, at least three (3) times per week.

Good drinking water shall be supplied free to all workers covered by this Award and shall be delivered into tanks at the camping place of the workers.

9.—Casuals.

All men not employed for the full working week shall be considered casuals and shall receive ten per cent. (10%) in addition to the rate specified. This clause shall not apply to pieceworkers.

10.—Payment of Wages.

All wages shall be paid weekly and within ten (10) minutes of such wages becoming due unless mutually agreed upon between the employer and the worker. Any worker, whose services are terminated shall be paid all wages and holidays' pay due within one (1) hour of the engagement being terminated.

## 11.—First Aid.

The employer shall provide at each camp first aid equipment, and keep same fully and sufficiently supplied.

## 12.—Shifting Camp.

When for the purpose of the employer's operations workers are required to shift their own camp, they shall be entitled to ordinary rates of pay for the time they actually are occupied in shifting camp.

## 13.—Sanitary Arrangements.

The employer shall provide reasonable facilities in the nature of sanitary arrangements at each camp.

## 14.—Wages Record.

The employer shall keep or cause to be kept a record showing the names of each worker, the hours worked, and the wages and allowances paid. Such record shall be open for inspection to a duly authorised representative of the Union during the usual office hours at the employer's head office.

## 15.—Piecework.

A worker working under any system of payment by results shall be paid at least the rate of pay to which he would have been entitled if working on a contract of daily service.

## 16.—Tool Allowance.

Where a worker is required to supply his own tools and files, a tool allowance at the rate of seven shillings (7s.) per week shall be paid.

## 17.—Sick Pay.

A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for one half ( $\frac{1}{2}$ ) day for each completed month of service.

## 18.—Board of Reference.

(1) For the purpose of this Award, a Board of Reference is hereby appointed, which shall consist of a chairman and two (2) other representatives, one to be nominated by each of the parties. The said Board shall have assigned to it in the event of no agreement being arrived at between the parties to the dispute the functions of—

(a) adjusting any matters of difference which may arise from time to time, except such as involve interpretation of the provisions of this Award or any of them;

(b) dealing with any other matter which the Court may refer to the Board from time to time;

(c) classifying and fixing wages, rates and conditions for any occupation or calling not specifically mentioned in the Award.

(2) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the Industrial Arbitration Act, 1912-1941, which for this purpose are embodied in this Award.

## 19.—Camp Allowance.

Workers required to live in tents at or in the neighbourhood of the job shall be paid an additional allowance of fifteen shillings (15s.) per week.

The above allowance covers a week of forty-four (44) hours. For broken periods the allowance shall be calculated at one-sixth ( $\frac{1}{6}$ th), viz., two shillings and sixpence (2s. 6d.) per day.

## 20.—District Allowance.

District allowances calculated on the rates specified below shall be paid in the undermentioned areas:—

## 21.—Accidents, Transportation, Etc.

In cases of accident the employer shall pay the necessary railway and any other transportation fare of the injured worker to the nearest hospital town; when it is necessary for an attendant to accompany an injured worker, the employer shall pay the necessary transportation fare and wages, not exceeding eight (8) hours per day, for the actual time occupied on the journey.
