New Position-East end of "G", Shed, Victoria Quay.

Details—The two red lights previously exhibited on the roof of No. 2 Grain Shed, North Quay, have been transferred to the above position. Situated a few feet apart and one set slightly higher than the other, the lights are so screened that, when approaching from the Westward, they become visible about 200 feet from No. 1 Mooring Buoy and disappear at a point about 200 feet Westward of No. 2 mooring buoy.

The lights are in line, bearing 136 deg., at the actual
