NURSES REGISTRATION ACT, 1921-1944.

Department of Public Health, Perth, 22nd November, 1946.

HIS Excellency the Lieutenant-Governor in Council, acting under the provisions of the Nurses Registration Act, 1921-1944, has been pleased to repeal all the regulations heretofore made and in force under the said Act, and in lieu thereof to make new regulations as set forth in the Schedule hereunder, to come into operation and have effect as from the date of the publication of this notice in the Government Gazette.

Interpretation.

- 3. In the interpretation of these regulations the following terms shall have the meanings respectively set against them unless the context otherwise requires:—
 - "The Board" shall mean the Nurses' Registration Board.
 - "The Secretary" shall mean the person appointed by the Board to that office.
 - "The Act" shall mean the Nurses Registration Act, 1921-1944.
 - "Registered Nurse" shall mean a nurse registered under this Act.
 - "Regulations" shall mean the regulations made under the provisions of the

PART II .- THE BUSINESS AND PROCEEDINGS OF THE BOARD.

Meetings.

4. The Board shall meet in each month, nuless otherwise decided at a previous meeting, on such day as will suit the convenience of its members, and at such times as may be necessary. The chairman may at any time convene a meeting and the sceretary shall convene a meeting, if so required in writing by any two members of the Board.

Notice of Meeting.

5. Not less than two days' notice of any meeting shall be given to each member of the Board.

Quorum.

6. Five members of the Board shall constitute a quorum.

Order of Business.

- 7. The order of business shall be as follows:-
 - (1) Miuntes of previous meeting.
 - (2) Correspondence.
 - (3) Reports.
 - (4) Registrations.
 - (5) Notices of motion.
 - (6) Any other business.
 - (7) Date of next meeting.

Provided that the Board may at any meeting vary the order of business on the ground of urgency or convenience.

Voting.

8. Every question before the Board shall be decided by a majority of members present and voting, and the chairman shall have a vote in his own right, together with a casting vote.

Motions.

9. Every motion or amendment shall be moved and seconded, and shall be reduced to writing and handed to the chairman (if so required by him) and shall be read before it is further discussed or put to the meeting.

Notices of Motion.

10. Every notice of motion shall be in writing, signed by the member giving the notice, and shall be given or sent to the Secretary who shall insert in the agenda paper of the next ordinary meeting of the Board in the order in which they have been received by him all notices of motion received not less than one clear day prior to the day on which the agenda paper is sent out to members.

Rescinding of Resolution.

11. No resolution of the Board shall be altered or rescinded at a subsequent meeting except upon a notice of motion of which a copy has been sent out to members by the secretary seven clear days before such meeting.

Committees.

- 12. (1) Every committee appointed by the Board shall make a report of its proceedings to the Board, and the recommendations of every committee shall, as far as practicable, be in the form of resolutions to be considered by the Board.
- (2) The Acts and proceedings of every committee shall be submitted to the Board for approval, unless the resolution of the Board appointing the committee shall otherwise so direct, in respect of all or any of the matters referred to it.

Reports.

- 13. (1) Every report from a committee shall be submitted by the chairman of the committee (if present), who shall move that it be received by the Board, and, on the motion being carried, the chairman, or any other member of the committee, may move to agree with the resolutions of the committee, each such resolution being considered seriatim.
- (2) The question that the report (if necessary, as amended) be now approved shall be put by the Chairman and no debate shall be allowed thereon.

Decision of Chairman.

14. The presiding chairman shall decide upon any point of order or procedure, and his decision shall be final.

PART III.-NOMINATION OF PERSONS AS MEMBERS OF THE BOARD.

- 15. The following provisions shall apply and be observed in relation to the selection and nomination of persons to be appointed by the Governor as members of the Board when in accordance with section 2 of the Act persons are required to be nominated before being so appointed, that is to say—
 - (A) In the case of the two medical practitioners to be selected and nominated by the British Medical Association, the following provisions shall apply—
 - (i) As soon as reasonably may be after it becomes known to the Commissioner of Public Health as the Chairman of the Board that the places or place of the medical practitioner members or of a medical practitioner member of the Board is or is about to become vacant, the Commissioner shall cause to be sent to the Secretary of the British Medical Association in Perth notice in writing requesting that the British Medical Association forthwith select for nomination two medical practitioners or one medical practitioner (as the case may require) for appointment by the Governor as members or member of the Board to fill such vacancies or vacancy. Such notice shall contain a reference to subparagraph (ii) of paragraph (a) of subsection (4) of section 2 of the Act.
 - (ii) On receipt of a notice from the Commissioner under subparagraph (i) of this paragraph, the secretary of the British Medical Association shall take the measures necessary for compliance with the notice by the said Association.
 - (iii) The selection by the Association of medical practitioners to be nominated for appointment by the Governor as members of the Board shall be made in accordance with the rules (if any) of the British Medical Association or otherwise in such manner as the said Association shall from time to time by resolution determine.
 - (iv) When the Association has selected a medical practitioner for nomination as aforesaid, such nomination shall be made by sending to the Commissioner of Public Health in writing signed by the Chairman of the British Medical Association particulars of the name and address of the medical practitioner selected and the date of his selection.
 - (v) When the Commissioner of Public Health receives from the British Medical Association notice in accordance with subparagraph (iv) hereof of the selection and nomination of a medical practitioner by the said association he shall immediately submit to the Governor for appointment as a member of the Board the name of the medical practitioner who has been so nominated.
 - (vi) In relation to the first two medical practitioners to be appointed to the Board after the 8th day of December, 1944, the appointment before the commencement of this regulation of two medical practitioners on the nomination of the British Medical Association shall be deemed to have been validly made and shall have effect to the same extent as if at the time of such nomination and appointment this regulation had already come into operation and the said nomination and the said appointment of such two medical practitioners had been made thereunder.
 - (B) In the case of general trained nurses, mental nurses and midwifery nurses to be selected and nominated for appointment by the Governor as members of the Board the following provisions shall apply:—
 - (i) For the purpose of every nomination under subparagraph (iv) of paragraph (a) of subsection (4) of section 2 of the Act, the Minister shall appoint some person to be the returning officer. The chairman or secretary of the Board or any other person may be so appointed. The name and address of the returning officer shall be published in the Government Gazette and The West Australian newspaper.
 - (ii) No person shall be entitled to propose or second the submission of a candidate for nomination unless she or he is at the time when such submission is signed by her or him duly registered as a general trained nurse, or a mental nurse, or a midwifery nurse.
 - (iii) Only a general trained nurse may propose or second the submission of a general trained nurse as a candidate for nomination, only a mental nurse may propose or second the submission of a mental nurse as a candidate for nomination, and only a midwifery nurse may propose or second the submission of a midwifery nurse as a candidate for nomination.
 - (iv) Every submission of a candidate for nomination and appointment as a member of the Board shall be made in writing upon a submission form as prescribed in Form No. 1 in Appendix I. to these regulations and shall be signed by the candidate herself or himself and also by her or his proposer and seconder.
 - (v) Every submission of a candidate shall be sent or delivered to the returning officer so as to be in his hands not later than 4 o'clock in the afternoon of the day fixed as hereinafter provided for as the last day for the receipt of submission forms by the returning officer.
 - (vi) Forthwith after the expiration of the time fixed for receipt of submission forms, the returning officer shall examine all the submission forms received by him, and satisfy himself that the candidates whose names are submitted on the submission forms are eligible for selection and nomination as a general trained nurse or as a mental nurse or as a midwifery nurse (as the case may be), and that the persons who have signed the submission form as proposer or seconder are entitled under this regulation so to sign the same.

(vii) The returning officer shall reject any submission form which in his opinion is not in order as required by this regulation, and any such rejection shall be final and conclusive as against the candidate.

(viii) Where only one candidate is submitted for nomination and appointment as a general trained nurse, or as a mental nurse, or as a midwifery nurse (as the case may be), the returning officer shall forthwith certify that fact, together with the name, address and occupation of the candidate submitted in accordance with Form No. 2 in Appendix I. to these regulations to the Minister. Such certificate when received by the Minister shall be deemed to be and shall be treated as the nomination of the candidate whose name appears on the certificate by the constituent body whose representative such candidate is intended to be on the Board.

(ix) As soon as reasonably may be after the receipt of the said certificate from the returning officer, the Minister shall submit to the Governor for appointment as a member of the Board the name of the person

mentioned in such certificate.

(x) As and whenever required by the returning officer for use by him in the performance of his duties under this regulation, the secretary of the Board shall supply to him true and correct lists of the names and addresses of the persons who for the time being are registered under the Act as general trained nurses, as mental nurses, and as midwifery nurses, respectively. The said secretary shall endorse and sign on each such list a certificate as to the correctness thereof, and such certificate shall be final and conclusive as against all candidates and persons voting in respect of the submissions or voting in relation to which such lists are used.

Provided that-

(a) if it be proved before the date fixed for the receipt of submissions that the name of a person eligible to be submitted as a candidate has been inadvertently omitted from the relevant list, or that the name of a person submitted as a candidate has been wrongly included in the relevant list, the error may be forthwith rectified on such list

by the returning officer; or
(b) if, when an election is necessary, it is proved before the closing of the poll at such election that the name of a person eligible to vote at such election has been inadvertently omitted from the relevant list or that a person whose name appears on the relevant list is not entitled to be included in such list, the error may be forthwith rectified on such list by the returning officer; and

(c) when after a person has voted at an election it is discovered that such person was not entitled to be included on the relevant list

that such person was not entitled to be included on the relevant list on which her or his name is included, the fact that such person has so voted shall not in any way operate to invalidate the election.

(xi) Whenever a vacancy exists or is about to occur in any place on the Board required to be filled by a general trained nurse or a mental nurse or a midwifery nurse, the returning officer appointed in connection with the nomination to fill such vacancy shall as soon as reasonably may be after his appointment fix a date on or before which submission of candidates for such nomination shall be sent or delivered to him, and shall cause notice of such data to be applicated in the Consequence Consequent shall cause notice of such date to be published in the Government Gazette and The West Australian newspaper.

Provided that the date so fixed shall not be less than fourteen days or more than thirty days after the date upon which such notice is

published in the Government Gazette as aforesaid.

(xii) Every submission of a candidate received by the returning officer after 4 o'clock in the afternoon of the date fixed as aforesaid under subpara-

graph (xi) hereof shall be rejected by him.

(xiii) Where any submission of a candidate is sent by post but the postage thereon is wholly unpaid or insufficiently prepaid thereon, the returning officer shall refuse to accept such submission and such submission shall be deemed not to have been sent or delivered to the returning officer within the meaning of this regulation.

(xiv) Whenever upon the receipt and acceptance by the returning officer of submissions of candidates the number of candidates submitted makes it necessary that an election shall be held, the returning officer shall fix a day being not less than fourteen days and not more than thirty days from the closing day for submissions of candidates for the closing of the poll at such election, and shall publish notice of the day so fixed by him in the Government Gazette and The West Australian news-

(xv) When in accordance with subparagraph (xiv) hereof the returning officer has fixed the closing day for the election he shall as soon as practicable thereafter but within seven days thereafter cause ballot papers to be prepared in accordance with Form No. 3 in Appendix I. to these regulations containing the names of all the candidates in alphabetical order. The ballot paper shall set forth in a space provided for the purpose, notice of the day fixed for the closing of the poll, and the

address of the returning officer.

(xvi) When the ballot papers have been prepared as aforesaid the returning officer shall send by prepaid letter post to each general trained nurse, or to each mental nurse, or to each midwifery nurse whose name appears on the relevant list of registered nurses held by him as the case shall require, at her or his postal address as shown on such relevant list, one ballot paper with the initials of the returning officer endorsed on the back thereof, together with—

(a) an envelope marked "Ballot Paper Envelope"; and

(b) a form of statement in accordance with Form No. 4 in Appendix I. to these regulations to be completed and signed by the voter; and (c) an envelope addressed to the returning officer. (xvii) The envelope marked "Ballot Paper Envelope" shall also have marked thereon words identifying such envelope and the ballot paper to be enclosed therein with the particular election in which the voter by the ballot paper is entitled to vote.

(xviii) The returning officer may before sending the statement mentioned in subparagraph (xvi) hereof to an elector fill in the particulars required to be furnished therein so that the same will be ready for signature and completion by the elector when marking his ballot paper.

(xix) For the purpose of casting her or his vote at the election, the elector shall mark her or his vote on the ballot paper in the manner hereinafter provided, and shall then place the same in the envelope marked "Ballot Paper" and seal the envelope. She or he shall then sign and complete Paper' and seal the envelope. She or he shall then sign and complete the statement in accordance with the directions stated thereon and then place the sealed envelope with the ballot paper enclosed therein and the statement signed and completed in the envelope addressed to the returning officer and seal such last-mentioned envelope.

(xx) The elector may then send by prepaid letter post or may deliver the envelope addressed to the returning officer with its contents to the returning officer at his address shown on the said envelope but so that such envelope shall be in the hands of the returning officer not later than 4 o'clock in the afternoon of the day fixed for the closing of the poll. Where any envelope is sent by post to the returning officer but the postage thereon is whelly impaid or insufficiently prepaid thereon the returning officer shall refuse to accept the same and such envelope with its contents shall be deemed not to have been sent or delivered to the returning officer within the meaning of this regulation.

(xxi) If prior to the closing of the poll, an elector satisfies the returning officer that she or he has not received a ballot paper and is entitled to vote at the election or that the ballot paper or envelopes received by her or him have been lost or destroyed and that she or he has not already voted at the poll, the returning officer may post or give personally to the elector a ballot paper and envelopes or a further ballot paper and envelopes or a further

ballot paper and envelopes as the case may be.

(xxii) Voting at elections shall be by means of a preferential ballot. The elector shall mark her or his vote on the ballot paper by placing the numeral 1 opposite the name of the candidate for whom she or he votes as her or his first preference, and the numeral 2 opposite the name of the candidate for whom she or he votes as her or his second preference, and she or he shall give contingent votes for all the

remaining candidates by placing the numerals 3, 4 and so on (as the case requires) opposite their names so as to indicate by such numerical sequence the order of her or his preference.

(xxiii) The returning officer shall keep a locked and sealed ballot box for each class of election held, and as and when the envelope containing the ballot paper and the statement is received by him from an elector, he shall open the onter envelope and extract therefrom the statement and the sealed envelope containing the ballot paper. He shall thereupon examine the statement and satisfy himself that the same is in order and that the elector who signed the statement is on the relevant list of registered nurses and entitled to vote. If and when he is so satisfied he shall keep the statement in some secure place for safe keeping and shall immediately place the envelope containing the ballot paper unopened in the proper ballot box and so leave the same until the class of the pall

same until the close of the poll.

(xxiv) If upon examining the statement as aforesaid the returning officer is not satisfied that the statement is in order or that the person who signed the same is on the relevant list of registered nurses and entitled to vote he shall retain such statement and the envelope containing the ballot paper in a secure place for safe keeping and at once notify the elector in writing that her or his ballot paper has not been accepted for the reasons to be stated in the notice. If before the closing of the poll an elector who has received notice as aforesaid satisfies the returning officer that he is an elector and entitled to vote at the election the returning officer shall forthwith place the sealed envelope containing such elector's ballot paper unopened in the proper ballot box and so leave the same until the closing of the poll. If an elector fails to satisfy the returning officer as aforesaid the returning officer shall reject the ballot paper received from such elector. Upon such rejection he shall endorse on the envelope containing the ballot paper the word "rejected" and sign the same and then place such envelope unopened in some secure place for safe keeping until after the election.

(xxv) For the purpose of counting the votes cast an an election, the Minister may nominate and appoint two persons to act as scrutineers. Provided

that no candidate shall act as a scrutineer.

(xxvi) The counting of the votes cast at an election shall be carried out by the returning officer in the presence of the scrntineers (if any), and the method of conducting the count shall be the same as that prescribed under the Electoral Act, 1907-1940, for the counting of votes taken at an election of members of the Legislative Assembly.

(xxvii) As soon as practicable after the closing of the poll, the returning officer shall, in the presence of the serutineers (if any)-(a) open the ballot box and remove therefrom the envelopes containing the ballot papers; (b) open the said envelopes and extract the ballot papers therefrom; (c) examine the ballot paper and satisfy himself that the same bears his initials endorsed thereon, and decide whether such ballot paper is formal or informal; (d) count all the formal ballot papers and reject all the informal ballot papers. The returning officer shall be the sole and final judge as to whether a ballot paper is informal.

- (xxviii) Any candidate may attend and be present at the counting of the votes.
- (xxix) A ballot paper shall be informal—(a) if it is not initialled by the returning officer; or (b) if, subject as hereinafter provided, it is marked in any other manner than prescribed in subparagraph (xxii) hereof; or (c) if it has upon it any mark or writing not authorised by this regulation which in the opinion of the returning officer will enable any person to identify the elector; or (d) if it does not indicate the elector's vote; or (e) if no mark is indicated on it. A ballot paper shall not be informal for any reason other than those enumerated in the above subparagraphs (a) to (e), but shall be given effect to according to the elector's intention so far as that intention is clear.
- (xxx) As and when the returning officer shall have completed the counting of the votes at an election, he shall declare the result of the election in the presence of the scrutineers and of any candidates who may be present at the time.
- (xxxi) When the result of an election has been ascertained and declared the returning officer shall forthwith furnish to the Minister a certificate of such result in accordance with Form No. 5 in Appendix I. to these regulations, and state therein the name and address and occupation of the candidate who has been elected; such certificate when received by the Minister shall be deemed to be the nomination within the meaning and for the purposes of section 2 of the Act of the person named in Such certificate by the constituent body which she or he has been elected to represent as a member of the Board. Such certificate shall be final and conclusive evidence that the person named therein has been duly and properly elected.
- (xxxii) On the receipt of a certificate from the returning officer under subparagraph (xxxi) hereof the Minister shall submit the name of the person named in such certificate to the Governor for appointment as a member of the Board.
- (xxxiii) Every appointment of a member of the Board shall be published in the Government, Gazette.
- (xxxiv) All costs, charges and expenses incurred by the returning officer in connection with the receipt of submission form of candidates, the conduct of elections, or in connection with other matters incidental thereto and as certified in writing under his hand by the returning officer, shall be borne and paid by the Minister reimbursed to the returning officer by the Minister.

Provided that the Minister may at his own expense have the accounts of the returning officer audited by the Auditor General, whose decision thereon shall be final as between the parties.

- (xxxv) The returning officer shall retain all ballot papers and statements received by him in connection with any election held under this regulation until the expiration of three months after the declaration of the result of such election, and shall then cause the same to be destroyed.
- (xxxvi) Notwithstanding anything to the contrary contained in the foregoing provisions of this regulation, any person whose name has been submitted as a candidate for nomination and appointment as a member of the Board may by notice in writing signed by him and sent or delivered to the returning officer withdraw such submission at any time prior to 4 o'clock in the afternoon of the day fixed by the returning officer as the last day for the receipt of submission forms of candidates by him, but so that such notice of withdrawal will be in the hands of the returning officer before such time and day aforesaid. Save and except as provided by this subparagraph, a person whose name has been submitted as a candidate shall not be permitted to withdraw such candidature.

PART IV .- TRAINING HOSPITALS.

Division 1-General.

- 16. For the purposes of these regulations, hospitals for the training of general nurses are hereinafter specifically referred to as "general nurses' training hospitals," as distinct from hospitals for the training of children's nurses, infant health nurses, mental nurses and midwifery nurses, hereinafter specifically referred to as "children's nurses' training hospitals," "infant health nurses' training hospitals," "mental nurses' training hospitals," and "midwifery nurses' training hospitals," respectively.
- 17. (1) The board of management, proprietor or other controlling authority of a hospital which it is desired shall be approved by the Board as a general nurses' training hospital, children's nurses' training hospital, infant health nurses' training hospital, mental nurses' training hospital or midwifery nurses' training hospital, as the case may be, shall make application for such approval to the Board, through the medical officer in charge or the matron of such hospital, in accordance with Form No. 6 or Form No. 7 in Appendix I. to these regulations, as the case may require.
- (2) The approval, if granted, shall be in writing, signed by the chairman of the Board in accordance with Form No. 8 in Appendix I. aforesaid.
- (3) The approval granted by the Board in respect of any hospital shall remain in force until revoked by notice in writing, signed by the chairman, in accordance with Form No. 9 in Appendix I. to these regulations.
 - (4) An approval by the Board may be revoked at any time.
- 18. A list of hospitals in this State approved by the Board at which the training of nurses may be undertaken shall be published in the *Government Gazette*, and such list may be amended whenever the Board shall so direct.

Division 2-General Nurses' Training Hospitals.

- 19. (1) For the purpose of these regulations the Board may classify general nurses' training hospitals into two classes, to be known as Class A and Class B, and may determine the period of training necessary in the training hospitals so classified, respectively.
 - (2) For the purposes of such classification-
 - (a) Class A general nurses' training hospitals shall be those which have a daily average of not less than forty occupied beds, excluding midwifery cases; and
 - (b) Class B general nurses' training hospitals shall be those which have a daily average of not less than twenty occupied beds, excluding midwifery cases.
- 20. Every hospital which is capable of being classified as a Class A or Class B general nurses' training hospital under regulation 19 (2) of these regulations may be approved by the Board as a general nurses' training hospital, provided such hospital fulfils and continues to fulfil the following conditions, namely:—
 - (a) The matron is a registered general and midwifery nurse who, in the opinion of the Board, has had adequate experience to undertake the training of general nurses and who holds nursing certificates approved by the Board.
 - (b) The buildings, equipment, and other facilities provided are suitable and adequate for the training of general nurses and suitable and adequate residential accommodation is also provided for trainees.
 - (c) In the case of a Class A general nurses' training hospital, when the whole of the training is undertaken in such hospital, a course is provided for a minimum period, exclusive of sick leave and leave other than ordinary leave, of three years or such longer period as the Board may determine by resolution notified in the Government Gazette.
 - (d) In the case of a Class B general nurses' training hospital, when the whole of the training is undertaken in such hospital a course of training is provided for a minimum period, exclusive of sick leave and leave other than ordinary leave, of four years or such longer period as the Board may determine by resolution notified in the Government Gazette.
 - (e) The trainees receive practical instruction in the wards of the hospital from the matron or another registered general nurse.
 - (f) Provision is made for systematic courses of instruction in theoretical and practical nursing during the period of training by duly qualified and registered medical practitioners and the matron of such hospital, or by lecturers approved by the Board, in accordance with the curriculum prescribed in Appendix III to these regulations.
 - (g) Provision is made for the examination of the trainees undergoing instruction at the end of each yearly course of lectures and demonstrations in the subjects taught and the results of such examinations are furnished to the Board in the annual report mentioned in paragraph (k) hereof.
 - (h) Provision is made for the issue to trainees of certificates at the conclusion of their final course of lectures that they have attended the systematic courses of lectures and received practical instruction in accordance with the curriculum prescribed in Appendix III to these regulations and have passed examinations in all the subjects prescribed therein.
 - (i) The staff includes at least two registered general nurses who, in the opinion of the Board, have adequate experience to undertake the training of general nurses.
 - \cdot (j) The hospital is, in the opinion of the Board, being conducted and managed in an efficient manner.
 - (k) The management undertakes t_0 furnish annually to the Board a report in accordance with the Form No. 10 in Appendix I. to these regulations containing the required information in regard to the particulars therein mentioned.
- 21. In relation to Government hospitals which are approved by the Board as general nurses' training hospitals, Wooroloo Sanatorium shall be deemed to be a hospital for the purposes of these regulations, but the wards thereof shall be regarded as medical wards and the period of training in such wards shall not exceed three months.

Division 3-Children's Nurses' Training Hospitals.

- 22. Upon application, a children's hospital which it is desired shall be approved by the Board as a children's nurses' training hospital, may be approved by the Board if such hospital fulfills and continues to fulfill the following conditions, namely:—
 - (a) The matron is a registered general and midwifery nurse who in the opinion of the Board has had adequate experience to undertake the training of children's nurses and holds nursing certificates approved by the Board.
 - (b) The buildings, equipment, and other facilities provided are suitable and adequate for the training of children's nurses and suitable and adequate residential accommodation is also provided for trainees.
 - (c) A course of training is provided for a minimum period, exclusive of sick leave and leave other than ordinary leave, of three years, or such longer period as the Board may determine by resolution notified in the Government Gazette.
 - (d) The daily average is not less than 40 occupied beds.
 - (e) The trainees receive practical instruction in the wards of the hospital from the matron or another registered children's nurse.
 - (f) Provision is made for systematic courses of instruction in theoretical and practical nursing during the period of training by duly qualified and registered medical practitioners and the matron of such hospital, or by lecturers approved by the Board in accordance with Appendix III. of these regulations.

- (g) Provision is made for the examination of the trainees undergoing instruction at the end of each yearly course of lectures and demonstrations in the subjects taught and the results of such examinations are furnished to the Board in the annual report mentioned in paragraph (k) hereof.
- (h) Provision is made for the issue to trainees of certificates at the conclusion of their final course of lectures that they have attended the systematic courses of lectures and received practical instruction in accordance with the curriculum prescribed in Appendix III. to these regulations, and have passed examinations in all the subjects prescribed therein.
- (i) The staff includes at least three nurses registered as general and children's nurses who, in the opinion of the Board, have adequate experience to undertake the training of children's nurses.
- (j) The hospital is in the opinion of the Board being conducted and managed in an efficient manner.
- (k) The management undertakes to furnish annually to the Board a report in accordance with the Form No. 10 in Appendix I. to these regulations containing the required information in regard to the particulars therein mentioned.

Division 4-Infant Health Nurses' Training Hospital.

- 23. Upon application, a hospital which it is desired shall be approved by the Board as an infant health nurses' training hospital may be approved by the Board if such hospital fulfills and continues to fulfill the following conditions, namely:—
 - (a) The matron or sister in charge is a registered general, midwifery and infant health nurse who, in the opinion of the Board, has had adequate experience to undertake the training of infant health nurses and holds nursing certificates approved by the Board.
 - (b) Adequate provision is made in the hospital for-
 - (i) residential accommodation for trainees;
 - (ii) accommodation for not less than four nursing mothers and their babies;
 - (iii) a sitting and dining room for mothers;
 - (iv) a special ward, properly equipped, for premature babies;
 - (v) not less than four cots for artificially fed babies, not including premature babies;
 - (vi) facilities for examination of cases, breast stimulation, test feedings, and weighing and measuring babies;
 - (vii) bathing and dressing facilities;
 - (viii) a properly equipped food dispensary;
 - (ix) a lecture and demonstration room;
 - (x) an emergency isolation room;
 - (xi) sun verandahs;
 - (xii) facilities for practical instruction in office work and keeping of records.
 - (c) During the course of training of trainees in the hospital, relative proportions of nursing staff and cots are maintained to the satisfaction of the Board, and the numbers of babies received or born in the hospital are, in the opinion of the Board, sufficient to warrant the approval by the Board of the hospital as an infant health nurses' training hospital.
 - (d) Provision is made in accordance with the curriculum prescribed in Appendix IV. to these regulations for— $\,$
 - (i) systematic courses of lectures by instructors approved by the Board; and
 - (ii) practical instruction in the wards from the matron or another registered nurse approved by the Board.
 - (e) Provision is made whereby there shall be not more than three courses of training in each year, each course of training is in accordance with the curriculum aforesaid, and each course of training extends over a period of not less than four months and includes at least twenty-one days at a district infant health centre approved by the Board for the purpose.
 - (f) Provision is made for the examination of the trainees undergoing instruction at the end of each course of lectures and demonstrations in the subjects taught and the results of such examinations are furnished to the Board in the annual report mentioned in paragraph (i) hereof.
 - (g) Provision is made for the issue to trainees of certificates at the conclusion of their final course of lectures that they have attended the systematic courses of lectures and received practical instruction in accordance with the curriculum prescribed in Appendix IV. to these regulations and have passed examinations in all the subjects prescribed therein.
 - (h) The hospital is, in the opinion of the Board, being conducted and managed in an efficient manner.
 - (i) The management undertakes to furnish annually to the Board a report in accordance with Form 11 in Appendix I. to these regulations and containing the required information in regard to particulars therein mentioned.
- 24. No infant health centre shall be approved by the Board for the purposes of paragraph (e) of regulation 23 hereof, unless—
 - (a) the buildings, equipment, appliances and daily average attendance are approved by the Board;
 - (b) the nurse in charge of the instruction at such infant health centre is a registered general, midwifery, and infant health nurse who, in the opinion of the Board, has had adequate experience to undertake the training of infant health nurses and holds certificates approved by the Board.

Division 5-Mental Nurses' Training Hospitals.

- 25. Upon application, a hospital being a hospital or reception house established or constituted under the Mental Treatment Act, 1927, or a hospital for the insane, licensed house or reception house constituted or appointed under the Lunacy Act, 1903-1920, which it is desired shall be approved by the Board as a mental nurses' training hospital may be approved by the Board if it fulfils and continues to fulfil the following conditions, namely:—
 - (a) The matron and head attendant are registered mental nurses who, in the opinion of the Board, have had adequate experience to undertake the training of mental nurses.
 - (b) The buildings, equipment, and other facilities provided are suitable and adequate for the training of mental nurses and suitable and adequate residential accommodation is also provided for trainees.
 - (c) A course of training is provided for a minimum period (exclusive of sick leave and leave other than ordinary leave) of three years or such longer period as the Board may determine by resolution published in the Government Gazette.
 - (d) The daily average is not less than 100 occupied beds.
 - (e) The trainees receive practical instruction in the wards of the hospital from the matron, head attendant, or another registered mental nurse.
 - (f) Provision is made for systematic courses of instruction in theoretical and practical nursing during the period of training by duly qualified and registered medical practitioners and the matron or head attendant of such hospital, or by lecturers approved by the Board in accordance with the curriculum prescribed in Appendix V to these regulations.
 - (g) Provision is made for the examination of trainees undergoing instruction at the end of each yearly course of lectures and demonstrations in the subjects taught and the results of such examinations are furnished to the Board in the annual report mentioned in paragraph (k) hereof.
 - (h) Provision is made for the issue to trainees of certificates at the conclusion of their final course of lectures that they have attended the systematic courses of lectures and received practical instruction in accordance with the curriculum prescribed in Appendix V to these regulations and have passed examinations in all the subjects prescribed therein.
 - (i) The staff includes at least two registered mental nurses who are also registered general nurses and who in the opinion of the Board have had adequate experience to undertake the training of mental nurses.
 - (j) The hospital is, in the opinion of the Board, being conducted and managed in an efficient manner.
 - (k) The management undertakes to furnish annually to the Board a report in accordance with the Form No. 12 in Appendix I to these regulations containing the required information in regard to particulars therein mentioned.

Division 6-Midwifery Nurses' Training Hospitals.

- 26. Upon application a hospital which it is desired shall be approved by the Board as a midwifery nurses' training hospital may be approved by the Board if it fulfils and continues to fulfil the following conditions, namely:—
 - (a) The matron is a registered general, midwifery and infant health nurse who in the opinion of the Board has had adequate experience to undertake the training of midwifery nurses.
 - (b) The buildings, equipment and other facilities provided are suitable and adequate for the training of midwifery nurses and suitable and adequate residential accommodation is also provided for trainees.
 - (c) A course of training is provided for a period of—(a) not less than eighteen months in the case of an untrained woman; (b) not less than nine months in the case of a registered general nurse; and (c) not less than fifteen months in the case of a registered mental nurse or such longer period as the Board may determine by resolution published in the Government Gazette.
 - (d) The daily average is not less than 60 occupied maternity beds.
 - (e) The trainees receive practical instruction in the wards of the hospital from the matron or another registered midwifery nurse.
 - (f) Provision is made for systematic courses of instruction in theoretical and practical nursing during the period of training by duly qualified and registered medical practitioners and the matron of such hospital, or by lecturers approved by the Board, in accordance with the curriculum prescribed in Appendix VI. to these regulations.
 - (g) Provision is made for the examination of trainees undergoing instruction at the end of each course of lectures and demonstrations in the subjects taught and the results of such examinations are furnished to the Board in the annual report mentioned in paragraph (k) hereof.
 - (h) Provision is made for the issue to trainees of certificates at the conclusion of their final course of lectures that they have attended the systematic courses of lectures and received practical instruction in accordance with the curriculum prescribed in Appendix VI. to these regulations and have passed examinations in all the subjects prescribed therein.
 - (i) The staff includes at least two nurses registered as general, midwifery and infant health nurses who, in the opinion of the Board, have had adequate experience to undertake the training of midwifery nurses.
 - (j) The hospital is, in the opinion of the Board, being conducted and managed in an efficient manner.
 - (k) The management undertakes to furnish annually to the Board a report in accordance with the Form No. 13 in Appendix I. to these regulations containing the required information in regard to the particulars therein mentioned.

PART V .- TRAINING AND EXAMINATION OF NURSES.

- 27. (1) Applicants for admission as trainees into an approved training hospital shall, unless the Board otherwise approves, be at least 18 years of age, except in the case of a trainee as a midwifery nurse, in which case she shall be at least 21 years of age.
- (2) Application shall be made to the matron of the training hospital or, in the case of Government hospitals, to the Principal Medical Officer.
- (3) The application shall be in the handwriting of the applicant and signed by the applicant and shall be accompanied by—(a) a certificate of birth; (b) three personal references; (c) a certificate of physical and mental fitness from a legally qualified medical practitioner, and (d) except in the case of applicants for admission as trainees in a mental nurses' training hospital, a certificate that he or she has passed the examination prescribed in the next succeeding regulation.
- 28. An applicant referred to in the preceding regulation shall be required before commencing his or her training to have passed an examination in general education conducted by the Board, unless he or she holds a Junior Certificate or Eighth Standard Certificate recognised by the Education Department.

Provided that, in the case of an applicant for admission as a trainee in a mental nurses' training hospital such person may be admitted as a trainee without having passed the examination aforesaid provided such trainee passes such examination before the completion of his or her probationary period, unless the Board in special circumstances otherwise approves, but in any case such trainee shall produce a certificate that he or she has passed such examination before being eligible to sit for the examination for registration hereinafter provided.

- 29. (1) Subject to the said qualifications, each applicant when admitted to a training hospital as a trainee shall enter such hospital on three months, probation, except in the case of a trainee as a midwifery nurse, in which case the period shall be two months.
- (2) No probationary period shall be required in the case of a trainee as an infant health nurse, but such trainee shall, before commencing her training, be a registered midwifery nurse in accordance with subsection 5 of section 5 of the Act.
- 30. Where a trainee has ceased training at any one training hospital, whether of his or her own accord or through dismissal, the Board shall have power to determine whether such trainee shall be permitted to enter another training hospital and to decide what period, if any, of the previous training, and what examinations shall be credited to him or her.

Division 1—Examinations.

- 31. The Board may from time to time as it thinks fit examine trainees in any of the courses of study prescribed for such trainees.
- 32. The Board may from time to time appoint such centres for examination as it may deem desirable.
 - 33. The examination of trainees shall be written, practical and oral.
- 34. A trainee shall be examined by the Board in the subjects prescribed in the course of study for the particular branch of nursing for which he or she desires registration.
- 35. (1) Candidates for admission to an examination for registration shall make application to the secretary of the Board in accordance with Form No. 14 in Appendix I to these regulations, not later than one month before the date of such examination.
- (2) The application shall be accompanied by the prescribed examination fee and a statement in accordance with the Form No. 14 aforesaid signed by the matron showing—(a) the date on which training commenced; (b) particulars of any period during which, apart from ordinary or holiday leave, a trainee may have been unavoidably absent from duty from illness or other cause; (c) that the applicant has attended the prescribed course of lectures and passed the necessary examinations; (d) that the applicant has had the practical experience prescribed by these regulations, and (e) in the case of a trainee as a midwifery nurse that she has attended and watched (under supervision satisfactory to the Board) the progress of not fewer than 20 labours, made abdominal and vaginal examinations during the course of labour and has personally delivered the patient, and nursed (to the satisfaction of the person certifying) not fewer than 20 lying-in women and their children during the ten days following labour.
- 36. A trainee shall not be eligible to sit for examination for registration until he or she has completed the prescribed period of training; passed all the examinations conducted by the management of the training hospital and/or by the Board in the courses prescribed, and has otherwise complied with the requirements of these regulations. Provided that, in the event of the end of a trainee's period of training falling between two examinations he or she may sit for the examination to be held nearest to the finishing date of his or her training period, but such trainee shall nevertheless complete his or her term of training before receiving a certificate of registration.
- 37. The examination papers for every examination shall be sent sealed to the various centres, where at the time appointed for the examination the seals shall be broken in the presence of the candidates and the papers shall be given out. After the close of the examination the papers of the candidates shall be forwarded to the examiners who shall report the result of the examination to the Board.
- 38. Each candidate for an examination shall be provided with a numbered card. Sealed envelopes containing numbered cards, shall be sent to the various centres and be distributed among the candidates immediately before the distribution of the examination papers.

- 39. (1) The oral examination of candidates for examination shall be conducted at each centre by the local examiners appointed as provided in the Act, and shall be held after the written examination, on a date to be fixed by the examiners.
- (2) For every oral examination the maximum number of marks to be allotted in each subject shall be fifty.
- 40. Upon the completion of the written, practical and oral examination of candidates, the examiners shall forward to the Board a report on each candidate examined.
- 41. The scope of the lectures and examinations shall be in accordance with the curricula in Appendices III., IV. V. and VI. to these regulations.
- 42. In the event of a candidate failing to satisfy the examiners at the first examination for registration taken by him or her, such candidate may sit for one other examination for registration without payment of a further entrance fee, and at other such examinations upon payment on each occasion of a further entrance fee as prescribed in Appendix II. to these regulations.

Division 2-Attendance at Lectures, etc.

- 43. (1) The subjects of the several courses prescribed in Appendices III., IV., V. and VI. to these regulations shall be taken in the order stated in the Appendices aforesaid.
- (2) A trainee, to be eligible to sit for the examination held at the end of each course, shall attend at least two-thirds of the lectures and demonstrations prescribed for each course and until a trainee has passed such examination he or she shall not proceed to the next course or to the examination for registration, as the case may be; provided that in the case of partial failure or sickness, a trainee may, with the approval of the Board, be permitted to sit within three months for a supplementary examination in the subject or subjects failed in or missed on account of sickness.

Division 3-Registration of Nurses.

- 44. Every murse applying for registration under the Act shall make application to the Board in accordance with the Form No. 15 in Appendix I. to these regulations.
- 45. An applicant for registration as a general nurse who has completed the course of training and passed the examinations prescribed for registration as a children's nurse may be registered as a general nurse, provided she produces evidence to the Board that she has completed a further period of six months' training in the nursing of adults of both sexes in an approved general nurses' training hospital.
- 46. An applicant who has passed the examinations for registration and has otherwise complied with the requirements of these regulations shall be registered by the Board and shall receive a certificate to that effect in the Form No. 16 in Appendix I. to these regulations, signed by the examiners and by the chairman and secretary of the Board.
- 47. The certificate of the registration of a nurse applying for registration under subsection 6 of section 5 of the Act shall be in the Form No. 17 in Appendix I. aforesaid.
- 48. Registration of nurses shall be effected by a record in the register to be kept by the Board for the purpose, in accordance with section 3 (1) of the Act, which shall be in the Form No. 18 in Appendix I. aforesaid.
- 49. The badge to be issued to a registered murse shall be in the form and design prescribed in Form No. 19 in Appendix I. aforesaid, or in such other form and design as may be prescribed by the Board at any time.
- 50. Every nurse who desires to apply for re-registration under the provisions of section 11 (1) of the Act, shall make application to the Board in the Form No. 20 in Appendix I. to these regulations and lodge therewith the fee of one shilling prescribed by section 11 (2) of the Act.
- 51. The various fees payable under these regulations shall be those prescribed in Appendix II. to these regulations.
- 52. A copy of a certificate, or a duplicate badge, may be issued on payment of the prescribed fee, if it is proved to the satisfaction of the Board that the original certificate, or the original badge, as the case may be, has been lost or accidentally destroyed.

The course of training in a general nurses' training hospital or a Children's Nurses' training hospital shall, as a minimum course, be in accordance with the following curriculum:—

1. Lectures on general nursing and practical instruction to be given by the matron or tutor sister.

Medical and surgical lectures to be given by the resident and honorary medical or surgical staff.

Course 1.—Anatomy and Physiology, at least twelve lectures. General nursing, at least twelve lectures and twelve demonstrations.

Course 2.—Medical nursing, at least twelve lectures. Surgical nursing, at least twelve lectures.

Course 3.—Hygiene and infection, at least six lectures. Invalid cookery, at least ten lectures. Practical instruction shall also be given in invalid cookery.

- A three years' period of training shall be arranged as follows:— In the first year—Course 1.
 - In the second year—Course 2.

Provided that a nurse registered in another branch of nursing may be granted exemption in respect of the actual number of lectures and demonstrations in the same subjects attended during the period of training in that branch of nursing for which such nurse is registered, but may be required to pass an examination in all the subjects prescribed for mental nurses.

The scope of the subjects of instruction shall be as follows:-

Course 1.

- (a) Anatomy and physiology (excluding nervous system)-Introductory structure, skin, fat, muscles and their functions. Bone and its function, cartilage, the skull, the vertebrae. The limbs, joints, movements. Body cavities, surface anatomy. The blood, circulatory system, blood vessels, lymphatic system. The respiratory system, alimentary system, digestion and assimilation. Secretion and excretion, urinary system, endocrine glands.
- (b) First aid-Asepsis and antiseptics, haemorrhage, wounds. Artificial respiration, emergencies—fainting, burns, bites, suffocation, etc. Poisoning. Fractures, dislocations, sprains. Bandaging
- (c) Hygiene-Ventilation and warming, rest and exercise, water supply, washing and bathing, food supply.

Course 2.

(a) Anatomy and physiology of the nervous system-

Introduction, evolution of the nervous system in animals, the anatomy of the nervous system.

The cerebro-spinal system, brain, spinal cord, the involuntary nervous system.

The special senses. How the nervous system works.

(b) Elementary psychology-

What is mind. The normal mind, instincts, habits, behaviour and conduct, consciousness, reason, judgment, etc.

(c) Subconsciousness or the unconscious mind-

The unconscious mind, repression sleep, dreams, phantasy, conversion, projection, dissociation, sublimation.

(d) Causes of nervous and mental diseases-

Heredity, physiogenic. Psychogenic.

(e) Signs and symptoms of nervous and mental diseases-Disorders of sensation, disorders of movement, disorders of nutrition. Interaction of mind and body; postures, stigmata of degeneration.

Disorders of mental functions, estimation of mental conditions, disorders of perception, consecutive thought and memory. Delusions.

Disorders of volition, disorders, disorders of emotion, insane habits and pro-

pensities, insomnia.

(f) Nursing requirements in special forms of nervous and mental diseases-States of excitement and exaltation, recurrent states, alternating states, violence.

Chorea, epilepsy, the neuroses and pyschoneuroses, states of depression. States of delirium, states of confusion, states of stupor, states of delusion. States of mental enfeeblement, dementia, dementia praecox, senile mental disorders.

Mental disorders due to alcohol and drugs, puerperal mental disorders, meningitis, apoplexy, hemiplegia, organic dementia.

Locomotor ataxia, general paralysis of the insane, paralysis agitans, disseminated sclerosis, ecrebral tumors, disease of the duetless glands.

(g) Congenital Mental Deficiency-

Physical pecularities of stigmata, psychological pecularities. Clinical types. Mental development in childhood. Intelligence tests and grading of mental defectives. Causation. Management and training of the mentally deficient.

(h) Management of wards-

Reception of patients, bathing occupation, recreation, amusement, sleep.

(i) Nursing in private homes-Points to be attended to, the principles of mental nursing.

Course 3.

(a) General nursing-

Requirements and management of sick room, cookery, diet, artificial feeding, administration of medicines, bed sores.

Observation of cases-temperature, pulse, respiration, charts and records. Antiseptic principles, general rules for nursing infectious diseases. Dressings and applications.

(b) Bodily diseases and disorders-

General symptoms and signs of disease, pain, headache, fever, etc.

Diseases of skin, muscles, bones, joints.

Diseases of the circulatory system, respiratory system.

Diseases, etc., digestive system, the urinary system.

General bodily diseases, disease due to micro-organisms.

The specific fevers.

(c) Invalid cookery-

The preparation of invalid drinks, the cooking of beef-tea, broths, poultry, fish, meats, eggs, light puddings, jellies, vegetables and fruits.

Invalid drinks-barley water, toast water, lemonade, apple water, gruel, white wine, whey, etc.

Beef juice.

Beef-tea, various methods.

Broths-chicken, mutton, etc.

Fish, filleting. Various methods of cooking.

Poultry-method of baking and boiling.

Chops and steak-various methods of cooking.

Brains and sweet-breads-various methods of cooking.

Custards and light puddings-baked and boiled custard, baked rice, rice custard, tapioca pudding, etc.

Jellies-wine and lemon.

Appendix VI.

CURRICULUM FOR TRAINING MIDWIFERY NURSES.

(Regulation No. 26 (f).)

The course of training in a midwifery nurses' training hospital shall, as a minimum course, be in accordance with the following curriculum:-

Curriculum.

Midwifery Nurses.

General anatomy and physiology, at least six lectures.

General nursing, at least eight lectures and eight demonstrations.

Midwifery, at least twenty lectures.

Obstetrical diagnosis, at least three demonstrations.

Infant feeding and mothercraft, at least six lectures.

Invalid cookery, at least ten lectures. Practical instruction shall also be given in invalid cookery.

Provided that during the period of training as a midwifery nurse a registered general nurse shall be required to attend lectures and demonstrations in midwifery, obstetrical diagnosis and infant feeding only, but may be required to pass an examination in all the subjects prescribed for midwifery nurses.

The scope of the subjects of instruction shall be as follows:-

1. Anatomy and Physiology-

The skeleton, names and functions of various bones; joints, nature of, chief varieties, functions, ball and socket, hinge, etc.

Nervous system, brief sketch of; brain, structure and functions; spinal cord, structure and functions; motor nerves, structure and functions.

The heart, structure and functions, its position.

The circulation.

The lungs, structure, position, functions. Respiration.

Digestion and absorption.

Saliva and salivary glands.

Position, structure and functions of-

The stomach, the small intestine, the colon (defaccation), the liver, the pancreas, the kidneys.

Secretion of urine. The ureters.

The bladder, its position and functions. Excretion.

The nrine, its composition and quantity.

The spleen, its position and functions.

The skin, its structure and functions. The sweat.

2. General nursing-

Outlines of anatomy and physiology; qualifications of a midwifery nurse; distinctions between the doctor's work and that of a nurse; bedmaking —management of helpless patients; hygiene of confinement room—ventilation, lighting, temperature, etc.; baths, sponging, etc.; infection—prevention and disinfection; use of clinical thermometer; the pulse, its variations and method of record; respiration, its method of record; external applications—preparation of poultices; fomentations, cold and hot packs, hot-air baths; asepsis (sterilisation of dressings, etc.); counter-irritation—leeches, blisters; various methods of administering drugs, enemata, subcutaneous injections (hypodermic, saline, etc.); lotions in common usc—strengths; rashes due to drugs, etc.; methods of observing symptoms and manner of reporting to the doctor; preparation for instrumental delivery; washing out uterus and curettage; instruments, their care and use; food—choice, care cleanliness and administration; bandaging—breast and leg; catheter—use of; urine testing; preparation of skin for operation—caesarean section.

3. Midwifery-

Anatomy of the pelvis and female organs of generation; pelvimetry; physiology of conception and development, signs and symptoms of pregnancy; hygiene and management of pregnancy; diseases and complications of pregnancy; abdominal pregnancy; abortions—symptoms, diagnosis, treatment; mechanism of labour; vertex, face brow, transverse and breech presentation; phenomena of labour; management of normal and abnormal labour; the normal puerperium and its management; complications of the puerperium; complicated labour—toxaemias of pregnancy, rupture of the nterus; haemorrhages—varieties and treatment; asepsis—anti-septics and their uses; abnormalities of child and pelvis; description and uses of appliances; duties of the midwife; obstetric emergencies and low they should be treated pending the arrival of the medical practitioner; manifestations of venereal disease; disinfection of person, clothing, and appliances; care of infants born apparently lifeless.

4. Infant Welfare-

Baths, attention to skin and buttocks; clothing; care of napkins; observation of stools; fresh air, exercise and rest; maternal nursing; care of the breasts; methods of artificial feeding up to one year; composition of human and cow's milk; care of milk and feeding utensils; composition of infant's foods and their deficiencies; growth and development of the child; nursing of premature infants.

5. Invalid Cookery-

The preparation of invalids' drinks, the cooking of beef-tea, broths, poultry, fish, eggs, light puddings, jellies, vegetables and fruits; invalid's drinks—barley water, toast water, lemonade, apple water, white wine, whey, ctc.; beef juice, beef tea, various methods; broths—chicken, mutton, etc.; fish—filleting, various methods of cooking; poultry—method of baking and boiling; brains, sweetbreads and tripe—various methods of cooking; chops and steak—various methods of cooking; custards and light puddings—baked and boiled custard; baked rice; rice custard, tapioca pudding, etc.; eggs—various methods of preparing; jellies—wine, lemon, etc.

6. Practical instruction-

Practical instruction shall include practical training—(a) in the duties of a midwifery nurse; (b) in the preparation of infants' foods; (c) in invalid cookery; and (d) in general nursing, so far as it applies to lying-in women and infants.
