Workers' Compensation Act, 1912-1944.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 10 of the Workers' Compensation Act, 1912-1944, that it shall be obligatory for every employer or group of employers to obtain from an incorporated insurance office, approved by the Minister, a policy of insurance for the full amount of the liability to pay compensation under this Act to all workers employed by him or them, but that if an employer or group of employers proves to the satisfaction of the Minister that such employer or group of employers has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability, the Governor may by Order in Council exempt such employer or group of employers from the operation of this section; and whereas Ernest Alexander Buckingham, of Claisebrook Road, East Perth, and James Thomas Buckingham, of Buckingham, via Collic, carrying on business together in partnership under the

registered firm name of "Buckingham Bros.," at Claisebrook Road, East Perth, and at Buckingham, via Collic, in this State, as sawmillers and timber merchants, are an employer or a group of employers within the meaning of the said Act, and as such are subject to the provisions of section 10 of the said Act, and have, in accordance with the regulations, made application for exemption from the operation of the said section; and whereas they have proved to the satisfaction of the Minister that as such employer or group of employers they have established a fund for insurance against the liability mentioned in the said section and have deposited securities, to wit, a certificate of fixed deposit account for five thousand pounds (£5,000) at the Union Bank of Australia, Limited, at Perth, in the name of the Honourable the Treasurer, Government of Western Australia, at the Treasury, charged with all payments to become due by them under the liability aforesaid: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the power conferred upon him by the said Act, doth hereby exempt the said Ernest Alexander Buckingham and the said James Thomas Buckingham, carrying on business as aforesaid under the registered firm name of Buckingham Bros., from the operation of section 10 of the Workers' Compensation Act, 1912-1944, for the period commencing as from the 1st day of June, 1947, and ending on the 1st day of June, 1949.

Land Drainage Act, 1925-1941.
By-laws.

PART I.

1.—Interpretation.

(a) The words "board," "district," "drain," "main drain," "occupier," "owner," "ratepayer," "watercourse," "works," "works or drainage works," shall have the meanings severally attached to them in the Land Drainage Act, 1925-1941, or any amendment thereof.

(b) "Minister" shall mean the Minister for Water Supply, Sewerage and Drainage acting in the exercise of the powers and authorities conferred on a Board in respect of each of the drainage districts to which these by-laws apply respectively.

PART II.

Protection of Water, Grounds, Works, etc., from
Trespass and Injury.

2.—Unauthorised Entry.

Trespassing within the fenced-off ground adjacent to or reserved for drainage works, or the entering without proper authority upon any works not open to the public, is prohibited.

3.—Camp Fires.

Camping or lighting of fires on any Government Drainage Reserve, except on land set apart for such purposes, is prohibited.

4.—Native Flora.

The removal, plucking or damaging of any wildflower, shrub, bush, tree or other plant growing on any land

reserved for or vested in the Minister within the drainage district is prohibited.

5.—Endangering Works.

No vehicle, conveyance, or animal shall be driven, taken, or ridden in such a manner as to endanger or damage any works, or shall cross the same, except at places where crossings have been provided.

6.—Rubbish.

No person shall cast away, throw, or deposit on any works any rubbish of any kind; or carry on any operations, or do any act which creates or tends to create any nuisance on any works, and no occupier shall allow any sillage from his land to enter in or upon any works.

7.—Unauthorised Water.

No person shall take or use or cause to be taken or used any water from any works without the Minister's authority.

8.—Interference with Works.

No person, without the Minister's authority, shall interfere in any way with any works or do anything likely to interfere with such works.

9.—Animals Straying.

No person owning or having the right of control of any animal shall drive or allow the same to stray upon any works. In the event of any contravention of this by-law the person guilty of such contravention shall, in addition to the penalties prescribed in by-law No. 12 hereunder, be liable for all damage that may thereby be caused to such works.

10.—Bathing.

No person, except with the express permission of the Minister first had and obtained, shall bathe in any drains, watercourses, or other works within the drainage district.

PART III.

11.—Drainage Rate.

(1) For the purpose of the drainage rate to be imposed under the Act, the financial year shall be the year ending on the 31st day of December.

(2) Every drainage rate shall be made and levied for the current year ending on the 31st day of December next ensuing.

PART IV.

12.—Breach of By-law—Penalties.

Any person committing a breach of any of the foregoing by-laws, or who shall refuse or neglect to obey any injunction in any such by-law, or to comply with any requirements therein contained, shall, upon conviction, be liable to a penalty not exceeding twenty pounds and, in the case of a continuing breach, a further penalty not exceeding five pounds for each day the offence continues after notice has been given by or on behalf of the Minister to the offender.

(4) The wages being paid to these workers will be altered proportionately, if and when necessary, to the alterations in the basic wages above declared by the application of the percentage where percentages are fixed in the award or industrial agreement and by direct proportion where the amount and not percentage is prescribed.

Contract of Employment.

(5) Payment shall be *pro rata* where the term of employment is for less than one (1) week.

No. 13 (84) of 1946.

Between Printing Industry Employees' Union of Australia, Western Australian Branch, Industrial Union of Workers, Perth, Applicant, and The Master Printers and Allied Trades Association of Western Australia (Union of Employers), Respondent.

HAVING heard Mr. G. W. Jones on behalf of the applicant and Mr. F. S. Cross on behalf of the respondents and by consent the Court in pursuance of the powers contained in section 92 of the Industrial Arbitration Act, 1912-1941, doth hereby order that Award, No. 6 of 1928, as amended, be further amended in the manner following:—

6.—Overtime.

Delete this clause and insert in lieu thereof the following:—

(a) Overtime shall be paid at the rate of time and a third for the first two (2) hours, time and a half for the next two (2) hours, and double time thereafter.

(b) Each day shall stand by itself.

(c) Work done on Saturday afternoon or Sunday shall be paid at double time rate.

(d) Work done on the days prescribed in clause 21 (a) hereof shall be paid for at double time rate.

21.—Holidays.

Delete this clause and insert in lieu thereof the following:—

(a) The following days, or the days observed in lieu thereof, shall, subject to clause 6 (d) hereof, be allowed as holidays without deduction of pay, namely, New Year's Day, Australia Day, Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, State Foundation Day, Christmas Day and Boxing Day.

(b) On any public holiday not prescribed as a holiday under this Award the employer's establishment or place of business may be closed, in which case a worker need not present himself for duty and payment may be deducted, but if work be done ordinary rates of pay shall apply.

(c) Except as hereinafter provided a period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve (12) months' continuous service with such employer.

(d) If any Award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(e) If after one month's continuous service in any qualifying twelve-monthly period a worker lawfully leaves his employment, or his employment is terminated by the employer through no fault of the worker, the worker shall be paid one-sixth of a week's pay at his ordinary rate of wage in respect of each completed month of continuous service.

(f) Any time in respect of which a worker is absent from work except time spent on holidays or annual leave as prescribed by this Award shall not count for the purpose of determining his right to annual leave.

(g) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled, subject to subclause (c) of this clause, to such leave on full pay as is proportionate to his length of service during that period with such employer, and if such leave is not equal to the leave given to the other workers he shall not be entitled to work or pay whilst the other workers of such employer are on leave on full pay.

(h) A worker who is dismissed for misconduct or who illegally severs his contract of service shall not be entitled to the benefit of the provisions of this clause.

(i) The provisions of this clause shall not apply to casual workers.

(j) The quantum of annual leave to be allowed to a worker shall, for service prior to 1st September, 1946, be calculated in accordance with the provisions of the Award applicable before that date, and for service subsequent to 1st September, 1946, in accordance with the provisions of this amendment.

IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

No. 235 (18) of 1946.

Between The Metropolitan and South-Western Federated Engine Drivers and Firemen's Union of Workers of Western Australia, Applicant, and State Electricity Commission of Western Australia, Respondent.

HAVING heard Mr. G. A. Bradshaw on behalf of the applicant and Mr. L. B. Crosbie on behalf of the respondent and by consent the Court in pursuance of the powers contained in section 92 of the Industrial Arbitration Act, 1912-1941, doth hereby order that Award No. 3 of 1938, as amended, be further amended in the manner following:—

1.—Definitions.

Item (4): Delete this item and insert in lieu thereof the following:—

(4) "Casual Worker" means a worker employed for less than one (1) week continuously, but does

not include a worker, who when work is available, leaves his employment before the expiration of one (1) week.

Insert the following new items:—

(9) "Temporary Worker" means a worker temporarily employed for a full week or more continuously but not appointed to a position on the regular staff.

(10) "Permanent Worker" means a worker who has been appointed to a position on the regular staff.

9.—Overtime and Special Rates for Sundays and Holidays.

Subclause (2): Strike out this subclause and insert in lieu thereof the following:—

(2) (a) Subject to subclause 1 (b), all time worked by day workers on Sundays, including casuals called upon for duty and required to work on such day, shall be paid at the rate of time and a half, with a minimum of seven (7) hours' work.

(b) Shift workers called upon to work on Sundays and the workers' rostered day off shall be paid at the rate of time and a half.

(c) Subject to subclause (1) (b), all time worked by casual workers called upon for duty and required to work on any of the public holidays referred to in clause 10A hereof, shall be paid at the rate of time and a half with a minimum of seven (7) hours' work.

(d) Liberty is reserved to the union to apply for amendment of paragraph (c) of this subclause at any time after the expiration of one month from the date of this order.

10.—Annual Leave.

Delete this clause and insert in lieu thereof the following new clauses:—

10.—Annual Leave.

(a) Except as hereinafter provided, a period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by the Commission after a period of twelve (12) months' continuous service with the Commission.

(b) (i) In addition to the leave hereinbefore prescribed, seven (7) day shift workers, that is, shift workers who are rostered to work regularly on Sundays and holidays shall be allowed seven (7) consecutive days' leave including non-working days.

(ii) Where an employee with twelve (12) months' continuous service is engaged for part of the twelve-monthly period as a seven (7) day shift worker, he shall be entitled to have the period of fourteen (14) consecutive days' annual leave, prescribed in subclause (a) hereof, increased by half a day for each month he is continuously engaged as aforesaid.

(c) Day workers employed at the East Perth Power House will be entitled to one day extra on their annual leave for every eight (8) Sundays worked during the year; Sunday work not to count for the purpose of this subclause unless at least three (3) hours' actual work is done.

(d) If any Award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(e) (i) Subject to paragraph (ii) when computing the annual leave due under this clause no deduction shall be made from such leave in respect of the period that a worker is on annual leave and/or holidays. Provided that no deductions shall be made for any approved period a worker is absent from duty through sickness with or without pay unless the absence exceeds three (3) calendar months, in which case deduction may be made for such excess only.

(ii) Approved periods of absence from work caused through accident sustained in the course of employment shall not be considered breaks in continuity of service, but the first six (6) months only of any such period shall count as service for the purpose of computing annual leave.

(f) In the event of a worker being employed by the Commission for portion only of a year, he shall only be entitled to such holidays on full pay as are proportionate to his length of service during that period with the Commission.

(g) Any worker who may resign or be dismissed from the service for any cause, other than for speculation or theft, shall be entitled to receive payment for any annual leave which may have been due up to the time of leaving the service. Provided always that if the worker has been dismissed for speculation or theft no claim for annual leave shall be recognised. Misconduct herein referred to shall not affect accumulated annual leave or payment therefor.

(h) When work is closed down for the purpose of allowing annual leave to be taken, workers with less than a full year's service shall only be entitled to payment during such period for the number of day's leave due to them. Provided that nothing herein contained shall deprive the Commission of its right to retain such workers at work during the close-down period as may be essential.

(i) "Ordinary wages" for the purpose of subclause (a) hereof shall mean the rate of wage the worker has received for the greatest proportion of the calendar month prior to his taking the leave.

(j) The provisions of this clause shall not apply to casual workers.

(k) Annual leave rights under this clause shall commence to accrue, in the case of permanent workers, as from the 1st July, 1946. In the case of temporary workers, such rights shall commence to accrue as from the date of this order.

(l) In computing the cash equivalent of each day's leave, it shall be taken on the basis of one-sixth (1/6th) of the pay for a normal forty-four (44) hours.

10A.—Public Holidays.

(a) Except as hereinafter provided, each of the following days, or the day observed in lieu thereof, shall be allowed as a holiday to all workers and be paid for, namely, New Year's Day, Australia Day (26th January), Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, Foundation Day, King's Birthday, Christmas Day and Boxing Day.

(b) Whenever any holiday falls on an employee's ordinary working day and the employee is not required to work on such day he shall be paid for the ordinary hours he would have worked on such day if it had not been a holiday. If he is required to work on a holiday he shall be paid for the time worked as if it was an ordinary working day and shall, in addition, be allowed a day's leave with pay to be added to the annual leave or to be taken at some subsequent date if the worker so agrees.

(c) In the case of workers working a five-day week, no payment or a day in lieu shall be granted for any public holiday falling on a Saturday.

(d) Payment for holidays shall be in accordance with the usual hours of work.

(e) When a worker is off duty owing to leave without pay or sickness, including accidents on or off duty, except time for which he is entitled to claim sick pay, any holiday falling during such absence shall not be treated as a paid holiday. Where the worker is on duty or available on the working day immediately preceding a holiday, or resumes duty, or is available on the working day immediately following a holiday, as prescribed in this clause, the worker shall be entitled to a paid holiday on all such holidays.

(f) A casual worker shall not be entitled to payment for any holiday referred to in this clause.

Between Coastal District Committee Amalgamated Engineering Union Association of Workers, Applicant, and The State Electricity Commission, Respondent.

HAVING heard Mr. J. F. Newman on behalf of the applicant and Mr. L. B. Crosbie on behalf of the respondent and by consent the Court in pursuance of the powers contained in section 92 of the Industrial Arbitration Act, 1912-1941, doth hereby order that Award, Nos. 5 and 6 of 1937, as amended, be and the same is further amended in the manner following:—

39.—Annual Leave, Holidays and Sunday Pay.

Subclause (b): Delete this subclause.

Subclause (1): Insert a new subclause as follows:—

“The provisions of this clause shall apply only to workers employed by the Commissioner of Railways in connection with the Tramways.”

Subclause (m): Insert a new subclause as follows:—

“Liberty is reserved to the Commissioner of Railways or to the applicant associations to apply for further amendment of this clause at any time after the 31st day of March, 1947.”

Insert a new clause as follows:—

39A.—Annual Leave (Electricity Commission).

(a) Except as hereinafter provided, a period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by the Commission after a period of twelve (12) months' continuous service with the Commission.

(b) All workers employed at the East Perth Power House will be entitled to one day extra on their annual leave for every eight (8) Sundays worked during the year; Sunday work not to count for the purpose of this subclause unless at least three (3) hours' actual work is done.

(c) If any Award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(d) (i) Subject to paragraph (ii), when computing the annual leave due under this clause no deduction shall be made from such leave in respect of the period that a worker is on annual leave and/or holidays: Provided that no deductions shall be made for any approved period a worker is absent from duty through sickness with or without pay unless the absence exceeds three (3) calendar months, in which case deduction may be made for such excess only.

(ii) Approved periods of absence from work caused through accident sustained in the course of employment shall not be considered breaks in continuity of service, but the first six (6) months only of any such period shall count as service for the purpose of computing annual leave.

(e) In the event of a worker being employed by the Commission for portion only of a year, he shall only be entitled to such holidays on full pay as are proportionate to his length of service during that period with the Commission.

(f) Any worker who may resign or be dismissed from the service for any cause, other than for peculation or theft, shall be entitled to receive payment for any annual leave which may have been due up to the time of leaving the service. Provided always that if the worker has been dismissed for peculation or theft no claim for annual leave shall be recognised. Misconduct herein referred to shall not affect accumulated annual leave or payment therefor.

(g) When work is closed down for the purpose of allowing annual leave to be taken, workers with less than a full year's service shall only be entitled to payment during such period for the number of days' leave due to them. Provided that nothing herein contained shall deprive the Commission of its right to retain such workers at work during the close-down period as may be essential.

(h) “Ordinary Wages” for the purpose of subclause (a) hereof shall mean the rate of wage the worker has received for the greatest proportion of the calendar month prior to his taking the leave.

(i) The provisions of this clause shall not apply to casual workers.

(j) Annual leave rights under this clause shall commence to accrue as from the 1st July, 1946.

(k) The provisions of this clause shall apply only to workers employed by the State Electricity Commission in connection with the East Perth Power Station and Electricity Supply.

Insert a further new clause as follows:—

39B.—Public Holidays and Sunday Pay (Electricity Commission).

(a) Except as hereinafter provided, each of the following days, or the day observed in lieu thereof, shall be allowed as a holiday to all workers and be paid for, namely: New Year's Day, Australia Day (26th January), Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, Foundation Day, King's Birthday, Christmas Day and Boxing Day.

(b) Whenever any holiday falls on an employee's ordinary working day and the employee is not required to work on such day he shall be paid for the ordinary hours he would have worked on such day if it had not been a holiday. If he is required to work on a holiday he shall be paid for the time worked as if it was an ordinary working day and shall, in addition, be allowed a day's leave with pay to be added to the annual leave or to be taken at some subsequent date if the worker so agrees.

(c) In the case of workers working a five-day week, no payment or a day in lieu shall be granted for any public holiday falling on a Saturday.

(d) Payment for holidays shall be in accordance with the usual hours of work.

(e) When a worker is off duty owing to leave without pay or sickness, including accidents on or off duty, except time for which he is entitled to claim sick pay, any holiday falling during such absence shall not be treated as a paid holiday. Where the worker is on duty or available on the working day immediately preceding a holiday, or resumes duty, or is available on the working day immediately following a holiday, as prescribed in this clause, the worker shall be entitled to a paid holiday on all such holidays.

(f) A casual worker shall not be entitled to payment for any holiday referred to in this clause.

(g) Sunday time shall be paid for at the rate of time and a half for the first two (2) hours and double time thereafter.

(h) The provisions of this clause shall apply only to workers employed by the State Electricity Commission in connection with the East Perth Power Station and Electricity Supply.

Browne on behalf of the respondents and by consent the Court in pursuance of the powers contained in section 92 of the Industrial Arbitration Act, 1912-1941, doth hereby order that Award, No. 10 of 1937, made between the abovenamed parties be and the same is hereby amended in the manner following:—

6.—Hours.

Delete this clause and insert in lieu thereof the following:—

The ordinary hours of work shall be as follow:—

(a) Forty-four (44) hours shall constitute a week's work.

(b) Except as provided in subclause (c) hereof the hours of work shall be performed as follow:—

(i) Monday to Friday inclusive between the hours of 8.30 a.m. and 5.30 p.m.;

(ii) Saturday between the hours of 8.30 a.m. and 1 p.m.

(c) The hours of workers employed in shops comprised in the Fourth Schedule of the Factories and Shops Act shall be worked to suit the convenience of the employer. Provided that the worker shall be notified of the half day (which shall be granted to and taken by the worker on an afternoon of each week) upon which his or her services shall not be required.

(d) The spread of ordinary hours for all workers bound by this Award shall not inclusive of meal hour exceed nine (9) hours in any one day.

7.—Meal Times.

Delete the words "One hour shall be given and taken for meals" wherever they appear in this clause and insert in lieu thereof the following: "Not less than one hour, nor more than one hour and six (6) minutes shall be given and taken for meals."

IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

No. 235 (17) of 1946.

Between Australian Workers' Union, Westralian Branch Industrial Union of Workers, Applicant, and Hon. Minister for Education and Hon. Minister for Agriculture, Respondents.

HAVING heard Mr. W. Hodsdon on behalf of the applicant and Mr. C. A. Reeve on behalf of the respondents and by consent the Court in pursuance of the powers contained in section 92 of the Industrial Arbitration Act, 1912-1941, doth hereby order that Award, No. 33 of 1941, be and the same is hereby amended in the manner following:—

5.—Holidays.

Delete this clause and insert in lieu thereof the following:—

5.—Annual Leave and Public Holidays.

(i)—Annual Leave:

(a) Except as hereinafter provided a period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve (12) months' continuous service with such employer.

(b) If any Award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(c) (i) Subject to paragraph (ii), when computing the annual leave due under this clause no deduction shall be made from such leave in respect of the period that a worker is on annual leave and/or holidays. Provided that no deductions shall be made for any approved period a worker is absent from duty through sickness with or without pay unless the absence exceeds three (3) calendar months, in which case deduction may be made for such excess only.

(ii) Approved periods of absence from work caused through accident sustained in the course of employment shall not be considered breaks in continuity of service, but the first six (6) months only of any such period shall count as service for the purpose of computing annual leave.

(d) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled to such holidays on full pay as are proportionate to his length of service during that period with such employer.

(e) A worker may be rostered off and granted annual leave with payment of ordinary wages as prescribed prior to his having completed a period of twelve (12) months' continuous service, in which case should the services of such worker terminate or be terminated prior to the completion of twelve (12) months' continuous service the said worker shall refund to the Minister the difference between the amount received by him for wages in respect of the period of his annual leave and the amount which should have accrued to him by reason of the length of his service up to the date of the termination of his services.

(f) Any worker who may resign or be dismissed from the service for any cause, other than for peculation or theft, shall be entitled to receive payment for any annual leave which may have been due up to the time of leaving the service. Provided always that if the worker has been dismissed for peculation or theft no claim for annual leave shall be recognised. Misconduct herein referred to shall not affect accumulated annual leave or payment therefor.

(g) "Ordinary wages" for the purpose of subclause (a) hereof shall mean the rate of wage the worker has received for the greatest proportion of the calendar month prior to his taking the leave.

(h) Annual leave rights under this clause shall commence to accrue as from 1st January, 1946.

(ii)—Public Holidays:

(a) Except as hereinafter provided, each of the following days, or the day observed in lieu thereof, shall be allowed as a holiday to all workers and be paid for, namely, New Year's Day, Australia Day (26th January), Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, Foundation Day, King's Birthday, Christmas Day and Boxing Day.

(b) Whenever any holiday falls on an employee's ordinary working day and the employee is not required to work on such day he shall be paid for the ordinary hours he would have worked on such day if it had not been a holiday. If he is required to work on a holiday he shall be paid for the time worked as if it was an ordinary working day and shall, in addition, be allowed a day's leave with pay to be added to the annual leave or to be taken at some subsequent date if the worker so agrees.

(c) In the case of workers working a five-day week, no payment or a day in lieu shall be granted for any public holiday falling on a Saturday.

(d) Payment for holidays shall be in accordance with the usual hours of work.

(e) When a worker is off duty owing to leave without pay or sickness, including accidents on or off duty, except time for which he is entitled to claim sick pay, any holiday falling during such absence shall not be treated as a paid holiday. Where the worker is on duty or available on the working day immediately preceding a holiday, or resumes duty, or is available on the working day immediately following a holiday, as prescribed in this clause, the worker shall be entitled to a paid holiday on all such holidays.

INDUSTRIAL AGREEMENT.

No. 15 of 1947.

(Registered 2/4/1947.)

THIS Agreement made in pursuance of the Industrial Arbitration Act, 1912-1941, this 20th day of March, 1947, between the Minister for Works (hereinafter referred to as "the Minister") of the one part and the Federated Engine Drivers and Firemen's Association of Australasia West Australian Branch Association of Workers (hereinafter referred to as "the Union") of the other part, the parties hereto mutually covenant and agree as follows:—

1.—Area and Scope.

This Agreement shall apply to those Pumping Stations controlled by the Minister for Works and Water Supply as specifically referred to in clause 5 (a) hereof.

2.—Term.

The term of this Agreement shall be for one year from the date hereof.

3.—Definitions.

(a) Wherever the term "Pumper-in Charge" is referred to herein, it shall mean a worker who is employed as a Pumper-in-Charge-engine driver.

(b) Wherever the term "Second Pumper" is referred to herein, it shall mean a worker who is employed as a Second Pumper-engine driver.

(c) "Engineer" means the officer occupying for the time being the position of Engineer, Goldfields Water Supply, Hydraulic Engineer, or any Executive officer of the aforesaid engineers, as the case may be.

4.—Hours.

(a) Forty-four (44) hours shall constitute a week's work.

(b) Such ordinary hours shall not exceed eight (8) hours on the first five days of the week and four (4) hours on Saturdays. Provided that employees shall, if required, work seven (7) shifts, each of eight (8) hours in the week. Sunday time to stand alone.

(c) The hours of labour shall include all time occupied in raising steam or gas, banking fires, starting up or closing down of engines.

(d) Where circumstances permit, a regular starting and finishing time may be fixed by agreement in writing between the Union and the Department or its representative.

(b) Where a Pumper-in-Charge or Second Pumper is required to attend an electric generator exceeding 10 kilowatt capacity, he shall be paid an extra margin of 6s. per week.

(c) In addition to the margins prescribed in subclause (a) of this clause:

(i) The Pumpers-in-Charge at Barbalin, Waddouring, Knungagin, Narambeen, and Kondinin, shall be paid an extra margin of 15s. per week to cover all overtime worked in addition to such special duties as defined in clause 6 hereof.

(ii) The Pumpers-in-Charge at Meckering, Station Creek, Meekatharra, Nallan, Ora Banda and Menzies shall be paid an amount of 19s. per week to cover all overtime worked in any case where such a worker is required to work 100 hours or more in any one fortnight.

6.—Special Duties.

All Pumpers-in-Charge and the Second Pumpers at Barbalin and Waddouring shall be required to undertake maintenance and repair work on the water mains and reticulations, fix and cut off services, read, remove and replace meters when necessary in addition to the duties in and around the pumping station.

7.—No Reduction.

This Agreement shall not of itself operate to reduce the wage of any worker who is at the date of the Agreement receiving above the minimum rate prescribed for his class of work.

8.—Quarters.

(a) Pumpers-in-Charge:

(i) Except as hereinafter provided, where free quarters or fuel, light and water are not provided for a Pumper-in-Charge, an allowance as agreed upon between the department and the worker concerned, or in default of agreement as fixed by a Board of Reference, shall be paid to such worker.

(ii) The Pumper-in-Charge at Pingelly shall be paid an amount of 12s. per week, and the Pumper-in-Charge at Menzies an amount of 10s. per week in lieu of free quarters, fuel, light, and water.

(b) Second Pumpers:

(i) Where quarters are provided for a Second Pumper, an amount as agreed upon between the Department and the worker concerned, or in default of agreement as fixed by a Board of Reference, shall be deducted for rent from the wages of the said worker by the Department.

(ii) Where free fuel, light and water are not provided for a Second Pumper, an allowance as agreed upon between the Department and the worker concerned, or in default of agreement as fixed by a Board of Reference, shall be paid to such worker.

9.—District Allowances.

District allowances, calculated on the rates specified below, shall be paid to workers employed at the under-mentioned stations:—

10.—Shift Work.

(a) Pumpers-in-Charge:

Pumpers-in-Charge shall take day shift or portion of day shift as necessary to meet the requirements of pumping.

(b) Second Pumpers:

(i) Where only one Second Pumper is employed, the Pumper-in-Charge may rotate with the Second Pumper and the shifts shall be as mutually arranged between themselves, or in default of agreement as fixed by the Engineer.

(ii) Where two Second Pumpers are employed, they shall work a weekly rotation of afternoon and night shifts between themselves.

(iii) Where three Second Pumpers are employed they shall rotate day, afternoon, and night shifts amongst themselves.

(c) Where pumping is necessary outside of the hours of 8 a.m. to noon on a Saturday, or on a Sunday, each Second Pumper shall take up to an eight (8) hours shift, provided that, if the circumstances in the opinion of the Pumper-in-Charge require his special attention, he may take a shift.

(d) Second Pumpers, when employed on afternoon or night shift, shall be paid five per cent. (5%) in addition to their ordinary rates for such shifts in accordance with subclause (e) hereof.

(e) For the purpose of assessing the payment of loading for shift work the following shall be the recognised hours of the various shifts:—

- Day shift—8 a.m. to 4 p.m.
- Afternoon shift—4 p.m. to 12 midnight.
- Night shift—12 midnight to 8 a.m.

11.—Overtime.

With respect to Second Pumpers—

(a) All time worked in excess of the normal working hours of each day during week days shall be paid at the rate of time and a half for the first four (4) hours and double time thereafter.

(b) All time worked on Sundays shall stand alone and be paid for at time and a half.

(c) Should a worker be called back for any purpose after completing his continuous shift for the day, he shall receive a minimum of two (2) hours' overtime, but if he is called out more than once within any period of two (2) hours of a call, he shall not be entitled to additional payment unless the time actually worked at overtime rates exceeds two (2) hours.

12.—Annual Leave.

(a) (i) Except as hereinafter provided a period of two consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve months' continuous service with such employer.

(ii) Seven day shift workers, i.e., shift workers who are rostered to work regularly on Sundays and holidays, shall be allowed, in addition to clause (a) (i) hereof, seven consecutive days' leave including non-working days.

Where an employee with twelve months' continuous service is engaged for part of the twelve-monthly period as a seven day shift worker he shall be entitled to have the part of two weeks' consecutive days annual leave described in subclause (a) (i) hereof increased by half a day for each month he is continuously engaged as aforesaid.

(b) If any Award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(c) (i) Subject to paragraph (ii) when computing the annual leave due under this clause no deduction shall be made from such leave in respect of the period that a worker is on annual leave and/or holidays: Provided that no deductions shall be made for any approved period a worker is absent from duty through sickness with or without pay unless the absence exceeds three (3) calendar months, in which case deduction may be made for such excess only.

(ii) Approved periods of absence from work caused through accident sustained in the course of employment shall not be considered breaks in continuity of service, but the first six months only of any such period shall count as service for the purpose of computing annual leave.

(d) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled to such holidays on full pay as are proportionate to his length of service during that period with such employer.

(e) Any worker who may resign or be dismissed from the service for any cause, other than for pecculation or theft, shall be entitled to receive payment for any annual leave which may have been due up to the time of leaving the service: Provided always that if the worker has been dismissed for pecculation or theft no claim for annual leave shall be recognised. Misconduct herein referred to shall not affect accumulated annual leave or payment therefor.

(f) Workers regularly working for the Government North of South Latitude 26 shall be allowed to accumulate annual leave for two years, subject to the convenience of the Department. Such workers who proceed to Fremantle and Geraldton during the period of such leave shall be allowed once in each two years reasonable travelling time on the forward and return journeys between the place of their employment and either of the said Ports.

(g) "Ordinary wages" for the purpose of subclause (a) hereof shall mean the rate of wage the worker has received for the greatest proportion of the calendar month prior to his taking the leave.

(h) The provisions of this clause shall not apply to casual workers.

(i) Annual leave rights under this clause shall commence to accrue as from 1st January, 1946.

13.—Public Holidays.

(a) Except an hereinafter provided, each of the following days, or the day observed in lieu thereof, shall be allowed as a holiday to all workers and be paid for, namely: New Year's Day, Australia Day (26th January), Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, Foundation Day, King's Birthday, Christmas Day and Boxing Day.

(b) Whenever any holiday falls on an employee's ordinary working day and the employee is not required to work on such day he shall be paid for the ordinary hours he would have worked on such day if it had not been a holiday. If he is required to work on a holiday he shall be paid for the time worked as if it was an ordinary working day and shall, in addition, be allowed a day's leave with pay to be added to the annual leave or to be taken at some subsequent date if the worker so agrees.

(c) In the case of workers working a five day week, no payment or a day in lieu shall be granted for any public holiday falling on a Saturday.

(d) Payment for holidays shall be in accordance with the usual hours of work.

(e) When a worker is off duty owing to leave without pay or sickness, including accidents on or off duty, except time for which he is entitled to claim sick pay, any holiday falling during such absence shall not be treated as a paid holiday. Where the worker is on duty or available on the working day immediately preceding a holiday, or resumes duty, or is available on the working day immediately following a holiday, as prescribed in this clause, the worker shall be entitled to a paid holiday on all such holidays.

(f) A casual worker shall not be entitled to payment for any holiday referred to in this clause.

14.—Casual Workers.

Casual workers shall be paid 10 per cent. (10%) over the usual rate in this Agreement for the employee's occupation. A casual worker is one for whom work, over a period of six (6) consecutive days, not counting holidays is not provided by the employer.

15.—Contract of Service.

(a) Except in the case of a casual worker, whose engagement shall be by the hour, the contract of hiring of every worker shall be a weekly contract, terminable on either side by one (1) week's notice given on any day.

(b) Any worker not attending for duty shall lose his pay for the actual time of such non-attendance, subject to the provisions of clause 16 hereof, as to payment for absence on account of illness.

(c) This clause does not affect the right to dismiss for misconduct, in which case wages shall be paid up to the time of dismissal only.

(d) The employer shall be entitled to deduct payment for any day upon which the worker cannot be usefully employed because of any strike by the Union or Unions affiliated with it or by any other association or union or through any breakdown of the employer's machinery or from any other cause for which the employer is not responsible.

16.—Payment for Sickness.

(a) (i) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for one half ($\frac{1}{2}$) day for each completed month of service.

(ii) The liability of the employer hereunder shall in no case exceed one (1) week's wages during each calendar year in respect of each worker.

(iii) Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(b) This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

(c) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer, or his representative, of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) consecutive working days or more.

(d) No payment will be made for any absence due to the worker's own fault, neglect, or misconduct.

17.—Payment of Wages.

When an employee is discharged before the usual pay day he shall be paid his wages when he ceases work, or it shall be forwarded to his address the day after by registered post, at the employer's risk, unless the employee desires to collect it at the office.

18.—Travelling Time, Fares, Etc.

(a) When a worker is instructed to proceed on duty from the place where he is then or is usually employed, the employer shall pay all fares (including sleeper, where travelling is by rail and if considered necessary by the Engineer) and a proper allowance at current rates for all necessary meals or board and lodging.

(b) The time necessarily occupied by all workers in travelling on duty (including waiting time) shall be paid, subject as hereinafter provided, as from the time of departure of the train or other means of transport to the arrival at destination at the ordinary rate of wages attached to the place of departure, but not to exceed eight (8) hours per day. Overtime rates shall not apply. Sunday travelling time shall be paid for at the same rates and on the same conditions as on week days. When a worker is obliged to travel by road, a reasonable time for the road journey, as determined by the Engineer, shall be allowed. No worker shall lose any time by transfer.

(c) When a worker is engaged by the Department at a place other than at the place of employment and the employer does not provide for transport for the worker, the worker shall be entitled, on the completion of the job or after the completion of twelve (12) months' service on the job whichever should first occur, to a refund of the fare actually paid by him in travelling from the place of engagement (or from such other place as may be agreed upon between the Department and the worker) to the place of employment. The worker shall also be entitled in accordance with the provisions of subclause (e) hereof to a return fare free of cost. Provided that where a worker can travel by rail and elects to travel by other conveyance, the employer shall not be liable for payment of any expenses incurred by the worker unless the means of conveyance is approved by the Engineer prior to the journey and in no case shall the worker be entitled to expenses exceeding the cost of the fare that would have been involved if the worker had travelled by rail.

(d) Where the Department has paid the fare of a worker to enable him to proceed to a job, and such worker leaves the job of his own accord or is dismissed on account of misconduct or unsatisfactory work within six (6) weeks of time of engagement, the amount of the fare to the job may be deducted from any amounts due to such worker at the time of dismissal or the termination of his service and he shall forfeit privileges of fare returns to place of engagement or such other place as provided in subclause (c) hereof.

(e) Rail fares shall be first class in the case of Pumpers in Charge and second class in the case of Second Pumpers. Return fares by rail or other means of conveyance shall also be paid on completion of job or after twelve (12) months on job.

19.—Firing and Repairs.

(a) Pumpers-in-Charge shall do their own firing where necessary and shall carry out such maintenance and repairs to the plant as are necessary to maintain it in efficient running order.

(b) Second Pumpers shall do their own firing where necessary and shall also do such minor repairs to the plant as in the opinion of the Pumper-in-Charge can be done during their shift.

20.—Preference of Employment.

Preference of employment shall be given in respect of tasks for which rates of wages are specified in this Agreement, to members of The Federated Engine Drivers and Firemen's Association of Australasia, West Australian Branch Association of Workers.

21.—Interviewing Workers.

Provided he has previously notified the Engineer, any officer of the Union authorised in writing by the President and Secretary of the Union shall have the right to enter any place or premises during ordinary working

hours wherein members of such union covered by this Agreement are engaged, for the purpose of conversing with or interviewing the employees in such place or premises.

Provided that such officer shall not hamper or otherwise hinder the employees in the carrying out of their work. The Engineer shall determine whether employees are being hampered or hindered in their work.

22.—Inspection of Wages Sheets.

The wages sheets of the Department shall be open for inspection at the Local or Head Office by the Secretary or other authorised member of the Union, upon reasonable notice given of his desire to inspect same.

23.—Board of Reference.

(1) For the purpose of this Agreement, Boards of Reference are hereby appointed, which shall each consist of a chairman and two (2) other representatives, one to be nominated by each of the parties. Each Board shall have assigned to it, in the event of no agreement being arrived at between the parties to the dispute, the function of:—

(a) Adjusting any matters of difference which may arise from time to time, except such as involve interpretation of the provisions of this Agreement or any of them;

(b) Dealing with any other matter which the Court may refer to the Board from time to time.

(c) Classifying and fixing wages, rates and conditions for any occupation or calling not specifically mentioned in the Agreement.

(2) An appeal shall lie from any decision of a Board in the manner and subject to the conditions prescribed in the regulations to the Industrial Arbitration Act, 1912-1941, which, for this purpose, are embodied in this Agreement.

24.—Long Service Leave.

The conditions governing the granting of long service leave to full time Government wages workers generally shall apply to workers covered by this Agreement.

25.—Camp Allowance.

Workers required to live in tents at or in the neighbourhood of the job shall be paid an additional allowance of 15s. per week. The above allowance covers a week, whether of six or seven days. For broken periods this particular allowance shall be calculated at one-sixth (1/6), viz., 2s. 6d. per day.

(c) All work performed on Sunday or on the holidays prescribed in subclause (a) hereof shall be paid for at the rate of time and a half.

(d) Except as hereinafter provided a period of two consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve months continuous service with such employer.

(e) If any holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(f) If after one month's continuous service in any qualifying twelve-monthly period a worker lawfully leaves his employment, or his employment is terminated by the employer through no fault of the worker, the worker shall be paid one-sixth of a week's pay at his ordinary rate of wage in respect of each completed month of continuous service.

(g) Any time in respect of which a worker is absent from work except time for which he is entitled to claim sick pay or time spent on holidays or annual leave as prescribed by this Agreement shall not count for the purpose of determining his right to annual leave.

(h) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled, subject to subclause (f) of this clause, to such leave on full pay as is proportionate to his length of service during that period with such employer, and if such leave is not equal to the leave given to the other workers he shall not be entitled to work or pay whilst the other workers of such employer are on leave on full pay.

(i) A worker who is dismissed for misconduct or who illegally severs his contract of service shall not be entitled to the benefit of the provisions of this clause.

(j) The provisions of this clause shall not apply to casual workers.

(k) The quantum of annual leave to be allowed to a worker shall, for service prior to 1st September, 1946, be calculated in accordance with the provisions of the Agreement applicable before that date, and for service subsequent to 1st September, 1946, in accordance with the provisions of this amendment.
