#### ROYAL COMMISSION

WESTERN AUSTRALIA | By His Excellency Sir James Mitchell,
TO WIT. | J. G.C.M.G., Lieutenant-Governor in and
over the State of Western Australia
lieutenant-Governor and its Dependencies in the Commonwealth of Australia.

To Alexander J. Gibson, Esq., of Messrs. Julius, Poole & Gibson of Sydney, Chartered Engineers; and D. H. C. Duplessis, Esq., of the Government Railways of South Africa.

I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council, do hereby appoint you Alexander J. Gibson, of Messrs. Julius, Poole & Gibson of Sydney, in the State of New South Wales, Chartered Engineers, and you D. H. C. Duplessis of the Government Railways of South Africa, to be a Royal Commission to examine, inquire into and report upon—

- (a) The management, workings and control of the Government Railways in Western Australia in all its branches except the Midland Junction Railway Workshops and the supply of local coal, but including the housing of employees (particularly in country districts), and the provision of amenities at larger centres calculated to promote the welfare and working conditions of employees;
- (b) such alterations and improvements in relation to the foregoing, including the management of the said Government Railways, as may be advisable for economical and efficient working, having due regard to adequate services;
- (c) what action, if any, should be taken in regard to reduction in the capital liabilities of the said Government Railways, having regard to obsolete, depreciation and charges in respect of purely developmental railways; and
- (d) the administration generally of the said Government Railways.

And I hereby appoint you the said Alexander J. Gibson to be Chairman of the said Royal Commission.

And I declare that you shall by virtue of this Commission be a Royal Commission within the Royal Commissioners' Powers Act, 1902, as reprinted in the Appendix to the Sessional Volume of the Statutes for

the year 1928, and that you shall have the powers of a Royal Commission or the Chairman thereof under that Act.

And I hereby request you as soon as reasonably may be to report to me in writing the result of this your Commission, with interim reports as your inquiries proceed

# The Fisheries Act, 1905-1946. PROCLAMATION

IN pursuance of the provisions of section 9 of the Fisheries Act, 1905-1946, I, the Lieutenant-Governor of the State of Western Australia, do hereby prohibit all persons from taking by any means of capture whatsoever the fish known as or called "Crayfish," in that portion of Western Australian waters lying south of 28 deg. 15 min. of South latitude, and West of 114 deg. 10 min. of East longitude, including the waters surounding the island situated therein, from 1st October, 1947, to 15th February, 1948.

# The Game Act, 1912-1913. PROCLAMATION

WESTERN AUSTRALIA, By His Excellency Sir James Mitchell, G.C.M.G., Lieutenant-Governor in and over the State of Western Australia and its Dependencies in the Commonwealth of Australia

F.D. 619/46; Ex. Co. No. 1678.

WHEREAS it is provided by the Game Act, 1912-1913, that the Governor may, by proclamation, declare from time to time that any bird or animal indigenous to Western Australia shall be at all times strictly preserved, either generally throughout the State or in any one or more portions thereof, and that the Governor may in like manner exempt from the operation of any such declaration under the said Act any defined locality; and whereas by a proclamation dated 30th July, 1924, it is provided that the portions of the State and localities defined in the Schedule thereto shall be a reserve for Grey Kangaroos, known scientifically as Macropus giganteus; and whereas it is desirable to exempt from the operations of the said proclamation a defined locality. Now, therefore I, the said Lieutenant-Governor, in exercise of the power aforesaid, do hereby, by and with the advice and consent of the Executive Council, exempt from the operations of the aforesaid proclamation and the declaration contained therein all those localities mentioned and defined in the Schedule hereto as from 1st September, 1947, to 31st December, 1947, inclusive.

#### Schedule.

All that area included within a radius of 10 miles of Young's Siding on the Elleker-Denmark railway.

#### Plant Diseases Act, 1914. PROCLAMATION

WESTERN AUSTRALIA, By His Excellency Sir James Mitchell, G.C.M.G., Lieutenant-Governor in and over the State of Western Australia lieutenant-Governor. and its Dependencies in the Commonwealth of Australia.

WHEREAS by section 5 of the Plant Diseases Act, 1914-1944, it is provided that the Governor may by proclamation prohibit, either absolutely or except in accordance with regulations, the bringing into the State of Western Australia, either generally or from any specified State, country or place, of any specified kind of plant. fruit, or other thing which in his opinion may be likely to introduce any diseases into the State of Western Australia; and whereas the said Lieutenant-Governor is of the opinion that the bringing of bananas into the State of Western Australia from any of the following States of the Commonwealth of Australia, that is to say Victoria, New South Wales, South Australia and Queensland, unless subject to regulations, would be likely to introduce into the State of Western Australia the disease known as Nigrospora Sphaerica, "Squirter": Now, therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council, and in exercise of the powers in this behalf conferred upon me by the said Act, do by this proclamation prohibit the bringing into the State of Western Australia from any of the following States of the Commonwealth of Australia, that is to say Victoria, New South Wales, South Australia and Queensland of all bananas during the period May to September of any year except in accordance with the regulations specified hereunder:—

The regulations referred to are as follows:-

- 1. No person shall bring or cause to be brought, or be party or privy to the bringing into Western Australia, any bananas from any of the following States of the Commonwealth of Australia, that is to say, Victoria, New South Wales, South Australia and Queensland during the period May to September in any year unless—
- (a) such bananas shall have been treated with the preparation known as "Shirlan" as graded either "W.S." or "A.G." on the plantation on which they

were grown in accordance with the standard recommendations to control Nigrospora Sphaerica, "Squirter," adopted in the State where such bananas were grown;

- (b) all cases packed with bananas so treated shall have stencilled on one end thereof the words "Shirlan Treated" or "Shirlan Dipped"; and
- (c) each consignment of such bananas is accompanied by a statutory declaration signed by the consignor or grower to the effect that all such bananas have been treated in accordance with paragraphs (a) and (b) hereof and such declaration shall be produced by the consignee or his assign to an inspector or other person duly authorised by the Department of Agriculture on demand.
- 2. Any person who commits a breach of the foregoing regulation shall be guilty of an offence and shall be liable on conviction to a penalty not exceeding twenty-five pounds.

AT a meeting of the Executive Council held in the Executive Council Chamber at Perth on the 27th August, 1947, the following Order in Council was authorised to be issued:—

# Workers' Compensation Act, 1912-1944. ORDER IN COUNCIL.

WHEREAS it is enacted by section 10 of the Workers' Compensation Act, 1912-1944, that it shall be obligatory for every employer to obtain from an incorporated insurance office approved by the Minister a insurance for the full amount of the liability to compensation under this Act to all workers employed by him but that if an employer proves to the satis-faction of the Minister that such employer has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability the Governor may, by Order in Council, exempt such employer from the operation of the said section; and whereas Midland Railway Company of Western Australia Limited, of Midland Junction, Western Australia, being an employer within the meaning of the said Act and having duly made application in accordance with the said Act and the regulations made thereunder for exemption from the operation of the said section 10 has proved to the satisfaction of the Minister that it has established a fund for insurance against the liability aforesaid and that it has deposited at the Treasury securities to wit a Fixed Deposit Receipt No. 405 for five thousand pounds issued to the company by the English, Scottish and Australian Bank Limited, of Midland Junction aforesaid, charged with all payments to become due under the said liability in connection with the Railway Department of the said company: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the said Act, doth hereby exempt Midland Railway Company of Western Australia Limited aforesaid from the operation of section 10 of the Workers' Compensation Act, 1912-1944, in so far as relates to workers employed in or in connection with the Railway Department of the said company for the period commencing on the 8th day of August, 1947, and ending on the 7th day of August, 1940. 1949.

Infectious Diseases.
ORDER IN COUNCIL.

WHEREAS it is enacted by section 3 of the Health Act, 1911-44, that the term "Infectious Disease" means and includes certain specified diseases, and also any

other disease which the Governor may declare to be an infectious disease for the purpose of the said Act; and whereas it is desired to so declare the disease known at Tetanus (Lockjaw): Now, therefore, His Excellency the Lieutenant-Governor of Western Australia, by and with the advice and consent of the Executive Council, doth hereby declare the disease abovementioned, that is to say, Tetanus (Lockjaw), to be an infectious disease for the purposes of the Health Act, 1911-44.

Traffic Act, 1919-1946. Wyalkatchem Road Board. ORDER IN COUNCIL.

The Metropolitan Water Supply, Sewerage and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 281/47.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909, it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct and extend Water Works, Sewerage Works and Stormwater Drainage Works; and whereas the preliminary requirements of the said Act have been complied with, and plans, sections and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Lieutenant-Governor, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage and Drainage to undertake the construction of the following works under the said Act, namely:—

#### Metropolitan Sewerage.

Perth District Reticulation Area No. 43, Part 2, Ejector Area—6-inch diameter reticulation sewers with all man-holes and other apparatus connected therewith, also Ejector Station and house, together with all necessary apparatus connected therewith, as shown in red and blue on Plan M.W.S.S. & D.D., W.A. No. 6938.

This Order in Council shall take effect from the 5th day of September, 1947.

Land Drainage Act, 1925-1941.
Wilson Drainage District.
ORDER IN COUNCIL.

P.W.W.S. 442/46.

WHEREAS by section 12, subsection (1) of the Land Drainage Act, 1925-1941, the Governor may repeal, vary or amend any of the provisions of any previous order relating to any district: Now, therefore, His Excellency the Lieutenant-Governor with the advice of the Executive Council doth hereby vary and amend the boundaries of the Wilson Drainage District in the manner described in the Schedule hereto.

Western corner of Plantagenet Location 3422, and extending Easterly and Southerly along boundaries of the said location, and onwards, in the latter direction to the seashore of the Southern Ocean; thence generally South-Easterly along the said seashore to a point situate in prolongation Southerly of the Eastern boundary of Location 3599; thence Northerly, to and along the said Location 3599; thence Northerly, to and along the said boundary to the Southern boundary of Location 3988; thence generally North-Easterly along boundaries of Locations 3988 and 1794 to the Southern boundary of Torbay Agricultural Area Lot 47; thence East along the said boundary and onwards to a South-Western boundary of lot 44; thence South-Easterly, East and North, along boundaries of the said lot to the South-Western corner of lot 45; thence East to the Western shore of Tor Bay; thence generally Northerly and North-Easterly along the said shore to the mouth of the Torbay Tulet: thence continuing North-Easterly to the Torbay Inlet; thence continuing North-Easterly to the South-Westernmost corner of location 1148; thence East along the Southern boundary of the said location and onwards to the South-Eastern corner of location 506; thence North to the Southern boundary of location 2736; thence Easterly and Northerly to and along boundaries of location 536, to the South-Western corner of location 3103; thence East and North along boundaries of the said location to a point situate in prolongation Westerly of the Southern boundary of location 478; thence Easterly and Northerly to and along boundaries of the said erly and Northerly to and along boundaries of the said location, to the South-Western corner of location 508; thence East along the Southern boundary of the said location and onwards to the Western boundary of location 33; thence South to the South-Western corner of the said location; thence East to the Western shore of Princess Royal Harbour; thence North-Easterly along said shore to the Easternmost boundary of the same location; thence Northerly along the said boundary to the Southern boundary of location 2; thence Easterly along the said boundary to the original South-Eastern corner of the said location; thence Northerly along corner of the said location; thence Northerly along the Eastern boundary of same to the Northern side of Ince Street, Albany; thence Easterly along the said side to a point situate in prolongation Southerly of the Easternmost boundary of location 167; thence Northerly, North-North-Westerly and Westerly to and along boundaries of the said location to the North-Western corner of the same; thence Northerly along the Eastern side of McDonald Road to the Southern side of Marbellup Road; thence generally Westerly along the said side, passing along the Northern boundaries of location side, passing along the Northern boundaries of location 2788, and onwards to and along the Southern side of road No. 8560 to a South-Eastern boundary of reserve 801; thence North-Easterly and Westerly along boundaries of the said reserve to the aforesaid side of road No. 8560; thence generally Westerly along same to the Southernmost corner of location 2447; thence North and West along boundaries of the said location to the North-Western corner of the same; thence North, West and South along boundaries of location 2446 to the North-Eastern corner of reserve 1998; thence West, North and West to and along boundaries of location 2827 to the North-Western corner of the same; thence Westerly to the North-Eastern corner of location 3241: Westerly to the North-Eastern corner of location 3241; thence West, South, West and South along boundaries of the said location, and boundaries of location 1424 to the South-Western corner of the said location; thence generally Westerly along the northern side of a one chain road to the Southern corner of location 3094; thence North to a point situate in prolongation Easterly of the Southern boundary of location 3801; thence West to the South-Western corner of the said location; thence Westerly to and along the Southern boundary of location 3975 and onwards to the North-Eastern boundary of location 3475; thence North-Westerly along the said boundary and onwards to and along boundaries of location 2880 to the Northern corner of the same; thence South to the North-Eastern corner of location 775; thence West, South and East along boundaries of the said location to the North-Eastern corner of location 3766; thence South and West along boundaries of the said location and onwards in the latter direction to the Eastern shore of Wilson Julet: thence South to the Eastern shore of Wilson Inlet; thence South-Westerly along the said shore to join the existing drainage district boundary at the North Eastern corner of location 34; and thence generally South-Easterly along the said existing boundary to the starting point; as shown bordered red on Plan P.W.D., W.A. 31020.

WHEREAS by the Road Districts Act, 1919-1946, the Board of any road district is empowered, for the order and good government of its district, to make by-laws for all or any purposes in the said Act mentioned: Now, therefore, the Drakesbrook Road Board, in pursuance of the powers vested in the said Board, under and by virtue of the said Act and of every other authority enabling it in that behalf, doth hereby make and publish the following by-laws.

#### Interpretation.

- 1. In the construction of these by-laws-
- (a) "District" means the district controlled by the Drakesbrook Road Board.
- (b) "Hawker" includes any person who trades or travels on foot or with any vehicle or animal from one town to another town, or from place to place, or to other men's houses, carrying with him any fruit, fish, meat, poultry, game, vegetables, drink, eatables, or any article of merchandise for the purpose of selling the same or exposing or offering the same for sale, and also includes any person who sells any such com-modity, or exposes or offers for sale the same by outery or similar form of advertisement, in or near any public reserve, or common or street or way; and "Hawk" includes every act done by a person which would cause him to be regarded as a hawker as defined
- (c) "Stall" includes any movable and/or temporarily fixed stall and any vehicle in or from which the arily fixed stall and any vehicle in or from which the stallholder sells meat, fish, poultry, game, fruit, vegetables, drink, eatables, or articles of merchandise. A fixed stall shall be deemed to have been temporarily fixed unless it is a building erected in accordance with the building regulations of the Board, and with the approval of the Board, as provided for in those regulations. lations.
- (d) "Fish" shall include fresh, salted, smoked, or dried fish, oysters, crayfish, crabs, prawns and shrimps.

#### Hawkers.

- 2. Any person who desires to hawk any fruit, fish, meat, poultry, game, vegetables, drink, eatables, or any articles of merchandise within any part of the district shall first apply for a license from the Board by completing and signing an application, in Form Number (1) in the Schedule hereto.
  - The Board may either—
  - (a) Grant the application, or
- (b) Refuse to grant the same, for any of the following reasons:-
  - (i) If in the opinion of the Board the applicant is not a fit and proper person to hold a license;
  - (ii) if the applicant has not been a bona fide resident and ratepayer of the district for a period of at least one year expiring on the date of his application;
  - (iii) if the commodities which the hawker intends to hawk will not be produced in the district;
  - (iv) if in the opinion of the board the granting of a license for hawking by the applicant may prejudice the interest of any bona fide resident and ratepayer of the district;

(v) if the Board does not desire hawkers to operate in the portion of the district in which the applicant wishes to hawk.

- 4. If the Boards grants the application, it shall issue to the applicant a license, in Form Number (2) in the schedule hereto, and also a badge, with a number and the year of issue displayed, upon the licensee paying to the Board a fee of 2s. 6d. for his license and 2s. 6d. for his badge.
- Every license shall be granted subject to the conditions :-
- (a) That the licensee shall not hawk any commodity which was not produced in the district, unless no such commodity is being produced in the district at the time such commodity is hawked.
- (b) That the licensee shall not hawk any commodity other than those specified in his license.

- (c) That the licensee shall not hawk any commodity in any portion of the district other than that portion which is specified in his license.
- (d) That the licensee shall not commit any offence, rendering him liable to prosecution and conviction summarily or after indictment.

These conditions shall be printed on the back of every license.

- 6. The Board may cancel any license by notice in writing, if the licensee commits a breach of any of the conditions mentioned in clause 5, whereupon the licensee shall surrender his license and badge to the Board.
- 7. Unless cancelled as provided in clause 6, every license shall remain in force for one year from the date of issue thereof.
- 8. Every licensee shall display his badge, upon demand, when hawking.
- 9. No person shall hawk any fruit, fish, meat, poultry, game, vegetables, drink, eatables, or any article of merchandise within the district unless he is the holder of a current Hawker's License from the Board.

#### Stallholders.

- 10. Any person who desires to place, erect, keep or conduct any stall within the district shall first apply for a license from the Board, by completing and signing an application, in Form Number (3) in the schedule hereto.
- 11. No stall shall be placed, erected, kept, or conducted in or near any street or way, or on any reserve, within one hundred yards of any shop, the occupier of which sells goods of a similar nature to any of those sold by the stallholder.
- 12. On receiving such an application, and provided that the position of the stall does not offend against the provisions of clause 11, the Board may issue a license to the applicant, in the Form Number (4) in the Schedule hereto.
- 13. Every license shall be issued subject to the conditions:—
- (a) That the licensee shall not sell any commodity which was not produced in the district, unless no such commodity is being produced in the district at the time such commodity is sold.
- (b) That the licensee shall not sell any commodity other than those specified in his license.
- (c) That the licensee shall not place, erect, keep or conduct his stall or earry on the business of a stall-holder at any place other than the place specified in his license.
- (d) That the licensee shall attach his license to his stall in a prominent position but protected from the
- (e) That the licensee shall not commit any offence rendering him liable to prosecution and conviction summarily or after indictment.

These conditions shall be printed on the back of every license.

- 14. The Board may cancel any license by notice in writing, if the licensee commits a breach of any of the conditions mentioned in clause 13, whereupon the licensee shall surrender his license to the Board.
- 15. Unless cancelled as provided in clause 14, every license shall remain in force for one week, but may be renewed from time to time, at the discretion of the board, and if renewed such license shall be subject to the provisions of clause 11.
- 16. No person shall place, erect, keep, or conduct any stall, or carry on the business of a stallholder within the district, unless he is the holder of a current Stallholder's License from the Board.
- 17. In conducting his stall every stallholder shall be quiet and courteous and shall not do anything which may lead to a breach of the peace, or commit any offence rendering him liable to prosecution and conviction summarily or after indictment.
- 18. Every stallholder shall keep his stall and the immediate surroundings thereof clean and tidy.
- 19. No stallholder shall sell any commodity which was not produced in the district unless no such commodity is being produced in the district at the time such commodity is being sold.

#### Offenders.

20. The Secretary or other officer appointed by the Board, or any officer of the Police Force, may demand and require his name and address from any individual committing or suspected of committing any offence against or breach of clauses 1-19 inclusive, of these by-laws, and every person who shall refuse or neglect to give his name and address, when required so to do, shall be liable to a penalty not exceeding £5.

21. Every person offending against provision of clauses 1-19 inclusive, of these by-laws, shall forfeit and pay for each offence a sum not exceeding \$20.
