ORDER IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1946, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the order in trust for the like or other public purposes to be specified in such order; And whereas it is deemed expedient that reserve No. 18163 should vest in and be held by the Mukinbudin Road Board in trust for the purpose of "Hallsite, Recreation and Showground": Now, therefore, His Excellency the Lieutenaut-Governor, by and with the advice and consent of the Excentive Council, doth hereby direct that the before-mentioned reserve shall vest in and be held by the Mukinbudin Road Board in trust for the purpose aforesaid, subject nevertheless to the powers reserved to him by section 37 of the said Act.

The previous Order in Council dated the 27th June, 1923, is hereby superseded.

The Land Act, 1933-1946. ORDER IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1946, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such order, and with power of sub-leasing; And whereas it is deemed expedient that reserve 14156 at Howatharra should vest in and be held by the Municipality of Geraldton in trust for Quarry and Recreation: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the before-mentioned reserve shall vest in and be held by the Municipality of Geraldton in trust for Quarry and Recreation with power to the said Municipality of Geraldton, subject to the approval of the Minister for Lands in writing being first obtained, to lease the whole or any portion of the said reserve for any term not exceeding 21 years from the date of the lease.

The Forests Act, 1918. ORDER IN COUNCIL.

WHEREAS by the Forests Act, 1918, it is provided that the Governor may by an Order in Council declare any Crown Lands as State Forests within the meaning and for the purpose of that Act: Now, therefore, His Excellency the Lieutenant-Governor with the advice and consent of the Executive Council doth hereby declare Nelson Location 3635 as an addition to State Forest No. 39 within the meaning and for the purpose of the Forests Act, 1918. (Plan 442C/40, E3.)

Land Drainage Act, 1925-1941. Preston Drainage District. ORDER IN COUNCIL.

P.W.W.S. 660/47.

WHEREAS by section 11 of the Land Drainage Act, 1925-1941, the Governor may by Order in Council constitute any defined portion of the State a drainage district, specify the boundaries of such district, and assign a name to such district; and whereas under section 9, subsection (1) the Minister may exercise within any district all the powers and authorities except the power to borrow money, and shall have all the immunities conferred by this Act on a board: Now, therefore, His Excellency the Lieutenant Governor, with the advice of the Executive Council, doth hereby constitute a Drainage District, having the boundaries described in the Schedule hereto, and assign the name of the Preston Drainage District thereto; and doth direct that the Minister shall exercise all the powers and authorities and have the immunities conferred by section 9, subsection (1).

Preston Drainage District. All that portion of land bounded by lines starting from the North-Western corner of Collie Agricultural Area Lot 45, and extending Southerly, along the Western boundary of the said lot, to the Southern side of Jubilee Road; thence Westerly, along the said side, to the Eastern side of Vittoria Road; thence Southerly along the said side, to the Northern side of Hay Street; thence Westerly to and along the Northern boundary of Wellington Location 39, to the right bank of the Preston River; thence Northerly, downstream, along the said bank, to a point situate in prolongation Easterly of the Northern side of the Eastern end of Picton Terrace; thence Westerly, and generally South-Westerly, to and along the said side, to the Southern boundary of Leschenault Location 26; thence Westerly, along the said boundary, to the North-Eastern side of the Perth-Bunbury Railway Reserve; thence North-Westerly, along the said side, to the Eastern side of King Road; thence generally Northerly, along the said side, and onwards, to the Low Water Mark of the Southern shore of Leschenault Inlet; thence generally North-Easterly, along the said L.W.M., to the left bank of the Collie River; thence South-Easterly, upstream, along the said bank, to the North-Westerly, upstream, along the said bank, to the North-Westerly, along the Western boundary of the said Location, to the starting point. (Plans 411A and D/40.) As shown bordered red on Plan P.W.D., W.A., 31028.

ORDER IN COUNCIL.

WHEREAS section 74 of the Constitution Act, 1889, provides that the Governor in Council may vest in heads of departments or other officers or persons within the State power to make minor appointments; and whereas it is desirable that power of appointment of foremen and other persons employed at a daily rate of wage on works under the control of the Department of Public Works, and of Water Supply, Sewerage and Drainage (exclusive of the Metropolitan Water Supply, Sewerage and Drainage Department) should be vested in John David Gillespie: Now, therefore, His Excellency the Lieutenant-Governor, by and with the advice of the Executive Council, hereby vests in John David Gillespie and any persons appointed to act temporarily in his place, the appointment of foremen and all other persons employed on such works at a daily rate of wage.

(u) (i) Loaders shall be started from the home camp at 7 a.m. In the event of delay in starting, camp at 7 a.m. In the event of delay in starting, and provided loaders have presented themselves for work and are willing to work, waiting time shall be paid for time lost, except that in any delay through breakdown or other cause beyond the control of the employer, and provided that the loaders' representa-tive has been notified not later than 6 a.m. of such delay, the starting time shall be retarded not more than one half hour without payment of waiting time. Should the delay be greater than one half hour, then waiting time shall be payable from 7 a.m.

(ii) From the time trucks are placed for the morning or afternoon loading, no waiting time shall accrue until the expiry of the time equivalent to one hour and ten minutes for each truck placed per pair of loaders.

Where sufficient trucks have been placed for the morning loading and loaders have taken their crib, no waiting time shall accrue until after the expiry of one hour and ten minutes per truck placed plus one hour for crib.

When loaders are returned to the home camp for lunch, they shall be picked up for return to work in one hour from the time of their arrival in the camp.

(iii) If in the opinion of the employer's representative waiting time will exceed one hour, loaders may at the option of the employer be placed on other work.

Waiting time shall be paid to the nearest quarter of an hour and shall not be payable for any period of less than eight minutes. It shall be at the following rates:

District allowances and any basic wage adjustment not incorporated in the piecework anto aball be orchided from this calcupiecework rate shall be excluded from this calculation.

(w) Loaders prevented from loading by wet weather shall receive no payment for time lost. The employer shall return them to the home camp as quickly as possible.

(x) Loaders required to travel more than six miles from the camp to the place of working shall take their crib and be paid one penny halfpenny per ton extra.
