- 3. Form No. 4 in the Schedule is rescinded and the following is substituted therefor:-

Form No. 4-Order of Adoption under Section 3 (or 4) of Act.

SUPREME COURT RULES.

Crown Law Department, Perth, 17th October, 1947.

THE following amendment to the Supreme Court Rules is published for general information.

H. B. HAYLES, Under Secretary for Law.

WE, the Honourable Sir John Patrick Dwyer, Chief Justice, the Honourable Albert Asher Wolff and the Honourable James Leonard Walker, Puisne Judges of the Supreme Court of Western Australia, do hereby in pursuance of the powers contained in the Supreme Court Act, 1935, and of every other power enabling us in this behalf, amend the Rules of the Supreme Court, 1909, as amended by the Rules of the Supreme Court, 1926, in the manner hereinafter mentioned and declare that such amendment shall come into operation forthwith upon publication thereof in the Government Gazette.

Appendix M.

Appendix M of the Rules of the Supreme Court, 1909, as amended by the Rules of the Supreme Court, 1926, is amended as follows:-

- 1. Regulation 1 is amended-
- (a) by deleting from lines four and five the words "Official Trustee" and inserting in lieu thereof the words "Accountant, Crown Law Department" (hereinafter in this Appendix referred to as "the Accountant");
- (b) by deleting the words "Official Trustee and Supreme Court Offices" in lines seven and eight and inserting in lieu thereof the words "Supreme Court Office and at the Office of the Accountant."

- 2. Regulation 2 is repealed and the following regulation is inserted in lieu thereof-
 - Money paid into Court shall be paid by the Accountant to the Treasurer, except when the money is to be invested by the Public Trustee, in which case it shall be transferred to the Public Trustee.
 - 3. Regulation 3 is amended-
 - (a) by deleting therefrom the words "Official Trustee" wherever appearing and inserting in lieu thereof the word "Accountant";

- (b) by adding a paragraph as follows:—
 "Where the money paid in is to be invested a similar entry shall be made in the books of the Public Trustee on receipt of the money by the Public Trustee.
- 4. Regulation 4 is amended—
- (a) by deleting the words "Official Trustee" wherever appearing in the said regulation and inserting in lieu thereof the word "Accountant";
 - (b) by adding a paragraph as follows:-
- "If the money or any part of the money is transferred to the public Trustee for investment the office copy of the order and notice shall be forwarded by the Accountant at the same time and a similar entry shall be made in the books of the Public Trustee.''

 5. Regulations 5, 6, 7, 8 and 9 are amended by substituting for the words "Official Trustee'" wherever appearing therein the word "Accountant."

6. A new regulation is inserted after regulation 9 as follows:-

- 9A. Where the money to be paid out has been transferred to the Public Trustee for investment, the documents required under the last two preceding regulations to be lodged with the Accountant, shall be lodged instead with the Public Trustee and the Public Trustee shall pay such money to the person entitled thereto.
- 7. Regulations 12 and 13 are amended by deleting the words "official Trustee" where appearing in each of the said regulations and substituting in each instance the words "Accountant or Public Trustee as the case may be."

 8. Regulations 15, 16 and 17 are repealed.
- Regulation 18 is repealed and the following regulation is inserted in lieu thereof:-
 - (1) In all cases in which it is desired to pay money into Court or to 18. receive money out of Court a form of request signed by the party so desiring, or his Solicitor, shall be presented to the Master and be by him examined, and if he shall be of opinion that such request may be legally complied with he shall mark his approval thereof.

(2) The request so marked shall then be presented by such party or his solicitor to the Accountant by whom the money mentioned in such request shall be received, or (if it is not money which has been invested by the Public

Trustee) paid out, as the case may require.

(3) The Accountant shall then endorse on the request a short note to the effect that the said money has been received or paid by him, as the case may be, and hand such request so endorsed to the party presenting the same, who shall

- forthwith file it in the Central Office of the Supreme Court.

 (4) If the money which it is desired to receive out of Court has been invested by the Public Trustee, the request marked by the Master shall be presented to the Public Trustee who upon payment shall endorse the request accordingly and hand the same to the party presenting the same who shall forthwith file it as aforesaid.
- 10. Regulation 19 is amended by deleting the words "Official Trustee" where-ever appearing therein and inserting in lieu thereof the words "Accountant or Public Trustee" Public Trustee.

INDUSTRIAL AGREEMENT.

No. 38 of 1947.

(Registered 19/8/47.)

THIS Agreement made in pursuance of the Industrial Arbitration Act, 1912-1941, this 1st day of July, 1947, between the Kalgoorlie Brewery and Ice Company, Limited, whose registered office is situated at Brookman Street, Kalgoorlie (hereinafter called the "employer" of the ene part) and The Eastern Goldfields Federated Engine-drivers and Firemens' Union of Workers (hereinafter called the "Union" of the other part).

1.

The parties to this Agreement agree that the minimum rate of wages and conditions of labour shall be as follows:-

2.—Hours—Overtime.

Forty-four (44) hours shall constitute a week's work, to be worked in shifts of eight (8) hours each, Mondays to Fridays inclusive, and four (4) hours on Saturdays, and/or shift of seven (7) hours fifty (50) minutes each, Mondays to Fridays inclusive, and four (4) hours fifty (50) minutes on Saturdays. All time worked beyond the hours of duty on any day shall be deemed overtime and shall be paid at time and a half rates. Each day shall stand by itself.

3.-Sundays and Holidays.

(a) All work performed on Sundays and holidays shall be paid for at double time.

(b) Any employee called in on Sunday or holidays as set out in clause 4, shall be paid a minimum of eight (8) hours at Sunday or holiday rates, and any work performed on Sundays or holidays in excess of cight (8) hours shall be paid for at double time.

4.—Wages.

The wages shall be weekly and shall be as follows:-Basic wage ... £5 16s. 0d. per week.

(a) Where three shifts are worked unless rotation of shifts is carried out the afternoon shift man shall be allowed and paid 6s. per week, and the night shift 9s. per week in addition to the weekly rates as set out in clause 3.
(b) Where only two shifts are worked unless rota-

tion of shifts is carried out the afternoon shift shall be allowed and paid an additional 6s. per week to the rates set out in clause 3.

5.-Holidays.

The following days shall be observed as holidays, but should any employee have to work on any of these days double time rates shall be paid. Holidays mean:—Christmas Day, Boxing Day, New Year's Day, Foundation Day, Good Friday, Easter Monday, Anzac Day, Labour Day, Kalgoorlie Cup Day, Boulder Cup Day, King's Birthday, and Brewery Employee's Pienic Day, providing that when Boxing Day falls on a Saturday

all men required to work on that day shall do so, and another day given in lieu thereof. And in case of any of the above holidays falling on a Sunday the following Monday shall be observed in lieu thereof.

6.—Annual Leave.

Each employee on completion of twelve (12) month's service shall be granted two (2) weeks annual leave on double pay, such leave to be taken at times to be mutually agreed upon between the workers and the employees between the 31st March and the 30th September in each year. The annual leave shall be in addition the holidays mentioned in clause 5 hereof.

On termination of service (other than by dismissal for misconduct) of a worker who has been continuously employed for more than three months he shall receive a pro rata payment in lieu of leave on the basis of one day's double pay for each completed month of

On termination of service (other than by dismissal for misconduct) of a worker who has been continuously employed for more than one month, but less than three months, he shall receive a pro rata payment in lieu of leave on the basis of one day's pay for each completed month of service.

Relieving engine-drivers and firemen shall be paid for annual holidays pro rata to the legth of time they have been employed on the higher rates.

7.—Christmas Bonus.

All workers who have worked continuously for the same employer from any date not later than 1st July in any year up to and including Christmas Day in that year shall be then entitled to receive a bonus equal to one week's pay.

8.—Absence Through Sickness.

(a) Any worker, being unable through sickness or (a) Any worker, being unable through sickness or accident to attend to his duties, shall notify the employer not later than 10 a.m. on the day he first absents himself from duty, and he shall also satisfy the employer that he is unable to attend to his duties, and if required shall provide a medical certificate that he is unfit to perform his work through sickness.

(b) A worker shall be entitled to payment for non-attendance on the ground of payment all health for

attendance on the ground of personal ill-health for one half (1/2) day for each completed month of service: Provided that payment for absence through such ill-health shall be limited to six (6) days in each calendar year. Payment hereunder may be adjusted at the end of each calendar year or at the time the worker leaves of each calendar year or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred. Except as aforesaid, a worker shall not be entitled to payment for the time lost through sickness. This clause shall not apply where the worker is entitled to compensation under the Workers' Commensation Act. the Workers' Compensation Act.

9.—General.

(a) No engine-driver or fireman shall be called upon to do other work which will preclude him from maintaining effective supervision or control of his engines and boilers.

(b) Where the employment or work involves functions of a mixed character the minimum wage to be paid to the employee shall be calculated as if he per-formed such only of the said functions as involves the highest rate of wages under this agreement.

10.—Engagement.

The engagement between the employer and employee shall be weekly, a week's notice from either side to terminate same, except in the case of the employee absenting himself without leave, not obeying the lawful commands, or being guilty of misconduct, or of the works of the employer being stopped by fire, tempest or other act of God, when such Agreement may be terminated immediately.

Suitable washing and changing facilities shall be provided adjacent to the engine-room.

12.—Definitions.

(a) Engine-driver means any person who starts, stops, takes charge of, or drives any engine or engines or machinery of which the motive power is steam, gas, suction gas, oil, air, electricity or any other motive

suction gas, oil, air, electricity or any other motive power other than manual or animal power—but this clause shall not apply to motors of 15 B.H.P. or under. (b) Full payment for shifts.—After beginning a shift workers shall not be paid less than a full shift's wages, unless they leave of their own accord, or are dismissed for wilful misconduct.

13.

This Agreement shall be limited in effect to the works and undertakings of the employer situated on the Eastern Goldfields.

This Agreement to commence as and from the 1st July, 1947, and to remain in force for a period of one (1) year from this date.

INDUSTRIAL AGREEMENT.

No. 37 of 1947.

(Registered 19/8/47.)

THIS Agreement, made in pursuance of the Industrial Arbitration Act, 1912-1941, this 15th day of July, 1947, between The West Australian Shop Assistants and Warehouse Employees' Industrial Union of Workers Perth, in the State of Western Australia, an Industrial Union registered under the said Act, whose registered office is situated at No. 5 Wellington Buildings, William Street, Perth (hereinafter called "the Union"), of the one part, and the Collie Industrial Cooperative Society, Ltd., and others, whose names appear in the Schedule of signatures of parties hereto carrying on auctioneering and/or wholesale and/or retail businesses within the area prescribed by this Agreement (hereinafter called "the Employers"), of the other part, whereby it is hereby mutually agreed that the Industrial Agreement numbered 22 of 1937, entered into between the abovementioned parties on the 30th day of August, 1937, be varied in the manner following, that is to say:-

By deleting clause 7 of the said Agreement and by inserting in lieu thereof the following:—

7.-Holidays.

- (a) The following days, or the days observed in lieu, shall, subject to clause 6 hereof, be allowed as holidays without deduction of pay, namely:—New Year's Day, Australia Day, Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, State Foundation Day, Christmas Day and Boxing Day.
- (b) On any public holiday not prescribed as a holiday under this Agreement the employer's establishment or place of business may be closed in which case a worker need not present himself for duty and payment may be deducted, but if work be done ordinary rates of pay shall apply.
- (e) Except as hereinafter provided a period of two consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve months' continuous service with such employer.
- (d) If any prescribed holiday falls within a workers' period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.
- (e) If after one month's continuous service in any qualifying twelve-monthly period a worker lawfully leaves his employment, or his employment is terminated

by the employer through no fault of the worker, the worker shall be paid one-sixth of a week's pay at his ordinary rate of wage in respect of each completed mouth of continuous service.

- (f) Any time in respect of which a worker is absent from work except time for which he is entitled to claim sick pay or time spent on holidays or annual leave as prescribed by this agreement shall not count for the purpose of determining his right to annual
- (g) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled, subject to subclause (e) of this clause to such leave on full pay as is proportionate to his length of service during that period with such employer, and if such leave is not equal to the leave given to the other workers he shall not be entitled to work or pay whilst the other workers of such employer are on leave on full pay.
- (h) A worker who is dismissed for misconduct or who illegally severs his contract of service shall not be entitled to the benefit of the provisions of this
- (i) The provisions of this clause shall not apply to casual workers.
- (j) The quantum of annual leave to be allowed to a worker shall, for service prior to 1st September, 1946, be calculated in accordance with the provisions of the Agreement applicable before that date, and for service subsequent to 1st September, 1946, in accordance with the provisions of this amendment.

INDUSTRIAL AGREEMENT.

No. 36 of 1947.

(Registered 13/8/1947.)

THIS Agreement made in pursuance of the Industrial Arbitration Act, 1912-1941, this 8th day of August, 1947, between the Board of Management of the Royal Perth Hospital, Western Australia (hereinafter referred to as the "Employer") of the one part, and The Metropolitan and South-Western Federated Engine-drivers and Firemen's Union of Workers of Western Australia (hereinafter referred to as "the Union") of the other part; witnesseth as follows:—Whereas the parties hereto, being the parties to the Industrial Agreement made on the 13th day of May, 1938, and Nod. 15 of 1938, have mutually agreed that the said Industrial Agreement be varied, now the said Industrial Agreement shall be and the same is hereby varied in the following manner, that is to say:-

Clause 5-Overtime Rates.-Delete subclause (b). Clauses 6 and 7.—Delete these clauses and insert in lieu thereof:-

Clause 6—Annual Leave.

- (a) (i) Except as hereinafter provided a period of wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve months' continuous service with such employer.
- (ii) Seven day shift workers, i.e., shift workers who are rostered to work regularly on Sundays and holidays, shall be allowed in addition to clause (a) (i) hereof, seven consecutive days' leave including nonworking days.

Where an employee with twelve months' continuous service is engaged for part of the twelve monthly period as a seven day shift worker he shall be entitled to have the period of two consecutive weeks' annual leave prescribed in subclause (a) (i) hereof increased by half a day for each month he is continuously engaged as aforesaid.

- (b) If any award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.
- (c) (i) Subject to paragraph (ii), when computing the annual leave due under this clause no deduction shall be made from such leave in respect of the period that a worker is on annual leave and/or holidays: Provided that no deductions shall be made for any

approved period a worker is absent from duty through sickness with or without pay unless the absence exceeds three (3) calendar months, in which case deduction may be made for such excess only.

- (ii) Approved periods of absence from work caused through accident sustained in the course of employment shall not be considered breaks in continuity of service, but the first six months only of any such period shall count as service for the purpose of computing annual leave.
- (d) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled to such holidays on full pay as are proportionate to his length of service during that period with such employer.
- (e) Any worker who may resign or be dismissed from the service for any cause, other than for peculation or theft, shall be entitled to receive payment for any annual leave which may have been due up to the time of leaving the service; Provided always that if the worker has been dismissed for peculation or theft no claim for annual leave shall be recognised. Misconduct herein referred to shall not affect accumulated annual leave or payment therefor.
- (f) "Ordinary wages" for the purpose of subclause (a) hereof shall mean the rate of wage the worker has received for the greatest proportion of the calendar mouth prior to his taking the leave.
- (g) The provisions of this clause shall not apply to casual workers,

Clause 7-Public Holidays.

- (a) Except as hereinafter provided, each of the following days, or the day observed in lieu thereof, shall be allowed as a holiday to all workers and be paid for, namely:—New Year's Day, Australia Day (26th January), Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, Foundation Day, King's Birthday, Christmas Day and Boxing Day.
- (b) Whenever any holiday falls on an employee's ordinary working day and the employee is not required to work on such day he shall be paid for the ordinary hours he would have worked on such day if it had not been a holiday. If he is required to work on a holiday he shall be paid for the time worked as if it was an ordinary working day and shall, in addition, be allowed a day's leave with pay to be added to the annual leave or to be taken at some subsequent date if the worker so agrees.
- (c) In the case of workers working a five day week, no payment or a day in lieu shall be granted for any public holiday falling on a Saturday.
- (d) Payment for holidays shall be in accordance with the usual hours of work.
- (e) When a worker is off duty owing to leave without pay or sickness, including accidents on or off duty, except time for which he is entitled to claim sick pay, any holiday falling during such absence shall not be treated as a paid holiday. Where the worker is on duty or available on the working day immediately preceding a holiday, or resumes duty, or is available on the working day immediately following a holiday, as prescribed in this clause, the worker shall be entitled to a paid holiday on all such holidays.
- (f) A casual worker shall not be entitled to payment for any holiday referred to in this clause.

- "(a) Except as hereinafter provided a period of three (3) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve (12) months' continuous service with such employer.
- (b) If any award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day, there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.
- (c) If after one month's continuous service in any qualifying twelve-monthly period a worker lawfully leaves his employment or his employment is terminated by the employer through no fault of the worker, the

worker shall be paid one-fourth of a week's pay at his ordinary rate of wage in respect of each completed month of continuous service.

- (d) Any time in respect of which a worker is absent from work except time for which he is entitled to claim sick pay or time spent on holidays or annual leave as prescribed by this award shall not count for the purpose of determining his right to annual leave.
- (e) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled, subject to subclause (e) of this clause to such leave on full pay as is proportionate to his length of service during that period with such employer, and if such leave is not equal to the leave given to the other workers he shall not be entitled to work or pay whilst the other workers of such employer are on leave on full pay.
- (f) A worker who is dismissed for misconduct or who illegally severs his contract of service shall not be entitled to the benefit of the provisions of this clause.
- (g) The provisions of this clause shall not apply to casual workers."
