Rules Under the Medical Act, 1894-1945. THE MEDICAL ACT, 1894-1945.

Department of Public Health, Perth, 22nd October, 1947.

HIS Excellency the Lientenant-Governor in Council, acting pursuant to the provisions of the Medical Act, 1894-1945, has been pleased to approve of the amendment in the manner mentioned in the Schedule hereunder, by the Medical Board, of its rules as made and in force under the said Act.

Schedule.

The Medical Board constituted under the Medical Act, 1894-1945, and acting under the provisions of the said Act, at a meeting held at Perth on the 12th day of September, 1947, amended the rules of the said Board as made and in force under the said Act, in the following manner, namely:—

Repeal all previous rules and amendments and substitute the following rules in lieu thereof:—

Interpretation.

In the construction of these rules, section 3 of the Act shall apply.

Meetings of Board.

1. Monthly meetings of the Board shall be held on the second Friday in each month at 5.15 p.m.; and special meetings shall be held at such times as the president or any two members of the Board may require.

Any monthly meeting of the Board may be postponed to and held at such hour and place as the Board may by resolution direct.

2. Special meetings shall be convened by the Registrar, at the request of the president or any two members of the Board, by posting or delivering to each member 48 honrs' written notice, stating the time and place of such meeting.

The omission to post or deliver any such notice, or the non-receipt thereof, shall in no manner affect or prejudice anything done or agreed to at any such meeting.

- 3. If a quorum of members be not present within 15 minutes of the time appointed, the meeting may be adjourned to such time and place as those present shall determine.
- 4. At all meetings voting shall be by a show of hands, unless a ballot is called for by any member present.
- 5. No resolution passed, or any act, matter or thing done or authorised by or at any meeting shall be rescinded, amended, cancelled or revoked at any subsequent meeting, unless prior notice of such intended rescission, amendment, cancellation or revocation has been given in the notices convening the meeting.
- 6. Minutes of every meeting shall be kept by the Registrar, and shall, when signed by the president or chairman of the same or any subsequent meeting, be binding and conclusive for all purposes.
- 7. (1) Every applicant for registration as a medical practitioner shall, at least five clear days before the then next ordinary monthly meeting of the Board, lodge with the Registrar—
 - (a) except as hereinafter provided, all diplomas by virtue of which he claims to be registered;
 - (b) a declaration in the Form A in the schedule; and
 - (c) the registration fee prescribed by section 16A of the said Act.

Provided that, wherever for any reason beyond his control an applicant is unable to produce any diploma required under paragraph (a) above, but presents to the Registrar a statutory declaration that he is the grantee of a diploma registerable in the United Kingdom of Great Britain and Northern Ireland, and setting out the name of the University or College by which and the date upon which such diploma was granted, the Board may dispense with the production of such diploma and grant registration subject to the applicant producing to the Registrar such diploma, or an authenticated copy thereof; if and when required by the Board so to do, and subject to such registration being cancelled, if the applicant fails to comply with any requisition by the Board as aforesaid.

8. Every applicant for registration shall attend in person before the Board, unless exempted from doing so by the Board, at any or every meeting when his application is being considered, and at such other meetings as the Board may require, and answer all such questions as may be put to him, and shall also supply in writing all such information and evidence as the Board may from time to time require.

The Board may require any applicant to answer questions or supply information or evidence on any matter, either verbally or in writing, under oath or affirmation or otherwise.

- 9. The registration fee paid by any medical practitioner employed by the Commonwealth Government who may be required to register as a medical practitioner in Western Australia for the purpose of carrying out the duties of his department for a period not exceeding six months shall be refunded to such medical practitioner at the conclusion of his temporary employment in Western Australia.
- 10. Every person applying to have his name restored to the register under section 10, subsection (4) of the Act, shall supply such written or verbal explanation as the Board may require, and pay a fee not exceeding two guineas.
- 11. Every person applying, under section 15 of the Act, to have a higher degree or qualification registered, shall supply such evidence of such higher degree or qualification as the Board may require, and pay a fee of five shillings.

Register.

- 12. The register shall be kept by the Registrar in the manner and form contained in Schedule B hereto.
- 13. Any person may on payment of a fee of 2s. 6d., inspect the register between 10 a.m. and 3 p.m. at the office of the Registrar.

Allegations and Inquiries.

14. When an allegation against a medical practitioner of any of the several matters or things referred to in subsection (1) of section 13 of the Act is made to the Board, and the Board considers the allegation shows justification for inquiry, then the medical practitioner against whom the allegation has been made shall have served upon him personally, or posted to him to his address in the register, or if there be no such address, to his last known address in Western Australia, notice of the nature of the allegation and of a date (not being less than 14 days from the date of such service or posting) when such allegation will be heard by the Board and organization. and considered.

The President may, upon the application of any medical practitioner against whom such an allegation has been made, extend the time for hearing such allega-

- 15. At the meeting of the Board at which such allegation is heard, the same may thereupon be dealt with forthwith, or the Board may from time to time, adjourn the hearing to such dates and hours and places as to it may seem meet.
- Every medical practitioner against whom such an allegation has been made may apply to the Registrar to issue a summons for the attendance or production of any person or documents whom or which it may be desired to call or produce. Such summons shall be in one of the forms C and D in the Schedule hereto.

Regional Registrations.

- 17. The fee for each and every regional certificate, or for each and every renewal thereof, issued under section 12 of this Act shall be the sum prescribed by section 16A of this Act.
- 18. Every applicant for registration for a regional area under section 12 of this Act shall make a declaration in the Form E in the Schedule to these regulations.
- 19. The register of persons to whom regional registration certificates are issued to be kept by the Registrar shall be in the Form F in the Schedule to these regula-
- Where a certificate of regional registration is issued to any person under section 12 of the Act, such certificate shall be in the Form G in the Schedule to these regulations.

Fines.

21. Any person liable under section 16A, subsection (1) of this Act to pay the annual practice fee prescribed in that subsection who fails in any year to pay such fee on or before the 31st day of March shall pay a fine of £1 for the month of April or any portion thereof and a fine of 10s. for each and every month or any portion thereof thereafter during which he shall fail to pay such annual practice fee but in no case shall the total amount of the fines exceed ten pounds.

POLICE ACT, 1892.

Police Department, Perth, 20th October, 1947.

THE Commissioner of Police, acting under the authority conferred by section 9 of the Police Act, 1892, and with the approval of the Minister for Police, has amended the regulations made under the said Act, as published in the Government Gazette on the 4th day of December, 1944, and amended by notices published in the Government Gazette on the 14th day of May, 1945, the 21st day of March, 1947, and the 25th day of July, 1947, in the manner set forth in the Schedule hereunder.

Schedule.

The abovementioned regulations are amended as follows:-

- 1. Regulation 43 is amended by deleting paragraph (f) and inserting in lieu thereof a new paragraph as follows:—
- (f) (i) Members of the Criminal Investigation Branch shall be eligible for promotion in other branches of the Force as provided for in regulation 113 on the same basis and conditions as other members of the Police Force.
- (ii) A member of the Criminal Investigation Branch may become eligible for promotion within that branch provided that such promotion shall be effective only while the member shall remain a member of that branch, and shall not be recognised on the seniority list mentioned in regulation 113 unless and until the rank and service of such member on the register of promotions entitles him to recognition on such seniority list: Provided further that nothing herein contained will prevent any special promotion as provided for elsewhere in these regulations nor the recognition of any such special promotion on the seniority list.

MUNICIPAL CORPORATIONS ACT, 1906-1945.

North Fremantle Municipality.

By-Law No. 18 Zoning.

P.W. 561/36.

A BY-LAW of the Municipality of North Fremantle made under section 180 of the Municipal Corporations Act, 1906-1945, and numbered 18 for regulating the classification into districts for residential, business, and industrial purposes of all the lands within the gazetted boundaries of the Municipality.

1. The area comprising the North Fremantle Municipality and all lands within its gazetted boundaries are hereby classified into districts for residential, business, and industrial purposes.

Residential Area.

- 2. (a) The residential area shall consist of all lots or land described in the First Schedule hereunder and which are within the boundaries of the area edged red on the sealed plan deposited at the offices of the Council and the Town Planning Board: Provided not more than one building is erected on an area of 6,000 square feet or under; provided also, that where a subdivision or separate title has existed prior to the gazettal of this by-law for lots of less than 6,000 square feet, the Council may permit the erection of single family dwellings subject to the Health and Building By-laws.
- (b) Churches, public buildings, may be erected in the residential area with the approval of the Council.
- (c) No residential lot shall be built on to cover more than one third of the area of such lots.
- (d) No lot shall be built on where such land is below the ten feet contour as defined in relation to low water mark, unless—
 - (i) the land is drained to the satisfaction of the Council; and/or,
 - (ii) the land is built up to the crown of the road (whether existing or to be built) on which the lot fronts, or to a level determined by the Council.

Business Area.

- 3. (a) The business area shall consist of all lots or land in the Second Schedule hereunder and which are within the area edged brown on the sealed plan.
- (b) Within such area the following uses and buildings may be permitted:—
 - (1) Any of the uses permitted in the residential area.
 - (2) The following:—Theatre, hall, club or place of amusement; office, bank or hotel; fire station, police station, post office, or public buildings; shops, salesroom or showroom, for the conduct of retail or wholesale business; workrooms, connected with retail business, in which not more than 50 per cent. of the total area is devoted to workrooms; garage or petrol selling or service station; blacksmithing or woodyard businesses; such other accessories as the authority might determine, but shall not include any industry, trade, manufactory, or stable.

(c) Where a business or shop has a residence attached or is used for residential purposes, it shall be erected or maintained on an area of not less than 600 square feet: Provided that lock-up shops may be erected on a less area with the Council's approval.

Industrial Area.

- 4. (a) The industrial area shall consist of all lots or land not described nor contained in the First or Second Schedules hereunder, and comprising the remainder of the Municipal area as shown edged blue on the sealed plan.
- (b) Within such area the following uses and buildings may be permitted:—
 - (i) Any of the uses permitted in the residential or business areas.
 - (ii) Any work, manufactory, industry, or use not permitted in the business area.
 - (iii) No noxious trade as defined by the Health Act, shall be established in the Municipality: Provided, however, that the Council shall not refuse to issue a license for a fish shop in the business area as defined by this by-law if the provisions of the Health Act and Health By-laws are complied with.
- 5. If at the time when this by-law shall come into operation, any building is being used for purposes other than those permitted by this by-law (hereinafter called a "non-conforming use"), such building may continue to be used for such non-conforming use and the Council may in its discretion permit such building to be added to or altered so as to cover the whole of the block on which it stands and/or on any adjoining land which may be owned by the proprietor of such building at the time when this by-law shall come into operation.

When a non-conforming use has been discontinued or changed to a conforming one, such use shall not thereafter be changed to a non-conforming use.

- 6. Any person who constructs or uses any premises in contravention of this by-law shall within 30 days of notice, given by the North Fremantle Council, remove, pull down, alter, or cease to use, any building so as to comply with this by-law.
- 7. If any person commits a breach of this by-law such person will incur a penalty not exceeding twenty pounds.

First Schedule.

Commencing at a point on the foreshore in prolongation of the Northern boundary of Harvest Road; thence proceeding Southerly and Westerly along the said Northern side of Harvest Road to the Southern boundary of Elizabeth Street; thence Southerly and Easterly by the Southern boundary of Elizabeth Street to the Northern boundary of John Street to the Western boundary of Stirling Highway; thence South along the Western boundary of Stirling Highway, to the Northern boundary of Swan Street, Westerly along said boundary 150.8 links and North by the rear boundary of lot P 28

to the Northern boundary of John Street; thence along the Northern boundary of John Street, to the Western side of De Lisle Street; thence Northerly to the Southern side of Jackson Street, and Westerly to the boundary of railway property; thence Northerly along the railway boundary to the North-Western corner of 6186 and East to the Eastern boundary of Stirling Highway; thence Southerly to the Northern boundary of Alfred Road and Easterly along it to the foreshore; thence along the foreshore to the point of commencement.

Second Schedule.

All lots with frontage to Stirling Highway on the East side between Alfred Road and John Street and on the West side between Swan Street and the North-East corner of Reserve 6186.

MUNICIPAL CORPORATIONS ACT, 1906-1945.

East Fremantle Municipality.

By-law to Control Woodyards.

P.W. 1384/25.

A By-law of the Municipality of East Fremantle made under Section 180 of the Municipal Corporations Act, 1906-1945, to become operative on the 1st February, 1948.

IN pursuance of the powers in that behalf contained in the Municipal Corporations Act, 1906-1945, the Municipal Council of East Fremantle doth hereby make the following by-law:—

1. No person shall stack, store or keep, or permit to be stacked, stored or kept, any hay, straw, bark, thatch, reeds, coal or firewood on any land within the Municipality of East Fremantle so that any part of such hay, straw, bark, thatch, reeds, coal or firewood shall be stacked, stored or kept closer than a distance of 6ft. to any part of any residence, shop, warehouse, factory or other building, or so that any part of such hay, straw, bark, thatch, reeds, coal or firewood shall be stacked, stored or kept closer than a distance of 6ft. to a boundary of such land; provided that nothing in this by-law shall prevent or be deemed to prevent any person stacking, storing or keeping or permitting to be stacked, stored or kept any coal or firewood on any part of any land within the Municipality of East Fremantle if such coal or firewood is stacked, stored or kept for use on such land for domestic purposes only.

A resolution adoping the foregoing by law was passed by the Council on the 22nd day of May, 1947.

P.W. 1384/25.

IN pursuance of the powers in that behalf contained in the Municipal Corporations Act, 1906-1945, the Municipal Council of East Fremantle doth hereby make the following by-law:—

- 1. All by-laws heretofore made by the Municipal Council of East Fremantle with reference to the matters hereinafter contained are hereby repealed.
- 2. The said Municipality may grant permits from time to time authorising owners or occupiers of premises in the Municipality of East Fremantle abutting streets in the Municipality of East Fremantle to plant lawns and or gardens on unmade portions of streets in the Municipality of East Fremantle.
- 3. The said Municipality may grant permits to any such owners or occupiers authorising them to lay pipes in abutting streets and to instal taps and sprinklers in any unmade portion of abutting streets, and to connect up such pipes and taps (subject to the provisions of the Metropolitan Water Supply, Sewerage and Drainage Act, where applicable) with the water supply of such owner or occupier on his premises.
- 4. All pipes, taps and sprinklers so laid shall be laid so that no damage is done to made streets and so that no nuisance is committed. All pipes in streets must be at least 12in. below the surface level, except where leading to taps, connections or sprinklers.
- 5. All taps, connections and sprinklers must be surface level and no higher and must be so placed that n_0 dangerous hole is left in any such street.
- 6. The said municipality shall have the power arbitrarily to cancel any such permit or permits so issued on giving 28 days' notice in writing to the holder of such permit.
- 7. On or before the expiration of such notice the holder of such permit shall remove such pipes, taps and sprinklers laid by him in any street without causing any damage to made streets. All holes made to effect such removal shall be forthwith filled up and no mound of earth shall be left in any street. In default of the holder of such permit removing same in such time, the said Municipality may remove same at the expense of such permit holder.
- 8. For every completed twelve months an owner or occupier lays and maintains in good condition a garden or lawns to the satisfaction of the said Municipality in that part of the street abutting his premises the said Municipality will pay him the sum of five shillings, being payment for upkeep of that portion of the street in which such garden or lawns are laid and maintained. Should any permit be cancelled by the said Municipality during any current twelve months, the expired portion of such current twelve months shall be deemed to be a completed twelve months for the purpose of authorising payment of the said five shillings.
- 9. No person shall ride or drive an animal or vehicle over any lawns or gardens laid and planted in any street in the Municipality of East Fremantle.
- 10. In this by-law, the following definition shall apply, unless inconsistent with the context:—

(a) The word "street" includes footpath.

UNIVERSITY OF WESTERN AUSTRALIA ACT, 1911-1944.

Amendments to Statutes.

HIS Excellency the Lieutenant-Governor in Executive Council has been pleased, under section 33 of the University of Western Australia Act, 1911-1944, to approve University Statute No. 4 of 1947 (amending Statute No. 8) as passed by the Senate and Convocation of the University, copy of which is shown hereunder.

Amending Statute No. 4 of 1947.

Amendment to Statute No. 8—Degrees and Faculties. The whole of Statute No. 8 is hereby repealed and the following substituted:—

The Faculties.

- 1. In this Statute, unless the context otherwise requires—
- "Faculty" shall mean any one or more of the Faculties mentioned in section 2.
- "Lecturer" shall include senior lecturer-in-charge, senior lecturer and lecturer and any person temporarily occupying any such appointment, but not part-time or visiting lecturer.
 - "Professor", shall include associate-professor.
- 2. (1) There shall be Faculties of, and degrees shall be granted after examination in, Arts, Law, Science, Engineering, Agriculture, and Dental Science, and such other Faculties as the Senate may from time to time establish.
- (2) For the purpose of section 17 (d) of the University of Western Australia Act, 1911-1944, there shall be deemed to be Faculties of Medicine and Music in which the following degrees ad eundem gradum may be conferred by the Senate, namely:—Bachelor of Medicine, Bachelor of Surgery, Master of Surgery, Doctor of Medicine, Bachelor of Music, Doctor of Music.
- 3. (1) Each Faculty shall have power to consider and subject to subsection (2) hereof, to decide all matters relating to its courses of study lectures, tutorial classes, laboratory work, examinations, degrees and cognate matters, and shall report its decisions to the Professorial Board for confirmation, except in regard to the following, namely:—
 - (a) The enrolment of students.
 - (b) Exemption from attendance at lectures laboratory or tutorial classes.

- (c) Exemption from any part of a prescribed course and variations of such courses.
- (d) The time table of lectures, tutorial classes and laboratory work.
- (e) The granting of credit for units passed at annual or supplementary examinations where in the opinion of the Faculty special circumstances exist which justify a departure from its regulations.
- (f) The approval or disapproval of the subject matter of theses proposed to be submitted for any degree.
- (g) The approval or rejection of theses submitted for any degree.
 - (h) The general administration of the Faculty.
- (2) Each Faculty shall, after each meeting, cause to be prepared and shall send to the Chairman of the Professorial Board a summary of its decisions in relation to the matters set out in clauses (a) to (h) of subsection (1) of this section, so that the Professorial Board on motion of its Chairman or of any member shall have power to reverse, vary or refer back to the Faculty any such decision.
- (3) (a) All questions which come before any Faculty shall, unless other statutes or regulations otherwise provide, be decided by a simple majority of the members present and voting.
- (b) The Dean or other chairman of the meeting shall have an ordinary vote and a casting vote.
- 4. (1) Each Faculty shall each year nominate one of its members, being a professor or senior lecturer in charge, or if no such latter person be available, a senior lecturer, for appointment by the Senate as its Dean.
- (2) The nomination of a Dean shall be sent to the Professorial Board for submission to the Senate at its June meeting in each year.
- (3) Each Dean on appointment by the Senate shall hold office for the 12 months next following his appointment, and shall be eligible for re-nomination and reappointment.
- 5. (1) Each Dean shall exercise general supervision over the educational and administrative work of his Faculty.
- (2) He shall be chairman of all meetings of his Faculty at which he is present, but in his absence, the members then present shall elect one of their number to be chairman of the meeting.
 - 6. (1) Meetings of each Faculty shall be held:-
- (a) As often and at such times and places as the Dean may think fit.

- (b) Within seven days of the service on the Dean or Registrar of a requisition signed by at least three members of the Faculty and containing a statement of the matters to be discussed.
- (2) It shall be the duty of the Registrar to act as secretary of each Faculty and to give to all members at least three days' written notice of all meetings thereof.
- 7. The Chancellor, Pro-Chancellor, Vice-Chancellor and Registrar shall *ex officio* be members of all Faculties, but shall not be counted for the purpose of determining whether a quorum of members as prescribed by sections 14 and 15 (4) is present.
- 8. The Faculty of Arts shall consist of the professors and lecturers in the departments of Classics and Ancient History, Economics, Education, History, Mathematics, Modern Languages, Philosophy, Psychology, and in such other departments as may from time to time be established within the Faculty, the University Librarian, and such other persons as may from time to time be appointed by the Senate on the nomination of the foregoing and on the recommendation of the Professorial Board.
- 9. The Faculty of Law shall consist of the professors and lecturers in the Law School; the visiting lecturers in Law, who shall be deemed to hold office as such until their successors are appointed; the professors of Economics, English and Philosophy, and such other persons as may from time to time be appointed by the Senate on the nomination of the foregoing and on the recommendation of the Professorial Board.
- 10. The Faculty of Science shall consist of the professors and lecturers in the departments of Biology, Botany, Chemistry, Geology, Mathematics, Physics and Psychology, and in such other departments as may from time to time be established within the Faculty, and of the Professor of Agriculture, the Conservator of Forests or his deputy, and of such other persons as may from time to time be appointed by the Senate on the nomination of the foregoing and on the recommendation of the Professorial Board.
- 11. The Faculty of Engineering shall consist of the professors and lecturers in the Engineering School; the professors of Chemistry, Geology, Mathematics and Physics or their deputies, and such other persons as may from time to time be appointed by the Senate on the nomination of the foregoing and on the recommendation of the Professorial Board.
- 12. The Faculty of Agriculture shall consist of the professors and lecturers in the Institute of Agriculture, the professors of Biology, Chemistry, Economics, Geology and Physics, the lecturers in charge of the departments of Botany and Organic Chemistry, and such other persons as may from time to time be appointed by the Senate on the nomination of the foregoing and on the recommendation of the Professorial Board.
- 13. The Faculty of Dental Science shall consist of the professors and lecturers in the School of Dental Science, the professors of Biology, Chemistry, Physics, and of such other departments as may from time to time be established within or associated with the Faculty and such other persons as may from time to time be appointed by the Senate on the nomination of the foregoing and on the recommendation of the Professorial Board.
- 14. The quorum for meetings of a Faculty shall be one-third of the members for the time being.
- 15. (1) There shall be Advisory Boards in Law, Engineering, Agriculture and Dental Science constituted as follows:—
 - (a) The Advisory Board in Law shall consist of the Dean and members of the Faculty of Law, a judge of the Supreme Court of Western Australia nominated by the Senate, the Attorney General, or if there be none, the Solicitor General, two persons nominated by the Barristers' Board of Western Australia, two persons nominated by the Law Society of Western Australia, and such other persons as may from time to time be appointed by the Senate on the nomination of the foregoing and on the recommendation of the Professorial Board.

- (b) The Advisory Board in Engineering shall consist of the Dean and members of the Faculty of Engineering, the Chairman of the Perth Division of the Institution of Engineers (Australia), and of such other persons being engineers or surveyors by profession as may from time to time be appointed by the Senate on the nomination of the foregoing and on the recommendation of the Professorial Board.
- (c) The Advisory Board in Agriculture shall consist of the Dean and members of the Faculty of Agriculture, the permanent head of the Department of Agriculture of Western Australia, the principal of Muresk College, one person nominated by the Pastoralists' Association of Western Australia (Incorporated), one person nominated by the Royal Agricultural Society of Western Australia (Incorporated), one person nominated by the Farmers' Union of Western Australia, two persons nominated by the Western Australian Branch of the Australian Institute of Agricultural Science, and of such other persons as may from time to time be appointed by the Senate on the nomination of the foregoing and on the recommendation of the Professorial Board.
- (d) The Advisory Board in Dental Science shall consist of the Dean and members of the Faculty of Dental Science, one member of the Senate appointed by it, two representatives of the Dental Board of Western Australia, two representatives of the Western Australian College of Dental Science, two representatives of the Australian Dental Association (Western Australian Branch), two representatives of the Dental Hospital of Perth, and of such other persons as may from time to time be appointed by the Senate on the nomination of the foregoing and on the recommendation of the Professorial Board.
- (2) The members of each Advisory Board other than the Dean and members of the Faculty shall hold office for three years from the date of appointment and shall be eligible for re-appointment.
- (3) (a) The Dean of the Faculty shall preside at all meetings of the Advisory Board at which he is present but in his absence the members then present shall elect one of their number to be Chairman of the meeting.
- (b) All questions which come before any Advisory Board shall, unless other Statutes or Regulations otherwise provide, be decided by a simple majority of the members present and voting.
- (c) The Dean or other chairman of the meeting shall have an ordinary vote and a casting vote.
- (4) The quorum for each Advisory Board shall be one-fourth of the number of members for the time being.
- (5) Each Advisory Board shall have power to consider and make recommendations concerning all matters within the competence of a Faculty other than those set out in section (3) (1) hereof (a) to (h) inclusive.
- (6) (a) The recommendations of each Advisory Board shall be reported by the Dean to the next meeting of the Professorial Board for consideration by that Board and for transmission to the Senate.
- (b) It shall be competent to the Faculty concerned to make such comments as it thinks fit on the recommendations of the Advisory Board and to report its comments to the Professorial Board.
- (7) The provisions of section 6 of this Statute shall apply to meetings of Advisory Boards.
- 16. The Dean of each Faculty shall send to the Professorial Board for submission to and confirmation by the Senate at its July meeting in each year a list of the names and qualifications of all members of the Faculty and of the Advisory Board where such a Board exists.
