Whether the system and procedure of the State Housing Commission with reference to permits to build houses or other buildings, or to make extensions, additions or alterations to existing buildings, or with refer-ence to the allocation of houses built by the Commis-sion for rental, have been and are adequate for the purpose of meeting the respective needs and claims of applicants, and what changes (if any) could be made to improve such system and procedure.

2. With reference to any cases that may be brought before you, whether or not the Commission, on the evidence before it, has assessed adequately the claims and needs of the applicants or granted any preference or priority not reasonably warranted, having regard to the building situation and the position of the applicant.

3. Whether the Commission has granted an unjustifiable preference to any of its officers by granting to them the occupancy of certain rental houses built by the Commission or by granting to them permits to build.

4. Whether, having due regard to the staff available for the purpose, the Commission has shown insufficient diligence and zeal in investigating the truth of statements made in applications for permits to build or to make extensions, additions and alterations to build-ings, or in applications for the allocation of rental houses built by the Commission.

5. Whether, having due regard to the staff available for the purpose, the Commission has shown insufficient diligence and zeal in detecting offences against the provisions of the Building Operations and Building Materials Control Act, 1945-1946, and the regulations made thereunder or in instituting prosecutions for such offences.

6. Whether officers or employees of the Commission have engaged in private work during time which should be devoted to the service of the Commission.

7. Whether any officers or employees of the Commission have accepted any bribe or any illicit benefit or reward of any kind as a consideration for or as an inducement to such officer or employee doing any act or omitting to do any act in the discharge or pur-ported discharge of his duties as such officer or em-ployee of the Commission.

8. Whether any of the officers of the Commission has been subject to wrong influences, and, if so, to what extent (if any) the decisions and administration of any such officer have been affected by such influences.

And I hereby request you as soon as reasonably may be to report to me in writing the result of this your Commission.

And I declare that you shall by virtue of this Commission be a Royal Commission within the Royal Commissioner's Powers Act, 1902, as reprinted in the Appen-dix to the Sessional Volume of the Statutes for the year 1928, and that you shall have the powers of a Royal Commission and the Chairman thereof under that Act.

## Marketing of Onions Act, 1938. PROCLAMATION

WHEREAS it is enacted by section 4 of the Marketing of Onions Act, 1938, that the Governor may at any time on the application of the Western Australian Onion Marketing Board, provide and declare by Proclamation marketing Board, provide and declare by Proclamation that the property in all onions belonging to growers shall forthwith upon the date of publication of the Proclamation, or on or from some other date specified therein be divested from the growers thereof and become vested in and be the ab-solute property of the said Board as the owner thereof and that any onions belonging to the growers there-after coming into existence within a time specified in the Proclamation shall become vested in and be the abthe Proclamation shall become vested in and be the ab-solute property of the said Board and may by such Proclamation make such further provision as will enable the Board effectively to obtain possession of such onions the Board effectively to obtain possession of such onions and to deal with the same as may be deemed necessary or convenient in order to give full effect to the objects and purposes for which the Board has been constituted: And whereas the said Board has made application for the issue of a Proclamation accordingly and it is deemed desirable and expedient that such a Proclamation shall be issued: Now therefore I the said Lieutenant-Governor, acting with the advice and consent of the Executive acting with the advice and consent of the Executive Council, and pursuant to the application of the Western Australian Onion Marketing Board, and in exercise of the powers conferred by section 4 of the said Act, do hereby provide and declare for the purposes of the said Act, that forthwith upon the date of publication of this Proclamation in the Government Gazette, the property in all onions then belonging to growers within the mean-ing of the said Act shall, subject to all lawful excepgranted by the said Board, be divested from the said growers thereof, and shall become vested in and be the absolute property of the said The West-ern Australian Onion Marketing Board as the ern Australian Onion Marketing Board as owner thereof and also that subject to the exceptions and exemptions aforesaid any onions be-longing to the said growers after the date of the publiand coming into existence within the gave of the publi-ing on the said date and ending on the 30th day of November, 1948, shall, as from the time when they come into existence as aforesaid become vested in and be the absolute property of the said Board and that as from the date of publication of this Proclamation in the Government Gazette and whilst it continues in operation. the Board may, but subject to the regulations at any time or from time to time in force do such lawful acts and things and take such lawful means as the owner
