### PROCLAMATION

WHEREAS by section 17, subsection (1) of the Charitable Collections Act, 1946, it is provided that the Governor may by proclamation vest in the Minister the moneys, securities for money, and articles in any war fund on being satisfied—(a) that a majority of at least three-fourths in number of the persons who are trustees or who have the control of the moneys or security for money or articles in such fund has consented thereto; and whereas such a majority of the W.A. Sportsmen's Organising Council for Patriotic Funds has so consented, and whereas by subsection (2) of section 17 of the Act the Governor may by proclamation vary such trusts and authorise the Minister to apply the said moneys and securities and articles or any part thereof to such charitable purposes as he may direct: Now therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred on me by section 17 of the Charitable Collections Act, 1946, hereby proclaim that the Minister is authorised to apply the said articles as set out in the Schedules 1 to 7 attached hereto, to the respective trusts of—

##### Amendment of Regulations.

C.S.O. 233/46.

THE Fremantle Harbour Trust Commissioners, acting pursuant to section 65 of the Fremantle Harbour Trust Act, 1902 (as reprinted with amendments in the 1934 Sessional Volume of Statutes), hereby amend the regulations made by them and in force under the said Act, as published in the *Government Gazette* of the 5th day of September, 1934, and amended from time to time thereafter (reprinted by the Government Printer with all amendments to the 28th day of February, 1946, and subsequently amended by notices published in the *Government Gazette* on the 31st day of May, 1946, the 5th day of July, 1946, the 8th day of November, 1946, and the 17th day of January, 1947) in the manner mentioned in the Schedule hereunder.

##### Schedule.

A new regulation is inserted after Regulation No. 103, to stand as Regulation No. 103A as follows:—

##### No. 103A.

Conditions to be observed by Masters of Vessels requiring Pilotage.—Masters of vessels approaching the Port of Fremantle and requiring the services of a pilot shall—

(a) lay to off the pilot boarding ground in such a manner as to provide the best possible lee;

(b) provide on the lee side a pilot ladder fitted with spreaders and a man rope on either side of the ladder made fast to the vessel quite independent of the ladder, such ladder to be suitably lighted at night;

(c) in ships of high structure in which gangway doors are fitted, one such door to be opened and the pilot ladder rigged thereat;

(d) provide a suitable boat rope in such a manner that the forward end is fast well forward of the ladder and the after end held abaft the ladder in readiness to be released when the pilot vessel has secured the boat rope; and

(e) arrange for all scuppers, sanitary and other refuse outlets in the vicinity of the pilot ladder to be closed.

Note: Similar facilities shall be provided by departing vessels for the disembarkation of a pilot.

In accordance with the conditions of the lease, a valuation shall be made at the end of the assistance period, or on the completion of the planned work, to ascertain the value of the additional non-structural improvements, for the purpose of adjusting the rent, and the value of the structural improvements, for the purpose of determining the half-yearly payments for the purchase of them.

It has been decided to defer the sale of the structural improvements until the end of the assistance period. Until then, they will remain the property of the Crown, and should not be removed or altered without approval in writing of the Field Superintendent, Farm Planner, District Supervisor or other authorised Officer.

Applicants are requested to supply all information required on application forms and Allotment Board Questionnaire, but the questionnaire will be required only if one has not already been submitted or, if particulars as supplied in the form already completed, have altered.
