## Native Administration Act, 1905-1941. Reserve for Natives at Highbury. PROCLAMATION

WHEREAS by section 11 of the Native Administration Act, 1905-1941, it is provided that the Governor is empowered by Proclamation to declare any Crown lands to be Reserves for Natives; and whereas it is deemed desirable that a Reserve for Natives should be declared at Highbury: Now, therefore I, the said Lieutenant-Governor, with the advice of the Executive Council, do hereby declare lot 84, Highbury, to be a Reserve for Natives.

## The Fisheries Act, 1905-1946. PROCLAMATION

WHEREAS by section 19 of the Fisheries Act, 1905-1946, it is provided that the Governor may, by Proclamation in the Government Gazette declare (inter alia) what length of net and size of mesh for the whole or any part of a fishing net shall, when used or intended to be used in any specified water or waters, or for eatching any specified kind or kinds of fish, be a lawful net: Now, therefore I, the Lieutenant-Governor, do hereby, in exercise of the powers aforesaid and of every other power enabling me in this behalf, declare and proclaim as follows:—

1. That nets which do not exceed in length 200 yards and have throughout meshes of not less than 2¼ inches measured from knot to knot on the inside of the mesh when wetted and ready for use and stretched so that the opposite knots on the alternate corners are in contact, shall when used or intended to be used for lawful fishing in the waters defined in the First Locality Schedule hereto be lawful nets, and that it shall not be lawful to use in such waters any net not in conformity with these conditions.

2. That nets which do not exceed in length 60 yards and have throughout meshes of not less than  $2\frac{1}{2}$  inches measured from knot to knot on the inside of the mesh when wetted and ready for use and stretched so that the opposite knots on the alternate corners are in contact, shall, when used or intended to be used for lawful fishing in the waters defined in the Second Locality Schedule hereto be lawful nets, and that it shall not be lawful to use in such waters any net not in conformity with these conditions. The Proclamation dated 16th November, 1921 (published in the *Government Gazette* of 18th November, 1921) and paragraph 1 and the First Locality Schedule of the Proclamation dated 20th December, 1916 (published in the *Government Gazette* of 22nd December, 1916), are hereby cancelled.

#### First Locality Schedule.

The waters of the Swan and Canning Rivers upwards (or Easterly) of a line drawn from the South-West extremity of Point Resolution to Point Walter Jetty, to-

1. Perth Causeway.

2. A line drawn from a point on the right bank of the Canning River and situate 8 chains North-Westerly from Salter Point, and extending 242 degrees 21 minutes 22 chains 3 6/10th links across the said river, the extremities of such line being marked on the ground with steel rails.

Second Locality Schedule.

The waters of the Swan River, extending from the Railway Bridge at Guildford to the Middle Swan Bridge, connecting Middle Swan Road.

IN pursuance of the provisions of section 9 of the Fisheries Act, 1905-1946, I, the Lientenant-Governor of the State of Western Australia, do hereby prohibit all persons from taking any fish whatsoever by means of fishing nets, in any of the portions of Western Australian waters specified in the Schedule hereto from date of publication of this Proclamation in the *Government Gazette* until 31st December, 1948, inclusive. The Proclamation dated 13th November, 1946 (published in the *Government Gazette* of 22nd November, 1946), is hereby cancelled.

#### Schedule.

1. The waters of the Swan River and of its tributaries from the Perth Causeway upwards to the Railway Bridge at Guildford.

2. The waters of the Swan River and of its tributaries from the Middle Swan Bridge connecting the Middle Swan Road upwards to its source.

3. The waters of the Swan River and of its tributaries from a line drawn from the South-Western extremity of Point Resolution to the South-Western extremity of the Point Walter jetty (situated at Point Walter), downwards to a line drawn from the Western extremity of the South Mole to the Western extremity of the North Mole at Fremantle.

4. The waters of the Canning River and of its tributaries upwards to its source, from a line drawn from a point on the right bank and situate 8 chains North-Westerly from Salter Point, and extending 242 degrees 21 minutes 22 chains 3 6/10th links across the said river, the extremities of such line being marked on the ground with steel rails.

5. All that area of Western Australiau waters bounded by a line drawn 150 chains due West from the Southerly extremity of the Fish Market breakwater at Fremantle; thence 50 chains due North; thence in an Easterly direction to Rous Head.

6. All that area of Western Australian waters from the Southerly extremity of Mudurup Rocks (South of Cottesloe Jetty) and extending in a Northerly direction to the South-Western extremity of North Street, Cottesloe, with a width of a quarter of a mile from the foreshore.

By-laws-Reserve No. 22672.

L. and S. 2442/19.

By-laws of the Harvey Road Board made under section 201 (8) of the Road Districts Act, 1919-1946, for the use Management and Maintenance and Preventing any Nuisance or Obstruction of or Damage or Injury of a Reserve created for the purpose of Recreation and Golf Links.

IN pursuance of the powers conferred by the said Act, the Harvey Road Board doth make the following bylaws:-

By-laws for Use and Management of Reserve 22672 created for Recreation and Golf Links.

In the construction of these by-laws unless the context otherwise requires-

"Board" means the Harvey Road Board.

"Reserve" means reserve No. 22672.

"Officer" means the secretary, health inspector, caretaker, a ranger of the Board or any person appointed in writing by the secretary.

1. Subject to the restrictions imposed by the next succeeding by-law, the reserve shall be open to the public at all hours free of charge.

2. In the event of the Board granting a lease of or permit to use the whole or any part of the reserve to any person or persons or club for the purpose of enabling any particular game or games to be played or established on the reserve, then so long as such lease or permit remains in force no games shall be played or action taken by any member of the public which may prevent, hamper, interfere or compete with such per-son or persons or club in the use of the reserve for the purpose set forth in such lease or permit to use and no person shall do or cause to be done anything which will or may be likely to interfere or compete with such person or persons or club in any manuer in commencing playing or carrying on such game or games or in carrying out of work necessary to make the said reserve fit for use for such game or games.

3. No person shall damage, destroy or injure any tree, shrub, tree guard, wall, fence, building, seat, sanitary convenience, water pipe, channel, drain, hose or fitting, soil, fairway, bunker, green, tee, or any other improvement now or hereafter erected or constructed upon the said reserve: Provided however that nothing herein contained shall be deemed to limit the rights of any person or persons or club in the carrying out of work under a lease or permit to use to develop the said reserve for the playing of any game or games which is authorised by an officer of the Board.

4. No person shall:-

(a) deposit or leave rubbish, refuse, paper, broken glass, china or litter of any kind upon the said reserve except in receptacles provided for that purpose:

(b) light a fire on such reserve without the consent of the Board;

(c) use firearms of any sort or description on such reserve;

(d) cause or allow or suffer any livestock to be upon or to depasture upon such reserve without having first obtained the authority of the Board to do so;

(c) commit a nuisance within such reserve or any building erected thereon.

Any person found in a state of intoxication or behaving in a disorderly manner or using indecent, profane or insulting language or creating or taking part in any disturbance or committing any act of indecency on such reserve may be forthwith removed from such reserve by any officer of the Board or any member of the police force and shall be, moreover, liable to prosecution for an offence against this by-law.

6. Every person offending against any of the pro-visions of these by-laws shall be liable for every such offence to a penalty not exceeding twenty pounds. Passed by resolution by the Harvey Road Board on

Fishing By-laws of the Gnowangerup Road Board.

P.W. 88/38.

WHEREAS by the Road Districts Act, 1919-1946, the Road Board of any district is empowered to make bylaws for all or any of the purposes of paragraphs (b) and (c) of section 6 of the Fisheries Act, 1905-1946, and for the purposes for which Proclamations may be made under sections 8 and 9 of such last-mentioned Act, and for the taking of fish under license from the Board, and for other matters set out in the said Road Districts Act, 1919-1946, so that the application and effect of such by-laws shall be restricted to Western Australian waters vested in or under the control of the Board; and whereas reserves No. 21646 (Wellstead Estuary) and No. 21647 (Beaufort Inlet), being Western Australian waters, are vested in or under the control of the said Gnowangerup Road Board: Now, in pursuance of the powers vested in the said Board under and by virtue of the said Acts and every other authority enabling it in that behalf, and pursuant to a resolution of the Board dated the 18th day of September, 1947, the said Board doth make and publish the following by-laws:

Control of Fishing in Reserves No. 21646 (Wellstead Estnary) and No. 21647 (Beaufort Inlet) vested in or under the Control of the Gnowangerup Road Board.

1. (a) The taking of fish of any species with a fishing net in any water or either of the said reserves is hereby prohibited, except in pursuance and under the terms and conditions set out in a license issued by the Board.

(b) No license shall be granted to any person to take fish of any species with a fishing net having a greater length than 100 yards of four-inch mesh or 50 yards of three-and-a-half-inch mesh, the maximum depth of any net shall be six feet, and the minimum size mesh shall be three and a half inches.

(c) A license may be granted under these by-laws to any person to take fish with a fishing net of any length, not being more than 100 yards, but such license shall not be granted for a longer period than 12 months from the date of issue thereof.

(d) A license to take fish with a fishing net shall be in the form numbered 1 in the Schedule attached hereto, and every such license shall be signed by the secretary.

(e) Any such license may be for the taking of fish in either or both of the said reserves.

(f) The fee for a license to take fish with a fishing net in the said reserves, or either of them as afore-said, shall be five shillings for every 100 feet or part of 100 feet of its length.

(g) Without assigning any reason for such refusal, the Board may at any time refuse to grant a license to take fish with a net to any person: Provided that any person who has been refused a license may appeal to a resident magistrate, whose decision shall be final and binding on all parties.

2. Any person or persons using, having used, or being about to use a fishing net to take fish in waters of the said reserves, or found in a boat containing a net on such waters, shall forthwith, on demand by the secretary of the Board, or any inspector, officer or member of the Board, produce his license permit, such net to be measured not only as to length but also as to depth and size of mesh, and give his name and address.

3. (a) The secretary of the Board or any inspector or officer or member of the Board may seize any net being used or about to be used in any waters of the said reserves, or either of them in respect of which no license is held by the person or persons concerned, or in respect of which the license held her expired or in respect of which the license held has expired, or in respect of which the limitations as to length, depth and the size of the mesh imposed by any license held by the person or persons concerned, or any of such limitations, are not in compliance with such license.

(b) Any person found in any boat containing a net on any waters of the said reserves shall, if such person be not the holder of a current license, or if the net be greater as to length and depth, or smaller as to mesh than the dimensions prescribed in by-law 1 (c), or if in the waters on which he is found the use of nets is prohibited by a notice issued by the Board, shall be liable to a penalty of not less than five pounds and not exceeding 20 pounds, and the net found in such boat shall, on the conviction of the defendant, be forfeited to His Majesty.

4. Any person who shall assault, resist, obstruct or delay, interfere with or give false information to, or use abusive language to the secretary of the Board, any inspector or officer or member of the Board, when in the execution of his duties, or authority under these by-laws, and any person who shall direct or encourage out other persons as to do shall be here a penalty. any other person so to do, shall be liable to a penalty not exceeding 20 pounds or to imprisonment for a term not exceeding six months.

5. No person shall at any time in either of the said reserves take fish of any species by means of a fixed engine.

6. The Board, subject to the approval in writing by the Chief Inspector of Fisheries, may from time to time by notice published in the *Government Gazette* and for the period specified in such notice, prohibit all persons from taking any fish whatsoever in the said reserves, or either of them, or any part or parts of them by means of fishing nets and fishing lines, or of each methods of each the methods of each the methods of each the such methods of each the specified in such notice.

7 Every person who commits any breach of or does anything contrary to any of these by-laws, shall be guilty of an offence, and shall, on conviction, where no other penalty is provided, be liable to a penalty not exceeding 20 pounds and not being less than two pounds, for every such offence.

8. In these by-laws-

(a) "Board" means the Gnowangerup Road Board.

(b) "The said reserves" means Reserves No. 21646 (Wellstead Estuary) and No. 21647 (Beaufort Inlet).

(c) "Secretary" means the secretary for the time being of the Board.

(d) "Inspector" means any person appointed by resolution of the Board and in possession of a certificate of authority signed by the chairman of the Board at the time of such resolution and who may act either without payment or be paid such remunera-tion or allowance as the Board by the same or an other resolution may determine. The Chief Inspector of Fisheries and Inspector appointed under the Fisheries Act, 1905-1946.

(e) "Member" means any member of the Board for the time being.

(f) "Fixed engine" has the same meaning as the "fixed engine" defined by section 3 of the Fisheries Act, 1905-1946.

(g) Unless otherwise required by the context, the singular includes the plural.

(h) "License" means a license issued by the Board.

## MARKETING OF EGGS ACT, 1945. Notice Fixing "The Appointed Day."

NOTICE is hereby given that the Western Australian Egg Marketing Board, acting pursuant to section 21 (1) of the Marketing of Eggs Act, 1945, has fixed Thursday the 1st day of January, 1948, as the appointed day on and after which every producer shall comply with the requirements of the said Act as to the sale and delivery of eggs.

The Board desires to draw the attention of producers to the provisions of subsection (2) of section 21 of the said Act which provides as follows:—

21. (2) On and after the appointed day a producer shall not sell or deliver any eggs to any person other than the Board and a person other than the Board shall not purchase or take delivery of any eggs from a producer: Provided that the foregoing provision of this subsection shall not apply to any eggs sold or delivered as allowed under section twenty-three of this Act.

Section 23 of the said Act refers to exemptions by granting permits to producers authorising the sale of eggs to persons other than the Board.

The definition of a "Producer" pursuant to section 5 (1) of the said Act is as follows:—

"Producer' means a person who owns or controls twenty adult female fowls and/or ducks and sells the eggs or any of the eggs produced thereby. For the purposes of the definitions contained in this section a fowl or duck shall be regarded as an adult if it has commenced laying eggs or is six months of age, whichever sooner happens.
