Six-inch and 4-inch diameter pipe sewers, two (2) pneumatic ejector stations, with 4in. diameter reinforced concrete rising main from each, and all manholes and other apparatus connected therewith, between Albany Highway and a line about 400 feet South of and parallel to Albany Highway, and Canterbury Terrace and Baillie Avenue (as shown in blue and green on Plan M.W.S.S. & D.D., W.A. No. 6884.

This Order in Council shall take effect from the 20th day of February, 1948.

By-laws for the Management of the Rockingham Public Cemetery (Reserve No. 841).

HIS Excellency the Lieutenant-Governor in Conneil. acting pursuant to the powers conferred by the provisions of the Cemeteries Act, 1897-1946, and of amending Acts, has been pleased to approve of the by-laws made by the Trustees of the Rockingham Public Cemetery as set out in the Schedule hereunder.

Schedule. PUBLIC CEMETERY, ROCKINGHAM. By-laws.

By virtue of all powers in that behalf vested in the Trustees of the Public Cemetery, Rockingham, the said Trustees make the following by-laws:—

- 1. All fees and charges payable to the Trustees as set forth in the Schedule A shall be paid at the times and manner therein mentioned.
- 2. The "secretary," as referred to in these bylaws, means the person for the time being employed by the Trustees as the secretary of the cemetery, and such person shall, subject to the Trustees, exercise a general supervision and control over all matters pertaining to the cemetery and to the carrying out and enforcement of these by-laws, and the direction of such person shall in all cases and for all purposes be presumed to be and to have been the direction of the Trustees,

- 3. The "superintendent," as referred to in these by-laws, means the person for the time being employed by the Trustees as the superintendent of the cemetery, and such person shall, subject to the Trustees, have charge of the general care of the cemetery, the supervision of the crection or placing of monumental work and fixtures, also the supervision of interments the opening, closing and dressing of graves, and such other duties as are mentioned in these by-laws or ordered by the Trustees.
- 4. Any person desiring to inter any dead body in the cemetery shall make an application to the Trustees. Upon such application being approved by the Trustees, and upon payment of the prescribed fees, they shall cause to be issued to the person so applying an order for burial.
- 5. All applications for interment shall be made at least five working hours prior to the time fixed for burial. An extra charge shall be made for applications within such time. No free interment shall be allowed, unless the application, together with the Justice's order therefor, be handed in in such time as to allow of at least five working hours as above.
- 6. No graves shall be dug, and no vault, brick graves, or graves shall be re-opened without the permission of the Trustees.
- 7. Before any interment is allowed the "Order for Burial" shall be handed to and retained by the secretary.
- S. Every coffin shall have upon the lid an approved metal plate hearing the name of the deceased, stamped or otherwise indelibly inscribed in legible characters thereon. No coffin not complying with this by-law shall be admitted to or be interred in the cemetery.
- 9. Every grave shall be at least off, deep at the first interment, and no interment shall be allowed in any grave with a less depth than 3ft, from the top of the coffin to the original surface of the surrounding ground.
- 10. In the case of an application for interment in any private grave or vault to which the deceased had no claim during life, the written and verified consent of the grantee shall be handed in with the application.
- 11. The hours for burial shall be as follows:—1st September to 30th April: Week days, from 8 a.m. to 6 p.m.; Sundays, from 2 p.m. to 6 p.m. 1st May to 31st August: Week days, from 8 a.m. to 5 p.m.; Sundays, from 2 p.m. to 5 p.m.; and no hurial shall be allowed to take place, nor any coffin allowed to enter the cemetery at any other hour, except by written permission of the Trustees.
- 12. The time fixed for any burial shall be the time at which the funeral is to arrive at the cemetery gates, and such time shall be rigidly and punctually observed.
- 13. No hearse, mourning coach or other vehicle shall enter the cemetery, or proceed, except at and hy such roads, as directed by the officer of the Trustees from time to time. Any driver or other person failing or neglecting to observe such directions commits an offence against these by-laws.
- 14. Children under the age of twelve years entering the cemetery must be in charge of some responsible person.
- 15. It shall be unlawful for any person to smoke within the cemetery, or to discharge any fireworks therein.
- 16. No dogs shall be allowed within the cemetery, and any person taking a dog into the cemetery commits an offence against these hy-laws.
- 17. Any person violating the rules of proprietry and decornm, or committing any unisance or trespass, or injuring any tree, shrub, flower horder, or any erection, commits an offence against these by-laws.
- 18. No person shall promote, or advertise, or carry on within the cemetery any trade, business, or calling, either by solicitation, distribution of circulars, by eards or otherwise, or by any other system of advertisement whatsoever,

- 19. No person employed by or under the Trustees shall accept any gratuity whatever, nor shall he be pecuniarily interested in any work in the cemetery other than the remuneration he receives from the Trustees, and any such person proved gnilty of accepting any gratuity, or being pecuniarily interested in any such work, shall be liable to summary dismissal.
- 20. Any person requiring an "Exclusive Right of Burial" in any part of the cemetery shall apply to the Trustees in writing, specifying the locations of the grave, and whether it is proposed to creek a brick grave or vault, and in such case submitting plans and specifications of the proposed work. Such application shall also state the name of any already deceased persons whose remains it is proposed to intertherein.
- 21. Subject to the by-laws the secretary shall exercise a general supervision and control over all matters pertaining to the cometery including the conduct of all funerals and interments within the cometery.
- 22. Upon being satisfied of the matters aforesaid, and of the saitability of the said work, plans and specifications, the Trustees may authorise the construction and erection thereof: or if no work is to be done, may issue a "Grant" in the prescribed "Form" in the Schedule.
- 23. Upon the completion of the work aforesaid, the Trustees may, if and when such work is done to their complete satisfaction, issue a "Grant" in the prescribed "Form" in the Schedule.
- 24. Every "Grant" shall be subject to the bylaws for the time being, and no interment in any grave or vault shall be allowed unless upon production of the "Order of Right of Burial" aforesaid, nor shall any such grave or vault be opened, unless with the written consent of the Trustees.
- 25. Every coffin placed in any such bricked grave or vault shall be bricked in, cemented, and covered with a slab of stone, slate, or iron, unless special written exemption be obtained from the Trustees.
- 26. If application be made for an "Order for Right of Burial" in any grave or vault of the remains of any person other than to whom the grant was issued, or his registered assign, the written and verified consent of such grantee or assignee shall be produced.
- 27. Should the grantee be unable to produce the "Grant of Right of Burial," on making application for a grave to be reopened for the purpose of interment, through having lost same, the said grantee shall make a sworn declaration to this effect, and shall pay the fee for a copy of such "Grant of Right of Burial," as prescribed in Schedule A, before an "Order for Burial" will be issued by the Trustees.
- 28. Any person desiring to place or creet any monument, tombstone, or enclose in any part of the cemetery, must first obtain the written consent and approval of the Trustees, and otherwise comply with section 23 of the Cemeteries Act. 1897.
- 29. Every tombstone, monument, or enclosure shall be placed on proper and substantial foundations, which, if required by the Trustees, shall extend to the bottom of the grave.
- 30. The materials used in every such crection shall be subject to the approval of the Trustees, and any material rejected shall be immediately removed from the cemetery by the contractor for the erection.
- 31. All refuse and other rubbish remaining after any work is completed shall be immediately removed from the cemetery by the person causing same.
- 32. Monumental masons and other tradesmen shall, before commencing work within the cemetery deposit with the secretary to the Trustees the sum of ten shillings, which shall be forfeited, if either of the two last preceding by-laws is not complied with to the satisfaction of the Trustees.
- 33. All materials required in the crection and completion of any work shall, as far as possible, be prepared before being taken to the cemetery, and all materials required by the tradesmen shall be admitted at such entrance as the Trustees shall direct: and no vehicle conveying any such material, with wheels less than four inches broad, shall be permitted to enter the cemetery,

- 34. No catacomb shall be allowed.
- 35. Every grave, vault, monment, tombstone, kerbing, or any other erection, shall be maintained and kept in thorough repair and proper condition by and at the expense of the grantee. Should the grantee's residence not be known, or be out of the State, the Trustees to have power to do the work and keep an account against the grantee. No mounds shall be allowed.
- 36. No wooden fence, railing, cross or other wooden erection shall be allowed on or around any grave or vault without permission of Trustees.
- 37. No trees or shrubs shall be planted on any grave, except such as shall be approved by the Trustees.
- 38. All workmen, whether employed by the Trustees or by any other person, shall at all times, whilst within the boundaries of the cemetery, be subject to the supervision of the Trustees, and shall obey such directions as they may find it necessary to give: and any workmen permitting any breach of these regulations and by-laws, or refusing or neglecting to comply with any directions of the Trustees, commits an offence against these by-laws.
- 39. Any person taking part in dressing or attending to any grave shall comply with the following rules:—
- (a) No rubbish, soil, sand, or other material removed in dressing a grave shall be placed on any other grave, and, if placed on any adjoining ground, shall be removed immediately the work is completed.
- (b) No sand, soil, or loam shall be taken from any portion of the cemetery for the purpose of dressing any grave, except with the permission of the Trustees.
- (c) The dressing of all graves and the wheeling and carting of all material shall be subject to the supervision of the Trustees.
- (d) Work in all cases shall be carried on with due dispatch, and only during regulation hours.
- 40. Prior to the conduction of any interment within the cemetery or making use of the cemetery for any purpose connected with interments, every undertaker shall pay to the Trustees a fee of 10s. 6d. for each burial, or £2 2s. per year, and shall at the time of making such payment give his assent in writing to such conditions as the Trustees may deem fit to impose. Upon such assent being given and payment of the fee made, he shall receive a "Permit." to hold good during good behaviour and until the first day of July following, and, unless in the possession of such a "Permit," no undertaker shall be allowed to engage in or carry out any duty or work within the cemetery.
- 41. The Trustees may decorate graves from time to time, when desired by the grantees so to do. If the grantees do not desire the Trustees to carry out this work, the grantees may either do it themselves or employ any person licensed by the Trustees for that purpose.
- 42. No person, except the relatives of the deceased, the Trustees or those licensed by the Trustees, shall be permitted to decorate any grave.
- 43. Any person committing any breach of these by-laws and regulations, or of any other rules, regulations or by-laws, lawfully made under authority of any Act relating to cemeteries, shall for every such offence be liable to a penulty not exceeding £5, and, in case of a continuing breach, a further sum not exceeding £1 for every day during which such breach continues, and shall forthwith be removable from the cemetery by the Trustees, the secretary or other officer of the Trustees, and shall be treated as a trespasser, and may be proceeded against accordingly.
- 44. A plan of the cemetery, showing the distribution of the land, compartments, sections, situation, and number of grave and a register of all certificates of "Right of Burial" shall be kept at the office.
- 45. Notwithstanding anything contained in the foregoing by-laws to the contrary, permission may be granted to the Defence Department of the Commonwealth to creet headstones on the graves of deceased soldiers without payment of any fec.

- 46. Free ground may be granted if it is proved to the satisfaction of the Trustees:—
- (a) That the deceased was a returned soldier, and that he died as a result of injuries or disease received in the late war:
- (b) and that the relatives of the deceased are in necessitons eircomstances; provided that such "Grant" shall be made subject to the condition that only the remains of deceased soldiers shall be interred in the grave.
- in the grave.

 47. The Trustees may maintain the graves of dereased soldiers free of cost for a term of seven years.

 48. All by-laws heretofore made by the Trustees are hereby repealed.

The foregoing by-laws, with the accompanying Schednles, were duly framed and presented to a meeting of the Board of Trustees held at their Office, at Rockingham on the lith day of March, 1947, and adopted.

HIS Excellency the Lieutenant-Governor in Executive Council acting pursuant to the provisions of the Laud Act, 1933-1946, has been pleased to amend, in the manner mentioned in the schedule hereunder, regulation 157 of the regulations as made under the said Act for the guidance of surveyors and published in the Government Gazette in particular on the 16th day of September, 1910.

HAVING heard Miss D. Place on behalf of the applicant, and Mr. G. D. Browne on behalf of the respondents and by consent the Court in pursuance of the powers contained in Section 92 of the Industrial Arbitration Act, 1912-1941, doth hereby order and declare that Award No. 10 of 1936 made between the abovenamed parties be, and the same is hereby further amended in the manner following:—

2.—Overtime.

Delete this clause and substitute in lieu thereof the following:

- (a) All overtime worked except in relation to Sundays and holidays, for which provision is made elsewhere in this Award, shall be paid for at the rate of time and one half for the first four (4) hours and double time thereafter. Watehmen or watehmeneleaners shall be paid at overtime rates for any work performed beyond one hundred and four (104) hours or eighty-eight (88) hours respectively in any fortnight.
- (b) Notwithstanding anything contained in this Award-
 - (i) An employer may require any worker to work reasonable overtime at overtime rates, and such worker shall work overtime in accordance with such requirement
 - (ii) No organisation, party to this Award, or worker or workers covered by this Award, shall in any way, whether directly or indirectly, be a party to or concerned in any ban, limitation or restriction upon the working of overtime in accordance with the requirements of this subclause.
 - (iii) This subclause shall remain in operation only until otherwise determined by the Court.

6.-Absence Through Sickness.

Delete subclause (a) of this clause and substitute in lien thereof the following:—

(a) A worker shall be entitled to payment for nonattendance on the ground of personal ill-health for one-twelfth (1/12th) of a week for each completed month of service: Provided that payment for absence through such ill-health shall be limited to one (1) week in each calendar year.

18.—Definitions.

Delete the first paragraph of subclause (a), and delete subclauses (e) (i), (h) and (i) of this clause and substitute in lien thereof the following:—

(a) "Caretaker" shall mean a worker required to reside on or in the vicinity of the premises of his employer and who shall do such work as his employer may direct not exceeding forty-four (44) hours in any one (1) week.

- (e) (i) "Casual Hand, male" shall mean a male worker who is employed for a period of one (1) week worker who is employed for a period of one (1) week or less or who is regularly employed and who does not perform more than 12 hours' work in any one (1) week. Provided further, that by agreement in writing between the employer and the Union the 12 hours herein mentioned may be increased.
- (h) "Full time hand" (female) shall mean a worker who is employed for less than forty (40) hours, but not less than twenty-five (25) hours in any one week. This definition is not applicable to Section (D).
- (i) "Weekly hand" (female) shall mean a worker who is employed for not less than forty (40) hours in any one week. This definition is not applicable to Section (D).

22.-Hours.

Delete this clause and substitute in lien thereof the following:-

- (a) Caretakers:-Forty-four (44) hours shall coustitute a week's work.
- (b) Watchmen (Oil Stores):—Fifty-two (52) hours shall constitute a week's work. This provision shall be deemed to have been complied with if the ordinary working hours do not exceed one hundred and four (104) hours per fortnight.
- (e) Watchmen (Others):--Fifty-two shall constitute a week's work. This provision shall be deemed to have been complied with if the ordinary working hours do not exceed one hundred and four (104) hours per fortnight.
- (d) Watchmen-Cleaners:—Forty-four (44) hours shall constitute a week's work. This provision shall be deemed to have been complied with if the ordinary working hours do not exceed eighty-eight (88) hours per fortnight.

(e) Cleaners:-

- (i) Forty (40) hours shall constitute a week's work.
- (ii) Such work shall be performed between the hours of 6 a.m. and 7 p.m. on five (5) days in the week excluding Sundays, and between 6 a.m. and 12 o'clock noon on the day upon which the weekly half-holiday is observed.
- (iii) Not more than eight (8) hours work shall be performed on any of the five (5) days referred to in subclause (ii) of this clause, and not more than four (4) hours work shall be performed on the day upon which the weekly half holiday occurs.
- (iv) The starting and finishing times prescribed in this clause may be altered in exceptional circumstances by agreement in writing between the employer and the union, or failing such agreement, by the Board of Reference.
- (f) Attendants:-Males: Forty-four (44) shall constitute a week's work to be worked between the hours of 8.20 a.m. and 6 p.m. on five (5) days of the week excluding Sundays and between 8.20 a.m. and 1 p.m. on the day upon which the weekly half holiday is observed.

32.—Hours.

Delete this clause and substitute in lien thereof the following:-

(a) Attendants:-

(i) Males: Forty-four (44) hours shall constitute a week's work, to be worked between the hours of 8.20 a.m. and 6 p.m. on five (5) days in the week, excluding Sundays, and between 8.20 a.m. and 1 p.m. on the day upon which the weekly half holiday is observed.

The starting and finishing times herein prescribed may be varied in exceptional circumstances by agreement in writing between the employer and the union, or failing agreement, by the Board of Reference.

(ii) Females:-Forty (40) hours shall constitute a week's work, to be worked between the hours of 7.30 a.m. and 6 p.m. on five (5) days in the week, excluding Sundays, and between 7.30 a.m. and 1 p.m. on the day upon which the weekly half holiday is observed. (iii) Not more than eight (8) hours work shall be performed on any of the five (5) days referred to in subclause (ii) of this clause, and not more than four (4) hours' work shall be performed on the day upon which the weekly half-holiday is changed. observed.

- (i) Passenger Lifts:-Forty-one and one half (i) Passenger Lifts:—Forty-one and one half hours (41½) hours shall constitute a week's work to be worked between the hours of 8.45 a.m. and 6 p.m. on five (5) days in the week excluding Sundays and between 8.45 a.m. and 1 p.m. on the day upon which the weekly half holiday is observed.
