WHEREAS an industrial dispute existed between the abovenamed parties, and whereas the said dispute was referred into Court for the purpose of hearing and determination, and whereas the parties subsequently met and conferred and have arrived at agreement on all matters in difference, and whereas the parties have this day appeared before the Court by their respective representatives and requested the Court to make the said Agreement an Award of the Court: Now, therefore, the Court, pursuant to section 65 of the Industrial Arbitration Act. 1919, 1941, and all other recovery therein. Arbitration Act, 1912-1941, and all other powers therein enabling it, hereby declares the memorandum herenuder written to have the same effect as and be deemed an Award of the Court.

#### Memorandum of Agreement.

(Note: Wherever the word "Award" occurs herein, it shall be taken to mean and include "Agreement.")

#### 1.—Scope.

This Award shall apply to workers following the vocations mentioned in clause 5 hereof engaged in the confectionery manufacturing industry.

#### 2.—Area.

This Award shall have effect over an area comprised within a radius of fifteen (15) miles from the General Post Office, Perth.

## 3.—Term.

The term of this Award shall be for a period of one (1) year commencing as from the beginning of the first pay period after the date hereof.

# 4.—Definitions.

- (a) "Confectioner" means an adult male, not expressly included in the definition of a machinist or general hand employed-
- (i) Handling or dealing with confectionery in any process of manufacture from raw materials such as sugar, glucose, gelatine, gnm or licorice, chocolate, or similar material to the finished article, and includes a worker who runs by hand with any kind of finnel or bag, jubes, jellies, cream fondant, snowballs, or other articles which are run into stamped or moulded starch trays or other moulded receptacles; or
- (ii) operating or controlling any of the following machines

Chocolate dipping or covering machine;

licorice making or shaping machine;

depositing machine;

cocoa bean roaster;

lozenge stamping machine;

lozenge cutting machine;

mogul depositing machine.

Provided that where the operator of a licorice shaping machine or the depositing machine or the lozenge stamping machine or the lozenge enting machine or the mogul depositing machine is a worker who is neither qualified nor, able to do the work of a confectioner but is merely the operator of the machine, machinists' rates only shall be paid.

(b) "Machinist" means an adult male employed operating any one or more of the following machines:— Combined refiner and melanguer;

melanguer;

refiners ;

conchers;

cocoa mill;

cocoa buter press;

neat work mill;

liquor mill;

gnin refining;

icing sngar mill.

(c) "General hand" means an adult male worker engaged on one or more of the following operations:grinding nuts;

stirring gnm or syrup; smoothing, emptying, sieving starch trays;

eleaning confectionery; washing tins or bottles with a capacity of over 4 lbs.;

stamping lozenges;

marking toffee on slabs; rolling confectionery sticks or balls;

blanching nuts by machine;

entting confectionery by hand or vertical or circular cutting machine;

grinding figs, acids, and other ingredients used in the trade;

weighing confectionery and ingredients 30 lbs.);

straining symp or other material used in trade;

all handling of confectionery or ingredients in the manufacture of confectionery;

up-ending sugar or lumping sugar;

glazing confections;

entting neat work;

coating boiled goods with such ingredients as dry

sugar or cocoanut, etc; feeding Forgrove and similar machines (except universal type).

# 5A.—Special Rates.

(a) Any adult male employed as a cocoa butter press operator shall be paid, whilst so engaged, one shilling per day in addition to the rates prescribed in clause 5 hereof.

(b) Leading hands, female—appointed as such by the employer shall be paid one shilling and sixpence (1s. 6d.) per day in addition to the rates prescribed in clause 5 lierenf

## 6.-Homs of Work.

(a) Forty hours shall constitute a week's work and shall be worked between the hours of 7 n.m. and 6 p.m. Monday to Friday inclusive.

(b) Where more than one shift is worked the starting and finishing times shall be as agreed upon between the employers and the Union, and failing agreement the matter shall be referred to the Board of Reference for decision.

(e) Any adult worker, other than a shift worker, called upon to commence work between twelve midnight and 7 a.m. on operations which must necessarily commence between those times shall be paid two shillings (2s.) per day in addition to his ordinary rate.

#### 7.—Shift Workers.

Any worker who works on shift work other than the recognised day shift shall be paid for such shifts at the

(a) Five per cent in addition to the ordinary rate for afternoon shift.

(b) Ten per cent, in addition to the ordinary rate for night shift.

# 8.—Overtime.

(a) All time worked in excess of eight (8) hours per day, or, subject to clause 6 (e) outside the usual starting and finishing times shall be deemed overtime and shall be paid for at the rate of time and a half for the first four (4) hours and double time thereafter.

(b) When a worker without being notified the pre vious day is required to continue working after the usual knock off time for more than one hour, he shall be provided with any meal required or shall be paid one shilling and sixpence (1s. 6d.) in lieu thereof. (c) Notwithstanding anything contained in this

Award-

(i) An employer may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such require-

(ii) No organisation, party to this Award or worker or workers covered by this Award shall in any way, whether directly or indirectly, be a party to or concerned in any han, limitation, or restriction upon the working of overtime in necordance with the requirements of this subclause.

(iii) This subclause shall remain in operation only until atherwise determined by the Camt.

# 9.-Mixed Functions.

A worker who is required to do work which is entitled to a higher rate under this Award than that which he or she usually performs shall be entitled to the higher rate whilst so engaged.

## 10 .- Contract of Service.

(a) Except in the case of a casual worker, whose engagement shall be by the hour, the contract of hiring of every worker shall be a weekly contract terminable by one week's notice on either side, given on any working

(b) Subject to clause 13 hereof, any worker not attending for duty shall lose his pay for the actual time of such non-attendance.

(e) This clause does not affect the right to dismiss for miseonduct, and in such ease wages shall be paid up to the time of dismissal only.

(d) The employer shall be entitled to deduct payment for any day or portion of a day upon which the worker cannot be usefully employed, because of any strike by the Union or Unions affiliated with it, or by any other association or Union, or through the breakdown of the employer's machinery or any stoppage of work by any cause which the employer cannot reasonably prevent.

# 11.-Holidays.

(a) The following days, or the days observed in lien, shall he allowed as holidays without deduction of pay, namely:—New Year's Day, Australia Day, Good Friday, Easter Monday, Anzae Day, Labour Day, State Foundation Day, Christmas Day and Boxing Day.

(b) All work performed on any of the foregoing days shall be paid for at the rate of double time.

(e) On any public holiday not prescribed as a holiday under this Award the employer's establishment or place of husiness may be closed, in which case a worker need not present himself for duty and payment may be deducted, but if work he done ordinary rates of pay shall

#### 12.—Annual Leave.

(a) Except as hereinafter provided a period of two consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve months' continuous service with such employer.

(h) If any Award holiday falls within a worker's period of annual leave and is observed on a day which in the ease of that worker would have been an ordinary working day there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(e) If after one month's continuous service in any qualifying twelve-monthly period a worker lawfully leaves his employment, or his employment is terminated by the employer, through no fault of the worker, the worker shall be paid one-sixth (1/6th) of a week's pay at his ordinary rate of wage in respect of each completed month of continuous service.

(d) Any time in respect of which a worker is absent from work, except time for which he is entitled to claim sick pay, or time spent on holidays or annual leave as prescribed by this Award shall not count for the purpose of determining his right to annual leave.

(e) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled, subject to subclause (e) of this clause to such leave on full pay as is proportionate to his length of service during that period with such employer, and if such leave is not equal to the leave given to the other workers he shall not be entitled to work or pay whilst the other workers of such employer are on leave on full pay.

(f) A worker who is dismissed for misconduct or who illegally severs his contract of service shall not be entitled to the benefit of the provisions of this clause.

(g) The provisions of this clause shall not apply to easnal workers.

# 13.—Absence Through Sickness.

- (a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for one-twelfth (1/12th) of a week for each completed month of service; provided that payment for absence through such ill-health shall be limited to one week's pay in each calendar year. Payment hereunder may be adjusted at the end of each calendar year or at the time the worker leaves the service of the employer, in the event of the worker heing entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred. This clause shall not apply when the worker is entitled to compensation under the Workers' Compensation Act.
- (h) A worker shall not be entitled to receive my wages from his employer for any time lost through any aecident wherever sustained arising out of his own wilful default or for siekness arising out of his own wilful default.
- (c) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

# 14.—Junior Workers.

- (a) Junior workers upon being engaged shall, if required, furnish the employer with a certificate containing the following particulars:-
  - (i) Name in full;
  - (ii) age and date of birth;
  - (iii) name of each previous employer and length of service with each such employer;
  - (iv) class of work performed for each previous employer.
- (b) Such of the foregoing particulars as are within the knowledge of the employer shall be endorsed on the certificate and signed by the employer upon request of the worker.

(c) No worker shall have any claim upon an employer for additional pay in the event of the age or length of service of the worker being wrongly stated on the certificate. If any worker shall wilfully mis-state his age or length of service in the above certificate, he alone shall be guilty of a breach of this Award.

## 15.-Posting of Award.

Every employer shall post a copy of this Award in a conspicuous place in the factory, easily accessible to all workers.

## 16.-Board of Reference.

The Court may appoint for the purpose of this Award a Board or Boards of Reference. Each such Board shall consist of a chairman and two other representatives, one to be nominated by each of the parties as prescribed by regulations.

There are assigned to each such Board in the event of no agreement being arrived at between the parties to this Award, the functions of:—

- (a) Adjusting any matters of difference which may arise from time to time, except such as involve interpretations of the provisions of the Award or any of them;
- (b) classifying and fixing wages, rates and conditions for any occupation or calling not specifically mentioned in the Award;
- (c) deciding any other matter that the Court may refer to such Board from time to time.

An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the regulations to the Industrial Arbitration Act, 1912-1941, which for the purpose are embodied in this Award.

# 17.—Payment of Wages.

Wages shall be paid at least once weekly.

#### 18.—Record.

- (a) The employer shall keep or cause to be kept a record or records containing the following particulars:—
  - (i) Name of each worker.
  - (ii) The nature of his work.
  - (iii) The hours worked each day and each week.
  - (iv) The wages and overtime (if any) paid each week.
  - (v) The age of each junior worker.

Any system of automatic recording by machines shall be deemed to comply with this provision to the extent of the information recorded.

(b) The time and wages record shall be open for inspection by a duly accredited official of the Union, during the usual office hours at the employer's office, or other convenient place, and the representative may be allowed to take extracts therefrom.

# 19.-No Reduction.

Nothing herein contained shall entitle an employer to reduce the wage of any worker who at the date of this Award was being paid a higher rate of wage than the minimum prescribed for his or her class of work.

## 20.-Meal Interval.

No female worker or junior male worker shall be employed for a longer period than five (5) hours without a break for a meal. The time allowed for each meal required shall not be more than one (1) hour.

# 21.-Under-rate Workers.

- (a) Any worker who by reason of old age or infirmity is unable to earn the minimum wage may be paid such lesser wage as may from time to time be agreed upon in writing between the Union and the employer.
- (b) In the event of no agreement being arrived at, the matter may be referred to the Board of Reference for determination.
- (e) After application has been made to the Board and pending the Board's decision the worker shall be entitled to work for the employer at the proposed lesser rate.

#### 22.-Piecework

- (a) An employer may make a contract with a worker or group of workers for payment by results by piecework.
- (b) A worker working under any system of payment by results shall be paid at least the time rate of pay apportioned if necessary.
- (e) Where a worker works part of a week at piecework rates and part at time rates he shall be paid so much as he is entitled to receive under piecework rates for the amount of work done, and, in addition thereto, such proportionate amount at time rates as prescribed in this Award for the portion of the week worked at time rates.
- (d) In the event of any dispute regarding piecework rates occurring and remaining unsettled between the employer and the workers, the employer or the Union may refer such dispute to the Board of Reference.

#### 23.—Casnals.

Any worker engaged for less than one (1) week shall be deemed a casual worker and shall be paid whilst so employed at the rate of ten per cent. (10%) in addition to the rates prescribed in clause 4 hereof.

## 24.—General Provisions.

- (a) No female under the age of eighteen (18) years shall be required to lift weights in excess of 25 lbs., and no female worker over eighteen (18) years of age shall be required to lift weights in excess of 35 lbs.
- (b) All female workers shall, where possible, be allowed to sit to perform their duties.
- (c) Where workers are required to stand at their jobs suitable floor covering shall be supplied.
- (d) When practicable, dining rooms with boiling water at meal times, and suitable changing rooms shall be provided.
