WHEREAS by regulation 2 of the Building Regulations contained in the Second Schedule of the Road Districts Act, 1919-1948, it is provided, in reference to buildings on any block of land laid out for such purpose, that the area allotted to any building, and the open space used in connection with such building shall together be not less than the area for the time being fixed by Proclamation as the proper area to be allotted to such building: Now, therefore, His Excellency the Governor, acting by and with the consent of the Executive Council, doth by this Proclamation declare that the proper area to be allotted to every building and the open space to be used therewith in the Harvey Road District shall

- (1) For dwelling or shop with dwelling attached—an area of ground not less than 6,000 square feet.
- (2) For tenement houses or flats or any buildings called or let or used as a flat—an area of ground of not less than one acre. The total floor area of any tenement house or building containing flats shall not exceed half of the area of the land or lot on which such building is erected.

IN pursuance of the powers conferred upon me by the Prices Control Act, 1948, and the Regulations for the time being in force thereunder, I, Constantin Paul Mathea, Prices Control Commissioner under the said Act, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 76.

Revocation.

2. Commonwealth Prices Regulation Orders Nos. 62 and 96, published in the *Commonwealth Gazette* on 20th December, 1939, and 8th February, 1940, respectively, are hereby revoked.

Definition.

3. In this Order, unless the contrary intention

appears—
"'prevailing margin'' means, in relation to pig lead,
the margin for any particular quality, quantity
or shape, or in respect to any particular term
or condition of sale, that existed between the
price of £22 per ton and the particular vendor's selling price on 31st December, 1948, of
pig lead of that particular quality, quantity,
or shape, or sold under that particular term or
condition of sale.

Maximum Prices.

4. I fix and declare the maximum price at which pig lead may be sold by any person to be £35 per ton, plus the prevailing margin where that person's selling price on 31st December, 1948, was greater than £22 per ton, or minus the prevailing margin where that person's selling price on the aforesaid date was less than £22 per ton, as the case may be.

Variation of Maximum Price by Notice.

5. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which pig lead specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

IN pursuance of the powers conferred upon me by the Prices Control Act, 1948, and the Regulations for the time being in force thereunder, I, Constantin Paul Mathea, Prices Control Commissioner under the said Act, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 92.

Application.

2. Nothing in this Order shall apply to garments made from knitted fabric.

Revocations.

3. Prices Regulation Order No. 3020, published in the Commonwealth Gazette on the 5th day of August, 1947, as amended by Prices Regulation Order No. 3185, published in the Commonwealth Gazette on the 5th day of December, 1947, is hereby revoked.

Definitions.

4. In this Order and the Schedule thereto, and for the purposes of any notice issued in pursuance of this Order, unless the contrary intention appears-

"allowance for freight" means in relation to the value of any material-

(i) where the point of delivery in Western Australia is not less than 25 miles from the purchaser's premises, the sum of sixpence per lineal yard;

(ii) where the point of delivery is in some State of Australia other than Western Australia, the sum of ninepence per lineal yard;

"landed cost" means, in relation to the value of any material which has been imported from a source outside the Commonwealth of Australia, the aggregate of-

(a) the purchase price paid or payable to the overseas supplier for that material after the deduction of any trade dis-count, but before the deduction of any

eash discount;

- rerseas office or forwarding agent's charges actually incurred, but not in excess of two and one-half per centum (b) overseas office or of the invoice price after the deduction of any trade discount, but before the deduction of any cash discount, and
- (c) insurance, freight, exchange calculated at telegraphic transfer rates, duty, wharfage, stacking charges, Customs entry and Customs agent's charges, except insofar as any item of transport from wharf or bond store is concerned;
- "make-up" means, in relation to the supply of any service of manufacturing or partially manufacturing any tailored garment, a person who manufactures, or partially manufactures, or causes to be manufactured or partially manufactured, that garment from material furnished to him by some other person for such purpose, whether or not any linings or trimmings for such garment are supplied by that maker-up;

"manufacturer" means, in relation to the sale of any tailored garment, a person who manufac-tures that garment from his own material, linings and trimmings;

"material" means, in relation to any tailored gar-ment, the material or materials used in the manufacture of that garment, other than mate-rial or materials used for linings, trimmings or facings;

"point of delivery" means, in relation to the value of any material, the place at which liability for payment of transport charges in conveying

that material to the purchaser's place of business passed to the purchaser from the person from whom such material was purchased;

"rate" includes remuneration;
"semi-manufacturer" means, in relation to the sale of any tailored garment, a person who owns the material from which that garment is manufactured and who furnishes that material, whether or not with any linings or trimmings to a maker-up for manufacture or partial manufacture of that garment; "sports coat" means a man's or youth's single-

breasted lined sports coat;
"supply" means, in relation to any service of
manufacturing or partially manufacturing any
tailored garment by a maker-up, the supply of any declared service or services or the sale of any declared goods or the sale of any declared goods and the supply of any declared service or services in relation to such garment by that maker-up;

"tailored garment", means-

(a) any garment of men's, youths' or boys' outerwear attire, and

(b) women's costumes, slacks, or top coate

of woodlen or worsted material, made to the special measurements and for the personal use of an individual;

- "three-piece single-breasted suit" means a men's or youths' suit comprising-
 - (a) lined single-breasted coat,
 - (b) vest,
 - (c) trousers;
- "three-piece double-breasted suit" means a men's or youths' suit, comprising-
 - (a) lined double-breasted coat, (b) vest,

 - (c) trousers;
- "two-piece single-breasted suit" means a men's or youths' suit comprising-
 - (a) lined single-breasted coat,
 - (b) trousers;
- "two-piece double-breasted suit" means a men's or youths' suit comprising—

 (a) lined double-breasted coat,

 (b) trousers;
- "two-piece costume" means a women's or maids' costume comprising-
 - (a) lined single or double-breasted coat,
 - (b) skirt;
- "value" means, in relation to any material-
 - (a) in respect of material, manufactured within the Commonwealth of Australia and purchased by a manufacturer, semi-manufacturer or maker-up, as the case may be, from the manufacturer of that material, the purchase price paid or payable therefor plus one and one-quarter per centum, plus allowance for freight;
 - (b) in respect of material, purchased by a manufacturer, semi-manufacturer, or maker-up, as the case may be, from the Division of Import Procurement of the Department of Trade and Customs, or from the Commonwealth Disposal Commission—the purchase price paid or payable therefor plus one and onequarter per centum, plus allowance for freight;
 - (c) in respect of material, imported by a manufacturer, semi-manufacturer, or maker-up, as the case may be, from a source outside the Commonwealth of Australia—the landed cost plus two and one-half per centum;
 - (d) in respect of material purchased by a manufacturer, semi-manufacturer, or maker-up, as the case may be, from a wholesale merchant within the Commonwealth of Australia—the purchase price paid or payable therefor, plus allowance for freight;
 - (e) in respect of material purchased by a manufacturer, semi-manufacturer, or maker-up, as the case may be, from a retail trader—
 - (i) the purchase price paid or payable therefor, less thirty per centum thereof, plus allow-ance for freight; or
 - (ii) where an amount is specified by the Commissioner in relation to that material and notified in writing to that manufacturer, semi-manufacturer or maker-up-then such amount.

Specified Records to be Kept.

- 5. Any manufacturer, semi-manufacturer, or makerup, who manufactures or partially manufactures, or causes to be manufactured or partially manufactured any tailored garment, in addition to records required to be kept by law or for his own purpose, shall keep—
 - (a) a sales record in relation to that garment in the form specified in the Schedule to this Order: Provided that one such sales record shall be kept for each garment ordered and that such sales record shall be numbered consecutively from No. 1 onwards. For the purpose of this subparagraph, a two or three piece suit or costume shall be deemed a garment;

(b) a carbon duplicate receipt book in which shall be entered all payments received in respect of any tailored garment sold or supplied, and also the sales record number in relation to such garment.

Exhibition of Tickets.

- 6. Every manufacturer, semi-manufacturer, or makerup who sells or supplies any tailored garment shall in respect of any material which is in his possession and could be manufactured or partially manufactured into a tailored garment or garments, attach to such material ticket or label setting fouth the following particu-
 - (a) the value per yard of such material;(b) the supplier's name, and

(c) the identity number, or symbol (if any) of such material:

Provided that where such material is held by a makerup pursuant to this paragraph, it shall be sufficient if the owner's name of such material, together with his address, is shown on such ticket or label.

Exhibition of Prices and Rates.

7. Every manufacturer, semi-manufacturer, or makerup shall exhibit in a prominent position in his place or places of business, the notice or notices in writing issued to that manufacturer, semi-manufacturer, or maker-up, as the case may be, which stipulate the maximum prices for the sale of any tailored garment or garments, and/or the maximum rates for the supply of the service of manufacturing or partially manufacturing any tailored garment or garments, as the case may be. Provided that where a notice has been issued in relation to any garment or garments for a specific customer or customers, specifying such customer or customer's name, it shall be deemed sufficient compliance with this paragraph if such notice is made available for such customer or customer's inspection.

Application for Maximum Prices or Rates.

A manufacturer or semi-manufacturer shall not sell and a maker-up shall not supply the service of manusell and a maker-up shall not supply the service of manufacturing or partially manufacturing any tailored garment in respect of which a maximum price or maximum rate has not been fixed by the Commissioner, unless, and until, such manufacturer, semi-manufacturer, or maker-up has made written application to the Commissioner to fix a maximum price or maximum rate in respect of such garment, and the Commissioner has fixed a maximum price or rate accordingly.

Validation of Existing Notices.

9. All notices given in pursuance of any Order made under the National Security (Prices) Regulations and the Prices Control Act, 1948, which fix a maximum price for the sale of any tailored garment, or a maximum rate for the supply of the service of manufacturing or partially manufacturing any tailored garment by any person, and which are in force at the commencement of this Order, shall be deemed to have been given under this Order and continue in full force and effect.

Fixation of Maximum Prices or Rates by Notice.

10. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which any person may sell any tailored garment, or the maximum rate at which any person may supply the service of manufacturing or partially manufacturing any tailored gar-ment to be such price or rate as is fixed by the Commissioner by notice in writing to that person.

IN pursuance of the powers conferred upon me by the Prices Control Act, 1948, and the regulations for the time being in force thereunder, I, Constantin Paul Mathea, Prices Control Commissioner under the said Act, hereby make the following Order:-

Citation.

1. This Order may be cited as Prices Control Order No. 93.

Revocation.

Commonwealth Prices Regulation Order No. 2928 published in the Commonwealth Gazette on the 15th April, 1947, is hereby revoked.

Definitions and Interpretation.

3. In this Order unless the contrary intention appears—
"cost of transport" means in relation to the sale

- (a) in the case of mattresses and bedding imported direct from a source outside the Commonwealth of Australia by that retail trader—the amount of of freight, packing and insurance actually incurred by the retail trader in transporting those goods from the point of entry into the Commonwealth of Australia to his place of business, or (b) in the case of mattresses and bedding
- purchased by that retail trader from a source within the Commonwealth of Australia-the amount of freight, packing and insurance actually incurred by the retail trader in transporting those goods from the point of delivery of those goods to his place of business.
- (c) in the case of mattresses and bedding manufactured by that retail trader-the amount of freight, packing and insurance (if any) actually incurred by the retail trader in transporting those goods from the place of manufacture to the place at which sales

or offers for sale by retail are made.

Provided that the amount of cost of transport to be included in the maximum retail selling price of those goods shall not exceed the provisions pursuant to paragraph 4 of this Order.

"imported" means in relation to mattresses and bedding, mattresses and bedding manufactured outside the Commonwealth of Australia.

"landed cost" means in relation to the sale of imported mattresses and bedding by any person, the aggregate of the purchase price paid or payable to the overseas supplier for such goods after deduction of any trade discount but before deduction of any cash discount, Overseas Office or Overseas Forwarding Agent's charges actually incurred but not in excess of 2½ per centum of the invoice value after deduction of any trade discount but before the deduction of any cash discount, insurance, freight, exchange calculated at telegraphic transfer rates, duty, wharfage and stacking charges, Customs Entry and Customs Agents' charges.

"mattresses and bedding" means mattresses and pillows filled with kapok, wool, flock, fibre, wadding, down, feathers, rubber, hair, springs, linters or like materials; box spring mattresses, base supports and wire mattresses of all descriptions whatsoever.

"point of delivery" means in relation to the sale of any mattresses and bedding which have been purchased by a retail trader from a wholesaler or manufacturer within the Commonwealth of Australia, the place at which liability for payment of cost of transport in conveying those goods to his store passed to that retail trader from the person from whom the retail trader purchased such goods.

"retail trader" means a person who purchases mattresses and bedding in a manufactured state and resells or offers for sale mattresses and bedding by retail; or a person who manufactures mattresses and bedding and sells or offers such mattresses and bedding for sale by

retail.

Maximum Retail Prices.

- 4. I fix and declare the maximum price at which mattresses and bedding may be sold by retail to be the sum of-
 - (a) in respect of mattresses and bedding imported by that retail trader direct from overseas-
 - (i) the landed cost of such imported mattresses and bedding;
 - (ii) 27½ per centum of such cost;
 - (iii) Sales Tax paid or payable.
 - (b) in respect of imported mattresses and bedding purchased by that retail trader other than direct from overseas-
 - (i) the purchase price paid or payable by that retail trader for such mattresses and bedding;
 - 271/2 per centum of such purchase (ii) price;
 - (iii) Sales Tax paid or payable.
 - (c) in respect of mattresses and bedding manufacfactured by that retail trader-
 - (i) the cost to that retail trader of such mattresses and bedding;
 - (ii) 37½ per centum of such cost;
 (iii) Sales Tax paid or payable.
 - (d) in respect of mattresses and bedding other than imported mattresses and bedding and other than mattresses and bedding manufactured by that retail trader-
 - (i) the purchase price paid or payable by that retail trader for such mattresses and bedding;
 - (ii) 371/2 per centum of such purchase price;
 - (iii) Sales Tax paid or payable;

plus in each case the cost of transport actually incurred by the retail trader in relation to such mattresses and bedding-

- (a) from any place within a radius of 15 miles from the General Post Office, Perth, to premises of that retail seller outside that radius, or-
- (b) from any place within a radius of five miles from the principal post office of any place other than Perth, to premises of that retail seller outside that radius.

Records to be kept of Purchases.

- 5. Any retail trader who sells or offers for sale mattresses and bedding shall keep in respect of such goods and in addition to proper books and accounts required to be kept by law a book or books containing the following particulars:-
 - (a) a full description of those goods;
 - (b) the date of delivery of those goods into his store;
 - (c) the name and address of the person from whom he purchases those goods;
 - (d) (i) in respect of mattresses and bedding purchased by the retail trader from a source within the Commonwealth of Australia, the point of delivery and the cost of those goods, or
 - (ii) in respect of mattresses and bedding imported by the retail trader from a source outside the Commonwealth of Australia-the landed cost of those goods, and
 - (e) Sales Tax paid or payable.

Provided that it shall be deemed to be sufficient compliance with the foregoing provisions of this paragraph if, at the time of such sale or offer for sale, the retail trader has in his possession or control an invoice or docket delivered to him in relation to such goods containing the particulars specified in sub-paragraphs (a), (c), (d) and (e) of this paragraph.

Sales Dockets.

- 6. Any person who sells by retail any article of mattresses or bedding shall supply to the purchaser of such mattresses or bedding an invoice or docket containing the following particulars-
 - (a) the vendor's name and place of business;
 - (b) name and address of purchaser of such mattresses and bedding;
 - date of sale of such mattresses and bedding;
 - (d) full description of such goods; (e) price charged for such goods.

Exhibition of Price Tickets.

7. Any person who sells or offers for sale by retail mattresses or bedding shall attach to those goods or display in relation to those mattresses or bedding a ticket or label setting forth his selling price for those goods.

Any ticket or label required by this paragraph to be attached to, or displayed with, any goods shall be in such form as to be easily legible to any person inspecting or viewing those goods and as to be properly associated with such goods.

Fixation of Maximum Prices by Notice.

8. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which mattresses and bedding which are specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

 - Duck eggs shall be graded as follows:—

 (a) "First quality" eggs shall be divided into two grades, namely:
 - (i) "First quality duck" which shall consist of eggs more than 2 ounces each in weight.
 - (ii) "First quality medium duck" which shall consist of eggs not less than 11 ounces each in weight, but not more
 - than 2 ownces each in weight.

 (b) "Second quality" eggs shall be divided into two grades, namely:—

 (i) "Second quality duck" which shall consist of eggs more

than 2 ounces each in weight.

(ii) "Second quality medium duck" which shall consist of eggs not less than 11/2 ounces each in weight, but not more than 2 ounces each in weight.,

Regulation 11 is amended as follows:—

(1) Delete the words "or 'First Grade Duck' "in line 3 of paragraph (3) and insert in lieu thereof the following "Duck", 'Medium Duck', 'Second Duck', or 'Second Medium Duck'."

- 1. Part 1B—Citrus Fruits—Grading of Oranges is amended by inserting after regulation 5L a new regulation to stand as regulation 5M:—
 - 5M. All oranges other than those graded as factory shall be firmly and fully packed in containers approved under the Fruit Cases Act, 1919-1933.
- 2. New regulations and new headings are inserted after regulation 5M to stand as regulations 5N to 5V, both inclusive, of "Division (2)—Grading of Lemons" and as regulations 5W to 5AE, both inclusive, of "Division (3)—Grading of Grapefruit" of the said Part 1B—Citrus Fruits.

Division (2)-Grading of Lemons.

- 5N. Lemons either grown in Western Australia or imported into Western Australia and intended for sale in Western Australia shall be graded and packed according to the following grades:—
 - (a) Special.
 - (b) Standard.
 - (e)Plain.
 - (d) Inferior.
 - (e) Factory-First Grade.
 - (f) Factory-Second Grade.
 - 50. In this Division, for the purpose of grading lemons-
 - (a) 'special' grade shall consist of reasonably mature lemons which are of normal shape, free from malformation and from more than slight corrugation or ridging, free from disease, clean and of the appearance common to the variety, sound, of even colour, none of which is disfigured over an area exceeding 2½ per centum of the total superficial area of the individual fruit, and none of which shall be dry. The skin shall be of good texture and the rind of not more than medium thickness. The lemons shall have been clipped from the tree;
 - (b) "standard" grade shall consist of reasonably mature lemons which are of normal shape, practically free from malformation and from marked corrugation or ridging, free from disease, clean, and of the appearance common to the variety, sound, of reasonably even colour, none of which is disfigured over an area exceeding 10 per centum of the total superficial area of the individual fruit and none of which shall be dry. The skin shall be of good texture and the rind of not more than medium thickness. The lemons shall have been clipped from the tree;
 - (c) "plain" grade shall consist of lemons which are of reasonably normal shape, free from dirt, and of the appearance common to the variety, sound, none of which is disfigured over an area exceeding 25 per centum of the total superficial area of the individual fruit and none of which shall be dry;
 - (d) "inferior" grade shall consist of lemons which do not qualify for inclusion in any of the three superior grades;
 - (e) "factory—first grade" shall consist of lemons which are of reasonably normal shape, free from dirt, sound, and none of which shall be dry;
 - (f) "factory—second grade" shall consist of lemons which comply with the requirements of "factory—first grade" lemons as regards soundness, but do not comply with the requirements as regards cleanness, dryness and malformation.
 - 5P. In this division in respect of lemons-
 - (a) "dry" used in relation to a lemon means that the weight of juice extractable (by means of rotating the halves of a freshly divided lemon on a conical glass lemon squeezer under hand pressure only and straining the resultant juice with moderate pressure through a strainer of not less than 30 meshes to the lineal inch) is less than (33%) of the total weight of the lemon;
 - (b) "disfigured" used in relation to a lemon means disfigured by sears, scratches of the skin, cavities, punctures or blemishes due to any insect or fungus pest, hail marks or oil stains;
 - (c) "sound" means not over-ripe, not soft, not wilted, and free from excessive bruising or physical injuries affecting the keeping quality of the fruit;
 - (d) "clipped" in relation to lemons, means cut from the tree, with stalk trimmed smooth by means of a sharp, blunt-nosed clipper or by any other approved means;

- (e) "disease" means any abnormal condition of or in lemons, and includes any condition arising from functional disorders, or caused by, or due to, the presence, operation, development or growth of any insect, fungus, bacterium or virus.
- 5Q. No person shall pack for sale, or seil in any package any lemon unless it is of one of the grades mentioned in these Regulations.
- 5R. All lemon other than those graded as factory shall be firmly and fully packed in containers approved under the Fruit Cases Act, 1919-1933.
- 58. The outer layers or shown surfaces of the lemons shall be a true indication of the contents of each box, which shall contain one variety of lemon only.
- 5T. The lemons in each box shall not vary in diameter by more than one-quarter of an inch.
- 5U. Every package containing lemons intended for sale in the State of Western Australia shall bear on one end thereof in letters or figures of not less than one-quarter of an inch in height, if printed on labels, and not less than three-quarters of an inch in height, if stencilled on the package, particulars of the variety, grade and count of the fruit contained therein.
- 5V. The foregoing regulations in this Division shall be read and construcd in conjunction with the regulations made under the Fruit Cases Act, 1919-1933, and for the time being in force: Provided that lemons may be packed with other kinds of fruit in the same case only in instances where such lemons and other kinds of fruit are not for sale.

Division (3)—Grading of Grapefruit.

- 5W. Grapefruit either grown in Western Australia or imported into Western Australia and intended for sale in Western Australia shall be graded and packed according to the following grades:—
 - (a) Special.
 - (b) Standard.
 - (c) Plain.
 - (d) Inferior.
 - (c) Factory-First Grade.
 - (f) Factory-Second Grade.
 - 5X. In this division, for the purpose of grading grapefruit-
 - (a) "special" grade shall consist of mature grapefruit which are of normal shape, free from malformation and from more than slight corrugation or ridging, free from disease, clean, and of the appearance common to the variety, sound, of even yellow colour, none of which is disfigured over an area exceeding 2½ per centum of the total superficial area of the individual fruit, and none of which shall be dry. The skin shall be of good testure and the rind of not more than medium thickness. The grapefruit shall have been elipped from the tree. No grapefruit shall measure less than 3½ in in diameter;
 - (b) "standard" grade shall consist of mature grapefruit which are of normal shape, practically free from malformation and from marked corrugation or ridging, free from disease, clean, and of the appearance common to the variety, sound, of reasonably even yellow colour, none of which is disfigured over an area exceeding 10 per centum of the total superficial area of the individual fruit and none of which shall be dry. The skin shall be of good texture and the rind shall not be thick. The grapefruit shall have been clipped from the tree. No grapefruit shall measure less than 3in. in diameter;
 - (c) "plain" grade shall consist of mature grapefruit which are of reasonably normal shape, free from dirt, and of the appearance common to the variety, sound, none of which is disfigured over an area exceeding 25 per centum of the total superficial area of the individual fruit and none of which shall be dry. No grapefruit shall measure less than 2½ in. in diameter;
 - (d) "inferior" grade shall consist of grapefruit which do not qualify for inclusion in any of the three superior grades;
 - (e) "factory—first grade" shall consist of reasonably mature grapefruit which are of reasonably normal shape, free from dirt, sound, and none of which shall be dry;
 - (f) "factory—second grade" shall consist of grapefruit which comply with the requirements of "factory—first grade" grapefruit as regards soundness and maturity, but do not comply with the requirements as regards cleanness and dryness.
 - 5Y. In this Division in respect of grapefruit-
 - (a) "dry" used in relation to a grapefruit means that the weight of juice extractable (by means of rotating the halves of a freshly divided grapefruit on a conical glass squeezer under hand pressure only and straining the resultant juice with moderate pressure through a strainer of not less than 30 meshes to the lineal inch) is less than (33%) of the total weight of the grapefruit;
 - (b) "disfigured" used in relation to a grapefruit means disfigured by sears, scratches of the skin, cavities, punctures or blemishes due to any insect or fungus pest, hail marks or oil stains;

- (c) "sound" means not over-ripe, not wilted, and free from excessive bruising or physical injuries affecting the keeping quality of the fruit;
- (d) "elipped" in relation to grapefruit, means cut from the tree, with stalk trimmed smooth and not protruding above the top of the basin, by means of a sharp, blunt-nosed clipper or by any other suitable means;
- (e) "discase" means any abnormal condition of or in grapefruit, and includes any condition arising from functional disorders, or caused by, or due to, the presence, operation, development or growth of any insect, fungus, bacterium or virus.
- 5Z. No person shall pack for sale, or sell in any package any grapefruit unless it is of one of the grades mentioned in these Regulations.
- 5AA. All grapefruit other than those graded as factory shall be firmly and fully packed in containers approved under the Fruit Cases Act, 1919-1933.
- 5AB. The outer layers or shown surfaces of the grapefruit shall be a true indication of the contents of each box, which shall contain one variety of grapefruit only.
- 5AC. The grapefruit in each box shall not vary in diameter by more than one-quarter of an inch for fruit up to and including those of $3\frac{1}{4}$ inches in diameter, and by more than $\frac{1}{2}$ inch for larger fruit.
- 5AD. Every package containing grapefruit intended for sale in the State of Western Australia shall bear on one end thereof in letters or figures of not less than one-quarter of an inch in height, if printed on labels, and not less than three-quarters of an inch in height, if stencilled on the package, particulars of the variety, grade and count of the fruit contained therein.
- 5AE. The foregoing regulations in this Division shall be read and construed in conjunction with the regulations made under the Fruit Cases Act, 1919-1933, and for the time being in force: Provided that grapefruit may be packed with other kinds of fruit in the same case only in instances where such grapefruit and other kinds of fruit are not for sale.
