WHEREAS by section 99 of the Factories and Shops Act, 1920-1948, the Governor may, by proclamation, constitute any defined portion of the State a shop district for the purposes of this Act, and specify the boundaries of such district, and may abolish or alter the boundaries of any district, and may assign a name to or change the name of any district; and whereas it is desired to bring certain shop districts into conformity with the road districts bearing the same name as at present constituted under the Road Districts Act, 1919-1947: Now, therefore I, the said Governor, acting with the advice and consent of the Executive Council, do hereby abolish the Mandurah Specified Locality and Murray shop districts as at present constituted under the Factories and Shops Act, 1920-1948, and do hereby constitute and name the shop districts as set forth and described in the Schedule hereunder.

The following road districts as at present constituted under the Road Districts Act, 1919-1947, to be shop districts with the same place-name as the corresponding road districts:—Mandurah; Murray.

Workers' Compensation Act, 1948.

#### ORDER IN COUNCIL.

WHEREAS by section 5 of the Workers' Compensation Act, 1912-1948, it is enacted that if the Governor is satisfied that by the laws operating similarly to the provisions of this Act, of any other country, whether part of the Deninions of the Crown or not, compensation for injury by accident to a deceased worker is payable to his dependants who are resident in this State the Governor may, by Order in Council, declare that when a worker is so injured in this State and dies as a result of the injury his dependants, who are not resident in this State, shall have the same rights and remedies under the provisions of this Act as if they were resident in this State: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, declares that when a worker is injured in this State and dies as a result of the injury his dependants, who are resident in the Dominion of New Zealand, shall have the same rights and remedies under the provisions of the said Act as if they were resident in this State.

4. The practitioner shall at or immediately after each examination, make and sign a report in writing in the form required by the Commissioner, and in such report shall deal with any particular aspects as may have been specified by the Commissioner.

5. The practitioner shall furnish his report to the Commissioner within 48 hours of the examination.

6. Forthwith after completion of his examination, the practitioner shall advise the Commissioner of conclusions.

the practitioner shall advise the Commissioner of such completion, with a view to the arrangement by the Commissioner for the due disposal of the body.

7. The practitioner will ensure the proper conduct of the examination and the cleanliness of the

laboratory.
