ELECTORAL ACT, 1907-1948.

Crown Law Department, Perth, 18th July, 1949.

HIS Excellency the Governor in Executive Council has been pleased, pursuant to the provisions of the Electoral Act, 1907-1948, to make the following regulations.

ELECTORAL ACT, 1907-1948.

Regulations. (Section 213.)

Short Title.

1. These regulations may be cited as the Electoral Act Regulations, 1949.

#### Interpretation.

2. In these regulations unless the context requires otherwise—

"Act" means the Electoral Act, 1907-1948 (Act No. 27 of 1907, as reprinted with amendments to and including Act No. 47 of 1940, incorporated pursuant to the provisions of the Amendments Incorporation Act, 1938, in Volume 2 of the Reprinted Acts of the Parliament of Western Australia, 1943, and further amended by Act No. 63 of 1948);

"form" means the appropriate form in the Appendix to these regulations;

Act No. 30 of 1918, s. 39.

expressions used shall have the same respective meanings as in the Act; sections referred to are the sections of the Act; regulations referred to are these regulations.

#### Revocation.

3. The Electoral Regulations, 1937 (regulations made pursuant to the provisions of section 210 of the Electoral Act, 1907-1936, and published in the Gazette of 31st December, 1937, as amended by regulations made pursuant to those provisions and published in the Gazette of 24th February, 1939), are revoked.

Appointment of Assistant Registrars for Provinces and Districts.

4. (a) The Governor may appoint for any Province or District one or more Assistant Registrars to assist the Registrar in the performance of his duties.

(b) Claims may be lodged with Assistant Registrars, to be sent by them, on behalf of the claimant, to the Registrar, for approval and enrolment.

#### Appointment of Returning Officers.

5. The declaration required to be lodged by a Returning Officer on his appointment may be in accordance with Form 1.

#### Claims Under Section 17 (3).

6. When a member of the Legislative Assembly and his wife are enrolled pursuant to the provisions of section 17, subsection (3) as electors for the District represented by him the following additions to their occupations shall be made respectively in the Roll—

(M.L.A. for the (name of) District);

(Wife of M.L.A. for the (name of) District),

so as to denote the special qualification under which they are enrolled.

#### Form of Rolls (sec. 22).

7. The Rolls for the Legislative Council and the Legislative Assembly may be in accordance with Forms 2 and 3 as the case may be and shall contain the particulars indicated therein.

#### The Rolls.

#### (Section 32.)

8. The latest printed or written copy of the Roll referred to in section 32 shall, as occasion arises, be supplied to each Registrar by the Chief Electoral Officer, who shall indorse that copy of the Roll with a certificate in the forms set out hereunder that it is the Roll for the Province or District, for the purposes of section 32, and any alterations, pursuant to the provisions of the Act, shall from time to time be made on that copy of the Roll by the Registrar, until a new Roll is issued to him by the Chief Electoral Officer as a substitute for the one then in use.

The method to be followed in effecting the alterations shall be as prescribed in sections 54 and 55 of the Act. The indorsement shall be in the following words:—

#### Enrolment.

- 10. The claim for eurolment for a Legislative Council Province or to substitute for a registered qualification any other sufficient qualification, or for a notification of a change of a name or change of an address of an elector may be in accordance with Form 4.
- 11. The claim for enrolment for any district or sub-district for the Legislative Assembly or for a transfer of enrolment from one district or sub-district to another district or sub-district; or for a notification of a change of a name or change of an address of an elector within the same district may be in accordance with Form 5.
- 12. The notification to a claimant of the rejection of his claim for enrolment for the Legislative Assembly or for the Legislative Council may be in accordance with Form 6.

Enforcement of the Law Relating to Compulsory Enrolment on the Legislative Assembly Rolls.

#### (Section 45.)

- 13. The Registrar for a District shall, when any failure to comply with the law relating to compulsory enrolment of a person qualified as an elector for the Assembly is disclosed, make inquiries into the circumstances and consider all the facts, and if he is satisfied that the qualified person has failed to comply with the requirements of section 45 of the Act, he shall, in accordance with Form 7, forthwith inform him of such failure, and such person may reply by statutory declaration setting out any facts relevant to the matter, within such time as is set out in the notification. The time within which the declaration may be lodged with the Registrar may be varied by him so as to afford sufficient time for reply in each individual case, but shall not be less than seven days from the date of the notification.
- 14. Where a person to whom notification has been sent fails to reply within the time specified or fails by his reply to satisfy the Registrar, the Registrar shall cause proceedings to be instituted against him in a court of summary jurisdiction.
- 15. If, in any case in which proceedings are instituted the Registrar has received from the person concerned a statutory declaration he shall, so far as it is practicable and necessary for him to do so, inquire into the truth of the statements it contains and shall, unless the prosecution be discontinued, cause the declaration to be brought to the notice of the court.
- 16. The notification by the Registrar to an elector for a Province that his application to substitute another qualification is not in order may be in accordance with Form 8.

#### Objections to Claims and Enrolments.

- 17. The notice of objection lodged by an elector in respect of a claim may be in accordance with Form 9.
- 18. The notice of objection by a Registrar in respect of a claim may be in accordance with Form 10.
- 19. The notice of objection lodged by an elector in respect of a name on a roll may be in accordance with Form 11.
- 20. The notice of objection by a Registrar in respect of a name on a roll may be in accordance with Form 12.

## Objections to Claims and Envolments. (Sections 47 and 48.)

21. The notice in writing to be given by the Registrar to the objector to a claim or enrolment, and to the person whose claim or enrolment is objected to, pursuant to the provisions of sections 47 and 48 respectively, shall be in such of the Forms Nos. 13, 14, 15 and 16 as the case requires.

### Lists to be Supplied by the Registrar General and Others. (Sections 56-59.)

22. The lists to be forwarded to the Chief Electoral Officer by the Registrar General of Births, Deaths and Marriages, pursuant to the provisions of section 56, by the Inspector General of the Insane, pursuant to the provisions of section 57, by the Superintendent of Public Charities, pursuant to the provisions of section 58, and by the Comptroller General of Prisons, pursuant to the provisions of section 59, shall be in such of the Forms Nos. 17, 18, 19, 20 and 21 as the case requires.

#### Writs.

- 23. The Warrant for the issue of Writs for a General Election or for a By-election under the provisions of sections 64 and 67 respectively, may be in accordance with Forms 22 or 23, as the case may require.
- 24. The certificate of death, which is required to be sent to the President or Speaker or to the Governor as may be required may be in accordance with Form 24.
- 25. The Writ required to be issued by the Clerk of the Writs may be in accordance with Form 25.
- 26. The Nomination to be lodged by a candidate for a Legislative Council or Legislative Assembly election may be in accordance with Form 26.

#### Conduct of Elections.

#### Postal and Absent Voting.

- 27. The Postal Vote Books and the forms contained therein to be supplied to Postal Vote Officers, may be in accordance with Form 27.
- 28. In a Legislative Assembly election or a Legislative Council election, an elector may, subject to the provisions of these regulations, vote as an absent voter on polling day at any polling place at which a polling booth is open, not being a prescribed polling place for the Province or district for which he is enrolled.
- 29. In every such case the person claiming to vote as an absent voter must state his name, place of living and occupation as appearing on the roll and the province or district for which he is enrolled and before being issued with a ballot paper, in Form 29, for an absent vote he must make a declaration in accordance with Form No. 28 and when he has done so, the Presiding Officer shall witness his signature.
- 30. The form of declaration may be printed on an envelope addressed to the State Chief Electoral Officer.
- 31. Before handing the ballot paper to the voter the Presiding Officer shall endorse on it in the space prescribed, the name of the province or district for which the voter declares he is enrolled and shall write in alphabetical order the names of all candidates for that province or district as appearing in the official list of candidates supplied to him, and shall initial the back of the ballot paper.
- 32. The voter shall mark his vote on the ballot paper in accordance with the instructions printed on it and then place the ballot paper in an envelope marked "Ballot Paper" and fasten and seal it and return it to the Presiding Officer.

The Presiding Officer shall forthwith enclose the envelope containing the ballot paper in an envelope addressed to the State Chief Electoral Officer and bearing the declaration of the voter, and shall securely fasten the latter envelope. He shall then enter on the prescribed form (Form 30), the surname and christian names of the voter and the province or district for which the voter has declared he is enrolled, and then deposit the envelope, addressed to the State Chief Electoral Officer in a sealed ballot box.

The envelopes containing absent votes may be placed in a scaled ballot box containing ordinary votes or votes recorded under section 122A.

33. At the close of the Poll the Presiding Officer shall fasten and seal the ballot box containing absent votes and with the least possible delay forward it to the Returning Officer or Assistant Returning Officer.

The Presiding Officer shall also forward to the Returning Officer, the Form 30 showing the names of electors who have voted at his polling place as absent voters.

The Returning Officer or Assistant Returning Officer on receipt from a Presiding Officer of a ballot box containing envelopes bearing absent voters' declarations and purporting to contain absent voters' ballot papers shall—

- (a) check the particulars of the envelopes with the particulars appearing in the Presiding Officer's record and record on the prescribed form (Form 31), the name of the polling place and the number of absent votes recorded;
- (b) forthwith place the envelopes in a locked sealed ballot box with the words "Absent Voters' Ballot Box" marked on it.

When all ballot boxes and returns have been received from all polling places within his district the Returning Officer or Assistant Returning Officer shall fasten and seal the ballot box marked "Absent Voters" and transmit it to the State Chief Electoral Officer by the most expeditious means available.

The Returning Officer or Assistant Returning Officer shall also forward to the State Chief Electoral Officer, the Form 31 of record showing the polling places and the number of absent votes recorded at each and the forms of return which he received from the Presiding Officers.

- 34. The scrutiny of absent voters' ballot papers shall commence as soon as practicable after the close of the poll and shall be conducted by the State Chief Electoral Officer or an Assistant Returning Officer appointed for that purpose.
  - 35. The officer conducting the scrutiny shall-
    - (a) produce and open the ballot boxes received from Returning Officers in which the envelopes containing the absent voters' ballot papers have been placed;
    - (b) sort the envelopes into separate parcels according to the Province or District respectively indicated on each of them and check the number of envelopes for each Province or District with the numbers shown on the return received from the Returning Officer;

- (c) verify the right to vote of the several voters claiming to vote by comparing the names on the envelopes with the certified rolls for the respective Province or District and if the right of any person to vote be established, strike out the person's name in the certified copy of the roll, stamp the envelope with the name of the Province or District and without opening the envelope, place it in a sealed box bearing the name of the Province or District for which the vote was recorded;
- (d) if the right to vote is not established, reject the vote and set it aside for separate custody without opening the envelope.
- 36. It shall not be necessary for the officer conducting the count to await the receipt from Returning Officers of all boxes containing absent votes before commencing the count of absent votes but he may at any time open the sealed boxes (referred to in paragraph (c) of regulation 35) for the respective Province or District and proceed with the count in the following manner:—
  - (a) He shall open the envelopes bearing the declarations of the electors and without further examining the declarations, withdraw from each envelope the envelope containing the ballot paper and without opening this envelope place it in a locked and sealed ballot box marked for the appropriate Province or District for subsequent counting and shall set aside the envelopes bearing the declarations from which ballot papers have been withdrawn and when all envelopes have been opened enclose them in separate sealed packages for each Province or District and endorse on each package "Envelopes bearing absent voters' declarations from which ballot papers have been withdrawn." He shall also endorse on the packages, the names of the appropriate Province or District and his signature and the date of the day when the endorsements are made.
  - (b) He shall reject each ballot paper which is not enclosed in an envelope endorsed with the absent voter's declaration.
  - (c) He may open the ballot box for each Province or District containing the absent votes and count the votes at any time after the commencement of the scrutiny, but if the count of the absent votes for a Province or District is not being completed, sufficient uncounted ballot papers must be kept in the box to ensure that all subsequent ballot papers received shall be taken from a number sufficient to prevent the identity of the voters from being disclosed.
  - 37. An absent voter's ballot paper shall be informal if it-
    - (a) is not initialled by the Presiding Officer;
    - (b) has upon it any mark or writing not lawfully authorised to be put upon it by which, in the opinion of the officer conducting the scrutiny, the voter can be identified;
    - (c) does not indicate the elector's vote or if when there are more than two candidates it does not indicate by numerical sequence, the voter's preference as regards all the candidates:

Provided that if numerals in arithmetical sequence are placed opposite the names of all candidates but one, the next following numeral shall be deemed to be placed opposite the name of the remaining candidate.

38. An absent voter's ballot paper shall not be informal for any reason other than the reasons enumerated in the last preceding regulation, but shall be given effect according to the voter's intention so far as his intention is clear.

In particular, an absent voter's ballot paper shall not be informal by reason only of the voter having indicated his vote or first preference by a cross instead of the numeral one.

- 39. An absent voter's ballot paper shall not be rejected as informal merely because of a formal defect therein, through the name of a wrong Province or District appearing on it, or the omission of the name of the Province or District if the vote is recorded for a candidate or candidates for the Province or District to correspond with the name of the Province or District to the vote is taken.
- 40. On completion of the scrutiny and count of absent votes and votes recorded under section 122A, the officer conducting the scrutiny shall—
  - (a) enclose in one packet for each respective Province or District, all absent voters' ballot papers, counted for the Province or District concerned and all ballot papers admitted and counted for that Province or District, of votes recorded under the provisions of section 122A;

- (b) seal up each packet and endorse on it a description and the number of the contents, the name of the Province or District and the date of the polling and his signature and the date of the day when the endorsement is made;
- (c) forthwith send to the Returning Officer for each Province or District-
  - (i) a certificate showing the number of absent votes and votes recorded under the provisions of section 122A for each candidate;
  - (ii) the certified copy of the Roll used for marking off the names of those electors who voted as absent voters;
  - (iii) a certified list of those voters whose votes recorded under the provisions of section 122A have been admitted to the scrutiny;
  - (iv) the sealed package for the Province or District, referred to in paragraph (a) of this regulation;
  - (v) the sealed package for the Province or District referred to in paragraph (a) of regulation 36;
  - (vi) a sealed package for each Province or District, containing the envelopes referred to in paragraph (d) of regulation 35.

#### Voting Pursuant to Section 122A.

- 41. A person claiming to vote pursuant to section 122A shall be required to make a declaration in accordance with Form No. 32 and when he has done so the Presiding Officer shall witness his signature.
- 42. The form of declaration may be printed on an envelope addressed to the State Chief Electoral Officer.
- 43. The ballot paper to be used by a person claiming to vote pursuant to the provisions of section 122A, may be in accordance with the form prescribed to be used by an elector voting as an absent voter. The words "Absent Vote" appearing on the ballot paper may be struck out and the words "Section 122A" substituted for them.
- 44. The provisions of regulations 31 and 32 relating respectively to the issuing of the ballot paper by the Presiding Officer to absent voters and the marking of the ballot paper by the voter shall as nearly as practicable, apply to ballot papers issued under the provisions of section 122A and the Presiding Officer shall make a record on the prescribed form of the name and other particulars of each person who has recorded a vote before depositing the envelope addressed to the State Chief Electoral Officer in a scaled box.
- 45. An envelope containing a vote recorded under the provisions of section 122A, may be deposited in a ballot box containing ordinary votes and votes recorded by absent voters.
- 46. The provisions of regulations 33 to 40 inclusive shall apply as nearly as is practicable to the despatch, receipt, scrutiny, parcelling and return of ballot papers and envelopes bearing declarations used for the purposes of voting under the provisions of section 122A and for the purpose of the scrutiny of ballot papers and envelopes bearing declarations used for the purpose of voting under section 122A, any reference in these regulations to a ballot paper, an absent voter's ballot paper, an absent voter's declaration or an absent voter's ballot box shall be read as a reference to a ballot paper, declaration or ballot box as the case requires, used for the purpose of voting under section 122A or for the receipt and scrutiny of votes cast under that section. The return of Presiding Officers and Returning Officers may be in accordance with Forms 33 and 34 respectively.

#### Appointment of Electoral Officials and Scrutineers.

- 47. The notice of appointment of Presiding Officers, Assistant Presiding Officers, Poll Clerks and Doorkeepers and the declaration by the officers accepting the appointments may be in accordance with Forms 35 and 36.
- 48. The declaration to be made by a scruntineer on his appointment may be in accordance with Form 37.

#### Ballot Papers.

49. The ballot paper to be used at an election may be in accordance with Form 38.

Declaration by Person Whose Name has been Objected to.

50. The declaration to be made by a person whose name has been objected to pursuant to sections 47, 48, 119 and 122 may be in accordance with Form 46.

#### Statistical Return.

51. The statistical return required to be completed by the Returning Officer after an election, may be in accordance with Form 47.

Enforcement of the Law Relating to Compulsory Voting at Elections of the Legislative Assembly—Section 156,

- 52. The list in duplicate of the names and descriptions of the electors enrolled for a District who did not vote at an election in the District for the Legislative Assembly which is required to be prepared by the Returning Officer pursuant to the provisions of subsection (2) of section 156 of the Act may be prepared on copies of the electoral roll used at the election; and the list may be certified in accordance with Form 39.
- 53. (1) The notice to be sent under the provisions of subsection (4) of section 156 to each elector whose name appears on the list when prepared shall be sent by post to each of them within three months after the close of the election.
  - (2) The notice shall be in accordance with Form 40,
- 54. (1) The reply which under subsections (6) and (7) of section 156 is required to be filled up and signed by or on behalf of an elector who has received notice from the Returning Officer as provided for by subsection (4) of section 156 may be in accordance with Form 41.
- (2) The witness to the signing of the form shall be an elector or a person qualified to be an elector.
- 55. An extract from a copy of a list of electors who failed to vote at an election prepared and endorsed by the Returning Officer in accordance with the provisions of section 156, and referred to in subsection (11) of that section required for use as evidence in any proceedings may be in accordance with Forms 42 and 45.
- 56. The notice to be sent under the provisions of subsection (12) of section 156, may be in accordance with Form No. 43.
- 57. The reply which under subsection (13) of section 156 is required to be filled in by an elector who desires the matter of his failure to vote to be dealt with by the Chief Electoral Officer, may be in accordance with Form No. 44.

#### Return of Electoral Expenses.

58. The return of expenses to be made by a candidate after an election may be in accordance with Form 48.

#### Honorary Government Electoral Agents.

- 59. (1) With a view to providing facilities for persons qualified but not enrolled as electors—
  - (a) to inspect the Rolls;
  - (b) to obtain information as regards qualifications and disqualifications;
  - (c) to procure the requisite claim forms,

the following public servants shall be ex officio Honorary Government Electoral Agents:—Clerks of Courts, Mining Registrars, Government Land Agents, Managers of State Batteries, Officers in the Police Force in charge of Stations, District Registrars of Births, Deaths and Marriages (except those paid by fees only), Post and Telegraph Masters,

- (2) The duties of Honorary Government Electoral Agents shall be as follows:—
  - (a) To exhibit in a conspicuous place outside their office a copy of an electoral poster and sign, supplied by the Chief Electoral Officer;
  - (b) to have charge of on behalf of the Chief Electoral Officer, for free inspection by the public, copies of the Rolls; and
  - (c) to hold sufficient quantity of claim forms at the disposal of the general public,
- (3) Honorary Government Electoral Agents shall not be required to render any returns or to collect any forms,
- (4) The Minister may appoint from time to time such additional Honorary Government Electoral Agents as he may think fit, and he may also cancel the appointment of any Honorary Government Electoral Agent.
- (5) Notice of every appointment to or removal from an office under this regulation shall be published in the Government Gazette.
- 60. The forms set out in the Appendix hereto shall, subject to the provisions of section 212, be used for the respective purpose for which each is prescribed, as indicated by the section of the Act cited on each of them.

#### Fees to Officers at Elections, etc.

- 61. (a) Every person who is an officer within the meaning of that expression as used in the Public Service Act, 1904-1948, may be required by the Governor to act, and when so required, shall act in the capacity of Returning Officer, Deputy or Assistant Returning Officer, Presiding Officer, Assistant Presiding Officer, Poll Clerk or Doorkeeper, pursuant to the provisions of the Act.
- (b) Those persons when so acting, and all officers appointed pursuant to the provisions of the Act, shall be entitled to receive and retain the appropriate fees or allowances prescribed in paragraph (d) of this regulation.
- (c) Subject to the provisions of this regulation, all electoral officers acting and residing in that portion of the State comprised within the Electoral Districts of Kimberley, Pilbara and Gascoyne, or such Districts as are comprised within the boundaries of the North Province, shall be entitled to receive and retain the appropriate fees prescribed for them in paragraph (d) of this regulation, together with an additional amount equal to ten per centum of that prescribed fee
- (d) The fees payable to Returning Officers, Deputy Returning Officers, Presiding Officers, Assistant Presiding Officers, Poll Clerks and Doorkeepers shall be as follows:—

#### Provided that-

- (i) in Districts where more than twelve polling places have been appointed for a Council or an Assembly Election the Returning Officer or Deputy Returning Officer, as the case may be shall be paid in addition to the fee prescribed in the foregoing table, a further fee in accordance with the following scale:—
  - (a) For every polling place in excess of twelve, up to and including thirty polling places ... 10 0
    (b) For every polling place in excess of thirty polling places ... ... ... ... ... 5 0

- (ii) if an officer holds simultaneously more than one position under the Act in respect of each of which fees by way of remuneration are prescribed, he shall be entitled only to the fee for that position for which the highest fee is prescribed, where the duties of all of the positions can be performed simultaneously. In all other cases he shall be entitled to the fee prescribed in respect of each position the duties of which he performs;
- (iii) the fees prescribed in the foregoing table for Presiding Officers, Assistant Presiding Officers, Poll Clerks and Doorkeepers shall cover all services performed between the hours of 7.30 a.m. and 8 p.m. on the day of the election;
- (iv) subject to the provisions of paragraphs (c), and (e) of this regulation, the fees prescribed in the foregoing table for Returning Officers and Deputy and Assistant Returning Officers shall cover all services required by the Act or by the regulations as well as instructions made or given under the Act to be performed by the officer on the day of election, and includes subsistence for that day.

Provided if any such officers aforesaid do not reside in the district for which they have been appointed as Returning Officers, Deputy Returning Officers or Assistant Returning Officers and if they are required to travel to the district to which they have been appointed prior to the day of the election for the purpose of performing their duties they shall be paid a travelling allowance in accordance with regulation 64 for the whole period that they are absent.

(e) The fee payable to officers engaged on the scrutiny and count of votes shall be as follows:—

- (f) (i) For the purposes of this paragraph, "authorised service" means service for which an application has been made through the Chief Electoral Officer to the Minister and by him approved, and after authority has been duly communicated by the Chief Electoral Officer in writing or by telegraph to the officer making application.
- (ii) Where officers are required prior or subsequent to the day of an election to perform in relation to the election, any authorised service referred to in this paragraph, those officers shall be entitled for the service to a special fee in accordance with the following scale:—

- (g) Persons who are officers within the meaning of that expression as used in the Public Service Act, 1904-1948, when acting as Returning Officers, Deputy Returning Officers, Assistant Returning Officers, Presiding Officers, Assistant Presiding Officers, Poll Clerks, or Doorkeepers on the day of an election shall be deemed to be absent from their public service offices on leave of absence with payment of salary in respect of those offices.
- 62. When on the day of an election any member of the staff of the State Electoral Office is instructed by the Chief Electoral Officer to be and remain at the State Electoral Office to carry out his normal duties, or such other duties in connection with the election that may be allotted to him, he shall be paid overtime or granted time off in lieu, as the case may be, as prescribed under the industrial agreement for the time being in force, or from time to time in force, between the Civil Service Association of Western Australia (Incorporated) and the Public Service Commissioner of Western Australia.

In all other cases, when any person is engaged on the staff of the State Electoral Office on the day of an election, he shall, with the approval of the Chief Electoral Officer, be paid the same fees as prescribed by paragraph (d) of the last preceding regulation as those to which he would have been entitled if he had in fact been specially appointed as Presiding Officer, Assistant Presiding Officer, Poll Clerk, or Doorkeeper, for the election.

63. (1) Where in accordance with the provisions of section 156 Returning Officers are required after an election for the Legislative Assembly to prepare a list of the electors who failed to vote at the election contrary to the requirements of that section, the Returning Officers shall be entitled to receive and retain for preparing the list a special fee calculated at the rate of 10s. for every 500 or portion of 500 votes polled, and where in respect of any election the number of Electoral Rolls to be examined by the Returning Officer or Deputy

Returning Officer for the purpose of the preparation of the list exceeds twenty-four, a fee additional to the relevant fee prescribed above shall be paid at the rate of two shillings and sixpence in respect of every Electoral Roll in excess of twenty-four.

- (2) Where in accordance with the provisions of the Act, Returning Officers or Deputy Returning Officers are required after an election for the Legislative Council to prepare a unified Roll of Electors in connection with the election for their respective districts, the Returning Officers or Deputy Returning Officers shall be entitled to receive and retain for preparing the unified roll a special fee calculated at the rate of 15s. for every 500 or portion of 500 votes polled, and where the number of votes polled for a district in a province is less than 1,000, a uninimum fee of £1 10s. shall be paid, and the Minister may, on the recommendation of the Chief Electoral Officer, approve of additional renumeration where it appears that the fee which would otherwise be payable pursuant to this subregulation is inadequate for the service rendered.
- 64. Officers who are required to travel outside the metropolitan area for the purpose of performing their duties as Electoral Officers shall be entitled to such travelling allowance as is prescribed under the industrial agreement for the time being in force or from time to time in force between the Civil Service Association of Western Australia (Incorporated) and the Public Service Commissioner of Western Australia.

Provided, subject to paragraph (d) subparagraph (iv) of Regulation 61, that no transport or meal allowance shall be paid to any officer in respect of the day of the election, but if approved by the Chief Electoral Officer, any expense necessarily incurred by an officer for the transport on the day of the election may be reconped to the officer.

- 65. (1) Whenever a Returning Officer is expressly instructed by the Chief Electoral Officer to despatch notices to electors who failed to vote at an election, the Returning Officer shall be entitled to receive and retain for the service a special fee, calculated at the rate of twelve shillings and sixpence for every fifty or portion of fifty of the notices despatched by him in accordance with the instructions.
- (2) Where subsequently to the despatch of those notices by the Returning Officer he is required to take any action or do any other act, matter or thing as provided by section 156 of the Act, the special fee payable under the provisions of the last preceding paragraph in respect of the despatch of the notices shall include the remuneration for the taking of that other action or the performance of that other service.


