GOD SAVE THE KING !!!

At a meeting of the Executive Council, held in the Executive Council Chamber, at Perth, the 1st day of March, 1950, the following Order in Council was authorised to be issued:—

Business Names Act, 1942-1946, ORDER IN COUNCIL.

WHEREAS it is enacted by section 24 of the Business Names Act, 1942-1946, inter alia, that notwithstanding anything in any Act no firm, individual, or corporation required to register under Part 11 of the said Act shall use a business name, and no business name shall be registered which includes the word "Royal," unless the Governor by Order published in the Government Gazette consents to the use of such word in the said business name; and whereas the company incorporated in the Netherlands as Koninklijke Java-China Paketvaart

Lijnen N.V. intends to register as a foreign company under the Companies Act, 1943-1949, and desires to carry on business within the State of Western Australia under the business name of "Royal Interocean Lines"; and whereas the said company has made written application and paid the prescribed fee of five pounds five shillings: Now, therefore, His Excellency the Governor in Council, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the Business Names Act, 1942-1946, doth hereby consent to the use of the word "Royal" in the business name of "Royal Interocean Lines."
