PRICES CONTROL ACT, 1948-1949. Prices Control Order No. 273.

Sales of Goods and Supply of Service for Undivided Reinuneration.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order :-

Citation.

1. This Order may be cited as Prices Control Order No. 273.

Revocation.

2. Commonwealth Prices Regulation Order No. 2418 published in the Commonwealth Gazette on the 7th day of February, 1946, is hereby revoked.

Maximum Remuneration.

3. I fix and declare the maximum remuneration for the sale of any declared goods and the supply of any declared service or services for an undivided remuneration, in any case in which the maximum remuneration is not fixed by any other Order, but in which a maxi-num price and maximum rate would be applicable to the sale of the goods and the supply of the service or services at a separate price and rate, to be the sum of that maximum price and maximum rate.

PRICES CONTROL ACT, 1948-1949.

Prices Control Order No. 275.

Bagged Whole Wheat.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:---

Citation.

1. This Order may be cited as Prices Control Order No. 275.

Revocation.

2. Commonwealth Prices Regulation Orders No. 2887, published in the *Commonwealth Gazette* on the 24th day of February, 1947, and No. 3183, published in the *Commonwealth Gazette* on the 1st day of December, 1947, are hereby revoked.

Definitions.

3. In this Order, unless the contrary intention appears-

- "bushel" means 60 lb.;
- "tou" means 2,240 lb.;
- "by retail" means, in relation to any sale of bagged whole wheat, that such sale is a sale by retail of not more than one ton;
- "by wholesale" means, in relation to any sale of bagged whole wheat, that such sale is not a sale by retail as defined herein;
- "Perth metropolitan area" means all that area of Western Australia comprised within a radius of 12 miles from the General Post Office at Perth;
- "cost per bushel into store of the retail seller" means the sum of-
 - (a) cost per bushel of that wheat;
 - (b) cost of the jute bag in which it is contained;
 - (c) cost of transport from the point of delivery to the retail seller to the retail seller's store, and
 - (d) if the wheat is purchased by the retail seller in bulk, three pence per bushel for bagging.

Sales by Wholesale.

4. I fix and declare the maximum price at which bagged whole wheat may be sold by wholesale to be-

- (a) in respect of sales within the Perth metropolitan area, the price specified in the First Schedule to this Order;
- (b) in respect of sales outside the Perth metropolitan area, the sum of---
 - (i) the price per bushel paid or payable for bulk wheat ex rail truck at the railway station or siding nearest the wholesale seller's store;
 - (ii) the cost per bushel of transporting the whole wheat from the railway station or siding nearest to the wholesale seller's store to that wholesale seller's store;
 - (iii) the maximum price fixed for the sale of the bag in which the whole wheat is contained; and
 - (iv) a margin at the rate of-
 - (i) sevenpence per bushel for sales ex store of more than one ton, or
 - (ii) eightpence per bushel for sales ex store of not more than one ton;

- (iii) ninepence per bushel for sales of more than one ton delivered to the purchaser's premises, or free on rail;
- (iv) elevenpence per bushel for sales of not more than one ton delivered to purchaser's premises, or free on rail.

Sales by Retail.

5. I fix and declare the maximum price at which bagged whole wheat may be sold by retail to be the cost per bushel into store of the retail seller plus the margin per bushel set out in columns 2 and 3 of the Second Schedule to this Order, according to the quantity sold and the point of delivery.

Variation of Maximum Prices by Notice.

6. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which bagged whole wheat specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

1. This Order may be cited as Prices Control Order No. 276.

- 2. Prices Control Order No. 270 is hereby amended-
 - (a) by omitting in each case from subparagraphs
 4 (a) (iii) and 4 (d) (i) thereof the figures
 "£13 19s. 9d." and inserting in their stead the figures "£14 4s. 9d.";
 - (b) by the addition of the amount of 5s. to each of the prices set forth in the third column of the First Schedule to the Order.
