 - 4½d. (four and a-half pence) per gallon.

Prices Control Order No. 359.

New Cornsacks.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner under the said Act, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 359.

Revocation.

2. Prices Control Order No. 264 is hereby revoked.

Definitions.

3. In this Order, and the Schedules thereto, "Wholesale Merchant" means, in relation to the sale of any new cornsacks, a person who has purchased those cornsacks from the Australian Wheat Board

Maximum Prices.

- 4. I fix and declare the maximum price at which new cornsacks may be sold by any person for cash, to be—
 - (a) in respect of sales of cornsacks for use as containers of wheat or barley 39s. 3d., plus a margin at the rate specified in the First Schedule to this Order;
 - (b) in respect of sales of cornsacks for use other than as containers of wheat or barley 39s. 3d. per dozen, plus a margin at the rate specified in the Second Schedule to this Order.

Provided that where such cornsacks are sold for other than cash to wheat and barley growers, the maximum price shall be the maximum price fixed by the provisions of this paragraph plus 6d. per dozen.

Variation of Maximum Prices by Notice.

5. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which any new cornsacks, specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

 - (c) in the case of fillets of fish, the price set out in the seventh column opposite each such variety of fish, less two pence per lb. weight.

- 2. Prices Control Order No. 354 is hereby amended— $\,$
 - by deleting from the third column appearing in the First Schedule the words "sales by wholesale" and inserting in their stead the words "sales by retail," and
 - by deleting from the third column appearing in the Second Schedule the word "reatail" and inserting in its stead the word "retail."

PRICES CONTROL ACT, 1948-1950.

Prices Control Order No. 362.

Tea.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 362.

Revocation.

2. Prices Control Order No. 290 is hereby revoked.

Definitions.

- 3. In this Order, unless the contrary intention appears—
 - "Tea Control Board" means Tea Control Board constituted under the National Security (Tea Control) Regulations of the Commonwealth of Australia;
 - "primary wholesaler" means primary wholesaler as defined in regulation 3 of the National Security (Tea Control) Regulations:
 - "licensed primary wholesaler" means a wholesaler who is licensed by the Tea Control Board to sell tea by wholesale;
 - "eliminated primary wholesaler" means a primary wholesaler who is not licensed as aforesaid by the Tea Control Board to sell tea by wholesale;
 - "secondary wholesaler" means any person who is registered with the Tea Control Board as a secondary wholesaler;
 - "first grade tea" means any tea the quality, brand, or description of which is set out or referred to in the first column of the Schedule to the Tea and Coffee Control Order No. 5, published in the Commonwealth Government Gazette of the 17th October, 1942, at page 2487;
 - "second grade tea" means any tea the quality, brand or description of which is not set out or referred to in the first column of the Schedule to the said Tea and Coffee Control Order No. 5;
 - "Perth Metropolitan Area" means all that area comprised within a radius of 15 miles from the General Post Office, Perth.
- 4. Notwithstanding anything contained in this Order, any person who is both a primary wholesaler and a secondary wholesaler as defined in paragraph 3 hereof shall be deemed to be—
 - (a) a primary wholesaler in respect of sales of tea received by him in its original package direct from the Tea Control Board or from a licensed primary wholesaler and blended and packed for sale by him; and
 - (b) a secondary wholesaler in respect of all other sales of tea made by him.

Maximum Prices.

- 5. I fix and declare the maximum price at which tea may be sold to a retailer to be—
 - (a) where such tea is sold in packages not exceeding 14 lb. net weight—
 - (i) first grade tea—3s. 6d. per lb.;
 - (ii) second grade tea-3s. 2d. per lb.;
 - (b) where such tea is sold in packages exceeding 14 lb. net weight, such packages being unopened original packages—
 - (i) first grade tea—3s. 33d. per lb.;
 - (ii) second grade tea—2s. 113d, per lb.:
 - (c) where such tea is sold in packages exceeding 14 lb. net weight, such packages not being unopened original packages—
 - (i) first grade tea—3s. 43d. per lb.;
 - (ii) second grade tea—3s. 03d. per lb.

Provided that where payment of the purchase price of such tea is made within 10 days from date of delivery, such maximum prices shall be reduced by 1d. per lb.

- 6. I fix and declare the maximum price at which tea may be sold by a primary wholesaler to a secondary wholesaler to be—
 - (a) where such tea is sold in packages not exceeding 14 lb. net weight—
 - (i) first grade tea-3s. 4d. per lb.;
 - (ii) second grade tea-3s, per lb.;
 - (b) where such tea is sold in packages exceeding 14 lb. net weight, such packages being unopened original packages—
 - (i) first grade tea—3s. 13d. per lb.;
 - (ii) second grade tea-2s. 93d. per lb.;
 - (c) where such tea is sold in packages exceeding 14 lb. net weight, such packages not being unopened original packages—
 - (i) first grade tea—3s. 23d. per lb.;
 - (ii) second grade tea-2s. 103d. per lb.
- 7. Where any tea, the maximum price for the sale of which is fixed by paragraphs 5 and 6 of this Order, is sold to any person for delivery to a purchaser in the Metropolitan Area, the maximum price fixed in relation thereto shall be deemed to include the costs of delivery to such purchaser.
- 8. In respect of tea, the maximum price of which is fixed by paragraphs 5 and 6 of this Order, sold to any person for delivery to a purchaser at any place other than in the Metropolitan Area, I fix and declare the maximum price at which such tea may be sold and delivered to the place of delivery to be that specified in paragraphs 5 and 6 of this Order, plus the costs properly incurred in and attributable to the transporting of each pound of such tea (calculated in relation to each such pound to the nearest upward farthing).

Provided that no amount may be added for costs of transport under the provisions of this paragraph unless such amount is properly recorded and vouched for in the books of the seller.

- 9. I fix and declare the maximum price at which tea may be sold by a licensed primary wholesaler to an eliminated primary wholesaler to be—
 - (i) first grade tea—3s. per lb.;
 - (ii) second grade tea-2s. 8d. per lb.

Provided that where payment of the purchase price of any such tea is delayed beyond the period of 30 days from the date of delivery thereof, the vendor may charge a further ½d. per lb. for such tea, which aggregate price I hereby fix and declare to be the maximum price thereof.

- 10. I fix and declare the maximum price at which tea may be sold by retail to be—
 - (i) first grade tea-3s. 10d. per lb.;
 - (ii) second grade tea—3s. 6d. per lb.

Provided that where such tea is sold by retail in a place outside the Metropolitan Area, the costs properly incurred in and attributable to the delivery of such tea into the store of the retailer and clearly recorded and vouched for in the retailer's books (calculated to the nearest upward ½d. per lb.) shall be added to the prices fixed and declared by this paragraph, which aggregate prices I hereby fix and declare to be the maximum prices for such tea.

11. Notwithstanding anything contained in this Order, I fix and declare the maximum price at which tea, packed by a primary wholesaler in packages supplied by the purchaser of such tea may be sold to be the maximum price fixed in accordance with the provisions of this Order, less the cost to the purchaser of such packages.

- Notwithstanding the foregoing provisions of this Order, I fix and declare the maximum price at which tea may be sold to the Commonwealth or the State of Western Australia to be
 - (a) in respect of sales by wholesalers

 - (i) bulk unblended tea—3s. $1\frac{1}{2}$ d, per lb.; (ii) bulk blended tea—3s. $2\frac{1}{4}$ d, per lb.; (iii) tea in 1-lb. packets—3s. $2\frac{3}{4}$ d, per lb.;
 - (a) in respect of sales by retailers
 - (i) bulk unblended tea—3s. 2½d. per lb.;
 - (ii) bulk blended tea—3s. 3\(\frac{1}{4}\)d. per lb.; (iii) tea in 1-lb. packets—3s. 3\(\frac{3}{4}\)d. per lb.;
- plus, in each case, cost of transport in to the seller's Provided that no amount may be added for cost of transport under the provisions of this paragraph unless such amount has been properly recorded in the seller's books of account.

Variation of Maximum Prices by Notice.

Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which tea specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

Prices Control Order No. 363.

Bulk Honey

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

Citation.

This Order may be cited as Prices Control Order No. 363.

Revocation.

Commonwealth Prices Regulation Order No. 2603, published in the *Commonwealth Gazette* on the 1st day of July, 1946, is hereby revoked.

Definitions.

- 3. In this Order, unless the contrary intention appears-
 - "bulk honey" means honey sold in containers containing more than 14 pounds weight of
 - "Perth Metropolitan Area" means all that area comprised within a radius of 12 miles from the General Post Office, Perth;
 - "cost of transport" means cost of transport by rail (or if rail transport is not available, any other service which is available) but does not include any cost of transport which is not recorded on an invoice de-livered by the seller;
 - "point of delivery" means in relation to the ant of delivery" means in relation to the sale of honey by any person the place at which liability for payment of transport charges in conveying that honey to the purchaser's place of business passed to the purchaser from the person from whom such benev was purphessed. such honey was purchased.

Sales to Wholesale Sellers.

- I fix and declare the maximum price at which bulk honey may be sold by any person to a wholesale seller to be
 - (a) where delivery is made in the Perth Metropolitan Area—84s. per cwt.;

(b) where delivery is made outside the Perth Metropolitan Area—84s. per cwt. less the cost of transport that would be incurred in transporting the honey from the seller's premises to the Perth Metropolitan Area, plus the cost of transport actually incurred and properly attributable to conveying the honey from such premises to the point of delivery to the purchaser.

Sales by Wholesale,

- I fix and declare the maximum price at which bulk honey may be sold by any person by wholesale to be-
 - (a) where delivery is made in the Perth Metropolitan Area—92s. 5d. per cwt.;
 - (b) where delivery is made outside the Perth Metropolitan Area, the sum of the following:
 - (i) The price paid or payable by the wholesale seller;
 - (ii) the cost of transport actually incurred in and properly attributable to conveying the honey from the point of delivery to the wholesale seller to the point of delivery by the wholesale seller;
 - (iii) margin at the rate of 8s. 5d. per

Variation of Maximum Prices by Notice,

Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which bulk honey specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to such person.

Revocation.

Prices Control Order No. 288 is hereby revoked.

Maximum Price.

3. I fix and declare the maximum price at which scrap copper may be sold by any person to be £200 per ton.

Variation of Maximum Prices by Notice.

Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which scrap copper specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.
