Road Districts Act, 1919-1948.

Busselton Municipal Council and Sussex
Road Board.

ORDER IN COUNCIL.

L.G.D. 442/51.

WHEREAS under the provisions of the Road Districts Act, 1919-1948, His Excellency the Governor has given notice of intention to exercise certain powers conferred by section 8 of the Road Districts Act, 1919-1948, and by this Order exercises such powers; and whereas, in consequence of the exercise of such power His Excellency the Governor has deemed it necessary to determine certain questions and matters regarding the representation of electors of the local authority affected and the constitution of such local authority: Now, therefore, under the provisions of the Road Districts Act, 1919-1948, His Excellency the Governor, acting by and with the advice and consent of the Executive Council and all other powers enabling him in this behalf, doth hereby—

(1) Constitute the whole of the Busselton Municipal District a Road District to be known as the Busselton Road District with a Board consisting of seven members being the members of the former Municipal Council.

- (2) Unite the Sussex Road District and the Busselton Road District into one district under the Road Districts Act, to be known as the Busselton Road District.
- (3) Divide the Busselton Road District into Wards to be known as:—
  - (i) Town Ward consisting of the whole of the land formerly comprising the Busselton Municipal District together with the whole of the land formerly comprising the West Busselton Ward of the Sussex Road District.
  - (ii) West Ward consisting of the land formerly comprising the West Ward of the Sussex Road District.
  - (iii) Central Ward consisting of the land formerly comprising the Central Ward of the Sussex Road District.
  - (iv) East Ward consisting of the land formerly comprising the East Ward of the Sussex Road District.
- (4) Declare that the Busselton Road District shall consist of thirteen members, six of whom shall be elected for the Town Ward; three of whom shall be elected for the Central Ward and two of whom shall be elected for each of the West and East Wards.
- (5) Declare that until the 18th day of August, 1951, Messrs. John Godfrey Blake, Robert Falkingham, Benjamin Kempston Killerby, James McCusker, Clifford Dare Riley and Louis Noel Weston shall represent the Town Ward; Messrs. Joseph George Clamp and Frank Henry Jolliffe shall represent the West Ward; Messrs. Frederick Harry Berryman and Edward Hopkins shall represent the Central Ward; Messrs. Arthur Ronald Blum and Frank James Oates shall represent the East Ward.

- (6) Determine that the first meeting of the Busselton Road District shall be held on the 18th day of May, 1951, at 7.30 p.m. at the Municipal Buildings, Busselton. The first business of the meeting will be election of a Chairman and Vice Chairman and the appointment of a Secretary and consideration given to the appointment of other officers; and that until the Chairman of the Board is elected from the members, the Secretary for Local Government, Mr. George Seddon Lindsay, shall act as Chairman of the meeting.
- (7) Determine that on the 18th day of August, 1951, all the existing members of the Busselton Road Board shall go out of office but shall be eligible for re-election and that an election for the return of members for each of the Wards of the District shall be held on the 18th day of August, 1951.
- (8) Determine that the vacancy caused in the Central Ward by the death of Francis William Stroud shall remain vacant until the 18th day of August, 1951.
- (9) Determine that the office of any person formerly employed by the Busselton Municipal Council or the Sussex Road Board but whose employment is determined within three months after the 18th day of May, 1951, shall, for the purpose of section 130 of the Road Districts Act, 1919-1948, be deemed to have ceased or to have been abolished.

This Order in Council shall take effect on and from the 18th day of May, 1951.

    - (d) A person who fails to deliver the Certificate certifying to the matters referred to in sub-paragraph (i) or sub-paragraph (ii) of paragraph (b) of this regulation within the time aforesaid shall not accept or continue employment as aforesaid. Provided that if the Certificate does not certify to the matters referred to in the said sub-paragraph (i) but does certify to the matters referred to in sub-paragraph (ii) such person may accept or continue employment as aforesaid but shall be eligible only for the benefits under and in accordance with the subsection (7) of section 21 of the Act.
- 3. Regulation 8 is amended by deleting paragraph (b).
- 4. Regulation 20 is amended by—substituting for paragraph (a) a new paragraph as follows:—  $\,$ 
  - (a) The period of disqualification under subsection (3) of section 12 of the Act shall commence on and from the day following the day on which the Mine Worker ceased work as a result of the injury in respect of which damages are received or recovered and shall continue during the number of weeks and part of a week ascertained by dividing that part of the damages which is apportioned by the Court, before which damages are recovered, as compensation for such injury or death by the maximum weekly amount of compensation payable under the Workers Compensation Act, 1912-1949.
  - 5. Regulation 21 paragraph (a) is amended by-
    - (a) inserting the word "annual" before the word "leave" in line three;
    - (b) deleting the words "section 10 or" in line six.
  - 6. Regulation 25 is repealed.
- 7. Regulation 26 is amended by substituting for the words "an amount equal to twice the total of the contributions paid for each such fortnight by the Mine Workers" in lines five and six the words "the amount prescribed by the Act, or by proclamation made under subsection (8) of section 21 of the Act, in respect of each Mine Worker."
  - 8. Regulation 27 is repealed.
  - 9. Regulation 28 is amended by-
    - (a) deleting all the words after the word "instalments" in line two of paragraph (a);
    - (b) deleting paragraph (b);
    - (c) deleting the words "so assessed and notified by the Tribunal" in line two of paragraph (c);
