## Potatoes.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, George Robert Marshall Garratt, Acting Prices Control Commissioner, hereby make the following Order:—

# Citation.

- This Order may be cited as Prices Control Order No. 430.
- Prices Control Order No. 365 is hereby amended-
  - (a) by omitting the figures "£21" from sub-paragraphs (a) and (b) of paragraph 4, from subparagraph (a) of paragraph 5 and from subparagraph (i) of paragraph 6 and inserting the figures "£22 12s. 6d." in their stead;
  - (b) by omitting the figures "£22 10s." from subparagraph (c) of paragraph 4 and from subparagraph (ii) of paragraph 6 and inserting the figures "£24 2s. 6d." in its stead:
  - (c) by omitting the First Schedule to the Order and inserting in its stead the schedule to this Order.

## Seed Potatoes.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, George Robert Marshall Garratt, Acting Prices Control Commissioner, hereby make the following Order:-

## Citation.

- 1. This Order may be cited as Prices Control Order No. 431.
- 2. Prices Control Order No. 366 is hereby amended-
  - (a) by omitting the proviso to paragraph 5 thereof and inserting in its stead the following-

Provided that where a sale is made to any person other than a secondary whole-saler and the purchase price is not paid by the purchaser within 30 days from the time of delivery of the seed potatoes by the primary wholesaler, the price fixed by this paragraph may be increased by 10s. per ton;

(b) by omitting the schedule thereto and inserting in its stead the schedule to this Order.
