Municipal Corporations Act, 1906-1947.

ORDER IN COUNCIL.

P.W. 235/41.

WHEREAS it is enacted by section 338A of the Municipal Corporations Act, 1907-1947, that the Governor may by Order in Council prescribe uniform general regulations with respect to all or any of the matters in relation to which a council may make by-laws under section 338 of the said Act. Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Act, hereby makes the uniform general regulations set out in the Schedule hereto and prescribes that such regulations shall have force in each and every municipal district for the time being constituted under the said Act.

Schedule.

- 1. The minimum height from floor to calling of all rooms of a building intended for use as a dwelling house may be nine feet or more, but not less than nine feet.
- 2. Any person who builds or crects or causes to be built or erected any room in a building intended for use as a dwelling house in contravention of the above regulation is guilty of an offence. Penalty £100.

Restrictions and Limitations.

- 8. If, during the term of the Special Lease, the settler fails to continue in ownership of his free-hold or conditional purchase lands, then the Minister may, at his discretion, cancel the Special Lease.
- 9. Special Lease so granted will be subject to the restrictions and limitations in regard to transfers, mortgages and subleases, as prescribed by the provisions of the Land Act, 1933-1950, and as are applicable to conditional purchase leases. Timber Reservations and Rights to the Crown.
- 10. No timber or scrub on the land in any such Special Lease shall be ringbarked, cut, destroyed or removed, without the approval in writing of the Conservator of Forests who may direct and prescribe that such timber or scrub as he deems necessary shall be preserved to prevent soil erosion and/or provide shade and shelter for stock.
- 11. - 13. The settler will be required to stock and keep stocked during the full term of his Special Lease the cleared land within such lease, with not less than one sheep to every 10 acres, or the equivalent thereof in large stock, and similarly uncleared land with not less than one sheep to every 30 acres, or the equivalent thereof in large stock: Provided that at his discretion the Minister may grant permission to the settler to carry for any specific period a less number of stock than otherwise required. For the purpose of this clause, six sheep shall be deemed to be equal to one head of large stock.
- 21. Power will be reserved to the Minister to direct that the number of stock depasturing on any Special Lease be reduced if the Minister is of the opinion that any such lease is overstocked to an extent sufficient or likely to cause permanent damage to the land. Right of appeal to the Board of Arbitration already referred to in clause 7 shall rest with the lessee in such case and the Board's determination shall be final.

INDUSTRIAL AGREEMENT.

No. 9 of 1951.

(Registered 1/6/51.)

THIS Agreement made in pursuance of the Industrial Arbitration Act, 1912-1950, this 31st day of May, 1951, between the West Australian Branch May, 1951, between the West Australian Branch of the Australasian Meat Industry Employees' Union Industrial Union of Workers' Perth (hereinafter called "the Union") of the one part, and the Air Beef Pty., Ltd. (hereinafter called "the Management" of the other part, witnesseth that, for the considerations hereinafter appearing, the parties hereto mutually covenant and agree the one with the other as follows:—

This Agreement shall apply in respect of the rates of wages and conditions at the Glenroy Abattoirs, for the 1951 season, and shall operate for a period of twelve (12) months from the date hereof.

2.—Definitions.

In this agreement, unless the context otherwise indicates, the following terms have the meanings

- respectively set out against them, that is to say:—

 (a) "Week-days"—Mondays, Tuesdays, Wednesdays, Thursdays and Fridays.

 (b) "A week"—shall mean Monday to Friday
 - inclusive.
 - "A day's work" shall mean eight hours on
 - (c) "A day's work" shall mean eight hours on week days Monday to Friday.
 (d) "Mutually agreed" or "Mutual arrangement" implies agreed between the Management of the works and the Union or its representatives, in writing.

3.—General Conditions.

- (a) Clauses under this heading are to be operative except where otherwise provided herein.
- (b) Any worker carrying out work classified at a higher rate than the rate pertaining to his recognised task shall be paid for that day at the highest rate of such tasks.
- (c) Wages shall be paid in accordance with arrangement arrived at between the management and the workers in accordance with sub-clause (d) of Clause 2.
- (d) The management shall give the delegate reasonable notice of workers required to work overreasonable notice of workers required to work over-time. The delegate shall be then responsible on behalf of the Union for supplying such workers. Overtime shall be distributed on a roster system, but any employee shall have the right to forego his place on the roster except for work in his own department, if required by the Management for work in that department. In all cases of over-time sufficient men for the job required must be supplied. supplied.
- (e) Employees shall be provided without charge with accommodation in the quarters erected for that purpose, including stretcher, mattress and pillow.
- (f) All delegates shall be officially recognised by the Management.
- (g) Notwithstanding that the rates of pay are set forth on a weekly basis, there shall be no obligation on the part of the Management or the employees to give a week's or any other notice to determine the employment, the position being in this respect the same as if the employee was employed at a daily wage.
- (h) The duties of the slaughter floor team shall include all operations, i.e., killing and dressing, (in the event of knocking operations having to be done by the slaughter fioor team they shall be paid an extra amount of 1.5d. per beast in excess of the amounts showing in clauses 17 and 19 of this agreement).

4.—Clothing.

- 1. The Management agrees to supply each employee with two (2) singlets or fiannels and 2 pairs of shorts or long trousers.
- 2. Such clothing to be washed and kept in good repair by the employee.
- 3. The employee shall report for work each day in a clean set of such clothing.

- 4. If at any time the management considers the clothing is no longer serviceable the employee shall purchase and wear replacements which shall washed and worn in accordance with above
- 5. A laundry equipped with washing machine shall be provided by the Management.

5.—Preference.

Preference of employment in respect of tasks for which rates of wages are specified in this Agreement shall be given to members of the Union who are parties to this agreement provided they are competent workmen for the task for which they are selected and do their work to the satisfaction of the Management.

Subject to preference to members of the Unions who are parties to this Agreement, the Management shall have the right-

- (a) To select employees with due regard to their qualifications for their respective tasks;
- To allot to employees their respective tasks: to dispense with the services of any employee for incompetence, drunkenness, misconduct.
- (c) In the event of the work of an employee being unsatisfactory at a task to which he has been transferred the Management shall have the right to place such employee on waiting time in accordance with Clause 33.
- (d) Employees engaged in Perth shall be selected from the lists supplied by the Unions who are parties to this Agreement.

6.-Transfer.

The Management may transfer employees from one department to another. In this case the rates payable shall be those specified for the task performed, subject to clause 4 of general conditions. In the case of alleged unreasonableness, the legal delegator are discuss with the Management. the local delegates can discuss with the Management.

7.—Hours of Labour.

Unless otherwise specifically mentioned, forty (40) hours shall constitute a week's work, divided into five (5) working days as follows:—

Five (5) week days each eight (8) hours—
40 hours.

Starting and ceasing times shall be as mutually arranged, taking into consideration arrival and departure times of aircraft.

Except where otherwise provided herein "ordinary working hours" shall comprise the hours between the ordinary starting time on any day and the ordinary ceasing time, excepting meal times and smokos except in any case of alteration, by mutual agreement.

8.—Meal Times.

Meal times shall be as mutually arranged in accordance with clause $7. \ \,$

9.—Smokos.

Except as provided in clause 18 or otherwise mutually agreed, smokos of 15 minutes each shall be allowed and paid for as working time, as follows:--

9 a.m. to 9.15 a.m.

2 p.m. to 2.15 p.m.

and one smoko after every two hours' continuous work done outside ordinary working hours.

When reasonably required by the management,

owing to exigencies of work. employees shall forego their smoko until a convenient time.

10.—Overtime Rates.

Overtime rates shall be paid in respect of all

- (a) After ordinary ceasing time (clause 7) to midnight, time and a half ordinary rates, thereafter double ordinary rates.
- (b) During meal hours and smokos, except as provided in clause 9, double ordinary rates.

(c) The hide man shall assist in loading operations off the 'plane and shall be paid at overtime rates for such work. The hide man's rate is calculated on the

basis of 40 hides per day and all hides treated in excess of 40 per day shall be paid for at this rate, i.e., 16.54d. per hide.

(e) The boner's rate is calculated on a tally of 24 quarters per day at 2s. 2.94d. per quarter, all boning done in excess of tally on an ordinary working day, or before the agreed starting time, or after the agreed ceasing time shall be paid for at double ordinary paters in at 4s. 5.88d per quarter. ordinary rates, i.e., at 4s. 5.88d. per quarter.

11.—Minimum of Overtime.

Subject to any mutual arrangement, employees called back to work after the meal time following called back to work after the meal time following ordinary ceasing time shall be provided with a minimum period of two hours' work, or shall be entitled to payment for such. Employees called out on Sundays or holidays shall be provided with a minimum period of two hours' work or shall be entitled to payment for such minimum periods to be a convenient in classes. to be at overtime rates as appearing in clauses 10 and 12.

12.—Holidays and Holiday Rates.

(a) Except as hereinafter provided, each of the following days or the days observed in lieu thereof shall be allowed as a holiday to all workers and be paid for, namely:—New Year's Day, Australia Day (26th January), Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, Wyndham Cup Day, King's Birthday, Christmas Day and

Cup Day, King's Birthday, Christmas Day and Boxing Day.

(b) Whenever any holiday falls on an employee's ordinary working day and the employee is not required to work on such day he shall be paid for the ordinary hours he would have worked on such day if it had not been a holiday. (f) A casual worker shall not be entitled to payment for any holiday referred to in this clause.

13.—Annual Leave.

(a) Except as hereinafter provided a period of two consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of 12 months' continuous service with such em-

(b) If any Award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day there shall be added to that period one day being an ordinary working day for each such day observed as aforesaid.

(c) (i) Subject to paragraph (ii) when computing the annual leave due under this clause no deduction shall be made from such leave in respect of the period that a worker is on annual leave and/or holidays: Provided that no deductions shall be made for any approved period a worker is absent from duty through sickness with or without pay unless the absence exceeds three (3) calendar months, in which case deduction may be made for such excess only.

(ii) Approved periods of absence from work caused through accident sustained in the course of employment shall not be considered breaks in continuity of service, but the first six months only of any such period shall count as service for the

purpose of computing annual leave.

- (d) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled to such holidays on full pay as are proportionate to his length of service during that period with such employer.
- (e) Annual leave must be granted not later than four (4) weeks after the leave falls due, and at least 14 days' notice shall be given to the worker of the date upon which he is to commence his annual leave.
- (f) Any worker who may resign or be dismissed from the service for any cause, other than for peculation or theft, shall be entitled to receive payment for any annual leave which may have been due up to the time of leaving the service: Provided always that if the worker has been dismissed for peculation or theft no claim for annual leave shall be recognised. Misconduct herein referred to shall not affect accumulated leave or payment therefor.
- (g) When work is closed down for the purpose of allowing annual leave to be taken, workers with less than a full year's service shall only be entitled to payment during such period for the number of days' leave due to them. Provided that nothing herein contained shall deprive the employer of his right to retain such workers at work during the close-down period as may be essential.
- (h) Workers regularly working for the management North of South latitude 26 shall be allowed to accumulate annual leave for two years, subject to the convenience of the management. Such workers who proceed to Fremantle and Perth during the period of such leave shall be allowed once in each two years reasonable travelling time on the forward and return journeys between the place of their employment and either of the said cities.
- (i) "Ordinary wages" for the purpose of subclause (a) hereof shall mean the average rate of wage the worker has received over the period of his employment in respect of his ordinary hours of
- (j) The provisions of this clause shall not apply to casual workers.

Each employee shall be entitled to-

- (a) passage from place of engagement to Glenroy and travelling time allowance.
- (b) passage (and travelling time allowance) by first available plane at discretion of Management from Glenroy to place of engagement after termination of work in his department; or when his services are not further required by the Management; provided that his duties have been performed to the satisfaction of the Management.

Travelling time allowance referred to in clause 23, shall be at the task rate applicable.

Waiting Time Allowances.

FREMANTLE HARBOUR TRUST ACT, 1902.

Amendment of Regulations.

THE Fremantle Harbour Trust Commissioners, acting pursuant to section 65 of the Fremantle Harbour Trust Act, 1902 (as reprinted with amendments in the 1934 Sessional Volume of Statutes), hereby amend the regulations made by them and in force under the said Act, as published in the Government Gazette on the 5th day of September, 1934, and amended from time to time thereafter (reprinted by the Government Printer with all amendments to the 24th day of November, 1950), and since further amended by notices published in the Government Gazette on the 22nd day of March, 1951, and the 1st day of June, 1951, in the manner mentioned in the Schedule hereunder.

Schedule.

The abovementioned regulations are amended as follows:-

- 1. By deleting the figures and symbols "11s. 6d." where appearing in the third line of paragraph (1) of regulation 249 and inserting in lieu thereof the symbol and figure "£1."
- 2. By deleting paragraph (3) of Regulation 249 and inserting in lieu thereof the following:—
 - (3) Casual or special lifts, exceeding 3 tons in weight, a fraction of a ton to be computed as a ton:—
 - (a) Over 3 tons and not exceeding 4 tons, 9s. 0d. per ton.
 - (b) Over 4 tons and not exceeding 5 tons, 11s. 0d. per ton.
 - (c) Over 5 tons and not exceeding 6 tons, 14s. 0d. per ton
 - (d) Over 6 tons and not exceeding 10 tons, 16s. 0d. per ton.
 - (e) Over 10 tons and not exceeding 20 tons, 18s. 0d. per ton.
