PRICES CONTROL ACT, 1948-1950.

Prices Control Order No. 491.

Timber, Mouldings, Joinery and Cartage.

Timber, Mouldings, Joinery and Cartage.

WHEREAS it is provided, inter alia, by subregulations (3) and (7) of regulation 17 of the Prices Control Regulations, 1949, that the powers conferred respectively by paragraph (a) of subregulation (1) and paragraph (a) of subregulation (5) of regulation 17 of those regulations, to fix and declare by Order published in the Gazette, the maximum price at which any declared goods may be sold or the maximum rate at which any declared service may be supplied or carried on, shall for all purposes be deemed to be validly exercised by an Order so published which fixes any such price or any such rate by reference to a list of prices or rates approved by the Commissioner, and issued by a body or association of persons which is recognised by the Commissioner, in the case of sales by a trader in goods, or in the case of a supplier of a service, to be representative of the traders in the goods or the suppliers of the service, in relation to the sale or the supply of which the price or rate is so fixed; and whereas I, Constantin Paul Mathea, Prices Control Commissioner, have recognised the Associated Sawmillers and Timber Merchants of W.A. Perth, as representative of traders in timber, mouldings and joinery and suppliers of the service of cartage of timber and mouldings; and whereas I, the said Constantin Paul Mathea, have approved of the following list of prices of timber, mouldings and joinery, and rates for the cartage of timber and mouldings issued by the Associated Sawmillers and Timber Merchants of W.A. Perth, that is to say, the list referred to as "Price List No. 54, as from 7th May, 1951": Now, therefore, I, the said Constantin Paul Mathea, in pursuance of the powers conferred upon me by the aforesaid regulations, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 491.

Revocation.

Prices Control Order No. 368 is hereby re-2 voked.

Definition.

3. In this Order, "Perth Metropolitan Area" means all that area comprised within a radius of 20 miles from the General Post Office at Perth.

Maximum Prices for Timber, Mouldings and Joinery.

4. I fix and declare the maximum prices at which timber, mouldings and joinery specified in the abovementioned price list, No. 54, may be sold by retail in the Perth Metropolitan Area, to be the prices specified in that price list or computed in accordance therewith.

Maximum Rates for Cartage of Timber and Mouldings.

I fix and declare the maximum rates at which the service of the cartage of timber and mouldings may be supplied by any retail seller of such timber or mouldings, to be the cartage rates specified by that price list or computed in accordance therewith.

Variation of Maximum Prices or Rates by Notice.

6. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which timber, mouldings or joinery, or the maximum rate at which the service of the cartage of timber or mouldings specified in a notice in pursuance of this paragraph may respectively be sold or supplied by any person to whom such notice is given, to be such price or rate as is fixed by the Commissioner by notice in writing to that person. sioner by notice in writing to that person.

PRICES CONTROL ACT, 1948-1950.

Prices Control Order No. 492.

Floor Coverings.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I. Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 492.

Revocation.

2. Prices Control Order No. 237 is hereby revoked.

Application.

3. Nothing in this Order shall apply to plain and marbled jaspe, feltex, teprac, feloura, bisonia, underfelt and other similar felt products manufactured by Felt & Textiles of Australia Limited and Federal Felters Pty. Ltd.

Definitions.

4. In this Order, unless the contrary intention appears—

"floor coverings" means floor coverings of all descriptions whatsoever (other than of rubber), including carpets, linoleums and substitutes, floor rugs, runners, floor mats and matting, felt and paper underbases:

"cost" means-

- (a) in relation to floor coverings imported by the seller from a source outside the Commonwealth of Australia—the aggregate of the purchase price paid or payable for those goods to the overseas supplier after deduction of trade discount, but before deduction of cash discount, together with inland carriage, outside packing, overseas office or forwarding agents' commission actually incurred (but not in excess of 3½ per centum of the invoice price of the goods after deduction of trade discount, bill of lading and shipping charges, insurance, freight (but not in excess of current standard sea freight rates), exchange and bank fees actually incurred (but not in excess of mail steamer sight draft rate and ½ of one per centum, respectively), duty and primage, wharfage, stacking, harbour dues and Stevedoring Industry Commission levy, Customs entry and Customs Agents' charges (but not including any charges for costing or any percentage surcharge on cost), cartage actually incurred in transporting goods from wharf to store or from wharf to bond only (but not in excess of the maximum rate fixed to the Western Australian Road Transport Association (Inc.) for the cartage from wharf to store or from wharf to bond of such goods);
- (b) in relation to floor coverings not imported by the seller from a source outside the Commonwealth of Australia—the purchase price paid or payable for that floor covering after deduction of any trade discount, but before deduction of any cash discount, plus packing charges and cartage actually incurred, and the cost of transporting (if any), such floor coverings from the point of delivery to the seller's premises and attributable to such floor coverings and recorded on an invoice delivered in relation thereto.

For the purpose of this subparagraph—

"cost in transporting" means freight charges, provided that where more than one freight service operates, the lowest freight rate only shall be allowed;

"point of delivery" means the place at which liability for payment of transport charges in conveying those goods to the seller's store passed to the seller from the person from whom such goods were purchased.

Maximum Wholesale Prices.

- 5. I fix and declare the maximum price at which any floor covering may be sold by any person by wholesale to be— $\,$
 - (a) in the case of the floor coverings specifled in the First and Second Schedules to this Order, the sum of—
 - (i) the cost of that floor covering;
 - (ii) 15 per centum of such cost.
 - (b) in the case of the floor coverings specifled in the Third Schedule to this Order, the sum of—
 - (i) the cost of that floor covering;
 - (ii) 12½ per centum of such cost.

Maximum Retail Prices.

- 6. I fix and declare the maximum price at which floor coverings specified in the First Schedule to this Order may be sold by any person by retail to be the sum of—
 - (a) the cost of such goods;
 - (b) sales tax paid or payable;
 - (c) (i) in respect of floor coverings purchased by the retail seller from a source outside the Commonwealth of Australia, or floor coverings purchased by the retail seller at a manufacturer's price —35 per centum of (a) and (b); or
 - (ii) in respect of floor coverings purchased by the retail seller from a wholesaler
 —30 per centum of (a) and (b).
- 7. I fix and declare the maximum price at which floor coverings specified in the Second Schedule to this Order may be sold by any person by retail to be the sum of—
 - (a) the cost of such goods;
 - (b) sales tax paid or payable;
 - (c) (i) in respect of floor coverings purchased by the retail seller from a source outside the Commonwealth of Australia, or floor coverings purchased by the retail seller at a manufacturer's price—40 per centum of (a) and (b); or
 - (ii) in respect of floor coverings purchased by the retail seller from a wholesaler
 —33 1/3rd per centum of (a) and (b).
- 8. I fix and declare the maximum price at which floor coverings specified in the Third Schedule to this Order may be sold by any person by retail to be the sum of—
 - (a) the cost of such goods;
 - (b) sales tax paid or payable;
 - (c) (i) in respect of floor coverings purchased by the retail seller from a source outside the Commonwealth of Australia, or floor coverings purchased by the retail seller at a manufacturer's price —37½ per centum of (a) and (b); or
 - (ii) in respect of floor coverings purchased by the retail seller from a wholesaler —30 per centum of (a) and (b).

Exhibition of Price Tickets.

9. (1) Every person who has for sale by retail any goods, the maximum price of which is fixed by or under the provisions of this Order, shall attach to or display with those goods a ticket or label setting forth his selling price thereof.

(2) Any ticket or label required by subparagraph (1) of this paragraph to be attached to or displayed with any goods shall be in such form as to be easily legible to any person inspecting or viewing those goods, and as to be properly associated with such goods.

Discounts.

- 10. Notwithstanding anything contained in this Order, where a seller of floor coverings by wholesale or by retail has customarily allowed any difference in price—
 - (a) to any person or to persons included in any class of persons;
 - (b) in respect of sales of certain quantities of floor coverings; or
 - (c) in respect of sales of floor coverings under certain conditions of sale, or upon certain terms of payment,

the maximum price fixed by or under this Order in respect of those floor coverings shall, in the case of sales to any such person or persons, or of such quantities or under such conditions, or upon such terms of payment, be reduced by the allowance of that difference.

Variation of Maximum Price by Notice.

11. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which floor coverings specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given, to be such price as is fixed by the Commissioner by notice in writing to that person.

The First Schedule.

Linoleum of a higher grade than "C" grade.

The Second Schedule.

Linoleum and linoleum substitutes of all grades other than those specified in the First Schedule to this Order, felt and paper under bases.

The Third Schedule.

All floor coverings covered by this Order, other than those specified in the First and Second Schedules to this Order.

Onions.

Sales by Retail.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 496.

Revocation.

2. Prices Control Order No. 409, as amended by Prices Control Order No. 429, insofar as it relates to the sale of onions by retail, is hereby revoked.

Definitions and Interpretations.

- 3. In this Order and the Schedule thereto, unless the contrary intention appears—
 - "cost per cwt. into retailer's store" means the sum of the following:—
 - (a) the price per cwt. paid or payable by the retail seller for the onions computed on the basis of the full weight of the onions and bag and without any allowance for wastage;
 - (b) cost of transport actually incurred in and properly attributable to conveying the onions from the point of delivery to the retail seller to that retail seller's store;

Provided that cost of transport shall not be allowed unless it is recorded on an invoice for the onions delivered to the seller;

"point of delivery" means, in relation to the sale of onions, the place at which liability for payment of transport charges passed to the purchaser from the person from whom such onions were purchased;

in this Order and the Schedule thereto, unless the contrary intention appears, "onions" means onions grown in or outside Australia.

Sales by Retail.

4. I fix and declare the maximum price at which onions may be sold by any person by retail to be the price specified in the second column of the Schedule to this Order according to the cost per cwt. into the retailer's store set out in the first column of that Schedule.

Exhibition of Price Tickets.

5. Every person who sells or has for sale onions by retail shall exhibit a notice or notices setting forth his selling price in relation to each lot of onions displayed by that person in the following manner, that is to say, by exhibiting a prices card specifying the selling price applicable to each lot of such onions displayed so as properly to associate such price with the lot of onions to which that price applies.

Variation of Maximum Price by Notice.

6. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which any onions specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to such person.
