PRICES CONTROL ACT, 1948-1950.

Prices Control Order No. 515.

Furniture.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 515.

Revocation.

2. Prices Control Order No. 51, as amended by Prices Control Orders Nos. 55, 212 and 356, is hereby revoked.

Definitions and Interpretations.

- 3. In this Order, unless the contrary intention appears, the expression—
 - "furniture" means furniture of all kinds and descriptions;
 - "cost," in relation to any furniture, means the amount paid or payable by the seller by retail for that furniture, plus any expenses actually incurred by that seller and recorded in his books of account for finishing, fitting, or completing the manufacture of the furniture, plus Commonwealth Sales Tax paid in relation to that furniture, but not including any expenses incurred in the packing or transport of that furniture.

Application for Maximum Prices.

4. Any person who manufactures any article of furniture shall not sell that furniture unless and until that person has made a written request to the Prices Control Commissioner to fix the maximum price at which that furniture may be sold and the Prices Control Commissioner has fixed the maximum price accordingly.

Maximum Retail Prices.

- 5. I fix and declare the maximum price at which any article of furniture may be sold by any person by retail to be—
 - (a) in respect of sales by retail of furniture by the manufacturer of such furniture, the price fixed by notice in writing to that manufacturer in pursuance of paragraph 4 of this Order;
 - (b) in respect of sales by any person other than a manufacturer, the sum of—
 - (i) the cost to the retail seller of that furniture, or

an amount equal to the maximum price fixed in pursuance of the provisions of paragraph 4 of this Order to the manufacturer of such furniture for sales other than by retail of that furniture in a finished, completely fitted and completely manufactured condition, plus Commonwealth Sales Tax paid in relation thereto—

whichever is the lesser;

- (ii) an amount equal to 37½ per centum of (i);
- (iii) the amount for packing actually charged by the manufacturer to the retail seller;
- (iv) where the retail seller has incurred any costs in transporting such furniture—
 - (a) from any place within a radius of 15 miles from the General Post Office, Perth, to premises of that retail seller outside that radius, or

(b) from any place within a radius of 5 miles from the principal post office of any place other than Perth, to premises of that retail seller outside that radius, or for insurance charges during transit as aforesaid—

an amount equal to the cost of transport and insurance so incurred.

Records to be kept of Purchases.

- 6. Any person who sells or offers for sale by retail any article of furniture shall keep in relation to each such article of furniture a record of the following particulars:—
 - (a) A serial entry number.
 - (b) The name of the manufacturer from whom purchased.
 - (c) The manufacturer's invoice number and date.
 - (d) A full description of the article of furniture.
 - (e) The purchase price paid or payable.
 - (f) Sales Tax, if any, charged thereon.
 - (g) Any other costs, including finishing, polishing, etc.
 - (h) The total cost.
 - Any other charges, cartage, freight, insurance, packing.
 - (j) The maximum selling price fixed by or under the provisions of this Order.

Delivery of Invoices or Dockets.

- 7. Any person who sells any article of furniture, shall deliver with that furniture an invoice or docket specifying the following particulars:—
 - (a) His name and place of business.
 - (b) The name and address of the purchaser of that furniture.
 - (c) The date of sale of that furniture.
 - (d) A full description of the article sold.
 - (e) The price charged for such article of furniture.
 - (f) In the case of a sale by any person by retail, the serial entry number pursuant to paragraph 6 of this Order.

Exhibition of Price Tickets.

- 8. Any person who sells or offers for sale by retail any article or suite of furniture shall attach to that furniture for display in relation to that furniture, a ticket or label setting forth his retail selling price for that furniture, and the serial entry number as required to be recorded by that person pursuant to paragraph 6 of this Order.
- I hereby approve of the following form for the ticket or label referred to in this paragraph:—
 - A separate price card of a minimum size of 5 inches by 3 inches specifying the price of each such article or suite so as properly to associate such price with each article or suite of furniture and so as to be clearly legible by any person viewing or inspecting the furniture.

Variation of Maximum Prices by Notice.

9. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which any article of furniture specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given, to be such price as is fixed by the Commissioner by notice in writing to that person.

PRICES CONTROL ACT, 1948-1950.

Prices Control Order No. 516.

Cement Tiles, Cement Ridgecaps, Cement Shell Ends, Cement Apex Pieces and the Fixing or Construction therefrom of Roofs for Buildings.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 516.

Revocation.

2. Prices Control Order No. 486 is hereby revoked.

Definition.

3. In this Order, "Perth Metropolitan Area" means all that area comprised within a radius of 20 miles from the General Post Office at Perth.

Maximum Prices—Cement Tiles, Cement Ridgecaps, Cement Shell Ends, Cement Apex Pieces.

4. I fix and declare the maximum price at which any of the types or descriptions of cement tiles, cement ridgecaps, cement shell ends and cement apex pieces specified in the first column of the First Schedule to this Order, and of the colours specified in the second column of that Schedule may be sold in the Perth Metropolitan Area by any person to be the price set out in the third column of the Schedule opposite to each such type or description and colour.

Maximum Rates—Supply of Cement Tiles, Cement Ridgecaps, Cement Shell Ends and Cement Apex Pieces and the Fixing or Construction therefrom of Roofs.

5. I fix and declare the maximum rate at which any person may supply the service of supplying cement tiles, cement ridgecaps, cement shell ends and cement apex pieces of any of the colours specified in the first column of the Second Schedule to this Order and from such cement tiles, cement ridgecaps, cement shell ends and cement apex pieces, fixing or constructing a roof for any building upon any building site situated within the Perth Metropolitan Area to be the rate specified in the second column of such Schedule opposite such colour set out in the first column of that Schedule. Provided that the rate so specified shall include the supply of all cement, battens, nails and wire used in the fixing or constructing of any roof.

Delivery of Invoices or Dockets.

- 6. Any person who sells any cement tiles, cement ridgecaps, cement shell ends or cement apex pieces shall deliver with the cement tiles, cement ridgecaps, cement shell ends or cement apex pieces an invoice or docket specifying the following particulars:—
 - (a) His name and place of business.
 - (b) The name and address of the purchaser of the goods.
 - (c) The date of sale of the goods.
 - (d) A full description and quantity of each item of goods sold.
 - (e) The price charged for each item of goods sold.
 - (f) The total amount charged for each item of goods sold.

Variation of Maximum Prices or Rates by Notice.

7. Notwithstanding the foregoing provisions of this Order, where in any notice in writing to any person in pursuance of this paragraph, a maximum price is fixed in relation to the sale of cement tiles, cement ridges, cement shell ends and cement apex pieces, or a maximum rate is fixed for the service of supplying cement tiles, cement ridges, cement shell ends and cement apex pieces, and from such cement tiles, cement ridges, cement shell ends and cement apex pieces, the fixing or construction of roofs for buildings, I declare the maximum price at which such specified goods may be sold or the maximum rate at which such specified service may be supplied, to be such price or rate as is fixed by the Commissioner by notice in writing to that person.

PRICES CONTROL ACT, 1948-1950.

Prices Control Order No. 517.

Sandstone.

The Laying and Construction from Sandstone of Foundations for Dwelling Houses.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 517.

Revocation.

2. Prices Control Order No. 448 is hereby revoked.

Definitions.

- 3. In this Order and the Schedules thereto "cubic yard" means—
 - (a) in relation to sales of sandstone, 27 cubic feet;
 - (b) in relation to the laying or construction of foundations for dwelling houses, 16 cubic feet.

Maximum Prices-Sandstone.

4. I fix and declare the maximum price at which sandstone may be sold by any person for delivery to any building site situated in any of the municipal districts or road board districts specified in the first column of the First Schedule to this Order to be the price set out in the second column of that Schedule opposite the name of such municipal district or road board district.

Maximum Rates—Supply of Sandstone and the Laying or Construction therefrom of Sandstone Foundations.

5. I fix and declare the maximum rate at which any person may supply the service of supplying sandstone and from such sandstone laying or constructing foundations for dwelling houses upon any building site situated in any of the municipal districts or road board districts specified in the first column of the Second Schedule to this Order, to be the rate, according to the average height of stone, set out in the second or third or fourth column of that Schedule opposite the name of such municipal district or road board district.

Variation of Maximum Prices or Rates by Notice.

6. Notwithstanding the foregoing provisions of this Order, where in any notice in writing to any person in pursuance of this paragraph a maximum price is fixed in relation to the sale of sandstone, or a maximum rate is fixed for the supply of the service of supplying sandstone and from such sandstone the laying or construction of foundations for dwelling houses, I declare the maximum price at which such specified goods may be sold, or the maximum rate at which such specified service may be supplied, to be such price or rate as is fixed by the Commissioner by notice in writing to that person.
