PRICES CONTROL ACT, 1948-1950.

Prices Control Order No. 523.

Sheets, Tea Towels, Nursery Squares, Table Cloths, Pillowslips—Hemmed in Australia.

IN pursuance of the powers conferred upon me by the Prices Control Act, 1948-1950, and the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:-

Citation.

1. This Order may be cited as Prices Control Order No. 523.

Revocation.

2. Prices Control Order No. 407 is hereby revoked.

Application.

3. This Order shall apply only to specified goods hemmed or overlocked in Australia.

Definitions and Interpretations.

4. In this Order, unless the contrary intention appears

- "maker-up" means, in relation to the supply of any services of hemming, overlocking, or otherwise making up of any specified goods, a person who hems or overlocks or otherwise makes up those goods from material furnished to him by some other person for such purpose;
- "manufacturer" means, in relation to the sale of any specified goods, a person who manu-factures those specified goods from his own material;
- "semi-manufacturer" means, in relation to the sale of any specified goods, a person who owns the material from which those specified goods are manufactured and who furnishes that material to a maker-up for hemming, overlocking, or otherwise making

up of such specified goods, and includes a person who sells the material to a makerup or manufacturer and buys the goods hemmed, overlocked, or otherwise made up from the material back from the maker-up or manufacturer;

- "specified goods" means the goods specified in the Schedule to this Order;
- "wholesale merchant" means, in relation to the sale of any specified goods, a person who purchases such goods from a manufacturer or semi-manufacturer and resells those goods by wholesale.

Maximum Prices—Sales by Manufacturers and Semi-manufacturers.

5. I fix and declare the maximum price at which specified goods may be sold by the manufacturer or semi-manufacturer to be the sum of—

- (a) the maximum making allowance specified in the Schedule to this Order, plus-
- (b) (i) in respect of sales by wholesale—the maximum price fixed by or under the Prices Control Regulations, 1949, for the sale by wholesale by that manufacture or computer the sale by t facturer or semi-manufacturer, as the case may be, of the material contained in such goods;
 - (ii) in respect of sales by retail-the maximum price fixed by or under the Prices Control Regulations, 1949, for the sale by retail by that manufacturer or semi-manufacturer, as the case may be, of the material contained in such goods.

Maximum Rates-Makers-up.

6. I fix and declare the maximum rate at which the service of making up any specified goods may be supplied by the maker-up to be the amount specified in the Schedule to this Order. Maximum Prices-Sales by Wholesale Merchants.

7. I fix and declare the maximum price at which specified goods may be sold by a wholesale mer-chant to be the purchase price paid or payable for those goods by that wholesale merchant, before deduction of any discount or allowance thereon.

Discounts.

8. Notwithstanding anything contained in this Order, where a manufacturer, wholesale merchant or a semi-manufacturer has customarily allowed, in relation to sales other than by retail, any difference in price-

- (a) to any person, or to any person included in any class of persons;
- (b) in respect of sales of certain quantities;
- (c) in respect of sales under certain conditions of sale,

the maximum prices fixed by or under this Order shall, in the case of sales other than by retail to any such person or persons, or of such quantities, or under such conditions, be reduced by the allow-ance of that difference. Provided that in any case, whether any difference in price has been custo-marily cloved or not where payment is made marily allowed or not, where payment is made within 30 days from the date of invoice, such reduction shall not be less than $2\frac{1}{2}$ per centum of such price.

Delivery of Invoices Specifying Maximum Prices, Etc.

9. Every manufacturer or semi-manufacturer who sells to a wholesale merchant any specified goods, a maximum price for the sale of which is fixed by or under the provisions of this Order, shall deliver with those goods an invoice or docket setting forth-

- (a) a full description of the goods sold;
- (b) the price charged for those goods; and
- (c) the maximum price fixed by or under the provisions of this Order for the sale of those goods by that manufacturer, or semimanufacturer, to that wholesale merchant.

Variation of Maximum Prices or Rates by Notice.

10. Notwithstanding the foregoing provisions of this Order, where in pursuance of this paragraph a maximum price is fixed in relation to any specified maximum pirce is fixed in relation to any specified goods, or a maximum rate is fixed in relation to the supply of the service of hemming, overlocking or making up any specified goods by notice in writing to any person, I declare the maximum price at which such specified goods may be sold or the maximum rate at which the service of hemming, wurkleding up any specified and be and the service of hemming. overlocking or making up specified goods may be supplied, to be such price or rate as is fixed by the Commissioner by notice in writing to that person.

PRICES CONTROL ACT, 1948-1950. Prices Control Order No. 524.

Sugar-Sales by Wholesale.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:-

Citation.

This Order may be cited as Prices Control 1 Order No. 524.

Revocation.

Prices Control Order No. 291 is hereby re- $\mathbf{2}$. voked.

Maximum Wholesale Prices.

I fix and declare the maximum price at which 3 sugar of the grades specified in column 1 of the First and Second Schedules to this Order may be sold by any person by wholesale to be-

- (a) in respect of any sale of a quantity of 10 cwt. or more—
 - (i) where payment is made by cash with order—the price specified in columns 2 or 3 of the First Schedule, according to the quantity sold;
 - (ii) where payment is made other than by cash with order—the price speci-fied in columns 4 or 5 of that Sched
 - fied in columns 4 or 5 of that Schedule according to the quantity sold—
 (a) less, in any case where payment is made within 7 days, a discount of 3 per centum; or
 (b) less, in any case where payment is made within 30 days, a discount of 2¹/₂ per centum;
- (b) in respect of sales of quantities of less than 10 cwt.-
 - (i) where payment is made by cash with
 - (1) where payment is made by cash with order—the price specified in column 2 of the Second Schedule to this Order, less 3 per centum thereof;
 (ii) where payment is made other than by cash with order—the price specified in column 2 of the Second Schedule to this Order—
 - (a) less, in any case where pay-ment is made within 7 days, a discount of 3 per centum; or
 - (b) iess, in any case where payment is made within 30 days, a discount of $2\frac{1}{2}$ per centum.

Variation of Maximum Prices by Notice.

4. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which sugar specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.
