WESTERM AUSTRALIA, TO WIT, JOHN PATRICK DWYER, Administrator.
IL.S.1 By His Excellency The Honourable Sir John Patrick Dwyer, Knight Commander of the Most D'stinguished Order of Saint Michael and Saint George, Administrator in and over the State of Western Australia and its Dependencies in the Commonwealth of Australia.

the said Act, do hereby prorogue the Legislative Council and the Legislative Assembly until Tuesday, the 16th day of October, 1951.

WHEREAS under the provisions of the Constitution Act, 1889-1950, it is made lawful for the Governor to fix the time and place for the holding of the first and every other session of the Legislative Council and the Legislative Assembly; and whereas the Legislative Council and the Legislative Assembly; now stand prorogued until the 16th day of October, 1951: Now, therefore I, the said Administrator, the officer for the time being administering the Government of the State, in exercise of the powers conferred by the said Act, do by this Proclamation announce and proclaim that the Third Session of the Twentieth Parliament shall be holden for dispatch of business on Tuesday, the 16th day of October, 1951, at the hour of 4.30 p.m., in the House of Parliament in the City of Perth; and Members of the Legislative Council and Members of the Legislative Council and Members of the Legislative Assembly are hereby required to give their attendance at the said time and place accordingly. accordingly.
