IN pursuance of the powers conferred on it by the Road Districts Act, 1919-1948, section 201, the Gnowangerup Road Board doth make and publish the following by-laws.

1. In these regulations:-

"Act" means the Road Districts Act, 1919-1948.

"Board" means the Gnowangerup Road Board.

"Officer" means any officer appointed by the Board.

"Owner" includes any owner or consignee. whether joint or sole, or person in possession or in charge of any stock, or any agent of such owner or consignee, and includes the occupier for the time being of any portion of a saleyard.

"Saleyard" means the structures and property owned by the Gnowangerup Road Board used for the sale of stock.

"Stock" means all classes of livestock.

"Stock agent" means any person authorised by an owner or consignee to sell stock at the saleyards on his behalf, and includes a firm or body corporate.

2. No stock shall be kept in a saleyard by any owner or successive owners for an aggregate period of more than 24 hours unless such stock is provided with food and water.

3. All stock brought to a saleyard for sale shall be in the care of stock agents to whom such stock shall be consigned.

4. The Board will not be responsible for any injury or damage to, or for the death, or escape of any stock brought or delivered to a saleyard.

5. Sales shall be held in the saleyards, on such days and at such hours, between sunrise and sunset, as shall be determined from time to time by the Board.

6. No persons shall sell any stock in a saleyard owned or controlled by the Board without having first obtained a license so to do from the Board. Licenses shall be issued annually, and the fee payable for a license shall be (5s.) five shillings.

7. The order of priority in which stock agents shall sell stock on authorised sale days shall be determined by the stock agents.

8. (a) Yard fees shall be paid to the Board by any person for all stock yarded in the Board's saleyards, for sale or transit.

(b) The yard fees payable per head for stock shall be those prescribed by resolution of the Board.

9. Yard fees shall be charged only once for any lot of stock re-submitted for sale on the same day by the stock agent responsible for the first offering.

10. When any lots passed in or sold by stock agents are transferred to another stock agent, and again submitted for sale on the same day, yard dues shall be charged on both transactions.

11. Yard fees shall be payable for stock yarded in the Board's saleyards for drafting or any other purpose.

12. Every stock agent shall furnish to the Board a true statement in writing, setting out the total number of each class of stock yarded by him in a saleyard in respect of each sale day, and remit all dues and fees thereon within seven days after sale. The Board shall have power to inspect any books necessary to verify such statement.

13. Stock, which have been offered for sale at a sale held in the Board's saleyards, and upon whom all dues and fees have been levied up to and including the day of the sale, may be yarded free for a period of 24 hours after the day of sale if the consent of the officer of the Board is obtained. If stock be not despatched from the saleyard at the expiration of such period, the yarding fees to be paid upon such stock for every day or part of a day such stock shall remain yarded shall be as follows:—

14. The owner of stock shall, if so desired by the officer in charge, cause such stock to be removed from the saleyard at a specified time following the day upon which stock have been submitted to auction.

15. The owner or person having control of any dog in a saleyard shall tie or secure the dog, when the same is not working therein, in such a manner as to prevent such dog from running about the saleyard or interfering with any stock therein. Any dog, while not tied up, shall be muzzled, unless the approval of the officer in charge is obtained. No owner or person having charge or control of any mangy or diseased dog shall take same into a saleyard, or permit or suffer it to enter therein. Any officer of the Board may destroy any such dog found in a saleyard.

16. No person shall ride or drive any animal, whether attached to any vehicle or not, at more than a walking pace, within the precincts of a saleyard, excepting such places as shall be allotted for the purpose. 17. No person in a saleyard shall behave in a disorderly or indecent manner, and any person so doing may be removed from the saleyard by a Police officer or officer of the Board.

18. Stock which have died, or which have been maimed, shall be immediately removed from the saleyard by the stock agent or owner.

19. No person shall put or place any sign, advertisement or notice on any part of a saleyard, except with the written consent of the Board.

20. Every person who does, permits, or suffers any act, matter or thing contrary to these by-laws, shall be guilty of an offence against these by-laws, and shall be liable to a penalty not exceeding five pounds for every such offence.

ROAD DISTRICTS ACT, 1919-1948. Fremantle Road Board.

By-law relating to Blasting, Quarrying and Excavations.

L.G. 740/37.

THE Fremantle Road Board, in pursuance of section 202 of the Road Districts Act, 1919-1948, doth hereby make and publish the following by-law:—

1. No person, company or corporation shall, within the limits of the Fremantle Road District, directly or indirectly, quarry or permit quarries or excavations for stone, gravel, sand, or other materials, or do any act or thing, for the purpose of recovering any stone, gravel, sand or other material whereby an excavation is created or enlarged, without a license from the Board in writing first had and obtained: Provided that any person may excavate for foundations, wells, post-holes, septic tanks, reservoirs, air-raid shelters, according to the plans and specifications submitted to the Board upon the granting of a building permit. The owners (as shown by the rate book), the registered proprietor, the purchaser under contract of sale, the occupier and/or any person removing or assisting in removing any such material without a license having been granted in respect thereof, shall be liable as if such person were actually quarrying.

2. The application for a license shall be in writing, with a deposit of $\pounds 1$, and accompanied by a plan showing the site, with contours and levels and size of the proposed quarrying or excavation and its distance from the nearest buildings, roads, and footpaths.

3. The fee for such license shall be $\pounds 1$ per annum and, if cancelled by the Board during its currency, a proportionate part will be refunded.

4. The Board may refuse to grant or renew a license without assigning any reason to the applicant.

5. The licensee shall, before commencing any blasting or quarrying, erect and keep exhibited such notices of warning as may be directed by the Board.

6. The licensee shall obey the directions of the Board as to the limit in size, weight, or amount of any explosive that may be used in any charge.

7. Every quarry shall be enclosed by a sufficient fence to keep out persons, stock and cattle, and shall have gates, which shall be kept locked during the hours when quarrying operations are not being carried on. 8. No excavation shall be made below the level of the nearest road, except with the written consent of the Board, which may require a deposit from the licensee to cover the cost of levelling such excavation.

9. Before the grant of a license, the applicant shall notify every owner of land situated within 300 yards of the proposed excavation and such notification shall inform such owner that he may within seven days object in writing to the granting of a license.

10. No license will be granted for any excavation, and no excavation shall be made or maintained within 20 yards of any road, or of land owned by the Fremantle District Road Board, or any person, which would be likely (after allowing for a normal angle of slope of the materials excavated) to cause a subsidence of such road or land.

11. The license shall show on its face that it is granted for 12 months and may be renewed annually, and is subject to cancellation without compensation at any time for infringement of any of the by-laws governing the same, or on the breach of any conditions under which it has been issued.

12. The licensee shall drain and keep drained the excavations, and the responsibility for the discharge and disposal of the water drained shall be upon the licensee.

13. The Board may, before or pending the grant of a license, enter into agreements with the licensee as to compliance with the above by-laws, the observance of regulations relating to heavy traffic, the constructions and maintenance of a private road to the quarry or excavation or the licensee bearing a proportionate part of the maintenance of the public road in the said district used by him, and such agreements shall be conditions of the grant and holding of the license.

14. If the Board shall cancel the license for any reason other than the infringement of any of the conditions of the license or agreement (if any), the licensee shall be entitled to a refund of a proportionate part of the fee paid.

15. Between five and ten minutes before blasting a charge, the licensee shall, by bell, whistle, or other means, give sufficient warning of danger.

16. The holding of a license shall not exempt the licensee from damage or liability to the public or entitle or permit him to commit any nuisance.

17. Any contravention of an agreement, if any, or the conditions imposed upon the granting of a license, shall incur cancellation of the license.

18. If there is any breach of any of the above by-laws, the penalty shall be up to ± 20 .

19. These by-laws shall apply to existing as well as future quarries.

20. Nothing herein contained shall be construed to limit, diminish, or restrict any general by-law made or to be made under the Town Planning and Development Act, and in case of any inconsistency, such general by-law shall prevail.

By-laws-Bridges and Weirs.

THE Canning Road Board, under and by virtue of the powers conferred upon it by the Road Districts Act, 1919-1948, and all other powers enabling it in that behalf, doth hereby make and publish the following by-laws:—

1. No person shall fish with rod, line, net or otherwise from any bridge or weir, or from the roadway, approaches, buttresses or trestles or other part thereof, nor place or use any fishing nets or other fishing gear thereat or thereon, or upon or under the same.

2. No person shall clamber or climb on or about the structure of any bridge or weir or the approaches, buttresses or trestles thereto or thereof, or walk upon or use any part of the bridge or weir, save and except the roadway and/or footway thereof.

3. No person shall wilfully or negligently injure, maim, deface, destroy, remove, interfere, tamper with any part of a bridge or any of the timber or structure thereof, nor the approaches or buttresses thereto.

4. No person shall bathe or dive from any bridge or weir, nor from the roadway, approaches, buttresses or trestles, or any part of the structure of any such bridge or weir, or any part thereof, for any purpose connected with swimming.

5. In these by-laws, the word bridge means any bridge within the Canning Road District, and in particular the Nicholson Road and Riverton Bridges and the Kent Street Weir Footbridge.

6. Any person who does, permits or suffers any act, matter or thing contrary to any of these by-laws, or commits or permits any breach thereof, shall be guilty of an offence and shall be liable to a penalty not exceeding $\pounds 20$ for every such offence.

By-laws governing Long Service Leave to be granted to Employees of the Mcrawa Road Board.

THE Morawa Road Board under and by virtue of the powers conferred on it in that behalf by the Road Districts Act, 1919-1948, and all other powers enabling it doth hereby make and publish the following by-laws:—

1. In the interpretation of these by-laws the following words shall have the meaning assigned to them hereunder:—

(a) "Board" means the Morawa Road Board;
(b) "Continuous service" means service in the employment of the Board during which an employee has not been absent from the service of the Board for a continuous period of more than two days or an aggregate period of more than 10 days without leave of absence being granted by the Board.

2. All employees of the Board shall after each period of 10 years' continuous service as permanent full-time employees thereof commencing from 1st January, 1944, be entitled to three months' long service leave. Long service is to be taken at the convenience of the Board, which will, as far as possible meet with the wishes of the employee, but the Board may require the employee to take his leave by giving not less than three months' notice.

3. Absence on account of sickness shall not be deemed to be a break in the continuity of service, providing the period of absence shall not be longer than three months in any year, unless otherwise decided by the Board.

4. (a) Employees due to take long service leave shall be paid their salary or wage for the period thereof at the rate equivalent to the salary or wage paid in the week immediately preceding the taking of long service leave.

(b) The Board may at its discretion either-

- (i) pay to an employee his salary or wages periodically during long service leave, or
- (ii) pay to the employee in advance the sum representing the amount of his salary or wage for the period of his long service leave.

5. Employees shall not be entitled to long service leave until the completion of 10 years' service. After the completion of the first 10 years employees will be entitled to a $pro\ rata$ payment if they leave the service of the Board before the next period is completed.

6. In the event of resignation, retirement or death of an employee the Board may pay such employee (or in the case of death, to his personal representative, or if there be none, to his dependants) a sum of money equal to his salary or wages for the period of long service leave which the Board was empowered under these by-laws to grant to such employee at the date of his resignation, retirement or death, or if the Board after consideration of all the circumstances, directs that the death of an employee be presumed, the Board may authorise the payment to the dependants of the employee a sum equivalent to the amount of salary or wages which under this by-law might have been granted to the employee immediately prior to the date of his death, such date to be determined by the Board.

7. An employee dismissed by the Board except in the matter of retrenchment shall not be paid any sum in pursuance of the preceding by-law.

8. Long service leave shall be considered as a special period of recuperation after a lengthy term of service with a view to fitting the employee for a further term, and during such leave no employee shall undertake any form of employment for hire or reward unless by special permission of the Board. Any contravention of this by-law shall entitle the Board to dismiss the employee from its service and to cease paying or recover any amounts paid in advance on account of long service leave.

Division I. Teacher Training Advisory Council.

181. (i) The Teacher Training Advisory Council shall consist of the Director of Education, the Professor of Education in the University of Western Australia, the Superintendent of Teacher Training, a District Superintendent nominated by the Director of Education and a Representative of the Teachers' (ii) The duty of the council shall be to advise the Director on matters

relating to the Organisation of Teacher training.

Division II. Teacher Training Bursaries.

A number of Bursaries (not exceeding 250), tenable for two years 182 at Government High Schools or approved Secondary Schools, shall be allotted each year to Students intending to become teachers. The Bursaries shall be of an annual value of £80.

(i) The Bursaries shall be open to candidates who are domiciled in Western Australia.

Selection shall be made by the Teacher Training Selection Board consisting of the Superintendent of Teacher Training, the Superintendent of Primary or Secondary Education and a representative of the Teachers' Union. It shall be competent to appoint deputies for members of the Board when necessary. In selecting candidates the Board shall consider the following:—

(a) Personal interview

(b) Results in the Junior Certificate Examination of the University of Western Australia or its equivalent.

(c) Performance in any other test approved by the Department.

(ii) Candidates shall, when forwarding their entry forms for the Junior, apply to the University for the disclosure of their marks and pay the necessary fee.

(iii) The minimum requirement for the award of a Bursary is a Junior Certificate or its equivalent. A pass in English is essential.

(iv) Each candidate for a Bursary shall forward on the prescribed form, to the Director of Education, Education Department, Perth, not later than 30th September in each year, the information asked for therein, together with two certificates of character.

(v) Before entering on their Bursaries selected candidates shall forward a certificate of health furnished by the Government Medical Officer.

(vi) Each Bursar and his parent or guardian shall be required to submit an undertaking that the Busar shall complete the required courses in Secondary Education and Teacher Training.

(vii) Bursars shall attend a Government High School or an approved Secondary School for two years before sitting for the Leaving Certificate Examination.

(viii) The courses selected by the Bursars in their preparation for the Leaving shall be approved by the Director of Education, who reserves the right to direct a Bursar to take a course in any subject. (ix) On satisfactory completion of the secondary course the Bursar shall

be admitted to a course of teacher training as directed by the Director of Education.

(x) Payment shall be made at the end of each term and shall be contingent on the receipt of satisfactory reports from the Head of the School attended.

Division III. Teachers' College Courses.

183. Courses are available for periods varying from one to five years according to the academic qualifications of the students at entry

A-Graduates shall be given one year's professional training.

- B—Undergraduates who have completed part of a degree course may be selected for a course of training, the duration of which is sufficient to allow them to complete their degrees normally and take one year's professional training.
- C-Matriculants shall be admitted to a two year course. The first year may be spent in taking the first year towards a degree at the University. At the end of that year selected students may be granted an extension of their course to enable them to graduate. The final year of all students shall be spent in professional training at Teachers' College.

D-Holders of the Leaving Certificate shall be admitted to a two year course.

- E—Holders of the Junior Certificate or its equivalent who are at least 17 years of age shall be admitted to a three year course.
- Students who desire to specialise in Manual Training or Domestic Science teaching shall be given a three year course of professional and technical training beyond the Leaving Certificate. The periods to be spent in technical training shall be fixed by the Director.
- -Selected students may be granted an extension of training in order Gto pursue their studies in special fields.

Division IV. Admission of Students.

184. Applications for courses shall be invited from time to time and the selection made by the Teacher Training Selection Board.

185. Subject to Regulation 186 of these regulations, students may be paid allowances (as at 1/1/51) according to the following scale:— (i) Unmarried minors living with their parents, £186 per annum.

(ii) All other unmarried students, £243 per annum. (iii) Married students without family, £337 per annum.

(iv) Married students without family, £337 per annum.
(iv) Married students with family, £385 per annum. Allowances stated in sections (i), (ii), (iii) and (iv) of this regulation vary proportionately with basic wage adjustments.
(v) Students shall be entitled to recoup of expenditure not exceeding the sum of ten pounds per annum incurred by them in the purchase of text books and teaching aids required for use during training.

(iv) Students absent from College shall have any allowance payable to them under Regulation 185 reduced proportionately in respect of such absence, unless the Director approves of the said allowance not being reduced.

187. If the progress or conduct of any student be judged unsatisfactory by the Superintendent of Teacher Training the Minister may, on the recom-mendation of the Director, terminate the course of such student.

188. A student and his/her guarantor shall be required to enter into a contract with the Minister for Education, Western Australia, pledging themselves that the student will, on completion of his/her course of training at Teachers' College, serve in departmental schools for a period equal to the number of years spent in training under this agreement by that student plus one additional year (vide Appendix 8).
