PRICES CONTROL ACT, 1948-1951.

Notice-Declaration No. 61.

I, ARTHUR VALENTINE RUTHERFORD ABBOTT, Attorney General and the Minister of the Crown for the time being charged with the administration of the Prices Control Act, 1948-1951, in pursuance of the powers conferred by section 14 of the said Act and the Prices Control Regulations, 1949, do hereby amend the Schedule to Declaration No. 55 dated the 7th day of September, 1951, made under the said Act and published in the Government Gazette on the 7th day of September, 1951, in manner mentioned in the Schedule to this Declaration No. 61.

Schedule.

1. By omitting all the words appearing under the sub-heading "Fibres, Yarns, Threads and Fabrics" and inserting in their stead the words—

Blind Holland.

Carpet fabric.

Felts of wool or hair.

Fibres, natural or synthetic.

Jute and hessian piecegoods.

Linen, flax, hemp or ramie sewing threads and twists.

Rope, cordage and twine, including bindertwine.

Tyre cord and tyre fabric.

Wadding.

2. By omitting all the words appearing under the sub-heading "Clothing" and inserting in their stead the words, "Footwear, other than footwear made for the personal use and to the individual measurements of a customer." 3. By omitting all the words appearing under the sub-heading "Furniture, Furnishings and Household Drapery," and inserting in their stead the words—

Floor coverings of all kinds and descriptions, including mats, matting, carpet and carpeting.

Furniture of all kinds and descriptions (excluding furniture made solely from wicker, bamboo or cane).

Ice chests and ice boxes, domestic.

Mats and matting of coir or jute.

Mats, floor and bath, and druggets.

Moquettes and other upholstering covering material.

Spring rollers for blinds.

Tapestries and tapestry materials.

Underfelts and felt base.

Upholstering materials-

fibre;

webbing;

springs;

hessian;

piping; cord.

- 4. By omitting from the words appearing under the sub-heading "Timber, Bricks and other Building Materials" the word "Sleepers."
- 5. By omitting from the words appearing under the sub-heading "Timber, Bricks and other Building Materials," the words—

Timber, whether in the form of logs, poles or piles, sawn or unsawn, seasoned or unseasoned, dressed or undressed,

and inserting in their stead the words-

Timber, whether in the form of logs, poles or piles, sawn or unsawn, seasoned or unseasoned, dressed or undressed, other than sleepers, crossing sleepers, crossarms and wagon scantlings.

Notice—Declaration No. 62.

- 1. By omitting from the words appearing under the sub-heading "Industrial and Commercial" the words—
 - (e) The making up or partially making up of clothing (including dressmaking), furnishings, household drapery or manchester.

- (h) Any service of processing yarns, fabric or textiles, including dyeing, weaving an knitting, when such service is supplied or a custom or commission basis.
- (j) The packing or packaging of goods.
- (m) Any rights under an agreement for the hiring of films.
- (o) Storing or warehousing of goods.
- 2. By omitting from the words appearing under the sub-heading "Industrial and Commercial," the words—
 - (g) the making up or partially making up of furniture and bedding;
- and inserting in their stead the words—
 the making up or partially making up of furniture.
- 3. By omitting from the words appearing unde the sub-heading "Personal and Personal Upkeep the words—
 - (b) dry cleaning and dyeing;
 - (c) laundering.
