AT a meeting of the Executive Council, held in the Executive Council Chamber, at Perth, on the 25th day of June, 1952, the following Order in Council was authorised to be issued:—

Country Towns Sewerage Act, 1948-1951.  
Albany Sewerage Area.

### ORDER IN COUNCIL.

WHEREAS by section 4 (b) of the Country Towns Sewerage Act, 1948-1951, the Governor may, by Order in Council, constitute sewerage districts by dividing any sewerage area into sewerage districts under such names as may be directed: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, doth hereby divide the Albany Sewerage Area into two sewerage districts, namely—(a) Albany Town Sewerage District, and (b) Albany South Coastal Sewerage District, defined in the First and Second Schedules, respectively, hereunder.

#### First Schedule.

##### Albany Town Sewerage District.

All that portion of land bounded by lines starting at the North-Western corner of Plantagenet Location 5118 and extending Easterly along the Northern boundaries of locations 5118 and 779 and onwards to and along the Southernmost boundary of location 558 to the Western boundary of location 441; thence Northerly and Easterly along boundaries of that location to the South-Western corner of location 5318; thence Northerly and Easterly along boundaries of that location and onwards to and along the Southern boundary of lot A73 of location 401 to the North-Western side of Chester Pass Road (road No. 992); thence South-Westerly along that side to a point in prolongation Westerly of the Southern boundary of location 566; thence Easterly to and along the Southern boundaries of locations 566, 2308, 520 and 7 and onwards to the low water mark of Oyster Harbour; thence generally

South-Westerly along the low water mark of Oyster Harbour, Middleton Bay, King George Sound and Princess Royal Harbour to a point in prolongation South-Easterly of the South-Western boundary of location 33; thence North-Westerly, Westerly and generally Northerly along boundaries of that location (crossing the Great Southern Railway Reserve) and continuing along the Eastern side to a one-chain road about 16 chains 45 links through lot A6 of location 401 to the Southern side of an East-West road passing through that lot; thence Easterly and North-Easterly along that side to the North-Western corner of Gledhow Town Lot 60, a point on the Eastern boundary of lot A6 of location 401 as aforesaid and thence Northerly along that boundary to the starting point, as shown coloured blue on Plan P.W.D., W.A. 31842, drawing No. 2.

#### Second Schedule.

##### Albany South Coastal Sewerage District.

All that portion of land bounded by lines starting at the South-Western corner of Plantagenet Location 33 and extending Easterly and South-Easterly along the Southern and South-Western boundaries of that location and onwards to the low water mark of Princess Royal Harbour; thence generally South-Easterly, generally Northerly and again generally South-Easterly along the low water mark of Princess Royal Harbour, King George Sound, and Frenchman Bay to a point in prolongation Northerly of the Eastern boundary of location 468 (reserve 5225); thence Southerly to and along that boundary and onwards to the low water mark of the Southern Ocean; thence generally North-Westerly along that low water mark to a point in prolongation Southerly of the Western boundary of reserve 2903, and thence Northerly to and along that boundary and onwards to the starting point, as shown coloured yellow on Plan P.W.D., W.A., 31842, drawing No. 2.
